**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Adjusts hours of business of county clerk on election days.]*  
Renames card issued to electors upon registration, or update to registration, to "voter notification card."  
*[Allows Secretary of State to approve automated system for county clerks to use to verify signatures of electors casting ballots.]*  
Declares emergency, effective on passage.

**A BILL FOR AN ACT**

2 Relating to elections procedures followed by county clerks; amending ORS 166.291, 247.181, 247.191  
3 and 247.292; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 247.181 is amended to read:

6 247.181. (1) The county clerk shall prepare and issue by nonforwardable mail to each elector a  
7 *[memorandum]* **voter notification** card of convenient size containing the name and residence ad-  
8 dress of the elector, the name or number of the precinct in which the elector resides and a brief  
9 statement of the circumstances under which the elector is required to register or update a regis-  
10 tration.

11 (2) When an elector registers or updates a registration, the county clerk shall issue the elector  
12 a new *[memorandum]* **voter notification** card by nonforwardable mail.

13 (3) If an elector loses a *[memorandum]* **voter notification** card the elector may apply to the  
14 county clerk for a new card, and the county clerk shall issue the elector a new card by  
15 nonforwardable mail.

16 **SECTION 2.** ORS 247.191 is amended to read:

17 247.191. When changes in the boundaries of a precinct are made, the county clerk may alter the  
18 registration card of an elector to conform with the change, and *[shall]* **may** issue by nonforwardable  
19 mail a written notice of the change and a new *[memorandum]* **voter notification** card to the elector.  
20 This requirement does not apply to a change of precincts for special district or special elections.

21 **SECTION 3.** ORS 247.292 is amended to read:

22 247.292. (1) A county clerk shall update the registration of an elector in the county upon re-  
23 ceiving written evidence from:

24 (a) The elector indicating a residence or mailing address that is different from the residence or  
25 mailing address for the elector as contained in the records of the county clerk;

26 (b) The United States Postal Service indicating a residence address that is different from the

3 (2) When a county clerk updates the registration of an elector under subsection (1) of this sec-  
4 tion, the clerk shall send a new [*precinct memorandum*] **voter notification** card by nonforwardable  
5 mail to the elector as provided in ORS 247.181. The clerk shall include a notice stating that if the  
6 residence address or mailing address is not correct, the elector must notify the clerk.

7 (3) An elector is not disqualified from voting due to any error relating to an update of regis-  
8 tration made under this section.

9 **SECTION 4.** ORS 166.291 is amended to read:

10 166.291. (1) The sheriff of a county, upon a person's application for an Oregon concealed  
11 handgun license, upon receipt of the appropriate fees and after compliance with the procedures set  
12 out in this section, shall issue the person a concealed handgun license if the person:

13 (a)(A) Is a citizen of the United States; or

14 (B) Is a legal resident alien who can document continuous residency in the county for at least  
15 six months and has declared in writing to the United States Citizenship and Immigration Services  
16 the intent to acquire citizenship status and can present proof of the written declaration to the  
17 sheriff at the time of application for the license;

18 (b) Is at least 21 years of age;

19 (c) Is a resident of the county;

20 (d) Has no outstanding warrants for arrest;

21 (e) Is not free on any form of pretrial release;

22 (f) Demonstrates competence with a handgun by any one of the following:

23 (A) Completion of any hunter education or hunter safety course approved by the State Depart-  
24 ment of Fish and Wildlife or a similar agency of another state if handgun safety was a component  
25 of the course;

26 (B) Completion of any National Rifle Association firearms safety or training course if handgun  
27 safety was a component of the course;

28 (C) Completion of any firearms safety or training course or class available to the general public  
29 offered by law enforcement, community college, or private or public institution or organization or  
30 firearms training school utilizing instructors certified by the National Rifle Association or a law  
31 enforcement agency if handgun safety was a component of the course;

32 (D) Completion of any law enforcement firearms safety or training course or class offered for  
33 security guards, investigators, reserve law enforcement officers or any other law enforcement offi-  
34 cers if handgun safety was a component of the course;

35 (E) Presents evidence of equivalent experience with a handgun through participation in organ-  
36 ized shooting competition or military service;

37 (F) Is licensed or has been licensed to carry a firearm in this state, unless the license has been  
38 revoked; or

39 (G) Completion of any firearms training or safety course or class conducted by a firearms in-  
40 structor certified by a law enforcement agency or the National Rifle Association if handgun safety  
41 was a component of the course;

42 (g) Has never been convicted of a felony or found guilty, except for insanity under ORS 161.295,  
43 of a felony;

44 (h) Has not been convicted of a misdemeanor or found guilty, except for insanity under ORS  
45 161.295, of a misdemeanor within the four years prior to the application;

1 (i) Has not been committed to the Oregon Health Authority under ORS 426.130;

2 (j) Has not been found to be mentally ill and is not subject to an order under ORS 426.130 that  
3 the person be prohibited from purchasing or possessing a firearm as a result of that mental illness;

4 (k) Has been discharged from the jurisdiction of the juvenile court for more than four years if,  
5 while a minor, the person was found to be within the jurisdiction of the juvenile court for having  
6 committed an act that, if committed by an adult, would constitute a felony or a misdemeanor in-  
7 volving violence, as defined in ORS 166.470;

8 (L) Has not been convicted of an offense involving controlled substances or participated in a  
9 court-supervised drug diversion program, except this disability does not operate to exclude a person  
10 if:

11 (A) The person has been convicted only once of violating ORS 475.864 (3) and has not completed  
12 a court-supervised drug diversion program under ORS 135.907; or

13 (B) The person has completed a court-supervised drug diversion program under ORS 135.907 and  
14 has not been convicted of violating ORS 475.864 (3);

15 (m) Is not subject to a citation issued under ORS 163.735 or an order issued under ORS 30.866,  
16 107.700 to 107.735 or 163.738;

17 (n) Has not received a dishonorable discharge from the Armed Forces of the United States; and

18 (o) Is not required to register as a sex offender in any state.

19 (2) A person who has been granted relief under ORS 166.274 or 166.293 or section 5, chapter 826,  
20 Oregon Laws 2009, or 18 U.S.C. 925(c) or has had the person's record expunged under the laws of  
21 this state or equivalent laws of other jurisdictions is not subject to the disabilities in subsection  
22 (1)(g) to (L) of this section.

23 (3) Before the sheriff may issue a license:

24 (a) The application must state the applicant's legal name, current address and telephone number,  
25 date and place of birth, hair and eye color and height and weight. The application must also list the  
26 applicant's residence address or addresses for the previous three years. The application must contain  
27 a statement by the applicant that the applicant meets the requirements of subsection (1) of this  
28 section. The application may include the Social Security number of the applicant if the applicant  
29 voluntarily provides this number. The application must be signed by the applicant.

30 (b) The applicant must submit to fingerprinting and photographing by the sheriff. The sheriff  
31 shall fingerprint and photograph the applicant and shall conduct any investigation necessary to  
32 corroborate the requirements listed under subsection (1) of this section. If a nationwide criminal  
33 records check is necessary, the sheriff shall request the Department of State Police to conduct the  
34 check, including fingerprint identification, through the Federal Bureau of Investigation. The Federal  
35 Bureau of Investigation shall return the fingerprint cards used to conduct the criminal records  
36 check and may not keep any record of the fingerprints. The Department of State Police shall report  
37 the results of the fingerprint-based criminal records check to the sheriff. The Department of State  
38 Police shall also furnish the sheriff with any information about the applicant that the Department  
39 of State Police may have in its possession including, but not limited to, manual or computerized  
40 criminal offender information.

41 (4) Application forms for concealed handgun licenses shall be supplied by the sheriff upon re-  
42 quest. The forms shall be uniform throughout this state in substantially the following form:

- (B) \$50 to the sheriff for the issuance or renewal of a concealed handgun license.
- (C) \$15 to the sheriff for the duplication of a license because of loss or change of address.
- (b) The sheriff may enter into an agreement with the Department of Transportation to produce the concealed handgun license.
- (6) No civil or criminal liability shall attach to the sheriff or any authorized representative engaged in the receipt and review of, or an investigation connected with, any application for, or in the issuance, denial or revocation of, any license under ORS 166.291 to 166.295 as a result of the lawful performance of duties under those sections.

(d) Has documentation showing that the person filed an Oregon tax return for the most recent tax year showing a residence address in the county.

**SECTION 6. This 2013 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect on its passage.**
