

House Bill 2770

Sponsored by COMMITTEE ON HUMAN SERVICES AND HOUSING

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Prohibits use of public funds to pay home care worker who has specified criminal history.
Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to prohibition on use of public funds to pay home care worker with specified criminal his-
3 tory; amending ORS 443.004; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 443.004, as amended by section 17, chapter 70, Oregon Laws 2012, is amended
6 to read:

7 443.004. (1) The Department of Human Services or the Oregon Health Authority shall complete
8 a criminal records check under ORS 181.534 on:

9 (a) An employee of a residential facility or an adult foster home;

10 (b) Any individual who is paid directly or indirectly with public funds who has or will have
11 contact with a recipient of support services or a resident of an adult foster home or a residential
12 facility; and

13 (c) A home care worker registering with the Home Care Commission or renewing a registration
14 with the Home Care Commission.

15 (2)(a) A home health agency shall conduct a criminal background check before hiring or con-
16 tracting with an individual and before allowing an individual to volunteer to provide services on
17 behalf of the home health agency, if the individual will have direct contact with a patient of the
18 home health agency.

19 (b) An in-home care agency shall conduct a criminal background check before hiring or con-
20 tracting with an individual and before allowing an individual to volunteer to provide services on
21 behalf of the in-home care agency, if the individual will have direct contact with a client of the in-
22 home care agency.

23 (c) The authority shall prescribe by rule the process for conducting a criminal background
24 check.

25 (3) Public funds may not be used to support, in whole or in part, the employment in any capacity
26 having contact with a recipient of **home care services or** support services or a resident of a resi-
27 dential facility or an adult foster home, of an individual, other than a mental health or substance
28 abuse treatment provider, who has been convicted:

29 (a) Of a crime described in ORS 163.095, 163.115, 163.118, 163.125, 163.145, 163.149, 163.165,
30 163.175, 163.185, 163.187, 163.200, 163.205, 163.225, 163.235, 163.263, 163.264, 163.266, 163.275, 163.465,
31 163.467, 163.535, 163.537, 163.547, 163.689, 163.700, 164.055, 164.057, 164.098, 164.125 (5)(c) or (d),

1 164.215, 164.225, 164.325, 164.377 (2) or (3), 164.405, 164.415, 165.013, 165.022, 165.032, 165.800, 165.803,
 2 167.012, 167.017, 167.057, 167.320 or 167.322;

3 (b) Notwithstanding paragraph (a) of this subsection, of a crime described in ORS 163.465,
 4 163.467, 163.700, 164.055, 164.125 or 164.377, the date of conviction for which was within the five
 5 years immediately preceding employment in any capacity of an individual, other than a mental
 6 health or substance abuse treatment provider, having contact with a recipient of support services,
 7 a resident of a residential facility or a resident of an adult foster home, when the recipient or resi-
 8 dent is 65 years of age or older;

9 (c) Of a crime listed in ORS 181.594;

10 (d) In the last 10 years, of a crime involving the delivery or manufacture of a controlled sub-
 11 stance;

12 (e) Of an attempt, conspiracy or solicitation to commit a crime described in paragraphs (a) to
 13 (d) of this subsection; or

14 (f) Of a crime in another jurisdiction that is substantially equivalent, as defined by rule, to a
 15 crime described in paragraphs (a) to (e) of this subsection.

16 (4) If the criminal background check conducted by a home health agency or in-home care agency
 17 under subsection (2) of this section reveals that the individual who is subject to the criminal back-
 18 ground check has been convicted of any of the crimes described in subsection (3) of this section, the
 19 home health agency or in-home care agency may not employ the individual.

20 (5) Public funds may not be used to support, in whole or in part, the employment, in any ca-
 21 pacity having contact with a recipient of **home care services** or support services or a resident of
 22 a residential facility or an adult foster home, of a mental health or substance abuse treatment pro-
 23 vider who has been convicted of committing, or convicted of an attempt, conspiracy or solicitation
 24 to commit, a crime described in ORS 163.095, 163.115, 163.375, 163.405, 163.411 or 163.427.

25 (6) Upon the request of a mental health or substance abuse treatment provider, the department
 26 or authority shall maintain a record of the results of any fitness determination made under ORS
 27 181.534 (11) and (12). The department or authority may disclose the record only to a person the
 28 provider specifically authorizes, by a written release, to receive the information.

29 (7) If the department or authority has a record of substantiated abuse committed by an employee
 30 or potential employee of a home health agency, in-home care agency, adult foster home or residen-
 31 tial facility, regardless of whether criminal charges were filed, the department or authority shall
 32 notify, in writing, the employer and the employee or potential employee.

33 (8) As used in this section:

34 (a) "Adult foster home" has the meaning given that term in ORS 443.705.

35 **(b) "Home care services" has the meaning given that term in ORS 410.600.**

36 [(b)] (c) "Home care worker" has the meaning given that term in ORS 410.600.

37 [(c)] (d) "Home health agency" has the meaning given that term in ORS 443.005.

38 [(d)] (e) "In-home care agency" has the meaning given that term in ORS 443.305.

39 [(e)] (f) "Mental health or substance abuse treatment provider" means:

40 (A) A peer support specialist;

41 (B) An employee of a residential treatment facility or a residential treatment home that is li-
 42 censed under ORS 443.415 to provide treatment for individuals with alcohol or drug dependence;

43 (C) An individual who provides treatment or services for persons with substance use disorders;
 44 or

45 (D) An individual who provides mental health treatment or services.

- 1 [(f)] (g) "Peer support specialist" means a person who:
2 (A) Is providing peer support services as defined by the authority by rule;
3 (B) Is under the supervision of a qualified clinical supervisor;
4 (C) Has completed training required by the authority; and
5 (D) Is currently receiving or has formerly received mental health services, or is in recovery from
6 a substance use disorder and meets the abstinence requirements for staff providing services in al-
7 cohol or other drug treatment programs.
- 8 [(g)] (h) "Residential facility" has the meaning given that term in ORS 443.400.
- 9 **SECTION 2. This 2013 Act being necessary for the immediate preservation of the public**
10 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
11 **on its passage.**
