# B-Engrossed House Bill 2807

Ordered by the House June 24 Including House Amendments dated April 23 and June 24

Sponsored by COMMITTEE ON ENERGY AND ENVIRONMENT

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions related to collection of energy resource supplier assessment. Modifies certain provisions governing State Department of Energy operations.

Directs Director of State Department of Energy to convene work group composed of stakeholders for purpose of reviewing and making recommendations on certain departmental proposals.

Creates process by which department provides notice to certain energy resource suppliers of submitting comments or written or oral testimony in rulemaking, contested case, ratemaking or other proceeding conducted by certain state agencies or of intervening in proceeding conducted by federal agencies.

Requires department to make available, upon request, State Department of Energy Account records for prior fiscal year to any energy resource supplier that has paid annual assessment.

Transfers duties, functions and powers of Oregon Department of Administrative Services relating to Energy Facility Siting Council to State Department of Energy.

Makes technical amendments to provision authorizing State Department of Energy to use moneys in Jobs, Energy and Schools Fund.

# ANNUAL ENERGY RESOURCE SUPPLIER ASSESSMENT

7 8

SECTION 1. ORS 469.421 is amended to read:

469.421. (1) Subject to the provisions of ORS 469.441, any person submitting a notice of intent, 9 a request for exemption under ORS 469.320, a request for an expedited review under ORS 469.370, 10 a request for an expedited review under ORS 469.373, a request for the State Department of Energy 11 to approve a pipeline under ORS 469.405 (3), an application for a site certificate or a request to 12 13 amend a site certificate shall pay all expenses incurred by the Energy Facility Siting Council, the State Department of Energy and the Oregon Department of Administrative Services] and the depart-14 **ment** related to the review and decision of the council. These expenses may include legal expenses, 15 expenses incurred in processing and evaluating the application, issuing a final order or site certif-16 icate, commissioning an independent study by a contractor, state agency or local government under 17 ORS 469.360, and changes to the rules of the council that are specifically required and related to 18 the particular site certificate. 19

20 (2) Every person submitting a notice of intent to file for a site certificate, a request for ex-

emption or a request for expedited review shall submit the fee required under the fee schedule es-1 tablished under ORS 469.441 to the [State] department [of Energy] when the notice or request is 2 submitted to the council. To the extent possible, the full cost of the evaluation shall be paid from 3 the fee paid under this subsection. However, if costs of the evaluation exceed the fee, the person 4 submitting the notice or request shall pay any excess costs shown in an itemized statement prepared  $\mathbf{5}$ by the council. In no event shall the council incur evaluation expenses in excess of 110 percent of 6 the fee initially paid unless the council provides prior notification to the applicant and a detailed 7 projected budget the council believes necessary to complete the project. If costs are less than the 8 9 fee paid, the excess shall be refunded to the person submitting the notice or request.

(3) Before submitting a site certificate application, the applicant shall request from the [State] 10 department [of Energy] an estimate of the costs expected to be incurred in processing the applica-11 12 tion. The department shall inform the applicant of that amount and require the applicant to make 13 periodic payments of the costs pursuant to a cost reimbursement agreement. The cost reimbursement agreement shall provide for payment of 25 percent of the estimated costs when the applicant submits 14 15 the application. If costs of the evaluation exceed the estimate, the applicant shall pay any excess 16 costs shown in an itemized statement prepared by the council. In no event shall the council incur evaluation expenses in excess of 110 percent of the fee initially estimated unless the council pro-17 18 vided prior notification to the applicant and a detailed projected budget the council believes is 19 necessary to complete the project. If costs are less than the fee paid, the council shall refund the 20excess to the applicant.

(4) Any person who is delinquent in the payment of fees under subsections (1) to (3) of this
 section shall be subject to the provisions of subsection (11) of this section.

23(5) Subject to the provisions of ORS 469.441, each holder of a certificate shall pay an annual fee, due every July 1 following issuance of a site certificate. For each fiscal year, upon approval of the 2425[State Department of Energy's] department's budget authorization by an odd-numbered year regular session of the Legislative Assembly or as revised by the Emergency Board meeting in an interim 2627period or by the Legislative Assembly meeting in special session or in an even-numbered year regular session, the Director of the State Department of Energy promptly shall enter an order estab-28lishing an annual fee based on the amount of revenues that the director estimates is needed to fund 2930 the cost of ensuring that the facility is being operated consistently with the terms and conditions 31 of the site certificate, any order issued by the department under ORS 469.405 (3) and any applicable health or safety standards. In determining this cost, the director shall include both the actual direct 32cost to be incurred by the council[, the State Department of Energy and the Oregon Department of 33 34 Administrative Services] and the department to ensure that the facility is being operated consistently with the terms and conditions of the site certificate, any order issued by the [State] department 35 [of Energy] under ORS 469.405 (3) and any applicable health or safety standards, and the general 36 37 costs to be incurred by the council, the State Department of Energy and the Oregon Department of 38 Administrative Services] and the department to ensure that all certificated facilities are being operated consistently with the terms and conditions of the site certificates, any orders issued by the 39 40 [State] department [of Energy] under ORS 469.405 (3) and any applicable health or safety standards that cannot be allocated to an individual, licensed facility. Not more than 35 percent of the annual 41 42 fee charged each facility shall be for the recovery of these general costs. The fees for direct costs shall reflect the size and complexity of the facility and its certificate conditions. 43

(6) Each holder of a site certificate executed after July 1 of any fiscal year shall pay a fee for
the remaining portion of the year. The amount of the fee shall be set at the cost of regulating the

facility during the remaining portion of the year determined in the same manner as the annual fee. 1 2 (7) When the actual costs of regulation incurred by the council, the State Department of Energy and the Oregon Department of Administrative Services] and the department for the year, including 3 that portion of the general regulation costs that have been allocated to a particular facility, are less 4 than the annual fees for that facility, the unexpended balance shall be refunded to the site certif-5 icate holder. When the actual regulation costs incurred by the council, the State Department of 6 Energy and the Oregon Department of Administrative Services] and the department for the year, 7 including that portion of the general regulation costs that have been allocated to a particular fa-8 9 cility, are projected to exceed the annual fee for that facility, the director [of the State Department 10 of Energy] may issue an order revising the annual fee.

(8)(a) In addition to any other fees required by law, each energy resource supplier shall pay to the [State] department [of Energy] annually its share of an assessment to fund the **programs and** activities of the [Energy Facility Siting Council, the Oregon Department of Administrative Services and the State Department of Energy, determined by the Director of the State Department of Energy in the following manner:] council and the department.

16(b) Prior to filing budget forms under ORS 291.208 for purposes related to the compilation and preparation of the Governor's budget under ORS 291.216, the director shall determine the 17 18 projected aggregate amount of revenue to be collected from energy resource suppliers under this subsection that will be necessary to fund the programs and activities of the council and 19 20the department for each fiscal year of the upcoming biennium. After making that determination, the director shall convene a public meeting with representatives of energy resource 2122suppliers and other interested parties for the purpose of providing energy resource suppliers 23with a full accounting of:

27[(a)] (c) Upon approval of the budget authorization of the [Energy Facility Siting Council, the Oregon Department of Administrative Services and the State Department of Energy] council and the 28**department** by an odd-numbered year regular session of the Legislative Assembly, the director [of 2930 the State Department of Energy] shall promptly enter an order establishing the amount of revenues 31 required to be derived from an assessment pursuant to this subsection in order to fund [the activities of the Energy Facility Siting Council, the Oregon Department of Administrative Services and the State 32Department of Energy, including those enumerated in ORS 469.030 and others authorized by law,] 33 34 programs and activities that the council and the department are charged with administering 35 and authorized to conduct under the laws of this state, including those enumerated in ORS 469.030, for the first fiscal year of the forthcoming biennium. On or before June 1 of each even-36 37 numbered year, the director [of the State Department of Energy] shall enter an order establishing the 38 amount of revenues required to be derived from an assessment pursuant to this subsection in order to fund the [activities of the Energy Facility Siting Council, the Oregon Department of Administrative 39 40 Services and the State Department of Energy, including those enumerated in ORS 469.030 and others authorized by law, programs and activities that the council and the department are charged 41 42with administering and authorized to conduct under the laws of this state, including those enumerated in ORS 469.030, for the second fiscal year of the biennium. The order shall take into 43 account any revisions to the biennial budget of the [Energy Facility Siting Council, the State De-44 partment of Energy and the Oregon Department of Administrative Services] council and the depart-45

**ment** made by the Emergency Board meeting in an interim period or by the Legislative Assembly meeting in special session or in an even-numbered year regular session. [However, an assessment under this section may not be used to derive revenue for funding State Department of Energy activities

related to the energy efficiency and sustainable technology loan program described in ORS chapter
 470.]

6 [(b)] (d) Each order issued by the director pursuant to paragraph [(a)] (c) of this subsection shall 7 allocate the aggregate assessment set forth [therein] in the order to energy resource suppliers in 8 accordance with paragraph [(c)] (e) of this subsection.

9 [(c)] (e) The amount assessed to an energy resource supplier shall be based on the ratio which 10 that supplier's annual gross operating revenue derived within this state in the preceding calendar 11 year bears to the total gross operating revenue derived within this state during that year by all 12 energy resource suppliers. The assessment against an energy resource supplier shall not exceed 13 [*five-tenths of one*] **0.375** percent of the supplier's gross operating revenue derived within this state 14 in the preceding calendar year. The director shall exempt from payment of an assessment any indi-15 vidual energy resource supplier whose calculated share of the annual assessment is less than \$250.

16 [(d)] (f) The director shall send each energy resource supplier subject to assessment pursuant 17 to this subsection a copy of each order issued[,] by registered or certified mail or through use of 18 an electronic medium with electronic receipt verification. The amount assessed to the energy 19 resource supplier pursuant to the order shall be considered to the extent otherwise permitted by law 20 a government-imposed cost and recoverable by the energy resource supplier as a cost included 21 within the price of the service or product supplied.

[(e)] (g) The amounts assessed to individual energy resource suppliers pursuant to paragraph [(c)] (e) of this subsection shall be paid to the [State] department [of Energy] as follows:

(A) Amounts assessed for the first fiscal year of a biennium shall be paid not later than 90 days
following adjournment sine die of the odd-numbered year regular session of the Legislative Assembly; and

(B) Amounts assessed for the second fiscal year of a biennium shall be paid not later than July
1 of each even-numbered year or 90 days following adjournment sine die of the even-numbered year
regular session of the Legislative Assembly, whichever is later.

30 [(f)] (h) An energy resource supplier shall provide the director, on or before May 1 of each year, 31 a verified statement showing its gross operating revenues derived within the state for the [preceding calendar year.] calendar or fiscal year that was used by the energy resource supplier for the 32purpose of reporting federal income taxes for the preceding calendar or fiscal year. The 33 34 statement [shall] must be in the form prescribed by the director and is subject to audit by the di-35 rector. The statement [shall] **must** include an entry showing the total operating revenue derived by petroleum suppliers from fuels sold that are subject to the requirements of [section 3a,] Article IX, 36 37 section 3a, of the Oregon Constitution, and ORS 319.020 with reference to aircraft fuel and motor 38 vehicle fuel, and ORS 319.530. 2 (A) "Energy resource supplier" means an electric utility, natural gas utility or petroleum sup-3 plier supplying, generating, transmitting or distributing electricity, natural gas or petroleum pro-4 ducts in Oregon.

5 (B) "Gross operating revenue" means gross receipts from sales or service made or provided 6 within this state during the regular course of the energy supplier's business, but does not include 7 either revenue derived from interutility sales within the state or revenue received by a petroleum 8 supplier from the sale of fuels that are subject to the requirements of [section 3a,] Article IX, sec-9 tion 3a, of the Oregon Constitution, or ORS 319.020 or 319.530.

(C) "Petroleum supplier" has the meaning given that term in ORS 469.020.

[(h)] (j) In determining the amount of revenues that must be derived from any class of energy resource suppliers by assessment pursuant to this subsection, the director shall take into account all other known or readily ascertainable sources of revenue to the [Energy Facility Siting Council, the Oregon Department of Administrative Services and the State Department of Energy] council and department, including, but not limited to, fees imposed under this section and federal funds, and may take into account any funds previously assessed pursuant to ORS 469.420 (1979 Replacement Part) or section 7, chapter 792, Oregon Laws 1981.

18 [(*i*)] (**k**) Orders issued by the director pursuant to this section shall be subject to judicial review 19 under ORS 183.484. The taking of judicial review shall not operate to stay the obligation of an en-20 ergy resource supplier to pay amounts assessed to it on or before the statutory deadline.

(9)(a) In addition to any other fees required by law, each operator of a nuclear fueled thermal power plant or nuclear installation within this state shall pay to the [*State*] department [of Energy] annually on July 1[,] an assessment in an amount determined by the director to be necessary to fund the activities of the state and the counties associated with emergency preparedness for a nuclear fueled thermal power plant or nuclear installation. The assessment shall not exceed \$461,250 per year. Moneys collected as assessments under this subsection are continuously appropriated to the [*State*] department [of Energy] for this purpose.

(b) The [*State*] department [*of Energy*] shall maintain and [*shall*] cause other state agencies and counties to maintain time and billing records for the expenditure of any fees collected from an operator of a nuclear fueled thermal power plant under paragraph (a) of this subsection.

(10) Reactors operated by a college, university or graduate center for research purposes and
 electric utilities not connected to the Northwest Power Grid are exempt from the fee requirements
 of subsections (5), (8) and (9) of this section.

(11)(a) All fees assessed by the director against holders of site certificates for facilities that have
an installed capacity of 500 megawatts or greater may be paid in several installments, the schedule
for which shall be negotiated between the director and the site certificate holder.

37 (b) Energy resource suppliers or applicants or holders of a site certificate who fail to pay a fee 38 provided under subsections (1) to (9) of this section or the fees required under ORS 469.360 after it is due and payable shall pay, in addition to that fee, a penalty of two percent of the fee a month for 39 the period that the fee is past due. Any payment made according to the terms of a schedule nego-40 tiated under paragraph (a) of this subsection shall not be considered past due. 26 <u>SECTION 15.</u> (1) Nothing in sections 9 and 12 to 17 of this 2013 Act or the amendments 27 to ORS 184.345, 469.421 and 469.450 by sections 1, 10 and 11 of this 2013 Act relieves a person 28 of a liability, duty or obligation accruing under or with respect to the duties, functions and 29 powers transferred by section 9 of this 2013 Act. The State Department of Energy may 30 undertake the collection or enforcement of any such liability, duty or obligation.

(2) The rights and obligations of the Oregon Department of Administrative Services legally incurred under contracts, leases and business transactions executed, entered into or begun before the effective date of section 9 of this 2013 Act accruing under or with respect to the duties, functions and powers transferred by section 9 of this 2013 Act are transferred to the State Department of Energy. For the purpose of succession to these rights and obligations, the State Department of Energy is a continuation of the Oregon Department of Administrative Services and not a new authority.

38 SECTION 16. Notwithstanding the transfer of duties, functions and powers by section 9 of this 2013 Act, the rules of the Oregon Department of Administrative Services with respect 39 to such duties, functions or powers that are in effect on the effective date of section 9 of this 40 2013 Act continue in effect until superseded or repealed by rules of the State Department of 41 42Energy. # JOBS, ENERGY AND SCHOOLS FUND

SECTION 18. ORS 470.575 is amended to read: 13

470.575. (1) The Jobs, Energy and Schools Fund is established in the State Treasury, separate 14 15 and distinct from the General Fund. Interest earned by the Jobs, Energy and Schools Fund shall be 16 credited to the Jobs, Energy and Schools Fund. Moneys in the fund are continuously appropriated to the State Department of Energy for use as provided in this section. 17

18 (2) The fund shall consist of any moneys directed by law, gift, grant or donation to the fund and 19 moneys from base efficiency package fees collected pursuant to ORS 470.655.

20(3) The department shall use fund moneys:

(a) To promote energy efficiency, renewable energy and energy conservation projects, including 2122the clean energy deployment program established in ORS 470.810, that would otherwise result in a 23higher overall cost to the applicant when energy costs and the financing and repayment costs for the project are considered, [by using the fund moneys to help produce a lower-or zero-interest cost of 24 25loans obtained through the Small Scale Local Energy Project Loan Fund established in section 1, Article XI-J of the Oregon Constitution, or the Clean Energy Deployment Fund established in ORS 2627470.800 for the applicant] by using the fund moneys to help reduce the overall financing costs associated with related projects; or 28

(b) To transfer to an appropriate fund for carrying out any purpose under this chapter specified 2930 as a condition of a gift, grant or donation.
