SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Sets out uniform provisions for certain aspects of state building code administration and enforcement. Eliminates certain specific specialty code provisions regarding matters regulated under new uniform provisions.]

Allows charging *[investigative fee and higher permit fees]* **investigation fee** if construction, alteration, repair or installation is commenced without required *[plan review or without]* permit. Creates exceptions. Allows bringing suit to enjoin violation of state building code.

Prohibits engaging in business as specialty code contractor without required authorization. Prohibits holding out as authorized specialty code contractor without possessing authorization. Prohibits performance of work in unsafe manner. Prohibits building inspector from inspecting work if relative has interest in or affiliation with property. Revises civil penalty language.

Specifies authority of department and advisory boards when conducting building inspection programs.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Sections 2 to 4 of this 2013 Act are added to and made a part of ORS chapter**
6 **455.**

7 **SECTION 2. (1) Except as provided in subsection (2) of this section, the Department of**
8 **Consumer and Business Services, or a municipality administering and enforcing a building**
9 **inspection program, may assess an investigation fee against a person that is required to ob-**
10 **tain a permit for work on the electrical, gas, mechanical, elevator, boiler, plumbing or other**
11 **systems of a building or structure if the work is commenced before the permit required for**
12 **the work is obtained. The amount of the investigation fee shall be the average or actual ad-**
13 **ditional cost of ensuring that a building, structure or system is in conformance with state**
14 **building code requirements that results from the person not obtaining a required permit**
15 **before work for which the permit is required commences.**

16 **(2) This section does not apply to:**

17 **(a) An emergency repair required for health, safety, the prevention of property damage**
18 **or the prevention of financial harm if the required building permit for the repair is obtained**
19 **no later than five business days after commencement of the repair; or**

20 **(b) Any project for which construction, alteration, repair, maintenance or installation in**
21 **a building or structure prior to obtaining a permit is expressly authorized by law.**

22 **(3) The department may adopt rules and establish policies and procedures for use by the**

1 department or municipalities in assessing an investigation fee under this section.

2 **SECTION 3.** If the Department of Consumer and Business Services has reason to believe
3 that any person has been engaged, or is engaging, or is about to engage in any violation of
4 the state building code or of ORS 446.003 to 446.200, 446.225 to 446.285, 446.395 to 446.420,
5 479.510 to 479.945, 479.950 or 480.510 to 480.670 or this chapter or ORS chapter 447, 460 or 693
6 or any rule adopted under those statutes, the department may, without bond, bring suit in
7 the name and on behalf of the State of Oregon in the circuit court of any county of this state
8 to enjoin the acts or practices and to enforce compliance with the state building code and
9 ORS 446.003 to 446.200, 446.225 to 446.285, 446.395 to 446.420, 479.510 to 479.945, 479.950 and
10 480.510 to 480.670 and this chapter, and ORS chapter 447, 460 or 693 and any rule adopted
11 under those statutes. Upon a proper showing, a permanent or temporary injunction, re-
12 straining order or writ of mandamus shall be granted.

13 **SECTION 4.** A person may not:

14 (1) Perform work without appropriate licensing, certification or registration or employ,
15 allow, permit or suffer individuals to perform work for the person without appropriate li-
16 censing, certification or registration.

17 (2) Advertise or otherwise hold out as being a licensed, certified or registered specialty
18 code contractor without holding the appropriate specialty code contractor license, certif-
19 ication or registration.

20 (3) As a partner, officer, member or employee of a business, advertise or hold out that
21 the business is a licensed, certified or registered specialty code contractor if the business
22 does not hold the appropriate specialty code contractor license, certification or registration.

23 (4) Engage in business as a specialty code contractor without holding a valid specialty
24 code contractor license, certificate or registration required for the business.

25 (5) Perform work or operate equipment within the scope of a specialty code license, cer-
26 tificate or registration in a manner that violates an applicable minimum safety standard or
27 a statute or rule regarding safety.

28 **SECTION 5.** ORS 446.405 is amended to read:

29 446.405. (1) If a manufactured dwelling or cabana is not installed in accordance with the rules
30 adopted under ORS 446.003 and 446.395 to 446.420, the owner of the manufactured dwelling or
31 cabana, at the time of installation, may, within one year of the completion date of such installation,
32 file a written complaint with [*the Director of*] the Department of Consumer and Business Services.
33 The [*director*] **department** shall provide a copy of the complaint to the installer and shall also notify
34 the dealer, if any, that arranged for such installation and may then investigate the complaint. If [*it*
35 *is determined by the director*] **the department determines** that the installation fails to comply with
36 licensure requirements as provided by ORS 446.003 and 446.395 to 446.420 or the installation rules
37 adopted by the Director **of the Department of Consumer and Business Services**, the [*director*]
38 **department** shall provide notice of such failure to the installer and shall order the installer to bring
39 the installation into compliance [*within 30 days of date of notice*].

40 (2) The director shall establish, by rule, fees and a procedure for inspection of manufactured
41 dwellings and cabanas to carry out the provisions of this section.

42 (3) If the installer fails to bring the installation into compliance as ordered, the [*director*] **de-**
43 **partment** may suspend or revoke the installer's license as provided [*by Department of Consumer and*
44 *Business Services rules adopted*] under ORS 455.129.

45 (4) If the installer fails to bring the installation into compliance, the [*director*] **department** shall

1 order the dealer, if any, that arranged for such installation to bring the installation into compliance
2 with the provisions of ORS 446.003 and 446.395 to 446.420 and the rules adopted [*pursuant thereto*]
3 **under ORS 446.003 and 446.395 to 446.420**. The dealer is responsible to bring only those installation
4 activities into compliance [*which*] **that** the dealer arranged. The dealer shall have 30 days from the
5 date of the order to bring the installation into compliance. If the dealer fails to bring the installation
6 into compliance within 30 days of the date of the order, the dealer shall be subject to civil penalties
7 as provided by ORS 446.416.

8 (5) Hearings, penalties and appeals resulting from violation of this section shall be carried out
9 in conformance with ORS 183.325 to 183.497 and this section.

10 **SECTION 6.** ORS 455.070 is amended to read:

11 455.070. (1) Any person may report a suspected violation of the state building code[*which*] **that**
12 poses an imminent threat to public health or safety[,] to the local building official or, where the code
13 is state-administered, to the Department of Consumer and Business Services. The complaint shall
14 be in writing and submitted under rules adopted by the department. The rules of the department
15 shall provide for the disposition of frivolous or harassing complaints by requiring detailed de-
16 scriptions of the alleged violation and reference to the code sections allegedly violated. [*A copy of*
17 *the complaint shall be given by the municipality or agency*]

18 (2) **The municipality or the department shall give notice of the complaint** to the contractor,
19 building owner and subcontractor, if any, involved in the project alleged to be in violation. The
20 municipality or [*agency*] **the department** may charge the complainant for the necessary costs of
21 supplying, copying and distributing the complaint form.

22 (3) If, after five working days, no remedial action has taken place, the complainant has standing
23 to appeal the matter to the appeals board of the municipality, where one is established, or directly
24 to the [*applicable state*] **appropriate** advisory board where there is no local appeals board. The
25 municipal appeals board or state advisory board shall reach a final decision within 14 days of the
26 complainant's appeal. A municipal appeals board decision shall then be subject to appeal to a state
27 advisory board under ORS 455.690, provided that the state advisory board shall reach a final deter-
28 mination within 14 days of notice of an appeal. A record of the written complaint and the findings
29 of the appeals and advisory boards may be introduced into evidence in any judicial proceeding for
30 damages brought against the complainant by any person suffering damages as a result of the com-
31 plaint.

2 [(2)] (3) For purposes of ORS [701.100] **701.106**, a compliance failure described in subsection
3 [(1)(a)] (2)(a) of this section for which the director or an advisory board denies, suspends, conditions
4 or revokes a registration, certification, license or other authority **of a person** to perform work or
5 conduct business may be treated as a failure to be in conformance with this chapter.

29 **that the business is a licensed, certified or registered specialty code contractor if the busi-**
30 **ness does not possess the appropriate specialty code contractor license, certificate or regis-**
31 **tration.**

32 (g) **Has engaged in business as a specialty code contractor without holding a valid spe-**
33 **cialty code contractor license, certificate or registration required for the business.**

34 [(e)] (h) Has failed to meet any condition or requirement to obtain or maintain a license, cer-
35 tificate or registration.

36 [(f)] (i) Has acted in a manner creating a serious danger to the public health or safety.

37 (j) **Has performed work or operated equipment within the scope of a specialty code li-**
38 **cence, certificate or registration in a manner that violates an applicable minimum safety**
39 **standard or a statute or rule regarding safety.**

40 [(g)] (k) Has been subject to a revocation, cancellation or suspension order or to other disci-
41 plinary action by the Construction Contractors Board or has failed to pay a civil penalty imposed
42 by the board.

43 [(h)] (L) Has been subject to a revocation, cancellation or suspension order or to other disci-
44 plinary action by another state in regard to construction standards, permit requirements or
45 construction-related licensing violations or has failed to pay a civil penalty imposed by the other

1 state in regard to construction standards, permit requirements or construction-related licensing vi-
2 olations.

3 [(i)] (m) Has, while performing work that requires or that is related to work that requires a
4 valid license or certificate under ORS 446.003 to 446.200, 446.225 to 446.285, 446.395 to 446.420,
5 479.510 to 479.945, 479.950 or 480.510 to 480.670[,] or this chapter or ORS chapter 447, 460 or 693,
6 violated any statute or rule related to the state building code.

7 (n) **Has performed a code inspection or plan review on a project to construct, alter, re-**
8 **pair or make an installation in a structure if the inspector or reviewer, or an employer or**
9 **relative of the inspector or reviewer, has a financial interest in or business affiliation with**
10 **the project or structure.**

11 [(j)] (o) Is a business, the owner or an officer of which has an outstanding obligation to pay a
12 civil penalty assessed under ORS 455.895 or has been the subject of action against the license, cer-
13 tificate or registration by the Department of Consumer and Business Services, the director or [any]
14 **an appropriate** advisory board.

15 [(k)] (p) Is a business, owner or officer of a reorganized business entity as defined in ORS
16 657.682, if an owner, officer, shareholder or partner of the reorganized business entity, or a member

 25 nership or association, who personally participates in or is an accessory to any violation by the
 26 partnership, association or corporation of a provision or rule described in subsection (2) of this
 27 section is subject to the penalties prescribed in this section.

28 (9) In addition to the civil penalty set forth in subsection (1) or (2) of this section, any person
 29 who violates a provision or rule described in subsection (2) of this section may be required by the
 30 [director] **department** or the appropriate **advisory** board to forfeit and pay to the General Fund of
 31 the State Treasury a civil penalty in an amount determined by the [director] **department** or **advi-**
 32 **sory** board that [shall] **does** not exceed five times the amount by which such person profited in any
 33 transaction that violates a provision or rule described in subsection (2) of this section.

34 (10) If a civil penalty is imposed for a violation of a provision of ORS 446.566 to 446.646 and the
 35 violation relates to a filing or failure to file with a county assessor functioning as agent of the de-
 36 partment, the department, after deducting an amount equal to the department’s procedural, col-
 37 lection and other related costs and expenses, shall forward one-half of the remaining civil penalty
 38 amount to the county in which the manufactured structure is located at the time of the violation.

39 **SECTION 12.** ORS 480.530 is amended to read:

40 480.530. The Department of Consumer and Business Services may:

41 (1) Where it appears that a person is engaging in or is about to engage in an act or practice in
 42 violation of any provision of ORS 480.510 to 480.670, obtain without furnishing a bond, a restraining
 43 order and injunction from the circuit court in the county where the act or practice is occurring, or
 44 is threatened, enjoining the act or practice. However, before obtaining a restraining order and in-
 45 junction, unless the act or practice constitutes an immediate threat to health and safety, the de-

1 partment shall first notify the person concerned of the department's intentions. The notice shall be
2 in writing, shall advise the person concerned of the department's intentions and shall advise the
3 person concerned of the right to appeal in writing within 10 days and that the appeal will be heard
4 by the Board of Boiler Rules. In case there is a timely request for an appeal, proceedings will be
5 stayed pending the appeal, unless the act or practice constitutes an immediate menace to health or
6 safety or the person concerned fails to prosecute the appeal with diligence.

7 (2) Keep a complete record of the types, dimensions, maximum allowable working pressures, age,
8 location and date of the last recorded inspection of all boilers and pressure vessels to which ORS
9 480.510 to 480.670 apply.

10 (3) Publish and distribute copies of the rules and [*regulations*] **codes applicable to boilers and**
11 **pressure vessels.**

12 (4) Check or cause to be checked the authenticity, appropriateness and expiration dates of li-
13 censes and certificates issued under ORS 480.510 to 480.670.

14 (5) Administer written, oral or practical examinations to all applicants for certification as chief
15 boiler inspector, deputy inspector or special inspector under ORS 480.565.

16 **SECTION 13. Section 2 of this 2013 Act applies to amounts charged in the form of an**
17 **investigation fee on or after the effective date of this 2013 Act for construction, alterations,**
18 **repairs, maintenance and installations commenced before, on or after the effective date of**
19 **this 2013 Act.**
