SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires disclosure of shipping and handling charges in sale or advertisement of consumer good.

A BILL FOR AN ACT

2 Relating to consumer goods disclosures; creating new provisions; and amending ORS 646.608.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) As used in this section:**

5 (a) **“Advertise” means to communicate about a consumer good by newspaper, radio,**
6 **television, handbill, placard or other print, broadcast or electronic medium within this state**
7 **for the purpose of selling the consumer good.**

8 (b) **“Consumer goods” means goods that an individual uses or buys for use primarily for**
9 **personal, family or household purposes.**

10 (2) **A person that offers for sale, sells or advertises consumer goods that the person will**
11 **ship directly to a consumer in this state shall clearly disclose during the sales transaction**
12 **the charges, if any, that the consumer must pay for handling and shipping the consumer**
13 **goods.**

14 (3) **A person that fails to disclose the shipping and handling charges for consumer goods**
15 **in a transaction described in subsection (2) of this section commits an unlawful practice**
16 **under ORS 646.608 that is subject to enforcement under ORS 646.632 and an action under**
17 **ORS 646.638.**

18 **SECTION 2. ORS 646.608, as amended by section 6, chapter 52, Oregon Laws 2012, is amended**
19 **to read:**

20 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-
21 ness, vocation or occupation the person does any of the following:

22 (a) Passes off real estate, goods or services as those of another.

23 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
24 proval, or certification of real estate, goods or services.

25 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
26 ciation with, or certification by, another.

27 (d) Uses deceptive representations or designations of geographic origin in connection with real
28 estate, goods or services.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
2 ingredients, uses, benefits, quantities or qualities that *[they]* **the real estate, goods or services** do
3 not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection
4 that the person does not have.

5 (f) Represents that real estate or goods are original or new if *[they]* **the real estate or goods**
6 are deteriorated, altered, reconditioned, reclaimed, used or secondhand.

7 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
8 or that real estate or goods are of a particular style or model, if *[they]* **the real estate, goods or**
9 **services** are of another.

10 (h) Disparages the real estate, goods, services, property or business of a customer or another
11 by false or misleading representations of fact.

12 (i) Advertises real estate, goods or services with intent not to provide *[them]* **the real estate,**
13 **goods or services** as advertised, or with intent not to supply reasonably expectable public demand,
14 unless the advertisement discloses a limitation of quantity.

15 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
16 or amounts of price reductions.

17 (k) Makes false or misleading representations concerning credit availability or the nature of the
18 transaction or obligation incurred.

19 (L) Makes false or misleading representations relating to commissions or other compensation to
20 be paid in exchange for permitting real estate, goods or services to be used for model or demon-
21 stration purposes or in exchange for submitting names of potential customers.

22 (m) Performs service on or dismantles any goods or real estate when *[not authorized by]* the
23 owner or apparent owner *[thereof]* **of the goods or real estate does not authorize the service**
24 **or the dismantling.**

25 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
26 vides the information required under ORS 646.611.

27 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
28 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
29 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
30 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
31 discount or other value is contingent upon *[occurrence of]* an event *[subsequent to]* **occurring after**
32 the time the customer enters into the transaction.

33 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
34 cize a product, business or service.

35 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
36 not to deliver *[them]* **the real estate, goods or services** as promised.

37 (r) Organizes or induces or attempts to induce membership in a pyramid club.

38 (s) Makes false or misleading representations of fact concerning the offering price of, or the
39 person's cost for real estate, goods or services.

40 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
41 known material defect or material nonconformity.

42 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

43 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under
44 ORS 698.640, whether in a commercial or noncommercial situation.

45 (w) Manufactures mercury fever thermometers.

1 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
2 law, or is:

3 (A) Prescribed by a person licensed under ORS chapter 677; and

4 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and
5 on the proper cleanup of mercury should breakage occur.

6 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to
7 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be
8 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the
9 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-
10 graph, "thermostat" means a device commonly used to sense and, through electrical communication
11 with heating, cooling or ventilation equipment, control room temperature.

12 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains
13 mercury light switches.

14 (aa) Violates the provisions of ORS 803.375, 803.385 or 815.410 to 815.430.

15 (bb) Violates ORS 646A.070 (1).

16 (cc) Violates any requirement of ORS 646A.030 to 646A.040.

17 (dd) Violates the provisions of ORS 128.801 to 128.898.

18 (ee) Violates ORS 646.883 or 646.885.

19 (ff) Violates ORS 646.569.

20 (gg) Violates the provisions of ORS 646A.142.

21 (hh) Violates ORS 646A.360.

22 (ii) Violates ORS 646.553 or 646.557 or any rule adopted pursuant thereto.

23 (jj) Violates ORS 646.563.

24 (kk) Violates ORS 759.690 or any rule adopted pursuant thereto.

25 (LL) Violates the provisions of ORS 759.705, 759.710 and 759.720 or any rule adopted pursuant
26 thereto.

27 (mm) Violates ORS 646A.210 or 646A.214.

28 (nn) Violates any provision of ORS 646A.124 to 646A.134.

29 (oo) Violates ORS 646A.095.

30 (pp) Violates ORS 822.046.

31 (qq) Violates ORS 128.001.

32 (rr) Violates ORS 646.649 (2) to (4).

33 (ss) Violates ORS 646A.090 (2) to (4).

21 (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta-
22 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.
23 (3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney
24 need not prove competition between the parties or actual confusion or misunderstanding.
25 (4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-
26 torney General has first established a rule in accordance with the provisions of ORS chapter 183
27 declaring the conduct to be unfair or deceptive in trade or commerce.
28 (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought
29 under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is lim-
30 ited to an injunction and the prevailing party may be awarded reasonable attorney fees.
31 **SECTION 3. Section 1 of this 2013 Act and the amendments to ORS 646.608 by section 2**
32 **of this 2013 Act apply to a sale or advertisement of consumer goods that occurs on or after**
33 **the effective date of this 2013 Act.**
34
