SUMMARY

Requires disclosure of shipping and handling charges in sale or advertisement of consumer good.

A BILL FOR AN ACT

2 Relating to consumer goods disclosures; creating new provisions; and amending ORS 646.608.

3 Be It Enacted by the People of the State of Oregon:

4 **SECTION 1. (1)** As used in this section:

5 (a) "Advertise" means to communicate about a consumer good by newspaper, radio, 6 television, handbill, placard or other print, broadcast or electronic medium within this state

7 for the purpose of selling the consumer good.

8 (b) "Consumer goods" means goods that an individual uses or buys for use primarily for 9 personal, family or household purposes.

10 (2) A person that offers for sale, sells or advertises consumer goods that the person will 11 ship directly to a consumer in this state shall clearly disclose during the sales transaction 12 the charges, if any, that the consumer must pay for handling and shipping the consumer 13 goods.

(3) A person that fails to disclose the shipping and handling charges for consumer goods
in a transaction described in subsection (2) of this section commits an unlawful practice
under ORS 646.608 that is subject to enforcement under ORS 646.632 and an action under
ORS 646.638.

18 <u>SECTION 2.</u> ORS 646.608, as amended by section 6, chapter 52, Oregon Laws 2012, is amended

20 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-21 ness, vocation or occupation the person does any of the following:

22 (a) Passes off real estate, goods or services as those of another.

(b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap proval, or certification of real estate, goods or services.

(c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso ciation with, or certification by, another.

(d) Uses deceptive representations or designations of geographic origin in connection with real
 estate, goods or services.

(e) Represents that real estate, goods or services have sponsorship, approval, characteristics, 1 2 ingredients, uses, benefits, quantities or qualities that [they] the real estate, goods or services do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection 3 4 that the person does not have. (f) Represents that real estate or goods are original or new if [they] the real estate or goods 5 are deteriorated, altered, reconditioned, reclaimed, used or secondhand. 6 7 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade, or that real estate or goods are of a particular style or model, if [they] the real estate, goods or 8 9 services are of another. 10 (h) Disparages the real estate, goods, services, property or business of a customer or another by false or misleading representations of fact. 11 12 (i) Advertises real estate, goods or services with intent not to provide [them] the real estate, 13 goods or services as advertised, or with intent not to supply reasonably expectable public demand, unless the advertisement discloses a limitation of quantity. 14 15(j) Makes false or misleading representations of fact concerning the reasons for, existence of, or amounts of price reductions. 16 17 (k) Makes false or misleading representations concerning credit availability or the nature of the 18 transaction or obligation incurred. 19 (L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demon-20stration purposes or in exchange for submitting names of potential customers. 2122(m) Performs service on or dismantles any goods or real estate when [not authorized by] the 23owner or apparent owner [thereof] of the goods or real estate does not authorize the service or the dismantling. 2425(n) Solicits potential customers by telephone or door to door as a seller unless the person provides the information required under ORS 646.611. 2627(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of 28the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or 2930 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, 31 discount or other value is contingent upon [occurrence of] an event [subsequent to] occurring after

32 the time the customer enters into the transaction.

(p) Makes any false or misleading statement about a prize, contest or promotion used to publi cize a product, business or service.

(q) Promises to deliver real estate, goods or services within a certain period of time with intent
 not to deliver [*them*] the real estate, goods or services as promised.

37 (r) Organizes or induces or attempts to induce membership in a pyramid club.

(s) Makes false or misleading representations of fact concerning the offering price of, or the
 person's cost for real estate, goods or services.

40 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
 41 known material defect or material nonconformity.

42 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

(v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under
 ORS 698.640, whether in a commercial or noncommercial situation.

45 (w) Manufactures mercury fever thermometers.

(x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal 1 law, or is: 2 (A) Prescribed by a person licensed under ORS chapter 677; and 3 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and 4 on the proper cleanup of mercury should breakage occur. 5 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to 6 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be 7 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the 8 9 mercury does not become part of the solid waste stream or wastewater. For purposes of this paragraph, "thermostat" means a device commonly used to sense and, through electrical communication 10 with heating, cooling or ventilation equipment, control room temperature. 11 12 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains 13 mercury light switches. - (3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney
 need not prove competition between the parties or actual confusion or misunderstanding.
- (4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183
 declaring the conduct to be unfair or deceptive in trade or commerce.
- (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought
 under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney fees.
- 31 <u>SECTION 3.</u> Section 1 of this 2013 Act and the amendments to ORS 646.608 by section 2 32 of this 2013 Act apply to a sale or advertisement of consumer goods that occurs on or after 33 the effective date of this 2013 Act.
