

House Bill 3097

Sponsored by Representatives GORSEK, MATTHEWS; Representatives BARKER, FAGAN, JOHNSON, REARDON, VEGA PEDERSON, Senators MONNES ANDERSON, PROZANSKI

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Task Force on Department of Public Safety Standards and Training to study feasibility of establishing facility at Mt. Hood Community College.

Declares emergency, effective on passage.

A BILL FOR AN ACT

1
2 Relating to the Department of Public Safety Standards and Training; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Task Force on the Department of Public Safety Standards and**
5 **Training is established, consisting of eleven members appointed as follows:**

6 (a) **The President of the Senate shall appoint one member from among members of the**
7 **Senate.**

8 (b) **The Speaker of the House of Representatives shall appoint one member from among**
9 **members of the House of Representatives.**

10 (c) **The Governor shall appoint:**

11 (A) **Two representatives from the Department of Public Safety Standards and Training;**

12 (B) **One representative from the Multnomah County Sheriff's Office;**

13 (C) **One representative from Mt. Hood Community College;**

14 (D) **One representative from the Department of Corrections; and**

15 (E) **One representative from each of the city governments of Troutdale, Gresham,**
16 **Fairview and Wood Village.**

17 (2) **The task force shall study the feasibility of establishing a Department of Public Safety**
18 **Standards and Training facility at Mt. Hood Community College primarily for the use of East**
19 **Multnomah County law enforcement officers.**

20 (3) **A majority of the voting members of the task force constitutes a quorum for the**
21 **transaction of business. Members of the task force who are also members of the Legislative**
22 **Assembly are not voting members.**

23 (4) **Official action by the task force requires the approval of a majority of the voting**
24 **members of the task force.**

25 (5) **The task force shall elect one of its members to serve as chairperson.**

26 (6) **If there is a vacancy for any cause, the appointing authority for that vacancy shall**
27 **make an appointment to become immediately effective.**

28 (7) **The task force shall meet at times and places specified by the call of the chairperson.**

29 (8) **The task force may adopt rules necessary for the operation of the task force.**

30 (9) **The task force shall submit a report in the manner provided by ORS 192.245, and may**

1 include recommendations for legislation, to an interim committee of the Legislative Assem-
2 bly related to public safety no later than October 1, 2013.

3 (10) The Department of Public Safety Standards and Training shall provide staff support
4 to the task force.

5 (11) Members of the task force who are not members of the Legislative Assembly are not
6 entitled to compensation, but may be reimbursed for actual and necessary travel and other
7 expenses incurred by them in the performance of their official duties in the manner and
8 amounts provided for in ORS 292.495. Claims for expenses incurred in performing functions
9 of the task force shall be paid out of funds appropriated to the Department of Public Safety
10 Standards and Training for purposes of the task force.

11 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
12 the task force in the performance of its duties and, to the extent permitted by laws relating
13 to confidentiality, to furnish such information and advice as the members of the task force
14 consider necessary to perform their duties.

15 SECTION 2. Section 1 of this 2013 Act is repealed on the date of the convening of the 2014
16 regular session of the Legislative Assembly as specified in ORS 171.010.

17 SECTION 3. This 2013 Act being necessary for the immediate preservation of the public
18 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect
19 on its passage.
