SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Includes insurance in definition of real estate, goods and services that are subject to penalties for unlawful trade practices.

Permits person to obtain, and court to award, appropriate equitable relief in addition to monetary damages in action under Unlawful Trade Practices Act.

Requires Director of Department of Consumer and Business Services to request action before prosecuting attorney may take action under Unlawful Trade Practices Act against act or practice related to insurance.

Declares emergency, effective on passage.

- (6)(a) "Real estate, goods or services" means [those] real estate, goods or services, including insurance, that are or may be obtained primarily for personal, family or household purposes, that, with respect to insurance, are or may be obtained for purposes other than personal, family or household purposes, or that are or may be obtained for any purposes as a result of a telephone solicitation, and includes loans and extensions of credit[,] and franchises, distributorships and other similar business opportunities[, but does not include insurance].

 - (d) Uses deceptive representations or designations of geographic origin in connection with real estate, goods or services.
 - (e) Represents that real estate, goods or services have sponsorship, approval, characteristics, ingredients, uses, benefits, quantities or qualities that [they] the real estate, goods or services do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the person does not have.
 - (f) Represents that real estate or goods are original or new if [they] the real estate or goods

- (g) Represents that real estate, goods or services are of a particular standard, quality, or grade, or that real estate or goods are of a particular style or model, if [they] the real estate, goods or services are of another.
- (h) Disparages the real estate, goods, services, property or business of a customer or another by false or misleading representations of fact.
- (i) Advertises real estate, goods or services with intent not to provide [them] the real estate, goods or services as advertised, or with intent not to supply reasonably expectable public demand, unless the advertisement discloses a limitation of quantity.
- (j) Makes false or misleading representations of fact concerning the reasons for, existence of, or amounts of price reductions.
- (k) Makes false or misleading representations concerning credit availability or the nature of the transaction or obligation incurred.
- (L) Makes false or misleading representations relating to commissions or other compensation to be paid in exchange for permitting real estate, goods or services to be used for model or demonstration purposes or in exchange for submitting names of potential customers.
- (m) Performs service on or dismantles any goods or real estate [when not authorized by] if the owner or apparent owner [thereof] of the goods or real estate does not authorize the service or dismantling.
- (n) Solicits potential customers by telephone or door to door as a seller unless the person provides the information required under ORS 646.611.
- (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, discount or other value is contingent upon [occurrence of] an event [subsequent to] occurring after the time the customer enters into the transaction.

 - (3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney need not prove competition between the parties or actual confusion or misunderstanding.
 - (4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183 declaring the conduct to be unfair or deceptive in trade or commerce. The Attorney General may not establish a rule under this subsection with respect to conduct that is subject to the Insurance Code unless the Attorney General first submits the proposed rule to the Director of the Department of Consumer and Business Services for review and approval.
 - (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney fees.

SECTION 4. ORS 646.636 is amended to read:

646.636. [The] A court may make [such] additional orders or judgments [as may be] that the court deems necessary to restore to any person in interest any moneys or property, real or personal, of which the person was deprived by means of any practice declared to be unlawful in ORS 646.607 or 646.608, [or as may be necessary] to ensure cessation of unlawful trade practices and to provide any other equitable relief to the person in interest that the court deems appropriate.

SECTION 5. ORS 646.638 is amended to read:

- 646.638. (1) Except as provided in subsections (8) and (9) of this section, [any] a person [who] that suffers [any] an ascertainable loss of money or property, real or personal, as a result of [willful use or employment by] another [person] person's willful use or employment of a method, act or practice declared unlawful [by] under ORS 646.608, may bring an individual action in an appropriate court to recover actual damages or statutory damages of \$200, whichever is greater, and to obtain appropriate equitable relief. The court or the jury[, as the case may be,] may award punitive damages and the court may provide [the] any equitable relief the court considers necessary or proper.
- (2) [Upon commencement of any action brought] A person that brings an action under subsection (1) of this section [the party bringing the action] shall mail a copy of the complaint or other

- initial pleading to the Attorney General at the time the action commences and, upon entry of any judgment in the action, shall mail a copy of the judgment to the Attorney General. Failure to mail a copy of the complaint [shall not be] is not a jurisdictional defect, but a court may not enter judgment for the plaintiff until proof of mailing is filed with the court. Proof of mailing may be by affidavit or by return receipt of mailing. As soon as is practicable, the Attorney General shall provide the Director of the Department of Consumer and Business Services with a copy of any complaint or other initial pleading, and any judgment, that the Attorney General receives under this subsection in connection with an action that is related to insurance or involves a method, act or practice that is also subject to the Insurance Code.
- (3) The court may award reasonable attorney fees and costs at trial and on appeal to a prevailing plaintiff in an action under this section. The court may award reasonable attorney fees and costs at trial and on appeal to a prevailing defendant only if the court finds [there was no] that an objectively reasonable basis for bringing the action or asserting the ground for appeal did not exist.
- (4) The court may not award attorney fees to a prevailing defendant under the provisions of subsection (3) of this section if the action under this section is maintained as a class action pursuant to ORCP 32.
- (5) Any permanent injunction or final judgment or order [of] the court [made] makes under ORS 646.632 or 646.636 is prima facie evidence in an action brought under this section that the respondent used or employed a method, act or practice declared unlawful [by] under ORS 646.608, but an assurance of voluntary compliance, whether or not approved by the court, [shall not be] is not evidence of the violation.
- (6) Actions brought under this section [shall] must be commenced within one year [from] after the discovery of the unlawful method, act or practice. [However, whenever any complaint is filed by] Notwithstanding this limitation, if a prosecuting attorney filed a complaint to prevent, restrain or punish [violations] a violation of ORS 646.608, [running of] the complaint tolls the statute of limitations with respect to every private right of action under this section [and] that is based in whole or in part on any matter set forth in the prosecuting attorney's complaint for the period of time in which the proceeding that the prosecuting attorney initiated is pending [complained of in said proceeding shall be suspended during the pendency thereof].
- (7) Notwithstanding subsection (6) of this section, in any action [brought by] that a seller or lessor brings against a purchaser or lessee of real estate, goods or services, the purchaser or lessee may assert any counterclaim that the purchaser or lessee has arising out of a violation of ORS 646.605 to 646.652.
 - (8) A class action may be maintained under this section. In any class action under this section:
- (a) Statutory damages under subsection (1) of this section may be recovered on behalf of class members only if the plaintiffs in the action establish that the members have sustained an ascertainable loss of money or property as a result of a reckless or knowing use or employment by the defendant of a method, act or practice declared unlawful by ORS 646.608;
 - (b) The trier of fact may award punitive damages; and
 - (c) The court may award appropriate equitable relief.
- (9) This section does not apply to any method, act or practice described in ORS 646.608 (1)(aa). Actions for violation of laws relating to odometers are provided under ORS 815.410 and 815.415.
 - **SECTION 6.** ORS 646.648 is amended to read:
- 45 646.648. (1) As used in this section:

- (a) "Buyer" means a person who buys or agrees to buy a manufactured dwelling from a manufactured dwelling dealer.
- (b) "Cash sale price" means the price for which a manufactured dwelling dealer would sell to a buyer, and the buyer would buy from a dealer, a manufactured dwelling that is covered by a purchase agreement, if the sale were a sale for cash instead of a retail installment sale.
 - (c) "Manufactured dwelling" has the meaning given that term in ORS 446.003.
- 7 (d) "Manufactured dwelling dealer" means a person licensed under ORS 446.691 or 446.696 or a temporary manufactured structure dealer licensee under ORS 446.701.
 - (e) "Retail installment sale" has the meaning given that term in ORS 83.510.
- 10 (2) A manufactured dwelling dealer engages in an unlawful practice when, in a sale of a manu-11 factured dwelling, the dealer does any of the following:
