SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Early Learning Division in Department of Education. Clarifies responsibilities of Early Learning Division and Early Learning Council.

Requires State Interagency Coordinating Council to submit report that provides recommendation about appropriate entity to adopt rules and develop policy related to early childhood special education and early intervention services.

Changes name of Child Care Division to Child Care Office. Establishes office in Early Learning Division.

Declares emergency, effective on passage.

11 **Be It Enacted by the People of the State of Oregon:**

13 **THE EARLY LEARNING DIVISION**

14
15 **SECTION 1. (1) The Early Learning Division is established in the Department of Educa-**
16 **tion. The purpose of the division is to ensure that children enter school ready to succeed.**

17 **(2) The division shall function under the direction and control of the Early Learning**
18 **Council with the Early Learning System Director serving as the administrative officer.**

19 **SECTION 1a. The duties, functions and powers of the Early Learning Council relating to**
20 **the administration and enforcement of the Early Learning Council are imposed upon, trans-**
21 **ferred to and vested in the Early Learning Division of the Department of Education for the**
22 **purpose of fulfilling the duties, powers and functions of the Early Learning Division.**

23 **SECTION 1b. (1) The Early Learning System Director shall:**

24 **(a) Deliver to the Department of Education all records and property within the jurisdic-**
25 **tion of the director that relate to the duties, functions and powers transferred by section 1a**

1 of this 2013 Act; and

2 (b) Transfer to the Department of Education those employees engaged primarily in the
3 exercise of the duties, functions and powers transferred by section 1a of this 2013 Act.

4 (2) The Superintendent of Public Instruction shall take possession of the records and
5 property, and shall take charge of the employees and employ them in the exercise of the
6 duties, functions and powers transferred by section 1a of this 2013 Act, without reduction
7 of compensation but subject to change or termination of employment or compensation as
8 provided by law.

9 (3) The Governor shall resolve any dispute between the Early Learning Council and the
10 Department of Education relating to transfers of records, property and employees under this
11 section, and the Governor's decision is final.

12 SECTION 1c. (1) The unexpended balances of amounts authorized to be expended by the
13 Early Learning Council for the biennium beginning July 1, 2013, from revenues dedicated,
14 continuously appropriated, appropriated or otherwise made available for the purpose of ad-
15 ministering and enforcing the duties, functions and powers transferred by section 1a of this
16 2013 Act are transferred to and are available for expenditure by the Department of Education
17 for the biennium beginning July 1, 2013, for the purpose of administering and enforcing the
18 duties, functions and powers transferred by section 1a of this 2013 Act.

19 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
20 expenditures by the Early Learning Council remain applicable to expenditures by the De-
21 partment of Education under this section.

22 SECTION 1d. The transfer of duties, functions and powers to the Department of Educa-
23 tion by section 1a of this 2013 Act does not affect any action, proceeding or prosecution in-
24 volving or with respect to such duties, functions and powers begun before and pending at the
25 time of the transfer, except that the Department of Education is substituted for the Early
26 Learning Council in the action, proceeding or prosecution.

27 SECTION 1e. (1) Nothing in sections 1a to 1d of this 2013 Act relieves a person of a li-
28 ability, duty or obligation accruing under or with respect to the duties, functions and powers
29 transferred by section 1a of this 2013 Act. The Department of Education may undertake the
30 collection or enforcement of any such liability, duty or obligation.

31 (2) The rights and obligations of the Early Learning Council legally incurred under con-
32 tracts, leases and business transactions executed, entered into or begun before the operative
33 date of section 1a of this 2013 Act accruing under or with respect to the duties, functions
34 and powers transferred by section 1a of this 2013 Act are transferred to the Department of
35 Education. For the purpose of succession to these rights and obligations, the Department
36 of Education is a continuation of the Early Learning Council and not a new authority.

37 SECTION 1f. Notwithstanding the transfer of duties, functions and powers by section 1a
38 of this 2013 Act, the rules of the Early Learning Council with respect to such duties, func-
39 tions or powers that are in effect on the operative date of section 1a of this 2013 Act continue
40 in effect until superseded or repealed by rules of the Department of Education.

41 SECTION 1g. Whenever, in any uncodified law or resolution of the Legislative Assembly
42 or in any rule, document, record or proceeding authorized by the Legislative Assembly, in
43 the context of the duties, functions and powers transferred by section 1a of this 2013 Act,
44 reference is made to the administration of the Early Learning Council, or an officer or em-
45 ployee of the Early Learning Council, whose duties, functions or powers are transferred by

1 **section 1a of this 2013 Act, the reference is considered to be a reference to the Department**
2 **of Education or an officer or employee of the Department of Education who by this 2013 Act**
3 **is charged with carrying out such duties, functions and powers.**

4 **SECTION 2.** ORS 329.075 is amended to read:

5 329.075. (1) The State Board of Education shall adopt rules, in accordance with ORS 183.750 and
6 ORS chapter 183, as necessary for the statewide implementation of this chapter. The rules shall be
7 prepared in consultation with appropriate representatives from the educational and business and
8 labor communities.

9 (2) The Department of Education shall be responsible for implementing the provisions of this
10 chapter. Actions by the department to fulfill this responsibility and to increase student achievement
11 may include, but are not limited to:

12 (a) Developing academic content standards;

13 (b) Updating Common Curriculum Goals to meet rigorous academic content standards and up-
14 dating performance indicators and diploma requirements;

15 (c) Developing criterion-referenced assessments including performance-based, content-based and
16 other assessment mechanisms to test knowledge and skills and whether students meet the perform-
17 ance expectations as determined by the board; and

18 (d) Establishing criteria for early childhood education programs **governed by the Individuals**
19 **with Disabilities Education Act, 20 U.S.C. 1400 et seq.**

20 (3) The department shall make school districts and the public aware of public school choice
21 options available within our current public education framework.

22 **SECTION 3.** ORS 329.165 is amended to read:

23 329.165. (1) In consultation with the advisory committee for the Oregon prekindergarten pro-
24 gram, [*the Department of Education*] **the Early Learning Council, acting as the state advisory**
25 **council for purposes of the federal Head Start Act**, shall develop a long-range plan for serving
26 eligible children and their families and shall report to each odd-numbered year regular session of
27 the Legislative Assembly on the funds necessary to implement the long-range plan, including but not
28 limited to regular programming costs, salary enhancements and program improvement grants. The
29 [*department*] **council** shall determine the rate of increase in funding for programs necessary each
30 biennium to provide service to all children eligible for the prekindergarten program.

31 (2) Each biennial report shall include but not be limited to estimates of the number of eligible
32 children and families to be served, projected cost of programs and evaluation of the programs.

33 **SECTION 4.** ORS 329.170 is amended to read:

34 329.170. (1) As used in ORS 329.170 to 329.200:

35 (a) "Advisory committee" means the advisory committee established specifically for the Oregon
36 prekindergarten program established by ORS 329.170 to 329.200.

37 (b) "Oregon prekindergartens" means programs that are recognized by the [*department*] **Early**
38 **Learning Division** as meeting the minimum program rules to be adopted by the [*State Board of*
39 *Education*] **Early Learning Council** and that provide comprehensive health, education and social
40 services in order to maximize the potential of children three and four years of age.

41 (c) "Oregon prekindergarten program" means the statewide administrative activities carried on
42 within the [*Department of Education*] **Early Learning Division** to allocate, award and monitor state
43 funds appropriated to create or assist local Oregon prekindergartens.

44 (2) For purposes of ORS 329.175, "eligible child" means an at-risk child who is not a participant
45 in a federal, state or local program providing like comprehensive services and may include children

1 who are eligible under rules adopted by the [*State Board of Education*] **Early Learning Council**.
 2 As used in this subsection, “at-risk child” means a child at least three years of age and not eligible
 3 for kindergarten whose family circumstances would qualify that child for eligibility under the federal
 4 Head Start program.

5 **SECTION 5.** ORS 329.175 is amended to read:

6 329.175. (1) The [*Department of Education*] **Early Learning Division** shall administer the Oregon
 7 prekindergarten program to assist eligible children with comprehensive services including educa-
 8 tional, social, health and nutritional development to enhance their chances for success in school and
 9 life. Eligible children, upon request of parent or guardian, shall be admitted to approved Oregon
 10 prekindergartens to the extent that the Legislative Assembly provides funds.

11 (2) Nonsectarian organizations including school districts and Head Start grantees are eligible
 12 to compete for funds to establish an Oregon prekindergarten. Grant recipients shall serve children
 13 eligible according to federal Head Start guidelines and other children who meet criteria of eligibility
 14 adopted by rule by the [*State Board of Education*] **Early Learning Council**. However, not more than
 15 20 percent of the total enrollment shall consist of children who do not meet Head Start guidelines.
 16 School districts may contract with other governmental or nongovernmental nonsectarian organiza-
 17 tions to conduct a portion of the program. Funds appropriated for the program shall be used to
 18 establish and maintain new or expanded Oregon prekindergartens and shall not be used to supplant
 19 federally supported Head Start programs. Oregon prekindergartens also may accept gifts, grants and
 20 other funds for the purposes of this section.

21 (3) Applicants shall identify how they will serve the target population and provide all compo-
 22 nents as specified in the federal Head Start performance standards and guidelines, including staff
 23 qualifications and training, facilities and equipment, transportation and fiscal management.

24 (4) Oregon prekindergartens shall coordinate with each other and with federal Head Start pro-
 25 grams to ensure efficient delivery of services and prevent overlap. Oregon prekindergartens shall
 26 also work with local organizations such as local education associations serving young children and
 27 make the maximum use of local resources.

28 (5) Oregon prekindergartens shall:

29 (a) Participate in the planning process under ORS 417.777 to develop a voluntary local early
 30 childhood system plan; and

31 (b) Coordinate services with other services that are coordinated through the plan. The coordi-
 32 nation of services shall be consistent with federal and state law.

33 **SECTION 6.** ORS 329.175, as amended by section 87, chapter 37, Oregon Laws 2012, is amended
 34 to read:

35 329.175. (1) The [*Department of Education*] **Early Learning Division** shall administer the Oregon
 36 prekindergarten program to assist eligible children with comprehensive services including educa-
 37 tional, social, health and nutritional development to enhance their chances for success in school and
 38 life. Eligible children, upon request of parent or guardian, shall be admitted to approved Oregon
 39 prekindergartens to the extent that the Legislative Assembly provides funds.

40 (2) Nonsectarian organizations including school districts and Head Start grantees are eligible
 41 to compete for funds to establish an Oregon prekindergarten. Grant recipients shall serve children
 42 eligible according to federal Head Start guidelines and other children who meet criteria of eligibility

 13 Oregon Early Learning System. The coordination of services shall be consistent with federal and
 14 state law.

15 **SECTION 7.** ORS 329.183 is amended to read:

16 329.183. (1) The Prekindergarten Program Trust Fund is established as a fund in the State
 17 Treasury, separate and distinct from the General Fund. Interest earned by the trust fund shall be
 18 credited to the trust fund. The primary purpose of the trust fund is to assist eligible children with
 19 comprehensive services including educational, social, health and nutritional development to enhance
 20 their chances for success in school and life. For this purpose, the trust fund is continuously appro-
 21 priated to the *[Department of Education]* **Early Learning Division** for the Oregon prekindergarten
 22 program described in ORS 329.170 to 329.200.

23 (2) The *[department]* **division** may solicit and accept money in the form of gifts, contributions
 24 and grants to be deposited in the trust fund. Except as provided in ORS 329.185, the acceptance of
 25 federal grants for purposes of ORS 329.170 to 329.200 does not commit state funds nor place an ob-
 26 ligation upon the Legislative Assembly to continue the purposes for which the federal funds are
 27 made available.

28 (3) The trust fund may be listed, if otherwise qualified, on the Oregon income tax return for
 29 checkoff pursuant to application made to the Oregon Charitable Checkoff Commission under ORS
 30 305.690 to 305.753 by the *[department]* **division**.

31 **SECTION 8.** ORS 329.185 is amended to read:

32 329.185. When the federal Head Start program provides funding for programs for eligible chil-
 33 dren at or greater than the 1990-1991 per child level, eligibility for the state funded Oregon
 34 prekindergarten program shall be expanded to include programs for children whose family income
 35 exceeds the federal Head Start limits or who are in an underserved or unserved age category. After
 36 determining the increase in income limits or age level that would make children most in need of
 37 state programs eligible for them, the *[State Board of Education]* **Early Learning Division** may direct
 38 expenditure of any unexpended or unobligated funds appropriated for the biennium for eligible chil-
 39 dren to be expended for the additional children considered to be most in need. In the following
 40 biennium, the *[State Board of Education]* **Early Learning Division** shall include the cost of any
 41 added program for the children most in need in its biennial budget.

42 **SECTION 9.** ORS 329.190, as amended by section 40, chapter 37, Oregon Laws 2012, is amended
 43 to read:

44 329.190. The *[Department of Education]* **Early Learning Council** shall establish an advisory
 45 committee composed of interested parents and representatives from the health care profession, early

1 childhood education and development staff preparation programs, Oregon Head Start Association,
2 school districts, community colleges, Early Intervention Council, child care and other organizations.
3 The purpose of the advisory committee is to provide advice to *[the department and]* the Early
4 Learning Council on matters related to the Oregon prekindergarten program.

5 **SECTION 10.** ORS 329.195, as amended by section 18, chapter 37, Oregon Laws 2012, is
6 amended to read:

7 329.195. (1)(a) The *[State Board of Education]* **Early Learning Council, acting as the state**
8 **advisory council for purposes of the federal Head Start Act**, shall adopt rules for the estab-
9 lishment of the Oregon prekindergarten program.

10 (b) Rules adopted under this section specifically shall require:

11 (A) Performance standards and operating standards that are at a level no less than the level
12 required under the federal Head Start program guidelines.

13 (B) Processes and procedures for recompetition that are substantially similar to the processes
14 and procedures required under the rules and guidelines adopted under the federal Head Start Act.

15 (c) Federal Head Start program guidelines shall be considered as guidelines for the Oregon
16 prekindergarten program.

17 (2) In developing rules for the Oregon prekindergarten program, the *[board]* **council** shall con-
18 sult with the advisory committee established under ORS 329.190 and shall consider such factors as
19 coordination with existing programs, the preparation necessary for instructors, qualifications of in-
20 structors, training of staff, adequate space and equipment and special transportation needs.

21 (3) The *[Department of Education]* **Early Learning Division** shall review applications for the
22 Oregon prekindergarten program received and designate those programs as eligible to commence
23 operation by July 1 of each year. When approving grant applications, to the extent practicable, the
24 *[board]* **council** shall distribute funds regionally based on percentages of unmet needs as identified
25 in the voluntary local early childhood system plans that are part of the local coordinated compre-
26 hensive plans developed under ORS 417.775 for the county or region.

27 **SECTION 11.** ORS 329.195, as amended by sections 18 and 88, chapter 37, Oregon Laws 2012,
28 is amended to read:

29 329.195. (1)(a) The *[State Board of Education]* **Early Learning Council, acting as the state**
30 **advisory council for purposes of the federal Head Start Act**, shall adopt rules for the estab-
31 lishment of the Oregon prekindergarten program.

32 (b) Rules adopted under this section specifically shall require:

33 (A) Performance standards and operating standards that are at a level no less than the level
34 required under the federal Head Start program guidelines.

35 (B) Processes and procedures for recompetition that are substantially similar to the processes
36 and procedures required under the rules and guidelines adopted under the federal Head Start Act.

37 (c) Federal Head Start program guidelines shall be considered as guidelines for the Oregon
38 prekindergarten program.

39 (2) In developing rules for the Oregon prekindergarten program, the *[board]* **council** shall con-
40 sult with the advisory committee established under ORS 329.190 and shall consider such factors as
41 coordination with existing programs, the preparation necessary for instructors, qualifications of in-
42 structors, training of staff, adequate space and equipment and special transportation needs.

43 (3) The *[Department of Education]* **Early Learning Division** shall review applications for the
44 Oregon prekindergarten program received and designate those programs as eligible to commence
45 operation by July 1 of each year. When approving grant applications, to the extent practicable, the

1 [board] **council** shall distribute funds regionally based on percentages of unmet needs for the county
2 or region.

3 **SECTION 12.** ORS 329.200 is amended to read:

4 329.200. (1) The Superintendent of Public Instruction shall report to the Legislative Assembly
5 on the merits of continuing and expanding the Oregon prekindergarten program or instituting other
6 means of providing early childhood development assistance.

7 (2) The superintendent's report shall include specific recommendations on at least the following
8 issues:

9 (a) The relationship of the state-funded Oregon prekindergarten program with the common
10 school system;

11 (b) The types of children and their needs that the program should serve;

12 (c) The appropriate level of state support for implementing the program for all eligible children,
13 including related projects to prepare instructors and provide facilities, equipment and transporta-
14 tion;

15 (d) The state administrative structure necessary to implement the program; and

16 (e) Licensing or endorsement of early childhood teachers.

17 (3) The [Department of Education] **Early Learning Division** shall examine, monitor and assess
18 the effectiveness of the Oregon prekindergarten program. The superintendent shall make biennial
19 reports to the Legislative Assembly on the effectiveness of the program.

20 **NOTE:** Sections 13 through 18 were deleted by amendment. Subsequent sections were not re-
21 numbered.

22 **SECTION 19.** Section 10, chapter 37, Oregon Laws 2012, is amended to read:

23 **Sec. 10.** (1) The Early Learning [Council] **Division** Fund is established in the State Treasury,
24 separate and distinct from the General Fund. Interest earned by the Early Learning [Council] **Divi-
25 sion** Fund shall be credited to the fund.

26 (2) Moneys in the Early Learning [Council] **Division** Fund consist of:

27 (a) Amounts donated to the fund;

28 (b) Moneys transferred to the fund from the federal government, state agencies and local gov-
29 ernments;

30 (c) Amounts appropriated or otherwise transferred to the fund by the Legislative Assembly;

31 (d) Investment earnings received on moneys in the fund; and

32 (e) Other amounts deposited in the fund from any source.

33 (3) Moneys in the fund are continuously appropriated to the [Early Learning Council established
34 in section 4, chapter 519, Oregon Laws 2011,] **Department of Education** for the purpose of fulfilling
35 the [council's] duties, functions and powers **of the Early Learning Division.**

36 (4) The [council] **department** may establish accounts and subaccounts within the fund when the
37 [council] **department** determines that accounts or subaccounts are necessary or desirable and may
38 credit any interest or income derived from moneys in the fund to any account or subaccount in the
39 fund.

40 **SECTION 20.** (1) **The amendments to section 10, chapter 37, Oregon Laws 2012, by section
41 19 of this 2013 Act are intended to change the name of the "Early Learning Council Fund"
42 to the "Early Learning Division Fund."**

43 **(2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
44 may substitute for words designating the "Early Learning Council Fund," wherever they oc-
45 cur in statutory law, other words designating the "Early Learning Division Fund."**

1 **SECTION 21.** ORS 131A.360, as amended by section 33, chapter 37, Oregon Laws 2012, and
2 section 18, chapter 97, Oregon Laws 2012, is amended to read:

3 131A.360. (1) The provisions of this section apply only to a forfeiting agency other than the
4 state, and apply only to forfeiture proceeds arising out of prohibited conduct as defined by ORS
5 131A.005 (12)(a).

6 (2) If the forfeiting agency is not a county, the forfeiting agency shall enter into an agreement,
7 under ORS chapter 190, with the county in which the property was seized to provide a portion of
8 the forfeiture proceeds to the county.

9 (3) After entry of a judgment of forfeiture, a forfeiting agency shall first pay from the forfeiture
10 proceeds the costs incurred by seizing and forfeiting agencies in investigating and prosecuting the
11 case, including costs, disbursements and attorney fees as defined in ORCP 68 A, special expenses
12 such as the provision of currency for undercover law enforcement operations, the cost of disabling
13 a hidden compartment in a motor vehicle and the expenses of maintaining the seized property. The
14 forfeiting agency may not pay expenditures made in connection with the ordinary maintenance and
15 operation of a seizing or forfeiting agency under this subsection.

16 (4) After payment of costs under subsection (3) of this section, the forfeiting agency shall:

17 (a) Deduct an amount equal to five percent of the forfeiture proceeds and deposit that amount
18 in the Illegal Drug Cleanup Fund established by ORS 475.495 for the purposes specified in ORS
19 475.495 (5) and (6);

20 (b) Deduct an amount equal to 2.5 percent of the forfeiture proceeds and deposit that amount
21 in the Asset Forfeiture Oversight Account;

22 (c) Deduct an amount equal to 20 percent of the forfeiture proceeds and deposit that amount in
23 the Oregon Criminal Justice Commission Account established under ORS 137.662 for disbursement
24 to drug court programs as described in ORS 3.450; and

25 (d) Deduct an amount equal to 10 percent of the forfeiture proceeds and deposit that amount in
26 the Early Learning [Council] **Division** Fund established in section 10, chapter 37, Oregon Laws 2012,
27 for disbursement to relief nurseries as described in ORS 417.788.

28 (5) If the forfeiting agency has entered into an agreement with a county under subsection (2)
29 of this section, after paying costs under subsection (3) of this section and making the deductions
30 required by subsection (4) of this section, the forfeiting agency shall pay the county the amounts
31 required by the agreement.

32 (6) After making all payments and deductions required by subsections (3), (4) and (5) of this
33 section, the forfeiting agency may use the remaining forfeiture proceeds, including amounts received
34 by a county under subsection (5) of this section or by any other public body under an intergovern-
35 mental agreement entered into under ORS 131A.355, only for:

36 (a) The purchase of equipment necessary for the enforcement of laws relating to the unlawful
37 delivery, distribution, manufacture or possession of controlled substances;

38 (b) Currency for undercover law enforcement operations;

39 (c) Drug awareness and drug education programs offered in middle schools and high schools;

40 (d) The expenses of a forfeiting agency in operating joint narcotic operations with other for-
41 feiting agencies pursuant to the terms of an intergovernmental agreement, including paying for
42 rental space, utilities and office equipment;

6 (j) At least one council member shall represent the Early Learning [*Council*] **Division**.

7 (k) At least one council member shall represent the Child Development and Rehabilitation Cen-
8 ter of the Oregon Health and Science University.

9 (L) At least one council member shall be a member of the State Advisory Council for Special
10 Education created under ORS 343.287.

11 (m) At least one council member shall be a representative designated by the state coordinator
12 for homeless education.

13 (n) At least one council member shall represent the state child welfare agency responsible for
14 foster care.

15 (o) At least one council member shall represent the state agency responsible for children's
16 mental health.

17 (p) At least one council member shall be from the Oregon Health Authority.

18 (q) The council may include other members appointed by the Governor, including but not limited
19 to one representative from the United States Bureau of Indian Affairs or, where there is no school
20 operated or funded by the bureau, from the Indian Health Service or the tribe or tribal council.

21 (3) An individual appointed to represent a state agency that is involved in the provision of or
22 payment for services for preschool children with disabilities under subsection (2)(e) and (h) to (k)
23 of this section shall have sufficient authority to engage in making and implementing policy on behalf
24 of the agency.

25 (4) The State Interagency Coordinating Council shall:

26 (a) Advise the Superintendent of Public Instruction, the State Board of Education and the Early
27 Learning Council on unmet needs in the early childhood special education and early intervention
28 programs for preschool children with disabilities, review and comment publicly on any rules pro-
29 posed by the State Board of Education and the distribution of funds for the programs and assist the
30 state in developing and reporting data on and evaluations of the programs and services.

31 (b) Advise and assist the represented public agencies regarding the services and programs they
32 provide to preschool children with disabilities and their families, including public comments on any
33 proposed rules affecting the target population and the distribution of funds for such services, and
34 assist each agency in developing services that reflect the overall goals for the target population as
35 adopted by the council.

36 (c) Advise and assist the Department of Education and other state agencies in the development
37 and implementation of the policies that constitute the statewide system.

38 (d) Assist all appropriate public agencies in achieving the full participation, coordination and
39 cooperation for implementation of a statewide system that includes but is not limited to:

40 (A) Seeking information from service providers, service coordinators, parents and others about
41 any federal, state or local policies that impede timely service delivery; and

42 (B) Taking steps to ensure that any policy problems identified under subparagraph (A) of this
43 paragraph are resolved.

44 (e) Advise and assist the Department of Education in identifying the sources of fiscal and other
45 support for preschool services, assigning financial responsibility to the appropriate agencies and

1 ensuring that the provisions of interagency agreements under ORS 343.511 are carried out.

2 (f) Review and comment on each agency's services and policies regarding services for preschool
3 children with disabilities, or preschool children who are at risk of developing disabling conditions,
4 and their families to the maximum extent possible to assure cost-effective and efficient use of re-
5 sources.

6 (g) To the extent appropriate, assist the Department of Education in the resolution of disputes.

7 (h) Advise and assist the Department of Education in the preparation of applications and
8 amendments thereto.

11 (j) Prepare and submit an annual report to the Governor, **the Early Learning System Direc-**

12 (d) A private institution of higher education located in Oregon.

13 (4) "Law enforcement agency" means:

14 (a) A city or municipal police department.

15 (b) A county sheriff's office.

16 (c) The Oregon State Police.

17 (d) A police department established by a university under ORS 352.383.

18 (e) A county juvenile department.

19 (5) "Public or private official" means:

20 (a) Physician, osteopathic physician, physician assistant, naturopathic physician, podiatric phy-

8 (aa) Employee of a private agency or organization facilitating the provision of respite services,

38 secutively more than two full terms as a board member.

39 (2) In making appointments under subsection (1) of this section, the Governor shall select from
40 residents of Oregon one member from each congressional district and *[one member] two members*
41 from the state at large. An appointed member may not be engaged in teaching or participate in the
42 administration or operation of any school.

43 (3) The Governor may remove appointed members of the State Board of Education for cause at
44 any time after notice and public hearing.

45 (4) The State Treasurer and the Secretary of State, or the designee of the State Treasurer or

1 Secretary of State, are nonvoting, ex officio members of the board.
