SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Establishes Early Learning Division in Department of Education. Clarifies responsibilities of Early Learning Division and Early Learning Council.

Requires State Interagency Coordinating Council to submit report that provides recommendation about appropriate entity to adopt rules and develop policy related to early childhood special education and early intervention services.

Changes name of Child Care Division to Child Care Office. Establishes office in Early Learning Division.

Declares emergency, effective on passage.

THE EARLY LEARNING DIVISION

14

SECTION 1. (1) The Early Learning Division is established in the Department of Education. The purpose of the division is to ensure that children enter school ready to succeed.

(2) The division shall function under the direction and control of the Early Learning 1718 Council with the Early Learning System Director serving as the administrative officer.

SECTION 1a. The duties, functions and powers of the Early Learning Council relating to 19 the administration and enforcement of the Early Learning Council are imposed upon, trans-2021ferred to and vested in the Early Learning Division of the Department of Education for the purpose of fulfilling the duties, powers and functions of the Early Learning Division. 22

SECTION 1b. (1) The Early Learning System Director shall: 23

24 (a) Deliver to the Department of Education all records and property within the jurisdic-25tion of the director that relate to the duties, functions and powers transferred by section 1a 1 of this 2013 Act; and

2 (b) Transfer to the Department of Education those employees engaged primarily in the 3 exercise of the duties, functions and powers transferred by section 1a of this 2013 Act.

4 (2) The Superintendent of Public Instruction shall take possession of the records and 5 property, and shall take charge of the employees and employ them in the exercise of the 6 duties, functions and powers transferred by section 1a of this 2013 Act, without reduction 7 of compensation but subject to change or termination of employment or compensation as 8 provided by law.

9 (3) The Governor shall resolve any dispute between the Early Learning Council and the 10 Department of Education relating to transfers of records, property and employees under this 11 section, and the Governor's decision is final.

12 SECTION 1c. (1) The unexpended balances of amounts authorized to be expended by the 13 Early Learning Council for the biennium beginning July 1, 2013, from revenues dedicated, 14 continuously appropriated, appropriated or otherwise made available for the purpose of ad-15 ministering and enforcing the duties, functions and powers transferred by section 1a of this 16 2013 Act are transferred to and are available for expenditure by the Department of Education 17 for the biennium beginning July 1, 2013, for the purpose of administering and enforcing the 18 duties, functions and powers transferred by section 1a of this 2013 Act.

(2) The expenditure classifications, if any, established by Acts authorizing or limiting
 expenditures by the Early Learning Council remain applicable to expenditures by the De partment of Education under this section.

22 <u>SECTION 1d.</u> The transfer of duties, functions and powers to the Department of Educa-23 tion by section 1a of this 2013 Act does not affect any action, proceeding or prosecution in-24 volving or with respect to such duties, functions and powers begun before and pending at the 25 time of the transfer, except that the Department of Education is substituted for the Early 26 Learning Council in the action, proceeding or prosecution.

27 <u>SECTION 1e.</u> (1) Nothing in sections 1a to 1d of this 2013 Act relieves a person of a li-28 ability, duty or obligation accruing under or with respect to the duties, functions and powers 29 transferred by section 1a of this 2013 Act. The Department of Education may undertake the 30 collection or enforcement of any such liability, duty or obligation.

(2) The rights and obligations of the Early Learning Council legally incurred under contracts, leases and business transactions executed, entered into or begun before the operative date of section 1a of this 2013 Act accruing under or with respect to the duties, functions and powers transferred by section 1a of this 2013 Act are transferred to the Department of Education. For the purpose of succession to these rights and obligations, the Department of Education is a continuation of the Early Learning Council and not a new authority.

37 <u>SECTION 1f.</u> Notwithstanding the transfer of duties, functions and powers by section 1a 38 of this 2013 Act, the rules of the Early Learning Council with respect to such duties, func-39 tions or powers that are in effect on the operative date of section 1a of this 2013 Act continue 40 in effect until superseded or repealed by rules of the Department of Education.

41 <u>SECTION 1g.</u> Whenever, in any uncodified law or resolution of the Legislative Assembly 42 or in any rule, document, record or proceeding authorized by the Legislative Assembly, in 43 the context of the duties, functions and powers transferred by section 1a of this 2013 Act, 44 reference is made to the administration of the Early Learning Council, or an officer or em-45 ployee of the Early Learning Council, whose duties, functions or powers are transferred by

1 section 1a of this 2013 Act, the reference is considered to be a reference to the Department

9 (2) The Department of Education shall be responsible for implementing the provisions of this 10 chapter. Actions by the department to fulfill this responsibility and to increase student achievement 11 may include, but are not limited to:

(3) The department shall make school districts and the public aware of public school choice
 options available within our current public education framework.

22 SECTION 3. ORS 329.165 is amended to read:

23329.165. (1) In consultation with the advisory committee for the Oregon prekindergarten program, [the Department of Education] the Early Learning Council, acting as the state advisory 2425council for purposes of the federal Head Start Act, shall develop a long-range plan for serving eligible children and their families and shall report to each odd-numbered year regular session of 2627the Legislative Assembly on the funds necessary to implement the long-range plan, including but not limited to regular programming costs, salary enhancements and program improvement grants. The 28[department] council shall determine the rate of increase in funding for programs necessary each 2930 biennium to provide service to all children eligible for the prekindergarten program.

(2) Each biennial report shall include but not be limited to estimates of the number of eligiblechildren and families to be served, projected cost of programs and evaluation of the programs.

For this purpose, the trust fund is continuously appro-11 priated to the [*Department of Education*] **Early Learning Division** for the Oregon prekindergarten 12 program described in ORS 329.170 to 329.200.

After determining the increase in income limits or age level that would make children most in need of 36 37 state programs eligible for them, the [State Board of Education] Early Learning Division may direct 38 expenditure of any unexpended or unobligated funds appropriated for the biennium for eligible children to be expended for the additional children considered to be most in need. state, and apply only to forfeiture proceeds arising out of prohibited conduct as defined by ORS

6 (2) If the forfeiting agency is not a county, the forfeiting agency shall enter into an agreement, 7 under ORS chapter 190, with the county in which the property was seized to provide a portion of 8 the forfeiture proceeds to the county.

9 (3) After entry of a judgment of forfeiture, a forfeiting agency shall first pay from the forfeiture 10 proceeds the costs incurred by seizing and forfeiting agencies in investigating and prosecuting the 11 case, including costs, disbursements and attorney fees as defined in ORCP 68 A, special expenses 12 such as the provision of currency for undercover law enforcement operations, the cost of disabling 13 a hidden compartment in a motor vehicle and the expenses of maintaining the seized property. Distributions required under subsection (4) of this section must be made 8 once every three months and are due within 20 days of the end of each quarter.
