

House Bill 3234

Sponsored by COMMITTEE ON EDUCATION

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Early Learning Division in Department of Education. Clarifies responsibilities of Early Learning Division and Early Learning Council.

Requires State Interagency Coordinating Council to submit report that provides recommendation about appropriate entity to adopt rules and develop policy related to early childhood special education and early intervention services.

Changes name of Child Care Division to Child Care Office. Establishes office in Early Learning Division.

12 **Be It Enacted by the People of the State of Oregon:**

THE EARLY LEARNING DIVISION

16 **SECTION 1. (1) The Early Learning Division is established in the Department of Educa-**
17 **tion. The purpose of the division is to ensure that children enter school ready to learn.**

18 **(2) The division shall function under the direction and control of the Early Learning**
19 **Council with the Early Learning System Director serving as the administrative officer.**

20 **SECTION 2.** ORS 329.075 is amended to read:

21 329.075. (1) The State Board of Education shall adopt rules, in accordance with ORS 183.750 and
22 ORS chapter 183, as necessary for the statewide implementation of this chapter. The rules shall be
23 prepared in consultation with appropriate representatives from the educational and business and
24 labor communities.

25 (2) The Department of Education shall be responsible for implementing the provisions of this
26 chapter. Actions by the department to fulfill this responsibility and to increase student achievement
27 may include, but are not limited to:

28 (a) Developing academic content standards;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (b) Updating Common Curriculum Goals to meet rigorous academic content standards and up-
2 dating performance indicators and diploma requirements;

3 (c) Developing criterion-referenced assessments including performance-based, content-based and
4 other assessment mechanisms to test knowledge and skills and whether students meet the perform-
5 ance expectations as determined by the board; and

6 (d) Establishing criteria for early childhood education programs **governed by the Individuals
7 with Disabilities Education Act, 20 U.S.C. 1400 et seq.**

8 (3) The department shall make school districts and the public aware of public school choice
9 options available within our current public education framework.

10 **SECTION 3.** ORS 329.165 is amended to read:

11 329.165. (1) In consultation with the advisory committee for the Oregon prekindergarten pro-
12 gram, [*the Department of Education*] **the State Board of Education** shall develop a long-range plan
13 for serving eligible children and their families and shall report to each odd-numbered year regular
14 session of the Legislative Assembly on the funds necessary to implement the long-range plan, in-
15 cluding but not limited to regular programming costs, salary enhancements and program improve-
16 ment grants. The [*department*] **board** shall determine the rate of increase in funding for programs
17 necessary each biennium to provide service to all children eligible for the prekindergarten program.

18 (2) Each biennial report shall include but not be limited to estimates of the number of eligible
19 children and families to be served, projected cost of programs and evaluation of the programs.

20 **SECTION 4.** ORS 329.170 is amended to read:

21 329.170. (1) As used in ORS 329.170 to 329.200:

22 (a) "Advisory committee" means the advisory committee established specifically for the Oregon
23 prekindergarten program established by ORS 329.170 to 329.200.

24 (b) "Oregon prekindergartens" means programs that are recognized by the [*department*] **Early
25 Learning Division** as meeting the minimum program rules to be adopted by the State Board of
26 Education and that provide comprehensive health, education and social services in order to maxi-
27 mize the potential of children three and four years of age.

28 (c) "Oregon prekindergarten program" means the statewide administrative activities carried on
29 within the [*Department of Education*] **Early Learning Division** to allocate, award and monitor state
30 funds appropriated to create or assist local Oregon prekindergartens.

31 (2) For purposes of ORS 329.175, "eligible child" means an at-risk child who is not a participant
32 in a federal, state or local program providing like comprehensive services and may include children
33 who are eligible under rules adopted by the State Board of Education. As used in this subsection,
34 "at-risk child" means a child at least three years of age and not eligible for kindergarten whose
35 family circumstances would qualify that child for eligibility under the federal Head Start program.

36 **SECTION 5.** ORS 329.175 is amended to read:

37 329.175. (1) The [*Department of Education*] **Early Learning Division** shall administer the Oregon
38 prekindergarten program to assist eligible children with comprehensive services including educa-
39 tional, social, health and nutritional development to enhance their chances for success in school and
40 life. Eligible children, upon request of parent or guardian, shall be admitted to approved Oregon
41 prekindergartens to the extent that the Legislative Assembly provides funds.

42 (2) Nonsectarian organizations including school districts and Head Start grantees are eligible
43 to compete for funds to establish an Oregon prekindergarten. Grant recipients shall serve children
44 eligible according to federal Head Start guidelines and other children who meet criteria of eligibility
45 adopted by rule by the State Board of Education. However, not more than 20 percent of the total

1 enrollment shall consist of children who do not meet Head Start guidelines. School districts may
2 contract with other governmental or nongovernmental nonsectarian organizations to conduct a
3 portion of the program. Funds appropriated for the program shall be used to establish and maintain

10 (4) Oregon prekindergartens shall coordinate with each other and with federal Head Start pro-
11 grams to ensure efficient delivery of services and prevent overlap. Oregon prekindergartens shall
12 also work with local organizations such as local education associations serving young children and
13 make the maximum use of local resources.

14 (5) Oregon prekindergartens shall:

15 (a) Participate in the planning process under ORS 417.777 to develop a voluntary local early
16 childhood system plan; and

17 (b) Coordinate services with other services that are coordinated through the plan. The coordi-
18 nation of services shall be consistent with federal and state law.

19 **SECTION 6.** ORS 329.175, as amended by section 87, chapter 37, Oregon Laws 2012, is amended
20 to read:

21 329.175. (1) The [*Department of Education*] **Early Learning Division** shall administer the Oregon
22 prekindergarten program to assist eligible children with comprehensive services including educa-
23 tional, social, health and nutritional development to enhance their chances for success in school and
24 life. Eligible children, upon request of parent or guardian, shall be admitted to approved Oregon
25 prekindergartens to the extent that the Legislative Assembly provides funds.

26 (2) Nonsectarian organizations including school districts and Head Start grantees are eligible
27 to compete for funds to establish an Oregon prekindergarten. Grant recipients shall serve children
28 eligible according to federal Head Start guidelines and other children who meet criteria of eligibility
29 adopted by rule by the State Board of Education. However, not more than 20 percent of the total

43 (5) Oregon prekindergartens shall coordinate services with other services provided through the
44 Oregon Early Learning System. The coordination of services shall be consistent with federal and
45 state law.

SECTION 7. ORS 329.183 is amended to read:

329.183. (1) The Prekindergarten Program Trust Fund is established as a fund in the State Treasury, separate and distinct from the General Fund. Interest earned by the trust fund shall be credited to the trust fund. The primary purpose of the trust fund is to assist eligible children with comprehensive services including educational, social, health and nutritional development to enhance their chances for success in school and life. For this purpose, the trust fund is continuously appropriated to the *[Department of Education]* **Early Learning Division** for the Oregon prekindergarten program described in ORS 329.170 to 329.200.

(2) The *[department]* **division** may solicit and accept money in the form of gifts, contributions and grants to be deposited in the trust fund. Except as provided in ORS 329.185, the acceptance of federal grants for purposes of ORS 329.170 to 329.200 does not commit state funds nor place an obligation upon the Legislative Assembly to continue the purposes for which the federal funds are made available.

(3) The trust fund may be listed, if otherwise qualified, on the Oregon income tax return for checkoff pursuant to application made to the Oregon Charitable Checkoff Commission under ORS 305.690 to 305.753 by the *[department]* **division**.

SECTION 8. ORS 329.185 is amended to read:

329.185. When the federal Head Start program provides funding for programs for eligible children at or greater than the 1990-1991 per child level, eligibility for the state funded Oregon prekindergarten program shall be expanded to include programs for children whose family income exceeds the federal Head Start limits or who are in an underserved or unserved age category. After determining the increase in income limits or age level that would make children most in need of state programs eligible for them, the *[State Board of Education]* **Early Learning Division** may direct expenditure of any unexpended or unobligated funds appropriated for the biennium for eligible children to be expended for the additional children considered to be most in need. In the following biennium, the *[State Board of Education]* **Early Learning Division** shall include the cost of any added program for the children most in need in its biennial budget.

SECTION 9. ORS 329.190, as amended by section 40, chapter 37, Oregon Laws 2012, is amended to read:

329.190. The *[Department of]* **State Board of Education** shall establish an advisory committee composed of interested parents and representatives from the health care profession, early childhood education and development staff preparation programs, Oregon Head Start Association, school districts, community colleges, Early Intervention Council, child care and other organizations. The purpose of the advisory committee is to provide advice to *[the department]* **board** and the Early Learning Council on matters related to the Oregon prekindergarten program.

SECTION 10. ORS 329.195, as amended by section 18, chapter 37, Oregon Laws 2012, is amended to read:

329.195. (1)(a) The State Board of Education shall adopt rules for the establishment of the Oregon prekindergarten program.

(b) Rules adopted under this section specifically shall require:

(A) Performance standards and operating standards that are at a level no less than the level required under the federal Head Start program guidelines.

(B) Processes and procedures for recompetition that are substantially similar to the processes and procedures required under the rules and guidelines adopted under the federal Head Start Act.

(c) Federal Head Start program guidelines shall be considered as guidelines for the Oregon

1 prekindergarten program.

2 (2) In developing rules for the Oregon prekindergarten program, the board shall consult with the
 3 advisory committee established under ORS 329.190 and shall consider such factors as coordination
 4 with existing programs, the preparation necessary for instructors, qualifications of instructors,
 5 training of staff, adequate space and equipment and special transportation needs.

6 (3) The [*Department of Education*] **Early Learning Division** shall review applications for the
 7 Oregon prekindergarten program received and designate those programs as eligible to commence
 8 operation by July 1 of each year. When approving grant applications, to the extent practicable, the
 9 board shall distribute funds regionally based on percentages of unmet needs as identified in the
 10 voluntary local early childhood system plans that are part of the local coordinated comprehensive
 11 plans developed under ORS 417.775 for the county or region.

12 **SECTION 11.** ORS 329.195, as amended by sections 18 and 88, chapter 37, Oregon Laws 2012,
 13 is amended to read:

14 329.195. (1)(a) The State Board of Education shall adopt rules for the establishment of the
 15 Oregon prekindergarten program.

16 (b) Rules adopted under this section specifically shall require:

17 (A) Performance standards and operating standards that are at a level no less than the level
 18 required under the federal Head Start program guidelines.

19 (B) Processes and procedures for recompetition that are substantially similar to the processes
 20 and procedures required under the rules and guidelines adopted under the federal Head Start Act.

21 (c) Federal Head Start program guidelines shall be considered as guidelines for the Oregon
 22 prekindergarten program.

23 (2) In developing rules for the Oregon prekindergarten program, the board shall consult with the
 24 advisory committee established under ORS 329.190 and shall consider such factors as coordination

32 **SECTION 12.** ORS 329.200 is amended to read:

33 329.200. (1) The Superintendent of Public Instruction shall report to the Legislative Assembly
 34 on the merits of continuing and expanding the Oregon prekindergarten program or instituting other
 35 means of providing early childhood development assistance.

36 (2) The superintendent's report shall include specific recommendations on at least the following
 37 issues:

38 (a) The relationship of the state-funded Oregon prekindergarten program with the common
 39 school system;

40 (b) The types of children and their needs that the program should serve;

41 (c) The appropriate level of state support for implementing the program for all eligible children,
 42 including related projects to prepare instructors and provide facilities, equipment and transporta-
 43 tion;

44 (d) The state administrative structure necessary to implement the program; and

45 (e) Licensing or endorsement of early childhood teachers.

1 (3) The [*Department of Education*] **Early Learning Division** shall examine, monitor and assess
 2 the effectiveness of the Oregon prekindergarten program. The superintendent shall make biennial
 3 reports to the Legislative Assembly on the effectiveness of the program.

4 **SECTION 13.** ORS 329.235 is amended to read:

5 329.235. Subject to the approval of the Superintendent of Public Instruction **and the Early**
 6 **Learning Council:**

7 (1) The district school board of any school district in which there are resident children who are
 8 three years of age or older but who have not attained compulsory attendance age and who are not
 9 enrolled in a kindergarten of the district may:

10 (a) Provide early childhood education for such children as part of the district's educational
 11 program; or

12 (b) When the board considers a contract to be economically feasible and in the interests of the
 13 learning opportunities of eligible children, contract for instruction of such children in a school dis-
 14 trict operating an approved early childhood education program, subject to such reimbursement as
 15 the districts may agree.

16 (2) An education service district may operate an approved early childhood education program
 17 in the same manner as programs are provided under ORS 334.175 or 334.185.

18 **SECTION 14.** ORS 329.255 is amended to read:

19 329.255. (1) The district school board of every school district operating any elementary schools
 20 may establish a child development specialist program.

21 (2) If a district school board establishes a child development specialist program, the school dis-
 22 trict must meet the following requirements:

23 (a) The school district shall submit a written plan describing the program to the [*Department*
 24 *of Education*] **Early Learning Division**, and the program must be approved by the [*department*] **di-**
 25 **vision.**

26 (b) Upon approval of a program, a school district shall submit child development specialist
 27 candidate applications for [*department*] **division** approval.

28 (c) The school district shall conduct an annual review of the program and submit an updated
 29 plan to the [*department*] **division** for reauthorization of the program.

30 (d) Each child development specialist employed by a school district shall complete an annual
 31 evaluation of the specialist's child development plan to be included with the school district's updated
 32 plan.

33 (3) The [*department*] **division** shall review the plans annually.

34 (4) School districts may provide the child development specialist program by contract with
 35 qualified state or local programs.

36 **SECTION 15.** ORS 329.275 is amended to read:

37 329.275. (1) The [*State Board of Education*] **Early Learning Council** by rule shall establish
 38 guidelines for implementation of ORS 329.255, including but not limited to qualifications for child
 39 development specialists and procedures for community coordination of efforts. Such qualifications
 40 and procedures shall not be limited to traditional treatment oriented disciplines or the various dis-
 41 ciplines requiring certification.

42 (2) Exceptions to the qualifications established by the [*state board*] **council** may be made if the
 43 [*state board*] **council** determines after a hearing that an individual is capable of performing the re-
 44 quired functions.

45 **SECTION 16.** ORS 329.385 is amended to read:

1 329.385. (1) The [*Department of Education*] **Early Learning Division** shall prepare operating
 2 guides for child development programs and for student-parent programs applicable to programs un-
 3 der this section that are consistent with requirements imposed by the [*State Board of Education*]
 4 **Early Learning Council**.

5 (2) The [*Department of Education*] **Early Learning Division** shall review applications for ap-
 6 proval of child development programs and student-parent programs and may approve up to 20 child
 7 development and up to 20 student-parent programs after considering:

8 (a) The educational adequacy and type of programs.

9 (b) The number of students and children who are to be served by the program.

10 (c) The availability of trained personnel and facilities.

11 (d) The need for the programs in the applying district.

12 (3) In approving applications for child development programs, the [*department*] **division** shall
 13 require that the school district use the contributions described in ORS 315.234 (2003 or earlier edi-
 14 tion) for child development curriculum and in the formulation and initiation of on-site child devel-
 15 opment centers. Each center must be able to accommodate not more than 30 full-time equivalent
 16 spaces for children, distributed according to needs of the community.

17 (4) In approving applications for student-parent programs, the [*department*] **division** shall require
 18 that the school district use the contributions described in ORS 315.234 (2003 or earlier edition) for
 19 appropriate education for student-parents leading to graduation and in the formulation and devel-
 20 opment of appropriate on-site child care facilities. Each facility must be able to accommodate not
 21 more than 30 full-time equivalent spaces for children, distributed according to the needs of the
 22 student-parents.

23 (5) As used in this section:

24 (a) "Child development program" means an educational program that conforms to standards
 25 adopted by the [*State Board of Education*] **Early Learning Council** and that consists of an education
 26 component and a child care component.

27 (b) "Student-parent program" means an educational program that conforms to standards adopted
 28 by the [*State Board of Education*] **Early Learning Council** and that consists of education for the
 29 student-parent and child care for the student-parent's child.

30 **SECTION 17.** ORS 329.395 is amended to read:

31 329.395. As used in ORS 329.395 to 329.425:

32 (1) "Child development program" means an educational program funded by ORS 329.395 to
 33 329.425 that conforms to standards adopted by the [*State Board of Education*] **Early Learning**
 34 **Council** and that consists of an education component and a child care component.

35 (2) "Teenage parent program" means an educational program funded by ORS 329.395 to 329.425
 36 that conforms to standards adopted by the [*State Board of Education*] **Early Learning Council** and
 37 that consists of education for the student-parent and child care for the student-parent's child.

38 **SECTION 18.** ORS 329.415 is amended to read:

39 329.415. (1) The [*Department of Education*] **Early Learning Division** shall prepare operating
 40 guides for child development programs and for teenage parent programs applicable to programs un-
 41 der ORS 329.395 to 329.425 that are consistent with requirements imposed by the [*State Board of*
 42 *Education*] **Early Learning Council**.

43 (2) The [*department*] **division** shall review applications for approval of child development pro-
 44 grams and teenage parent programs and may approve those programs after considering:

45 (a) The educational adequacy and type of programs.

1 (b) The number of students and children who are to be served by the program.

2 (c) The availability of trained personnel and facilities.

3 (d) The need for the programs in the applying district.

4 (3) In approving applications for child development programs, the *[department]* **division** shall
5 require that the school district use its grant for child development curriculum and in the formulation
6 and initiation of on-site child development centers. Each center must be able to accommodate from
7 15 to 30 full-time equivalent spaces for children, distributed according to needs of the community.

8 (4) In approving applications for teenage parent programs, the *[department]* **division** shall re-
9 quire that the school district use the grant in connection with appropriate education for teenage
10 parents leading to graduation and in the formulation and development of appropriate on-site child
11 care centers. Each center must be able to accommodate from 15 to 30 full-time equivalent spaces for
12 children, distributed according to the needs of the teenage student-parents.

13 **SECTION 19.** Section 10, chapter 37, Oregon Laws 2012, is amended to read:

14 **Sec. 10.** (1) The Early Learning *[Council]* **Division** Fund is established in the State Treasury,
15 separate and distinct from the General Fund. Interest earned by the Early Learning *[Council]* **Divi-
16 sion** Fund shall be credited to the fund.

17 (2) Moneys in the Early Learning *[Council]* **Division** Fund consist of:

18 (a) Amounts donated to the fund;

19 (b) Moneys transferred to the fund from the federal government, state agencies and local gov-
20 ernments;

21 (c) Amounts appropriated or otherwise transferred to the fund by the Legislative Assembly;

22 (d) Investment earnings received on moneys in the fund; and

23 (e) Other amounts deposited in the fund from any source.

24 (3) Moneys in the fund are continuously appropriated to the *[Early Learning Council established
25 in section 4, chapter 519, Oregon Laws 2011,]* **Early Learning Division** for the purpose of fulfilling
26 the *[council's]* **division's** duties, functions and powers.

27 (4) The *[council]* **division** may establish accounts and subaccounts within the fund when the
28 *[council]* **division** determines that accounts or subaccounts are necessary or desirable and may
29 credit any interest or income derived from moneys in the fund to any account or subaccount in the
30 fund.

31 **SECTION 20.** (1) **The amendments to section 10, chapter 37, Oregon Laws 2012, by section
32 19 of this 2013 Act are intended to change the name of the “Early Learning Council Fund”
33 to the “Early Learning Division Fund.”**

34 **(2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
35 may substitute for words designating the “Early Learning Council Fund,” wherever they oc-
36 cur in statutory law, other words designating the “Early Learning Division Fund.”**

37 **SECTION 21.** ORS 131A.360, as amended by section 33, chapter 37, Oregon Laws 2012, and
38 section 18, chapter 97, Oregon Laws 2012, is amended to read:

39 131A.360. (1) The provisions of this section apply only to a forfeiting agency other than the
40 state, and apply only to forfeiture proceeds arising out of prohibited conduct as defined by ORS
41 131A.005 (12)(a).

42 (2) If the forfeiting agency is not a county, the forfeiting agency shall enter into an agreement,
43 under ORS chapter 190, with the county in which the property was seized to provide a portion of
44 the forfeiture proceeds to the county.

45 (3) After entry of a judgment of forfeiture, a forfeiting agency shall first pay from the forfeiture

1 proceeds the costs incurred by seizing and forfeiting agencies in investigating and prosecuting the
 2 case, including costs, disbursements and attorney fees as defined in ORCP 68 A, special expenses
 3 such as the provision of currency for undercover law enforcement operations, the cost of disabling
 4 a hidden compartment in a motor vehicle and the expenses of maintaining the seized property. The
 5 forfeiting agency may not pay expenditures made in connection with the ordinary maintenance and
 6 operation of a seizing or forfeiting agency under this subsection.

7 (4) After payment of costs under subsection (3) of this section, the forfeiting agency shall:

8 (a) Deduct an amount equal to five percent of the forfeiture proceeds and deposit that amount
 9 in the Illegal Drug Cleanup Fund established by ORS 475.495 for the purposes specified in ORS
 10 475.495 (5) and (6);

11 (b) Deduct an amount equal to 2.5 percent of the forfeiture proceeds and deposit that amount
 12 in the Asset Forfeiture Oversight Account;

13 (c) Deduct an amount equal to 20 percent of the forfeiture proceeds and deposit that amount in
 14 the Oregon Criminal Justice Commission Account established under ORS 137.662 for disbursement
 15 to drug court programs as described in ORS 3.450; and

 4 by submitting evidence that local stakeholders, including but not limited to service providers, par-
 5 ents, community members, county governments, local governments and school districts, have par-
 6 ticipated in the development of the application.

7 (b) The services coordinated by the entity will be in alignment with the services provided by the
 8 public schools of the community that will be served by the entity.

9 (c) The entity will make advantageous use of the system of public health care and services
 10 available through county health departments and other publicly supported programs delivered
 11 through, or in partnership with, counties.

12 (d) The entity has a governing body or an advisory body that:

13 (A) Has the authority to initiate audits, recommend the terms of a contract and provide reports
 14 to the public and to the Early Learning Council on the outcomes of the provision of early learning
 15 services to the community served by the entity.

16 (B) Has members selected through a transparent process.

17 (e) The entity will collaborate on documentation related to coordinated services with public and
 18 private entities that are identified by the Early Learning [Council] **Division** as providers of services
 19 that advance the early learning of children.

20 (f) The entity will serve a community that is based on the population and service needs of the
 21 community.

22 (g) The entity is able to raise significant funds from public and private sources to support early
 23 learning services coordinated by the entity.

 25 the Governor chooses not to name a chairperson, the council may elect one of its members to serve
 26 as chairperson. However, any member of the council who represents the Department of Education
 27 may not serve as the chairperson of the council.

28 (2) The membership of the council shall be composed as follows:

29 (a) At least 20 percent of the council members shall be parents, including minority parents, of
 30 preschool children with disabilities or of children with disabilities who are 12 years of age or
 31 younger who have knowledge of or experience with programs for infants and toddlers with disabili-
 32 ties. At least one council member shall be a parent of an infant or toddler with a disability or of a
 33 child with a disability who is six years of age or younger.

34 (b) At least 20 percent of the council members shall be public or private providers of early
 35 intervention and early childhood special education services.

36 (c) At least one council member shall be a member of the Legislative Assembly.

37 (d) At least one council member shall be involved in personnel preparation.

38 (e) At least one council member shall represent the Department of Human Services.

39 (f) At least one council member shall represent the federal Head Start program.

40 (g) At least one council member shall represent the [*Child Care Division of the Employment De-*
 41 *partment*] **Child Care Office.**

42 (h) At least one council member shall represent the Department of Education.

43 (i) At least one council member shall represent the Department of Consumer and Business Ser-
 44 vices.

45 (j) At least one council member shall represent the Early Learning [*Council*] **Division.**

1 (k) At least one council member shall represent the Child Development and Rehabilitation Cen-
2 ter of the Oregon Health and Science University.

3 (L) At least one council member shall be a member of the State Advisory Council for Special
4 Education created under ORS 343.287.

5 (m) At least one council member shall be a representative designated by the state coordinator
6 for homeless education.

7 (n) At least one council member shall represent the state child welfare agency responsible for
8 foster care.

9 (o) At least one council member shall represent the state agency responsible for children's
10 mental health.

11 (p) At least one council member shall be from the Oregon Health Authority.

12 (q) The council may include other members appointed by the Governor, including but not limited
13 to one representative from the United States Bureau of Indian Affairs or, where there is no school
14 operated or funded by the bureau, from the Indian Health Service or the tribe or tribal council.

15 (3) An individual appointed to represent a state agency that is involved in the provision of or
16 payment for services for preschool children with disabilities under subsection (2)(e) and (h) to (k)
17 of this section shall have sufficient authority to engage in making and implementing policy on behalf
18 of the agency.

19 (4) The State Interagency Coordinating Council shall:

20 (a) Advise the Superintendent of Public Instruction, the State Board of Education and the Early
21 Learning Council on unmet needs in the early childhood special education and early intervention
22 programs for preschool children with disabilities, review and comment publicly on any rules pro-
23 posed by the State Board of Education and the distribution of funds for the programs and assist the
24 state in developing and reporting data on and evaluations of the programs and services.

25 (b) Advise and assist the represented public agencies regarding the services and programs they
26 provide to preschool children with disabilities and their families, including public comments on any
27 proposed rules affecting the target population and the distribution of funds for such services, and
28 assist each agency in developing services that reflect the overall goals for the target population as

30 (c) Advise and assist the Department of Education and other state agencies in the development
31 and implementation of the policies that constitute the statewide system.

32 (d) Assist all appropriate public agencies in achieving the full participation, coordination and
33 cooperation for implementation of a statewide system that includes but is not limited to:

34 (A) Seeking information from service providers, service coordinators, parents and others about
35 any federal, state or local policies that impede timely service delivery; and

36 (B) Taking steps to ensure that any policy problems identified under subparagraph (A) of this
37 paragraph are resolved.

38 (e) Advise and assist the Department of Education in identifying the sources of fiscal and other
39 support for preschool services, assigning financial responsibility to the appropriate agencies and
40 ensuring that the provisions of interagency agreements under ORS 343.511 are carried out.

41 (f) Review and comment on each agency's services and policies regarding services for preschool
42 children with disabilities, or preschool children who are at risk of developing disabling conditions,
43 and their families to the maximum extent possible to assure cost-effective and efficient use of re-
44 sources.

45 (g) To the extent appropriate, assist the Department of Education in the resolution of disputes.

1 (h) Advise and assist the Department of Education in the preparation of applications and
2 amendments thereto.

3 (i) Advise and assist the Department of Education regarding the transition of preschool children
4 with disabilities.

5 (j) Prepare and submit an annual report to the Governor, **the Early Learning System Direc-**
6 **tor, the Early Learning Council, the Legislative Assembly** and [to] the United States Secretary
7 of Education on the status of early intervention programs operated within this state.

8 (5) The council may advise appropriate agencies about integration of services for preschool
9 children with disabilities and at-risk preschool children.

10 (6) Terms of office for council members shall be three years, except that:

11 (a) The representative from the State Advisory Council for Special Education shall serve a
12 one-year term; and

13 (b) The representatives from other state agencies and the representative from the Legislative
14 Assembly shall serve indefinite terms.

15 (7) Subject to approval by the Governor, the council may use federal funds appropriated for this
