House Bill 3305

Sponsored by Representative BARNHART

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes University of Oregon and Portland State University as independent public universities, governed by university boards of directors.

Empowers Oregon Education Investment Board to adopt performance benchmarks to be achieved by University of Oregon and Portland State University.

Requires Oregon Education Investment Board to approve tuition and fee increases greater than five percent annually.

Requires universities to get approval from Higher Education Coordinating Commission for new degree programs and policies for transfer of credits.

Allows universities to obtain insurance. Requires universities to adhere to existing collective bargaining agreements, unless modifications are collectively bargained, and to collectively bargain employee benefit plans. Allows universities to issue revenue bonds, subject to review by State Treasurer, and enter into credit enhancement agreements and financing agreements. Allows universities to sue and be sued, make all necessary or convenient contracts and do any other act in relation to university property and matters of university concern. Directs Oregon Education Investment Board to report to Legislative Assembly before December

Directs Oregon Education Investment Board to report to Legislative Assembly before December 1, 2017, on impact of higher education governance changes and recommend further changes if necessary.

Removes sunset for Oregon Education Investment Board.

Becomes operative on January 1, 2014. Directs university presidents to assume jurisdiction of universities on July 1, 2015.

Declares emergency, effective on passage.

Be It Enacted by the People of the State of Oregon: 3 4 UNIVERSITY OF OREGON 5 6 SECTION 1. As used in sections 1 to 52 of this 2013 Act: 7 (1) "Board" means the University of Oregon Board of Directors established under section 8 9 4 of this 2013 Act. (2) "University" means the University of Oregon public university established under sec-10 tion 2 of this 2013 Act. 11 12SECTION 2. (1) The University of Oregon is established as a public university and shall be governed by the University of Oregon Board of Directors. The board may exercise au-13 thority over matters of university concern to the fullest extent allowed by Constitutions and 14 laws of the United States and this state, as fully as if each particular power comprised in 15 that general authority were specifically listed in sections 1 to 52 of this 2013 Act. The board 16 may delegate and provide for the further delegation of any of its powers and authorities. 17 18 (2) The powers granted by this section are in addition to any other power granted to the 19 University of Oregon in sections 1 to 52 of this 2013 Act and may not be construed to limit or qualify any such power. The powers granted by this section shall be liberally construed 20to the end that the board shall have all powers over matters of university concern that is 2122possible for it to have under the Constitutions and laws of the United States and this state. 23(3) The university is an instrumentality of state government, performing governmental functions and exercising governmental powers. The university is independent, has statewide 24purposes and is without territorial boundaries. The university is a state institution of higher 25education, but is not an agency, department or division of the state, a unit of local or mu-26nicipal government or part of the executive branch, except as set forth in sections 1 to 52 27of this 2013 Act. 28(4)(a) A claim against the university is not a claim against the State of Oregon. A debt 2930 or obligation of the university is not a debt or obligation of the State of Oregon. Claims 31 against the university and obligations of the university are not recoverable from the assets and funds of the State of Oregon. 32(b) The university is not authorized to act in the name of the State of Oregon and at-33 34 torneys representing the university do not represent the state. (5) Nothing in sections 1 to 52 of this 2013 Act may be construed as a waiver by the 35 university of any form of defense or immunity, whether it be sovereign immunity, govern-36 37 mental immunity, immunity based upon the Eleventh Amendment to the Constitution of the 38 United States or immunity from any claim or from the jurisdiction of any court. SECTION 3. (1) It shall be the policy of the University of Oregon as a public university: 39 40 (a) To serve the people of this state by educating citizens of the state, region, nation and world; 41 (b) To provide: 42 (A) An educational environment that stimulates creative inquiry, critical thinking, clear 43 communication and original scholarship by and for the benefit of students, faculty, staff and 44

(B) Education, research and service that contribute to the development of new knowledge 1 2 and the enhancement of the culture and economy of this state; (c) To encourage the preservation, enhancement and dissemination of knowledge and 3 culture; 4 (d) To provide individuals with the tools for a lifetime of learning so as to allow them to 5 enhance their quality of life, contribute to civic discourse and civil society and participate 6 effectively in a global society; 7 (e) To create an educated workforce that keeps the Oregon economy innovative and 8 9 competitive; 10 (f) To provide public service activities that engage the professional expertise of faculty to solve society's problems; 11 12(g) To share with this state many services and cultural activities of immense importance 13 to the quality of life enjoyed by Oregonians and others; and (h) To strive for excellence in all of its endeavors while maintaining institutional integ-14 15rity. 16(2) The university shall carry out the policies of this section in the manner that, in the determination of the University of Oregon Board of Directors, best promotes the welfare of 17 18 the people of this state. SECTION 4. (1) There is established a University of Oregon Board of Directors, consist-19 ing of 15 members. 20(2) The membership of the board shall be as follows: 2122(a) Twelve members appointed by the Governor and confirmed by the Senate in the manner prescribed in ORS 171.562 and 171.565. These members shall include one student 23enrolled at the University of Oregon, one regular employee, as defined in ORS 240.015, of the 24university and one faculty member of the university. When appointing the faculty member, 25the Governor shall consider recommendations from the university faculty. When appointing 2627the student member, the Governor shall consider recommendations from a general student association recognized by the University of Oregon. 28(b) One member who is a nonstudent member of the Oregon Education Investment 2930 Board, appointed by the Oregon Education Investment Board. 31 (c) One member who is a member of the University of Oregon Foundation Board of Trustees, appointed by the University of Oregon Board of Directors in consultation with the 32foundation board of trustees. 33 34 (d) The president of the university, who shall be a nonvoting member. 35 (3) The board may appoint other nonvoting members as it deems in the best interests 36 of the university. 37 (4)(a) Except for the president of the university, the term of office of each nonstudent 38 member is four years. The term of office of the student member is two years. (b) Before the expiration of the term of a member, the appointing authority shall appoint 39 a successor whose term begins on July 1 next following. A member is eligible for reappoint-40 ment for one additional term. 41 (c) If there is a vacancy for any cause, the appointing authority shall make an appoint-42ment to become effective for the remainder of the unexpired term. 43 (d) A student enrolled at the university may not be appointed to, or continue to serve 44

45 on, the board unless the student is in good standing pursuant to bylaws or policies of the

1 **board.**

2 (5) Except as provided in subsection (2)(a) of this section, a voting member may not be 3 an employee of the university, the Oregon University System or the State of Oregon.

4 (6) The board shall select one of its members as the chairperson, another as vice chair-5 person and another as secretary, for such terms and with such duties and powers as the 6 board considers necessary for performance of the functions of those offices. The board shall 7 adopt bylaws for its governance, including provisions specifying how a quorum is constituted 8 and when a quorum is necessary.

9 (7) The board shall meet at least once every three months on the university campus. 10 Board members may participate in the meeting electronically as provided in ORS 192.610 to 11 192.690. The board shall meet at such other times and places specified by the chairperson or 12 by a majority of the members of the board.

(8) An appointing authority may remove any member appointed by the authority at any
 time for cause, after notice and public hearing.

<u>SECTION 5.</u> Notwithstanding the terms of office specified in section 4 of this 2013 Act,
 of the members first appointed to the University of Oregon Board of Directors, other than
 the president of the University of Oregon:

(1) Seven members appointed by the Governor, including the student member, shall serve
 for terms ending June 30, 2016; and

20 (2) The following shall serve for terms ending June 30, 2018:

(a) Five members appointed by the Governor, including the faculty member and the reg ular employee, as defined in ORS 240.015, of the university;

(b) The member appointed by the Oregon Education Investment Board; and

(c) The member appointed in consultation with the University of Oregon Foundation
 Board of Trustees.

26 <u>SECTION 6.</u> The Governor and the Oregon Education Investment Board shall appoint 27 members to the University of Oregon Board of Directors pursuant to section 4 (2)(a) and (b) 28 of this 2013 Act no later than January 15, 2014. These board members shall appoint the board 29 member described in section 4 (2)(c) of this 2013 Act no later than 60 days after confirmation 30 of the gubernatorial appointees by the Senate.

31 <u>SECTION 7.</u> (1) The University of Oregon Board of Directors may, within or outside the 32 state, do all things necessary or convenient involving matters of concern to the University 33 of Oregon, including without limitation the following:

(a) Enact any and all policies for the governance of the university, which, to the extent
 set forth in those policies, shall have the force of law and may be enforced through university procedures and in any court of competent jurisdiction.

(b) Hire and employ personnel and prescribe all conditions of employment, including but
 not limited to compensation, benefits and tenure.

(c) Enter into any and all contracts and agreements with any public or private entity.

40 (d) Enter into any partnership, joint venture or other business arrangement and create
 41 and participate fully in the operation of any business structure or organization.

42 (e) Borrow money and issue debt of any kind and pledge revenue to repay any loan or43 indebtedness.

44 (f) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-45 trol, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, issue, im-

prove, develop, use, expend and dispose of personal property, including intellectual property, 1

2 of any nature, tangible or intangible.

(g) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-3 trol, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, improve, 4 develop, use, expend and dispose of real property. 5

6

(h) Sue and be sued and issue and enforce subpoenas in the board's name.

(i) Obtain and receive gifts, bequests and donations for the benefit of the university and, 7 subject to the terms of the gift, retain, invest and use such gifts as deemed appropriate by 8 9 the university or the board. The board may assess a reasonable management fee against all gifts, bequests and donations and the earnings thereon. 10

(j) Acquire, purchase, accept, borrow, receive, own, hold, deposit, pledge, control, convey, 11 12manage, use, lend, expend and invest all funds, appropriations, instruments, earnings and 13 revenue. The authority under this paragraph includes accepting and expending funds from the United States Government for any purpose. The board may deposit any and all funds, 14 15 appropriations, instruments, earnings and revenue in any financial institution and retain all 16 interest, earnings, and appreciation accruing from such deposits.

17(k) Erect, construct, improve, remodel, develop, repair, maintain, equip, furnish, lease, 18 lend, convey, sell, manage, operate, use and dispose of any building, structure, land or project. 19

(L) Except as provided in ORS 243.105 to 243.585, acquire any and all insurance, operate 20a self-insurance program or otherwise arrange for the equivalent of insurance coverage of 2122any nature or type.

23(m) Create, develop, manage and control educational, research, service and any other 24programs.

25

(n) Set standards for the admission, graduation and discipline of students.

(o) Authorize, establish, eliminate, manage, operate, reorganize, reduce or expand any 2627program, school, institute, college or unit of operation, except that any new degree or program or any policy regarding transferability of credits to and from a public university listed 28in ORS 352.002, Portland State University, a community college in this state or Oregon 2930 Health and Science University must be authorized or approved by the Higher Education Co-31 ordinating Commission.

32(p) Authorize, establish, eliminate, charge, collect, manage, use in any manner and expend all revenue derived from tuition, fees and any other charges and fines. The board shall 33 34 request the joint recommendation of the recognized student government and the president 35 of the university, who shall obtain the recommendation of the recognized student government, prior to authorizing, establishing or eliminating incidental fees for programs under the 36 37 supervision or control of the board and found by the board to be advantageous to the cultural 38 or physical development of students. Any increase in tuition or any student fees above five percent on an annual basis must be approved by the Oregon Education Investment Board. 39

40 (q) Acquire, receive, own, hold, use, sell, mortgage, lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock, bonds, or other equity or interests in or 41 obligations of any entity. 42

(r) Make available and perform any and all services on such terms as considered appro-43 priate. 44

45

(s) Delegate any and all powers and duties and provide for any further delegation.

1 (t) Provide and disseminate to the public information relating to the program, operation 2 and finances of the university.

3 (u) Exercise any other power, duty or responsibility necessary or convenient over mat 4 ters of university concern.

5 (2) The absence of express authority may not be construed to deny that authority to the 6 university or to limit or qualify any such power. Powers of the board shall be liberally con-7 strued to effect the purposes of the university.

8 <u>SECTION 8.</u> The University of Oregon Board of Directors shall appoint a president of the 9 University of Oregon. The president of the university is the president of the faculty and is 10 the chief executive officer of the university. The president of the university has authority 11 to direct the affairs and operation of the university, subject to the policies and direction of 12 the board.

SECTION 9. Except as otherwise provided by law, the provisions of ORS 35.550 to 35.575, 180.060, 180.210 to 180.235, 184.305 to 184.345, 190.430, 190.480, 190.490, 192.105, 200.035, 243.696, 279.835 to 279.855, 357.805 to 357.895 and 656.017 (2) and ORS chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291, 292, 293, 294 and 297 do not apply to the University of Oregon or any not-for-profit organization or other entity if the equity of the entity is owned exclusively by the university and if the organization or entity is created by the university to advance any of the university's statutory missions.

SECTION 10. Notwithstanding section 9 of this 2013 Act, collective bargaining agreements 20negotiated by this state pursuant to ORS 240.321 after the effective date of this 2013 Act that 2122are applicable to employees of the Oregon University System apply to the University of 23Oregon if the new collective bargaining agreement is a successor to a collective bargaining agreement negotiated by this state and applicable to the same class of employees of the 24university prior to the effective date of this 2013 Act. Such successor agreements shall con-25tinue to apply to the university until the board and the applicable collective bargaining or-2627ganization agree to bargain a separate collective bargaining agreement between the university and the collective bargaining organization. 28

SECTION 11. (1) As used in this section:

(a) "Direct labor" includes all work required for preparation, processing and packing, but
 not supervision, administration, inspection or shipping.

(b) "Individual with a disability" means an individual who, because of the nature of the
 individual's disability, is not able to participate fully in competitive employment and for
 whom specialized employment opportunities must be provided.

(c) "Qualified nonprofit agency for individuals with disabilities" means a nonprofit activ ity center or rehabilitation facility:

(A) Organized under the laws of the United States or of this state and operated in the
 interest of individuals with disabilities, the net income of which does not inure in whole or
 in part to the benefit of any shareholder or other individual;

40 (B) That complies with any applicable occupational health and safety standards required
41 by the laws of the United States or of this state; and

42 (C) That in the manufacture of products and in the provision of services during the fiscal
43 year employs individuals with disabilities for not less than 75 percent of the work hours of
44 direct labor required for the manufacture or provision of the products or services.

45 (2) The University of Oregon Board of Directors shall further the policy of this state to

1 encourage and assist individuals with disabilities to achieve maximum personal independence

2 through useful and productive gainful employment by ensuring an expanded and constant

3 market for sheltered workshop and activity center products and services, thereby enhancing

4 the dignity and capacity of individuals with disabilities for self-support and minimizing their

5 dependence on welfare and need for costly institutionalization.

6

(3) It shall be the duty of the University of Oregon to:

(a) Determine the price of all products manufactured and services offered for sale to the
university by any qualified nonprofit agency for individuals with disabilities. The price shall
recover for the workshops the cost of raw materials, labor, overhead, delivery costs and a
margin held in reserve for inventory and equipment replacement.

11 (b) Revise such prices from time to time in accordance with changing cost factors.

(c) Make such rules regarding specifications, time of delivery and other relevant matters
 of procedure as shall be necessary.

(d) Utilize prices and specifications, in its discretion, established by the Oregon Depart ment of Administrative Services.

(4) The university shall establish and publish a list of sources or potential sources of
 products produced by any qualified nonprofit agency for individuals with disabilities and the
 services provided by any such agency that the university determines are suitable for its
 procurement. The university, in its discretion, may utilize any list established and published
 by the department.

(5) If the university intends to procure any product or service on the procurement list, the university shall procure such product or service at the price established by the university from a qualified nonprofit agency for individuals with disabilities, provided the product or service is of the appropriate specifications and is available at the location and within the period required by the university.

(6) It is the intent of the Legislative Assembly that there be close cooperation between
the board, the university and qualified nonprofit agencies for individuals with disabilities.
The university, on behalf of the board, is authorized to enter into such contractual arrangements, cooperative working relationships or other arrangements as may be necessary
for effective coordination and efficient realization of the objective of this section.

<u>SECTION 12.</u> The University of Oregon Board of Directors shall file with the Oregon Education Investment Board, the Higher Education Coordinating Commission, the Legislative Assembly and the Governor, not later than April 15 of each year, a report of the activities and operations of the University of Oregon for the preceding year.

<u>SECTION 13.</u> (1) The University of Oregon Board of Directors may lease, purchase or otherwise acquire such real property as in its sole discretion is necessary or convenient to carry out any power granted to the University of Oregon. The board may enter into contracts of purchase or agreements that the board deems necessary to carry out this authorization. The board may mortgage or pledge any property purchased, or its contracts to purchase, together with the income from such property, to secure the payment of the purchase price

(2) Legal title to all real property acquired by the University of Oregon after the effective
date of this 2013 Act shall be taken and held in the name of the university. Legal title to all
real property of this state held or managed for the use and benefit of the university as of
the effective date of this 2013 Act shall continue to be vested in this state.

(3) The board may lease, sell, convey and control the use of, in whole or in part, all 1 2 property of this state held or managed for the use and benefit of the university as of the effective date of this 2013 Act or that is acquired by the university after the effective date 3 of this 2013 Act. Authorized conveyances of all real property acquired by or vested in this 4 state for the use or benefit of the university or acquired by or vested in the university, other 5 than the state lands classified as university lands under ORS 273.251, shall be executed by 6 the chairperson and secretary of the board. 7

(4) Except as otherwise provided by law, proceeds from the lease, sale or conveyance of 8 9 real property pursuant to subsection (3) of this section shall be deposited into an account at the University of Oregon for the benefit of the university. 10

SECTION 14. The University of Oregon Board of Directors may, in the management of 11 12all forestlands under its control and supervision, sell the forest products on such lands. In the management of its forestlands, the board may lease mineral and geothermal resource 13 rights. 14

15 SECTION 15. The University of Oregon may acquire, by condemnation or otherwise, pri-16vate property that is necessary or convenient in carrying out any power granted to the uni-17 versity.

18 SECTION 16. The University of Oregon shall adopt a comprehensive alcohol and drug abuse policy and implementation plan. 19

20SECTION 17. (1) The University of Oregon shall develop contract policies that support openness, impartiality and competition in the awarding of contracts in accordance with ORS 2122279A.015.

23(2) The university shall also develop contract policies that are designed to encourage affirmative action, recycling, inclusion of art in public buildings, the purchase of goods and 24services from individuals with disabilities, the protection of workers through the payment 25of prevailing wages as determined by the Bureau of Labor and Industries, the provision of 2627workers' compensation insurance to workers on contracts and the participation of emerging small businesses and businesses owned by women and minorities. 28

(3) The University of Oregon Board of Directors shall have the authority to enact poli-2930 cies, appropriate for the use of the university, governing public contracting and may devise 31 and publish forms for use in carrying out the policies.

SECTION 18. (1)(a) On or before September 1 of each even-numbered year the University 32of Oregon shall submit to the Oregon Department of Administrative Services a funding re-33 34 quest for the following biennium.

35 (b) The department shall include and submit the university's funding request to the Legislative Assembly as part of the Governor's biennial budget. Any such request approved 36 37 by the Legislative Assembly shall be appropriated to the department for direct allocation to 38 the university.

(2) The University of Oregon Board of Directors is not required to seek expenditure 39 limitation approval from the Legislative Assembly to spend other available moneys, including 40 without limitation tuition and other fees or revenues collected pursuant to the board's au-41 thority under section 7 of this 2013 Act. 42

(3) The University of Oregon Board of Directors shall adopt a budget on a regular 43 schedule determined by the board. 44

SECTION 19. (1) The University of Oregon may conduct independent audits if such audits

1 are considered advisable by the university. The audits are subject to the exclusive discretion

and control of the university and are subject to disclosure pursuant to ORS 192.410 to 192.505.

3 (2) Nothing in this section affects the constitutional duties and authority of the Secretary

4 of State to audit public accounts.

5 <u>SECTION 20.</u> The University of Oregon may commission special campus security officers 6 with authority and immunities set forth in ORS 352.385.

SECTION 21. (1) The University of Oregon Board of Directors may enact such regulations 7 as the board deems convenient or necessary to provide for the policing, control and regu-8 9 lation of traffic and parking of vehicles on University of Oregon property. The regulations may provide for the registration of vehicles, the designation of parking areas and the as-10 sessment and collection of reasonable fees and charges for parking. The board may require 11 12that before a quarterly or yearly parking privilege for any vehicle is granted to any full-time or part-time student to use board property, the student must show that the vehicle is oper-13 ated by a student holding a valid driver license, that the vehicle is currently registered and 14 15 that the student driving the vehicle is insured under a motor vehicle liability insurance policy 16that meets the requirements described in ORS 806.080 or that the student or owner of the vehicle has provided the Department of Transportation with other satisfactory proof of 17 18 compliance with the financial responsibility requirements of this state.

19 (2) The regulations enacted pursuant to subsection (1) of this section shall be enforced 20administratively under procedures adopted by the board. Administrative and disciplinary sanctions may be imposed upon students, faculty and staff for violation of the regulations, 2122including, but not limited to, a reasonable monetary penalty that may be deducted from 23student deposits and faculty or staff salaries or other funds in the possession of the university. The board shall provide opportunity for hearing for the determination of controversies 24 25in connection with imposition of fines or penalties. Persons other than students, faculty or staff may voluntarily submit to the hearing procedures prescribed by the board, and shall 2627be bound by the results of the hearing. The powers granted to the board by this section are supplemental to the existing powers of the board with respect to the governance of activities 28of students, faculty and staff and the control and management of property under the board's 2930 jurisdiction.

(3) The regulations enacted pursuant to subsection (1) of this section may also be en forced by the impoundment of vehicles, and a reasonable fee may be enacted for the cost of
 impoundment and storage, if any, prior to the release of the vehicles to their owners.

(4) Every peace officer may enforce the regulations made by the board under subsection
(1) of this section. The board, for the purpose of enforcing its regulations governing traffic
control, may appoint peace officers who have the same authority as other peace officers as
defined in ORS 133.005.

(5) The board and any municipal corporation or any department, agency or political subdivision of this state may enter into agreements or contracts for the purpose of providing a
uniform system of enforcement of the regulations of the board enacted pursuant to subsection (1) of this section.

(6) In proceedings brought to enforce regulations enacted pursuant to subsection (1) of this section, it shall be sufficient to charge the defendant by an unsworn written notice as provided by law. Proceedings to enforce regulations enacted pursuant to subsection (1) of this section may be brought in the name of the board in a circuit court, a justice court or

a municipal court for offenses committed within the territorial jurisdiction of such court. 1 Such courts shall have concurrent jurisdiction over offenses committed within their respec-2 tive jurisdictions. All fines, penalties and court costs recovered shall be paid to the clerk of 3 the court involved and shall be disposed of as provided by law. 4 SECTION 22. (1) For the purpose of requesting a state or nationwide criminal records 5 check under ORS 181.534, the University of Oregon may require the fingerprints of a person 6 7 who: 8 (a)(A) Is employed or applying for employment by the university; or 9 (B) Provides services or seeks to provide services to the university as a contractor or 10 volunteer: and (b) Is, or will be, working or providing services in a position that is designated as a 11 12critical or security-sensitive position. (2) For the purposes of this section, "critical or security-sensitive position" means a po-13 sition in which the person: 14 15 (a) Has direct access to persons under 18 years of age, or has direct access to student residence facilities because the person's work duties require the person to be present in the 16 residence facility; 17 18 (b) Is providing information technology services and has control over, or access to, information technology systems that would allow the person to harm the information tech-19 20nology systems or the information contained in the systems; (c) Has access to information, the disclosure of which is prohibited by state or federal 2122laws, rules or regulations or information that is defined as confidential under state or federal 23laws, rules or regulations; (d) Has access to property where chemicals, hazardous materials and other items con-2425trolled by state or federal laws or regulations are located; (e) Has access to laboratories, nuclear facilities or utility plants to which access is re-2627stricted to protect the health or safety of the public; (f) Has financial, financial aid, payroll or purchasing responsibilities as one of the 28person's primary responsibilities; or 2930 (g) Has access to personal information about university employees or members of the 31 public including Social Security numbers, dates of birth, driver license numbers, medical information, personal financial information or criminal background information. 32SECTION 23. The University of Oregon Board of Directors may open, establish, lay out 33 34 and dedicate to the public use any streets through lands owned by or used for the University 35 of Oregon. When such streets are opened, established and laid out, they are declared to be dedicated to the public use. The university shall be the road authority pursuant to ORS 36 37 810.010 (4) for all roads through lands owned by or used for the university. 38 SECTION 24. The University of Oregon may adopt policies relating to the creation, use, custody and disclosure of, including access to, student education records of the university 39 that are consistent with the requirements of applicable state and federal law. (1) The University of Oregon may not refuse admission or expel a student 44 for the sole reason that, because of religious beliefs, the student is unable to attend classes 45

2 (2) Any student enrolled at the university who, because of religious beliefs, is unable to attend classes on a particular day, must be excused on that day from any examination, study 3 requirement or work requirement. However, at the student's own expense, the student may 4 be required to make up the examination, study requirement or work requirement missed 5 because of the absence. 6

SECTION 26. (1) A student enrolled at the University of Oregon who is a member of the 7 military, a member of the commissioned corps of the National Oceanic and Atmospheric 8 9 Administration or a member of the Public Health Service of the United States Department of Health and Human Services detailed by proper authority for duty with the Army or Navy 10 of the United States and who is ordered to federal or state active duty for more than 30 11 12 consecutive days has the following rights:

13 (a) With regard to a course in which the student is enrolled and for which the student has paid tuition and fees, the right to: 14

(A) Withdraw from the course, subject to the provisions of subsection (2) of this section; (B) Receive a grade of incomplete and, upon release from active duty, complete the 16 course in accordance with the university's practice for completion of incomplete courses; or 17 (C) Continue and complete the course for full credit, subject to the provisions of sub-18 section (3) of this section; 19

(d) The right to continuation of scholarships and grants awarded to the student that were 25funded by the university or the Oregon Student Access Commission before the student was 2627ordered to active duty.

(2) If the student elects to withdraw from a course under subsection (1)(a)(A) of this 2829section, the university may not:

30 (a) Give the student academic credit for the course from which the student withdraws;

31 (b) Give the student a failing grade or a grade of incomplete or make any other negative 32annotation on the student's record; or

(c) Alter the student's grade point average due to the student's withdrawal from the 3334 course.

These findings and recommendations shall identify the barriers to access that prevent persons with disabilities from meaningfully utilizing campus facilities related to instruction, 2122academic support, assembly and residence life. 23(3) In preparing funding requests for each biennium pursuant to section 18 of this 2013 Act, the university shall include amounts for capital improvement that will be applied to the 2425substantial reduction and eventual elimination of barriers to access by persons with disabilities as identified by the physical access committee. 2627(4) Nothing in this section and ORS 185.155 and 341.937 requires the university to undertake projects for accessibility that are not otherwise required unless such projects are 28funded specifically by the Legislative Assembly. 2930 SECTION 31. (1) The University of Oregon Board of Directors may adopt policies gov-31 erning access to University of Oregon personnel records that are less than 25 years old.

(2) Policies adopted under subsection (1) of this section shall require that personnel records be subjected to restrictions on access unless the president of the university finds that
the public interest in maintaining individual rights to privacy in an adequate educational
environment would not suffer by disclosure of such records. Access to such records may be
limited to designated classes of information or persons, or to stated times and conditions,
or to both, but cannot be limited for records more than 25 years old.

(3) A rule or order adopted pursuant to this section may not deny to a faculty member

(7) Letters and other information for a faculty member of the university submitted in 4 confidence to the State Board of Higher Education or its institutions, schools or departments 5 prior to July 1, 1975, shall be maintained in the files designated by subsection (4) of this 6 section. However, if a faculty member requests access to those files, the anonymity of the 7 contributor of letters and other information obtained prior to July 1, 1975, shall be protected. 8 9 The full text shall be made available, except that portions of the text that would serve to identify the contributor shall be excised by a faculty committee. Only the names of the 10 contributors and the excised portions of the documents may be kept in a file other than the 11 12 files designated by subsection (4) of this section.

(10) The university, when evaluating its employed faculty members, may not solicit or accept letters, documents or other materials, given orally or in written form, from individuals or groups who wish their identity kept anonymous or the information the individuals or groups provide kept confidential.

(11) A policy or order adopted pursuant to this section does not limit the authority of the
 university to prepare, without identification of individual persons who have not consented
 thereto, statistical or demographic reports from personnel records.

(12) Any category of personnel records specifically designated as confidential pursuant
 to valid policies or orders pursuant to this section is not a public record for the purposes
 of ORS 192.420.

(13) As used in this section, "personnel records" means records containing information
kept by the university concerning a faculty member and furnished by the faculty member
or by others about the faculty member at the request of the faculty member or the university, including but not limited to information concerning discipline, membership activity,
employment performance or other personal records of individual persons.

41 <u>SECTION 32.</u> (1) The University of Oregon Board of Directors may authorize receipt of 42 compensation by any officer or employee from private or public resources, including, but not 43 limited to, income from:

44 (a) Consulting;

1 (c) Intellectual property conceived, reduced to practice or originated and therefore owned 2 within the University of Oregon;

3 (d) Providing services or other valuable consideration for a private corporation, individual

6 private entity; and

(e) Performing public duties paid by private organizations, including university corporate

The disclosure is a public record subject to public inspection.

(4) (a) The principal, interest and any premium on any bonds, certificates of participation, financing agreements or other agreements for the borrowing of moneys issued prior to or on or after the effective date of this 2013 Act by the State of Oregon for the benefit of the university, and any credit enhancement devices or agreements for exchange of interest rates entered into in connection with those borrowings, shall be paid from the sources specified in the laws and documents authorizing the bond, certificate of participation, financing agree1 ment or other agreement for the borrowing of moneys, credit enhancement device or 2 agreement for exchange of interest rates. The university must pay any other expenses and 3 liabilities, including but not limited to closing costs, legal expenses, costs of settling claims, 4 judgments, federal arbitrage rebates and penalties and expenses arising from an inquiry, 5 audit or other action by a federal or state regulatory body, except to the extent that the li-6 ability or expense results from the negligence or willful misconduct of a state agency.

by the State of Oregon on behalf of the State Board of Higher Education for equipment or 1 projects for the benefit of the university, shall notify in writing the Legislative Assembly, 2 or if the Legislative Assembly is not in session, the Emergency Board, of the existence and 3 amount of the shortfall. 22SECTION 44. If the University of Oregon Board of Directors requests the State Treas-23urer to issue bonds pursuant to sections 41 to 43 of this 2013 Act, the board shall be a related agency under ORS 286A.001 to 286A.195 for issuance or administration of the bonds. 24

SECTION 45. As used in sections 45 to 49 of this 2013 Act:

(1) "Credit enhancement agreement" means any agreement or contractual relationship 2627between the University of Oregon and any bank, trust company, insurance company, surety bonding company, pension fund or other financial institution providing additional credit on 28or security for a financing agreement or certificates of participation authorized by sections 2930 45 to 49 of this 2013 Act.

31 (2) "Financing agreement" means a lease-purchase agreement, an installment sale 32agreement, a loan agreement, a note agreement, short-term promissory notes, commercial papers, lines of credit or similar obligations or any other agreement to finance real or per-33 34 sonal property that is or will be owned and operated by the university, or to refinance pre-35 viously executed financing agreements.

36

(3) "Personal property" means tangible personal property, software and fixtures.

(4) "Property rights" means, with respect to personal property, the rights of a secured 37 38 party under ORS chapter 79, and, with respect to real property, the rights of a trustee or lender under a lease authorized by section 48 (1)(d) of this 2013 Act. 39

40 (5) "Software" means software and training and maintenance contracts related to the operation of computing equipment. 41

42SECTION 46. (1) Subject to the limitations of section 37 of this 2013 Act, the University of Oregon may enter into financing agreements in accordance with sections 45 to 49 of this 43 2013 Act, upon such terms as the university finds to be advantageous. Amounts payable by 44 the university under a financing agreement shall be limited to funds available for such pur-45

poses under section 37 of this 2013 Act and specifically pledged, budgeted for or otherwise made available by the university. If there are insufficient funds available to pay amounts due under a financing agreement, the lender may exercise any property rights that the university has granted to it in the financing agreement against the property that was purchased with the proceeds of the financing agreement, and may apply the amounts so received toward payments scheduled to be made by the university under the financing agreement.

7 (2) Subsection (1) of this section does not apply to, and the university may not grant a 8 security interest in, lease as security for or grant any other right under, a financing agree-9 ment with respect to any real or personal property that has been financed with general ob-10 ligation bonds, certificates of participation, financing agreements or other borrowings of the 11 State of Oregon for the benefit of the university unless those obligations of the State of 12 Oregon are fully paid.

13 SECTION 47. The University of Oregon Board of Directors may delegate to any board member, the president of the University of Oregon, or the president's designee, the authority 14 15 to determine maturity dates, principal amounts, redemption provisions, interest rates or 16methods for determining variable or adjustable interest rates, denominations and other terms and conditions of such obligations that are not appropriately determined at the time 17 18 of enactment or adoption of the authorizing resolution. The board may also delegate entering 19 into financing agreements or any other instruments authorized by law. This delegated au-20thority shall be exercised subject to applicable requirements of law and such limitations and 21criteria as may be set forth in the authorizing resolution.

22

SECTION 48. (1) The University of Oregon may:

(a) Enter into agreements with third parties to hold financing agreement proceeds, payments and reserves as security for lenders, and to issue certificates of participation in the right to receive payments due from the university under a financing agreement. Amounts so held shall be invested at the direction of the University of Oregon Board of Directors.
Interest earned on any investments held as security for a financing agreement may, at the option of the board, be credited to the accounts held by the third party and applied in payment of sums due under a financing agreement.

(b) Enter into credit enhancement agreements for financing agreements or certificates
 of participation, provided that such credit enhancement agreements shall be payable solely
 from funds specifically pledged, budgeted for or otherwise made available by the university
 and amounts received from the exercise of property rights granted under such financing
 agreements.

(c) Use financing agreements to finance the costs of acquiring or refinancing real or
 personal property, plus the costs of reserves, credit enhancements and costs associated with
 obtaining the financing.

38 (d) Grant leases of real property with a trustee or lender. Such leases may be for a term that ends on the date on which all amounts due under a financing agreement have been paid 39 or provision for payment has been made, or for a term of up to 20 years after the last 40 scheduled payment under a financing agreement, whichever is later. Such leases may grant 41 42the trustee or lender the right to evict the university and exclude it from possession of the real property for the term of the lease if the university fails to pay when due the amounts 43 scheduled to be paid under a financing agreement, or otherwise defaults under a financing 44 agreement. Upon default, the trustee or lender may sublease the land to third parties and 45

1 apply any rentals toward payments scheduled to be made under a financing agreement.

2 (e) Grant security interests in personal property to trustees or lenders.

3 (f) Make pledges for the benefit of trustees and lenders.

4 (g) Purchase fire and extended coverage or other casualty insurance for property that is 5 acquired or refinanced with proceeds of a financing agreement, assign the proceeds thereof 6 to a lender or trustee to the extent of their interest, and covenant to maintain such insur-7 ance while the financing agreement is unpaid, as long as available funds are sufficient to 8 purchase such insurance.

9 (2) The provisions of subsection (1) of this section do not apply to, and the university 10 may not grant a security interest in, lease as security for or grant any other right under, a 11 financing agreement with respect to any real or personal property that has been financed 12 with general obligation bonds, certificates of participation, financing agreements or other 13 borrowings of the State of Oregon for the benefit of the university unless those obligations 14 of the State of Oregon are fully paid.

SECTION 49. A lease or financing agreement under sections 45 to 49 of this 2013 Act does
 not cause property to be subject to property taxation and is disregarded in determining
 whether property is exempt from taxation under ORS chapter 307.

18 SECTION 50. The University of Oregon Board of Directors may, in its discretion, accept financial assistance and grants, either in the form of money or labor, from the United States 19 or any of its agencies, subject to the terms and conditions thereof, regardless of any laws 20of this state in conflict with the regulations of the federal government with respect thereto, 2122and may also accept from others any donation or grant of land or gift of money or other 23valuable gift or thing, for any of the purposes contemplated by Article XI-F(1) and Article XI-G of the Oregon Constitution and sections 38 to 49 of this 2013 Act. Unless enjoined by 24 25the terms or conditions of any such gift or grant, the board may convert the same, or any of them, into money, through sale or disposal thereof. 26

27 <u>SECTION 51.</u> (1) The Oregon Education Investment Board, in coordination with the Uni-28 versity of Oregon, shall adopt performance benchmarks for the university. The benchmarks 29 must reflect the educational outcomes that the Oregon Education Investment Board expects 30 from the university. The Oregon Education Investment Board may not prescribe how the 31 benchmarks are to be achieved. The president of the university and the University of Oregon 32 Board of Directors have exclusive jurisdiction and control over the means and methods of 33 achieving the performance benchmarks.

(2) The Oregon Education Investment Board annually shall assess the university's compliance with the benchmarks described in subsection (1) of this section and shall issue an annual report as to the university's achievements. The investment board may recommend to the Legislative Assembly incentives to encourage compliance with the benchmarks or penalties for failure to comply with one or more benchmarks.

(3) The university and the Oregon University System shall coordinate academic programs
 so that the programs are integrated and complementary. To accomplish this purpose, uni versity officers shall maintain a role in the appropriate committees of the State Board of
 Higher Education and the Oregon University System.

43 (4) The Higher Education Coordinating Commission shall have final authority over cre 44 ation of new degree programs at the University of Oregon.

45 <u>SECTION 52.</u> The University of Oregon Board of Directors shall adopt a policy that pre-

scribes the requirements for a venture grant program and the requirements that a grant 1 2 applicant must meet in order to receive grant moneys from the university venture develop-

ment fund administered by the University of Oregon, including requirements: 3

(1) That a grant recipient remain within this state for at least five years following the 4 receipt of a grant or repay the grant plus interest; 5

(2) That the university report amounts of tax credit certificates issued by the university 6 and cease issuing certificates until the total amount owed to the General Fund by the uni-7 versity at any one time under ORS 351.697 (6) does not exceed \$2.4 million; and 8

9 (3) That the university maintain records of income realized by the university as the result of grants made from the university venture development fund and records of amounts 10 paid to the General Fund. 11

SECTION 53. As used in sections 53 to 64 of this 2013 Act:

(1) "Former university" means the University of Oregon in its former status as a uni-13 versity within the Oregon University System under ORS 352.002, as set forth in the 2011 14 15 Edition of the Oregon Revised Statutes.

16(2) "University" means the University of Oregon public university established under section 2 of this 2013 Act. 17

18 (3) "University board" means the University of Oregon Board of Directors established under section 4 of this 2013 Act. 19

SECTION 54. (1) Pursuant to the provisions of ORS 236.605 to 236.640, and except as 20otherwise expressly provided in sections 1 to 52 of this 2013 Act, all persons employed by the 2122University of Oregon on the effective date of this 2013 Act shall continue their employment 23with the university and shall retain any seniority, contractual rights or tenure granted prior to the effective date of this 2013 Act. 24

25(2) Nothing in sections 1 to 52 of this 2013 Act shall affect the representation rights of collective bargaining organizations that represent university employees. Nothing in sections 26271 to 52 of this 2013 Act shall affect any term or condition of any collective bargaining agreement in effect on the effective date of this 2013 Act. 28

SECTION 55. All of the duties, functions and powers of the former university are trans-2930 ferred to the university as if the university were a continuation of the former university and 31 not a new authority.

SECTION 56. (1) All records and property of the former university shall be considered 32the records and property of the university. 33

34 (2) There are transferred to the University of Oregon Board of Directors title to and 35 possession of all the supplies, materials, equipment, records, books, papers and facilities of the State Board of Higher Education pertaining to the former university. 36

37 (3) Title to real property acquired prior to the effective date of this 2013 Act utilized by 38 the former university or held or managed by the State of Oregon for the benefit of the former university shall be continuously held in the name of the State of Oregon, except that 39 the university has the exclusive care, custody and control of such real property and facilities. 40 (4) The University of Oregon Board of Directors may sell, convey or lease such property, 41

or any interest therein, as the university board deems in the best interest of the university 42 as provided in section 13 of this 2013 Act. 43

SECTION 57. All unexpended moneys, including but not limited to General Fund appro-44 priations, gifts, bequests, other funds, assessments, liability and worker's compensation re-45

serves and premiums that are appropriated to, held, managed or invested by or on behalf of

2 or otherwise available to the former university or its president, for the purposes of any of 3 its duties, functions or powers transferred by sections 1 to 52 of this 2013 Act to the uni-

4 versity, are appropriated and transferred to the university.

1

5 <u>SECTION 58.</u> (1) Any proceeding, action, prosecution or other business or matter 6 undertaken or commenced before the effective date of this 2013 Act by the former university, 7 with respect to the duties, functions or powers transferred to the university by sections 1 8 to 52 of this 2013 Act and still pending on the effective date of this 2013 Act may be conducted 9 and completed by the university in the same manner, under the same terms and conditions 10 and with the same effect as though undertaken, conducted or completed by the former uni-11 versity before the transfer.

(2) The transfer of duties, functions and powers to the University of Oregon Board of
Directors under sections 1 to 52 of this 2013 Act does not affect any action, suit, proceeding
or prosecution involving or with respect to such duties, functions and powers begun before
and pending at the time of the transfer, except that the university board shall be substituted
for the State Board of Higher Education in any such action, suit, proceeding or prosecution.
(3) Any proceeding, action, prosecution or other business or matter undertaken or commenced before the effective date of this 2013 Act by a state officer or agency, with respect

to the duties, functions or powers transferred to the university and still pending on the effective date of this 2013 Act, may be conducted and completed by the university in the same manner, under the same terms and conditions and with the same effect as though undertaken, conducted or completed by the former university before the transfer.

23 <u>SECTION 59.</u> Nothing in sections 1 to 52 of this 2013 Act relieves any person of any ob-24 ligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture or other 25 liability, duty or obligation.

<u>SECTION 60.</u> The university is considered to be a continuation of the former university with respect to its duties, functions and powers, and not a new authority for the purpose of succession to all rights and obligations of the former university as constituted at the time of such assignment or transfer, except as otherwise provided in sections 1 to 52 of this 2013 Act, with the same force and effect as if such duties, functions and powers had not been assigned or transferred.

<u>SECTION 61.</u> (1) Whenever, in any law or resolution of the Legislative Assembly or in any rule, document, record or proceeding authorized thereby, reference is made to the former university, or an employee of the former university, whose duties, functions or powers are assigned or transferred by sections 1 to 52 of this 2013 Act, except as otherwise provided by sections 1 to 52 of this 2013 Act, such reference is considered to describe the university or employee of the university that, by sections 1 to 52 of this 2013 Act, is charged with carrying out such duties, functions and powers.

(2) There are imposed upon, transferred to and vested in the University of Oregon Board
 of Directors the duties, functions and powers of the State Board of Higher Education that
 pertain to the former university.

(3) Notwithstanding the transfer of duties, functions and powers by sections 1 to 52 of
this 2013 Act, the lawfully adopted rules of the State Board of Higher Education pertaining
to the former university in effect on the effective date of this 2013 Act continue in effect
until lawfully superseded or repealed by the University of Oregon Board of Directors. Refer-

1 ences in rules of the State Board of Higher Education to the state board or an officer or

2 employee of the state board are considered to be references to the University of Oregon

Board of Directors.

4 <u>SECTION 62.</u> A transfer of duties, functions, powers, rights, records, property, employees 5 or moneys by sections 1 to 52 of this 2013 Act becomes operative on January 1, 2014. The 6 university shall exercise and perform such duties, functions, powers and rights, and shall 7 take charge of such records, property, employees and moneys.

8 <u>SECTION 63.</u> The rights and obligations of the State Board of Higher Education legally 9 incurred under contracts, leases and business transactions executed, entered into or begun 10 before the effective date of this 2013 Act pertaining to the former university are transferred 11 to the University of Oregon Board of Directors. For the purpose of succession to these rights 12 and obligations, the university board is considered to be a continuation of the State Board 13 of Higher Education and not a new authority, and the university board must exercise such 14 rights and fulfill such obligations as if they had not been transferred.

15 SECTION 64. For the purpose of administering and enforcing the duties, functions and powers transferred by sections 1 to 52 of this 2013 Act and for the payment of the expenses 16 lawfully incurred by the State Board of Higher Education with respect to the administration 17 and enforcement of such duties, functions and powers pertaining to the former university, 18 the University of Oregon Board of Directors may expend the moneys that are authorized to 19 be expended by the State Board of Higher Education for administering and enforcing the 20duties, functions and powers transferred by sections 1 to 52 of this 2013 Act and that are 2122unexpended on the effective date of this 2013 Act. Subject to section 36 of this 2013 Act, the 23university board shall assume and pay all outstanding obligations lawfully incurred by the State Board of Higher Education pertaining to the former university before the effective date 24of this 2013 Act that are properly charged against amounts authorized by this section to be 25expended by the university board. 26

PORTLAND STATE UNIVERSITY

SECTION 65. As used in sections 65 to 114 of this 2013 Act:

(1) "Board" means the Portland State University Board of Directors established under
 section 68 of this 2013 Act.

33 (2) "University" means Portland State University established under section 66 of this 2013
 34 Act.

SECTION 66. (1) Portland State University is established as a public university and shall be governed by the Portland State University Board of Directors. The board may exercise authority over matters of university concern to the fullest extent allowed by Constitutions and laws of the United States and this state, as fully as if each particular power comprised in that general authority were specifically listed in sections 65 to 114 of this 2013 Act. The board may delegate and provide for the further delegation of any of its powers and authorities.

(2) The powers granted by this section are in addition to any other power granted to
Portland State University in sections 65 to 114 of this 2013 Act and may not be construed to
limit or qualify any such power. The powers granted by this section shall be liberally construed to the end that the board shall have all powers over matters of university concern

that is possible for it to have under the Constitutions and laws of the United States and this
 state.

3 (3) The university is an instrumentality of state government, performing governmental 4 functions and exercising governmental powers. The university is independent, has statewide 5 purposes and is without territorial boundaries. The university is a state institution of higher 6 education, but is not an agency, department or division of the state, a unit of local or mu-7 nicipal government or part of the executive branch, except as set forth in sections 65 to 114 8 of this 2013 Act.

9 (4)(a) A claim against the university is not a claim against the State of Oregon. A debt 10 or obligation of the university is not a debt or obligation of the State of Oregon. Claims 11 against the university and obligations of the university are not recoverable from the assets 12 and funds of the State of Oregon.

(b) The university is not authorized to act in the name of the State of Oregon and at torneys representing the university do not represent the state.

(5) Nothing in sections 65 to 114 of this 2013 Act may be construed as a waiver by the
university of any form of defense or immunity, whether it be sovereign immunity, governmental immunity, immunity based upon the Eleventh Amendment to the Constitution of the
United States or immunity from any claim or from the jurisdiction of any court.

<u>SECTION 67.</u> (1) It shall be the policy of Portland State University as a public university:
 (a) To serve the people of this state by educating citizens of the state, region, nation and

21 **world;**

22

(b) To provide:

(A) An educational environment that stimulates creative inquiry, critical thinking, clear
 communication and original scholarship by and for the benefit of students, faculty, staff and
 the greater community; and

(B) Education, research and service that contribute to the development of new knowledge
 and the enhancement of the culture and economy of this state;

(c) To encourage the preservation, enhancement and dissemination of knowledge and
 culture;

(d) To provide individuals with the tools for a lifetime of learning so as to allow them to
 enhance their quality of life, contribute to civic discourse and civil society and participate
 effectively in a global society;

(e) To create an educated workforce that keeps the Oregon economy innovative and
 competitive;

(f) To provide public service activities that engage the professional expertise of faculty
 to solve society's problems;

(g) To share with this state many services and cultural activities of immense importance
 to the quality of life enjoyed by Oregonians and others; and

(h) To strive for excellence in all of its endeavors while maintaining institutional integ rity.

(2) The university shall carry out the policies of this section in the manner that, in the
 determination of the Portland State University Board of Directors, best promotes the welfare
 of the people of this state.

44 <u>SECTION 68.</u> (1) There is established a Portland State University Board of Directors, 45 consisting of 15 members. 1 (2) The membership of the board shall be as follows:

(a) Thirteen members appointed by the Governor and confirmed by the Senate in the
manner prescribed in ORS 171.562 and 171.565. These members shall include one student
enrolled at Portland State University, one regular employee, as defined in ORS 240.015 of the
university and one faculty member of the university. When appointing the faculty member,
the Governor shall consider recommendations from the university faculty. When appointing
the student member, the Governor shall consider recommendations from a general student
association recognized by Portland State University.

9 (b) One member who is a nonstudent member of the Oregon Education Investment
 10 Board, appointed by the Oregon Education Investment Board.

11 (c) The president of the university, who shall be a nonvoting member.

(3) The board may appoint other nonvoting members as it deems in the best interests
 of the university.

(4)(a) Except for the president of the university, the term of office of each nonstudent
 member is four years. The term of office of the student member is two years.

(b) Before the expiration of the term of a member, the appointing authority shall appoint
 a successor whose term begins on July 1 next following. A member is eligible for reappoint ment for one additional term.

(c) If there is a vacancy for any cause, the appointing authority shall make an appoint ment to become effective for the remainder of the unexpired term.

(d) A student enrolled at the university may not be appointed to, or continue to serve
on, the board unless the student is in good standing pursuant to bylaws or policies of the
board.

(5) Except as provided in subsection (2)(a) of this section, a voting member may not be
an employee of the university, the Oregon University System or the State of Oregon.

(6) The board shall select one of its members as the chairperson, another as vice chairperson and another as secretary, for such terms and with such duties and powers as the
board considers necessary for performance of the functions of those offices. The board shall
adopt bylaws for its governance, including provisions specifying how a quorum is constituted
and when a quorum is necessary.

(7) The board shall meet at least once every three months on the university campus.
Board members may participate in the meeting electronically as provided in ORS 192.610 to
192.690. The board shall meet at such other times and places specified by the chairperson or
by a majority of the members of the board.

(8) An appointing authority may remove any member appointed by the authority at any
 time for cause, after notice and public hearing.

37 <u>SECTION 69.</u> Notwithstanding the terms of office specified in section 68 of this 2013 Act, 38 of the members first appointed to the Portland State University Board of Directors, other 39 than the president of Portland State University:

40 (1) Seven members appointed by the Governor, including the student member, shall serve
 41 for terms ending June 30, 2016; and

42 (2) The following shall serve for terms ending June 30, 2018:

43 (a) Six members appointed by the Governor, including the faculty member and the regu-

44 lar employee, as defined in ORS 240.015, of the university; and

45 (b) The member appointed by the Oregon Education Investment Board.

1 <u>SECTION 70.</u> The Governor and the Oregon Education Investment Board shall appoint 2 members to the Portland State University Board of Directors pursuant to section 68 (2)(a) 3 and (b) of this 2013 Act no later than January 15, 2014.

4 <u>SECTION 71.</u> (1) The Portland State University Board of Directors may, within or outside 5 the state, do all things necessary or convenient involving matters of concern to Portland 6 State University, including without limitation the following:

7 (a) Enact any and all policies for the governance of the university, which, to the extent 8 set forth in those policies, shall have the force of law and may be enforced through univer-9 sity procedures and in any court of competent jurisdiction.

(b) Hire and employ personnel and prescribe all conditions of employment, including but
 not limited to compensation, benefits and tenure.

12 (c) Enter into any and all contracts and agreements with any public or private entity.

(d) Enter into any partnership, joint venture or other business arrangement and create
 and participate fully in the operation of any business structure or organization.

(e) Borrow money and issue debt of any kind and pledge revenue to repay any loan or
 indebtedness.

(f) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, control, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, issue, improve, develop, use, expend and dispose of personal property, including intellectual property, of any nature, tangible or intangible.

(g) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, control, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, improve,
develop, use, expend and dispose of real property.

(h) Sue and be sued and issue and enforce subpoenas in the board's name.

(i) Obtain and receive gifts, bequests and donations for the benefit of the university and,
subject to the terms of the gift, retain, invest and use such gifts as deemed appropriate by
the university or the board. The board may assess a reasonable management fee against all
gifts, bequests and donations and the earnings thereon.

(j) Acquire, purchase, accept, borrow, receive, own, hold, deposit, pledge, control, convey,
 manage, use, lend, expend and invest all funds, appropriations, instruments, earnings and
 revenue. The authority under this paragraph includes accepting and expending funds from
 the United States Government for any purpose. The board may deposit any and all funds,
 appropriations, instruments, earnings and revenue in any financial institution and retain all
 interest, earnings, and appreciation accruing from such deposits.

(k) Erect, construct, improve, remodel, develop, repair, maintain, equip, furnish, lease,
 lend, convey, sell, manage, operate, use and dispose of any building, structure, land or
 project.

(L) Acquire any and all insurance, operate a self-insurance program or otherwise arrange
 for the equivalent of insurance coverage of any nature or type.

(m) Create, develop, manage and control educational, research, service and any other
 programs.

(n) Set standards for the admission, graduation and discipline of students.

43 (o) Authorize, establish, eliminate, manage, operate, reorganize, reduce or expand any
 44 program, school, institute, college or unit of operation, except that any new degree or pro 45 gram and any policy regarding transferability of credits to and from a public university listed

in ORS 352.002, the University of Oregon, a community college in this state or Oregon Health
 and Science University must be authorized by the Higher Education Coordinating Commis-

3 **sion.**

(p) Authorize, establish, eliminate, charge, collect, manage, use in any manner and ex-4 pend all revenue derived from tuition, fees and any other charges and fines. The board shall 5 request the joint recommendation of the recognized student government and the president 6 of the university, who shall obtain the recommendation of the recognized student govern-7 ment, prior to authorizing, establishing or eliminating incidental fees for programs under the 8 9 supervision or control of the board and found by the board to be advantageous to the cultural or physical development of students. Any increase in tuition or any student fees above five 10 percent on an annual basis must be approved by the Oregon Education Investment Board. 11

(q) Acquire, receive, own, hold, use, sell, mortgage, lend, pledge, invest in or otherwise
dispose of and deal in or with the shares, stock, bonds, or other equity or interests in or
obligations of any entity.

(r) Make available and perform any and all services on such terms as considered appro priate.

17

(s) Delegate any and all powers and duties and provide for any further delegation.

(t) Provide and disseminate to the public information relating to the program, operation
 and finances of the university.

20 (u) Exercise any other power, duty or responsibility necessary or convenient over mat-21 ters of university concern.

(2) The absence of express authority may not be construed to deny that authority to the
 university or to limit or qualify any such power. Powers of the board shall be liberally con strued to effect the purposes of the university.

25 <u>SECTION 72.</u> The Portland State University Board of Directors shall appoint a president 26 of Portland State University. The president of the university is the president of the faculty 27 and is the chief executive officer of the university. The president of the university has au-28 thority to direct the affairs and operation of the university, subject to the policies and di-29 rection of the board.

<u>SECTION 73.</u> Except as otherwise provided by law, the provisions of ORS 35.550 to 35.575, 180.060, 180.210 to 180.235, 184.305 to 184.345, 190.430, 190.480, 190.490, 192.105, 200.035, 243.696, 279.835 to 279.855, 357.805 to 357.895 and 656.017 (2) and ORS chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291, 292, 293, 294 and 297 do not apply to Portland State University or any not-for-profit organization or other entity if the equity of the entity is owned exclusively by the university and if the organization or entity is created by the university to advance any of the university's statutory missions.

37 SECTION 74. Notwithstanding section 73 of this 2013 Act, collective bargaining agree-38 ments negotiated by this state pursuant to ORS 240.321 after the effective date of this 2013 Act that are applicable to employees of the Oregon University System apply to Portland 39 State University if the new collective bargaining agreement is a successor to a collective 40 bargaining agreement negotiated by this state and applicable to the same class of employees 41 42of the university prior to the effective date of this 2013 Act. Such successor agreements shall continue to apply to the university until the board and the applicable collective bargaining 43 organization agree to bargain a separate collective bargaining agreement between the uni-44 versity and the collective bargaining organization. 45

1 <u>SECTION 75.</u> (1) As used in this section:

(a) "Direct labor" includes all work required for preparation, processing and packing, but
 not supervision, administration, inspection or shipping.

4 (b) "Individual with a disability" means an individual who, because of the nature of the 5 individual's disability, is not able to participate fully in competitive employment and for 6 whom specialized employment opportunities must be provided.

7 (c) "Qualified nonprofit agency for individuals with disabilities" means a nonprofit activ8 ity center or rehabilitation facility:

9 (A) Organized under the laws of the United States or of this state and operated in the 10 interest of individuals with disabilities, the net income of which does not inure in whole or 11 in part to the benefit of any shareholder or other individual;

(B) That complies with any applicable occupational health and safety standards required
by the laws of the United States or of this state; and

(C) That in the manufacture of products and in the provision of services during the fiscal
 year employs individuals with disabilities for not less than 75 percent of the work hours of
 direct labor required for the manufacture or provision of the products or services.

17 (2) The Portland State University Board of Directors shall further the policy of this state 18 to encourage and assist individuals with disabilities to achieve maximum personal independ-19 ence through useful and productive gainful employment by ensuring an expanded and con-20 stant market for sheltered workshop and activity center products and services, thereby 21 enhancing the dignity and capacity of individuals with disabilities for self-support and mini-22 mizing their dependence on welfare and need for costly institutionalization.

23

(3) It shall be the duty of Portland State University to:

(a) Determine the price of all products manufactured and services offered for sale to the
 university by any qualified nonprofit agency for individuals with disabilities. The price shall
 recover for the workshops the cost of raw materials, labor, overhead, delivery costs and a
 margin held in reserve for inventory and equipment replacement.

28

(b) Revise such prices from time to time in accordance with changing cost factors.

(c) Make such rules regarding specifications, time of delivery and other relevant matters
 of procedure as shall be necessary.

(d) Utilize prices and specifications, in its discretion, established by the Oregon Depart ment of Administrative Services.

(4) The university shall establish and publish a list of sources or potential sources of products produced by any qualified nonprofit agency for individuals with disabilities and the services provided by any such agency that the university determines are suitable for its procurement. The university, in its discretion, may utilize any list established and published by the department.

(5) If the university intends to procure any product or service on the procurement list, the university shall procure such product or service at the price established by the university from a qualified nonprofit agency for individuals with disabilities, provided the product or service is of the appropriate specifications and is available at the location and within the period required by the university.

(6) It is the intent of the Legislative Assembly that there be close cooperation between
the board, the university and qualified nonprofit agencies for individuals with disabilities.
The university, on behalf of the board, is authorized to enter into such contractual ar-

1 rangements, cooperative working relationships or other arrangements as may be necessary

2 for effective coordination and efficient realization of the objective of this section.

3 <u>SECTION 76.</u> The Portland State University Board of Directors shall file with the Oregon 4 Education Investment Board, the Higher Education Coordinating Commission, the Legisla-5 tive Assembly and the Governor, not later than April 15 of each year, a report of the activ-6 ities and operations of Portland State University for the preceding year.

7 <u>SECTION 77.</u> (1) The Portland State University Board of Directors may lease, purchase 8 or otherwise acquire such real property as in its sole discretion is necessary or convenient 9 to carry out any power granted to Portland State University. The board may enter into 10 contracts of purchase or agreements that the board deems necessary to carry out this au-11 thorization. The board may mortgage or pledge any property purchased, or its contracts to 12 purchase, together with the income from such property, to secure the payment of the pur-13 chase price.

(2) Legal title to all real property acquired by Portland State University after the effective date of this 2013 Act shall be taken and held in the name of the university. Legal title to all real property of this state held or managed for the use and benefit of the university as of the effective date of this 2013 Act shall continue to be vested in this state.

(3) The board may lease, sell, convey and control the use of, in whole or in part, all property of this state held or managed for the use and benefit of the university as of the effective date of this 2013 Act or that is acquired by the university after the effective date of this 2013 Act. Authorized conveyances of all real property acquired by or vested in this state for the use or benefit of the university or acquired by or vested in the university, other than the state lands classified as university lands under ORS 273.251, shall be executed by the chairperson and secretary of the board.

(4) Except as otherwise provided by law, proceeds from the lease, sale or conveyance of
 real property pursuant to subsection (3) of this section shall be deposited into an account
 at Portland State University for the benefit of the university.

28 <u>SECTION 78.</u> Portland State University may acquire, by condemnation or otherwise, 29 private property that is necessary or convenient in carrying out any power granted to the 30 university.

31 <u>SECTION 79.</u> Portland State University shall adopt a comprehensive alcohol and drug 32 abuse policy and implementation plan.

33 <u>SECTION 80.</u> (1) Portland State University shall develop contract policies that support
 34 openness, impartiality and competition in the awarding of contracts in accordance with ORS
 35 279A.015.

(2) The university shall also develop contract policies that are designed to encourage affirmative action, recycling, inclusion of art in public buildings, the purchase of goods and services from individuals with disabilities, the protection of workers through the payment of prevailing wages as determined by the Bureau of Labor and Industries, the provision of workers' compensation insurance to workers on contracts and the participation of emerging small businesses and businesses owned by women and minorities.

(3) The Portland State University Board of Directors shall have the authority to enact
policies, appropriate for the use of the university, governing public contracting and may devise and publish forms for use in carrying out the policies.

45 <u>SECTION 81.</u> (1)(a) On or before September 1 of each even-numbered year Portland State

1 University shall submit to the Oregon Department of Administrative Services a funding re-

2 quest for the following biennium.

3 (b) The department shall include and submit the university's funding request to the 4 Legislative Assembly as part of the Governor's biennial budget. Any such request approved 5 by the Legislative Assembly shall be appropriated to the department for direct allocation to 6 the university.

7 (2) The Portland State University Board of Directors is not required to seek expenditure 8 limitation approval from the Legislative Assembly to spend other available moneys, including 9 without limitation tuition and other fees or revenues collected pursuant to the board's au-10 thority under section 71 of this 2013 Act.

(3) The Portland State University Board of Directors shall adopt a budget on a regular

SECTION 82. (1) Portland State University may conduct independent audits if such audits
 are considered advisable by the university. The audits are subject to the exclusive discretion
 and control of the university and are subject to disclosure pursuant to ORS 192.410 to 192.505.
 (2) Nothing in this section affects the constitutional duties and authority of the Secretary
 of State to audit public accounts.

18 SECTION 83. Portland State University may commission special campus security officers

19 with authority and immunities set forth in ORS 352.385.

20SECTION 84. (1) The Portland State University Board of Directors may enact such regulations as the board deems convenient or necessary to provide for the policing, control and 2122regulation of traffic and parking of vehicles on Portland State University property. The reg-23ulations may provide for the registration of vehicles, the designation of parking areas and the assessment and collection of reasonable fees and charges for parking. The board may 24 25require that before a quarterly or yearly parking privilege for any vehicle is granted to any full-time or part-time student to use board property, the student must show that the vehicle 2627is operated by a student holding a valid driver license, that the vehicle is currently registered and that the student driving the vehicle is insured under a motor vehicle liability insurance 28policy that meets the requirements described in ORS 806.080 or that the student or owner 2930 of the vehicle has provided the Department of Transportation with other satisfactory proof 31 of compliance with the financial responsibility requirements of this state.

(2) The regulations enacted pursuant to subsection (1) of this section shall be enforced 32administratively under procedures adopted by the board. Administrative and disciplinary 33 34 sanctions may be imposed upon students, faculty and staff for violation of the regulations, including, but not limited to, a reasonable monetary penalty that may be deducted from 35 student deposits and faculty or staff salaries or other funds in the possession of the univer-36 37 sity. The board shall provide opportunity for hearing for the determination of controversies 38 in connection with imposition of fines or penalties. Persons other than students, faculty or staff may voluntarily submit to the hearing procedures prescribed by the board, and shall 39 be bound by the results of the hearing. The powers granted to the board by this section are 40 supplemental to the existing powers of the board with respect to the governance of activities 41 42of students, faculty and staff and the control and management of property under the board's 43 jurisdiction.

2 (4) Every peace officer may enforce the regulations made by the board under subsection
3 (1) of this section. The board, for the purpose of enforcing its regulations governing traffic
4 control, may appoint peace officers who have the same authority as other peace officers as

6 (5) The board and any municipal corporation or any department, agency or political sub-7 division of this state may enter into agreements or contracts for the purpose of providing a 8 uniform system of enforcement of the regulations of the board enacted pursuant to sub-9 section (1) of this section.

(6) In proceedings brought to enforce regulations enacted pursuant to subsection (1) of 10 this section, it shall be sufficient to charge the defendant by an unsworn written notice as 11 12 provided by law. Proceedings to enforce regulations enacted pursuant to subsection (1) of this section may be brought in the name of the board in a circuit court, a justice court or 13 a municipal court for offenses committed within the territorial jurisdiction of such court. 14 15 Such courts shall have concurrent jurisdiction over offenses committed within their respective jurisdictions. All fines, penalties and court costs recovered shall be paid to the clerk of 16 the court involved and shall be disposed of as provided by law. 17

18 <u>SECTION 85.</u> (1) For the purpose of requesting a state or nationwide criminal records 19 check under ORS 181.534, Portland State University may require the fingerprints of a person 20 who:

(a)(A) Is employed or applying for employment by the university; or

(B) Provides services or seeks to provide services to the university as a contractor or
 volunteer; and

(b) Is, or will be, working or providing services in a position that is designated as a
 critical or security-sensitive position.

(2) For the purposes of this section, "critical or security-sensitive position" means a po sition in which the person:

(a) Has direct access to persons under 18 years of age, or has direct access to student
 residence facilities because the person's work duties require the person to be present in the
 residence facility;

(b) Is providing information technology services and has control over, or access to, in formation technology systems that would allow the person to harm the information tech nology systems or the information contained in the systems;

(c) Has access to information, the disclosure of which is prohibited by state or federal
 laws, rules or regulations or information that is defined as confidential under state or federal
 laws, rules or regulations;

(d) Has access to property where chemicals, hazardous materials and other items con trolled by state or federal laws or regulations are located;

(e) Has access to laboratories, nuclear facilities or utility plants to which access is re stricted to protect the health or safety of the public;

41 (f) Has financial, financial aid, payroll or purchasing responsibilities as one of the 42 person's primary responsibilities; or

(g) Has access to personal information about university employees or members of the
 public including Social Security numbers, dates of birth, driver license numbers, medical in formation, personal financial information or criminal background information.

SECTION 86. Portland State University may adopt policies relating to the creation, use, 1 2 custody and disclosure of, including access to, student education records of the university that are consistent with the requirements of applicable state and federal law. Whenever a 3 student has attained 18 years of age or is attending the university, the permission or consent 4 required of and the rights accorded to a parent of the student regarding education records 5 is thereafter only required of and accorded to the student. 6

SECTION 87. (1) Portland State University may not refuse admission or expel a student 7 for the sole reason that, because of religious beliefs, the student is unable to attend classes 8 9 on a particular day.

10 (2) Any student enrolled at the university who, because of religious beliefs, is unable to attend classes on a particular day, must be excused on that day from any examination, study 11 12 requirement or work requirement. However, at the student's own expense, the student may 13 be required to make up the examination, study requirement or work requirement missed because of the absence. 14

15 SECTION 88. (1) A student enrolled at Portland State University who is a member of the military, a member of the commissioned corps of the National Oceanic and Atmospheric 16 Administration or a member of the Public Health Service of the United States Department 17 18 of Health and Human Services detailed by proper authority for duty with the Army or Navy of the United States and who is ordered to federal or state active duty for more than 30 19 20consecutive days has the following rights:

(a) With regard to a course in which the student is enrolled and for which the student 2122has paid tuition and fees, the right to:

(A) Withdraw from the course, subject to the provisions of subsection (2) of this section; 24(B) Receive a grade of incomplete and, upon release from active duty, complete the course in accordance with the university's practice for completion of incomplete courses; or 25(C) Continue and complete the course for full credit, subject to the provisions of sub-26

(b) The right to a credit described in section 89 of this 2013 Act for all amounts paid for 28room, board, tuition and fees; 29

30 (c) If the student elects to withdraw from the university, the right to be readmitted and 31 reenrolled at the university within one year after release from active duty without a requirement for redetermination of admission eligibility; and 32

(d) The right to continuation of scholarships and grants awarded to the student that were 33 34 funded by the university or the Oregon Student Access Commission before the student was 35 ordered to active duty.

(2) If the student elects to withdraw from a course under subsection (1)(a)(A) of this 36 37 section, the university may not:

(a) Give the student academic credit for the course from which the student withdraws;

(b) Give the student a failing grade or a grade of incomplete or make any other negative 39 annotation on the student's record; or 40

(c) Alter the student's grade point average due to the student's withdrawal from the 41 42course.

(3) A student who elects to continue and complete a course for full credit under sub-43 section (1)(a)(C) of this section is subject to the following conditions: 44

willing to participate, a person with a disability who uses the university's facilities;

22 (b) One or more members of the faculty or staff who have disabilities;

23 (c) The coordinator of services for students with disabilities for the university;

(4) Nothing in this section and ORS 185.155 and 341.937 requires the university to under take projects for accessibility that are not otherwise required unless such projects are
 funded specifically by the Legislative Assembly.

38 <u>SECTION 93.</u> (1) The Portland State University Board of Directors may adopt policies 39 governing access to Portland State University personnel records that are less than 25 years 40 old.

(2) Policies adopted under subsection (1) of this section shall require that personnel records be subjected to restrictions on access unless the president of the university finds that
the public interest in maintaining individual rights to privacy in an adequate educational
environment would not suffer by disclosure of such records. Access to such records may be
limited to designated classes of information or persons, or to stated times and conditions,

or to both, but cannot be limited for records more than 25 years old. 1

2 (3) A rule or order adopted pursuant to this section may not deny to a faculty member full access to the member's personnel file or records kept by the university, except as pro-3 vided in subsections (7) and (8) of this section. 4

(4) The files relating to the evaluation of a faculty member shall be kept in designated, 5 available locations. 6

(5) Any evaluation received by telephone shall be documented in each of the faculty 7 member's files by means of a written summary of the conversation with the names of the 8 9 conversants identified.

(6) A faculty member shall be entitled to submit, for placement in the files, evidence re-10 butting, correcting, amplifying or explaining any document contained therein and other ma-11 12 terial that the member believes might be of assistance in the evaluation process.

(7) Letters and other information for a faculty member of the university submitted in 13 confidence to the State Board of Higher Education or its institutions, schools or departments 14 15 prior to July 1, 1975, shall be maintained in the files designated by subsection (4) of this 16section. However, if a faculty member requests access to those files, the anonymity of the contributor of letters and other information obtained prior to July 1, 1975, shall be protected. 17 18 The full text shall be made available, except that portions of the text that would serve to 19 identify the contributor shall be excised by a faculty committee. Only the names of the 20contributors and the excised portions of the documents may be kept in a file other than the files designated by subsection (4) of this section. 21

22(8) Confidential letters and other information submitted to or solicited by the university 23after January 1, 2014, and prior to the employment of a prospective faculty member are exempt from the provisions of this section. However, if the member is employed by the uni-24 25versity, the confidential preemployment materials shall be placed in the files designated by subsection (4) of this section. If a faculty member requests access to the member's files, the 2627anonymity of the contributor of confidential preemployment letters and other preemployment information shall be protected. The full text shall be made available, except that 28portions of the text that would serve to identify the contributor shall be excised and retained 2930 in a file other than the files designated by subsection (4) of this section.

31 (9) Classroom survey evaluations by students of a faculty member's classroom or laboratory performance shall be anonymous. The record of tabulated reports shall be placed in 32at least one of the files designated by subsection (4) of this section. All survey instruments 33 34 used to obtain evaluation data shall be returned to the faculty member.

35 (10) The university, when evaluating its employed faculty members, may not solicit or accept letters, documents or other materials, given orally or in written form, from individ-36 37 uals or groups who wish their identity kept anonymous or the information the individuals 38 or groups provide kept confidential.

(11) A policy or order adopted pursuant to this section does not limit the authority of the 39 40 university to prepare, without identification of individual persons who have not consented thereto, statistical or demographic reports from personnel records. 41

(12) Any category of personnel records specifically designated as confidential pursuant 42 to valid policies or orders pursuant to this section is not a public record for the purposes 43 of ORS 192.420. 44

(13) As used in this section, "personnel records" means records containing information

1 kept by the university concerning a faculty member and furnished by the faculty member

2 or by others about the faculty member at the request of the faculty member or the univer-

3 sity, including but not limited to information concerning discipline, membership activity,

4 employment performance or other personal records of individual persons.

5 <u>SECTION 94.</u> (1) The Portland State University Board of Directors may authorize receipt 6 of compensation by any officer or employee from private or public resources, including, but 7 not limited to, income from:

8 (a) Consulting;

9 (b) Appearances and speeches;

(c) Intellectual property conceived, reduced to practice or originated and therefore owned
 within Portland State University;

(d) Providing services or other valuable consideration for a private corporation, individual
 or entity, whether paid in cash or in-kind, stock or other equity interest, or anything of
 value regardless of whether there is a licensing agreement between the university and the
 private entity; and

(e) Performing public duties paid by private organizations, including university corporate
 affiliates, that augment an officer's or employee's publicly funded salary. Such income shall
 be authorized and received in accordance with policies and rules established by the board.

(2) The board may not authorize compensation, as described in subsection (1) of this
 section, that, in the board's judgment, does not comport with the mission of the university
 or substantially interferes with an officer's or employee's duties to the university.

(3) Any compensation described and authorized under subsection (1) of this section is considered official compensation or reimbursement of expenses for purposes of ORS 244.040 and is not considered an honorarium prohibited by ORS 244.042. If authorization or receipt of the compensation creates a potential conflict of interest, the officer or employee shall report the potential conflict in writing in accordance with rules of the board. The disclosure is a public record subject to public inspection.

(4) The board shall adopt by rule standards governing employee outside employment and
 activities, including potential conflicts of interest, as defined by board rule and consistent
 with ORS 244.020, and the public disclosure thereof, and procedures for reporting and hearing
 potential or actual conflict of interest complaints.

<u>SECTION 95.</u> The president and professors constitute the faculty of Portland State University and have the immediate government and discipline of it and the students therein. The faculty may, subject to the supervision of the Portland State University Board of Directors, prescribe the course of study to be pursued at the university and the textbooks to be used.

36 <u>SECTION 96.</u> Portland State University shall consider and maintain affirmative action 37 plans and goals when reductions in faculty and staff are required as a result of:

(1) Reductions in revenue that necessitate discontinuance of the university's educational
 program at its anticipated level;

40 (2) Elimination of classes due to decreased student enrollment; or

41 (3) Reduction in courses due to administrative decisions.

42 <u>SECTION 97.</u> A political or sectarian test may never be allowed or applied in the ap-43 pointment of faculty and other employees of Portland State University.

44 <u>SECTION 98.</u> (1) Nothing in sections 65 to 114 of this 2013 Act may be construed to impair 45 the obligations or agreements of the State of Oregon or the State Board of Higher Education

with respect to bonds, certificates of participation, financing agreements or other agree-1 ments for the borrowing of money issued prior to the effective date of this 2013 Act by the 2 State of Oregon on behalf of the State Board of Higher Education for equipment or projects 3 for the benefit of Portland State University. The university and the Oregon University Sys-4 tem shall take all actions necessary to ensure full compliance with all indentures, resol-5 utions, declarations, agreements and other documents issued with respect to the bonds, 6 certificates of participation, financing agreements or other agreements for the borrowing of 7 money issued prior to the effective date of this 2013 Act by the State of Oregon on behalf 8 9 of the State Board of Higher Education for the benefit of the university.

(2) The university and the Oregon University System shall establish, in a written agree ment that is subject to the approval of the State Treasurer:

(a) The responsibility of the university for the payment to the State Board of Higher
Education of moneys sufficient to pay when due all principal, interest and any other charges
on bonds, certificates of participation, financing agreements or other agreements for the
borrowing of money issued prior to the effective date of this 2013 Act by the State of Oregon
on behalf of the State Board of Higher Education for the benefit of the university; and

(b) A requirement that the university periodically provide cash flow projections and other 1718 information as the State Treasurer requests to determine the sufficiency of the university's 19 revenues to satisfy the requirements of bonds, certificates of participation, financing agree-20ments or other agreements for the borrowing of money issued prior to and on or after the effective date of this 2013 Act by the State of Oregon for the benefit of the university, credit 2122enhancement devices or agreements for exchange of interest rates entered into in connection 23with those borrowings and any loans to the university funded by state general obligation bonds issued prior to the effective date of this 2013 Act. 24

(3)(a) Holders of obligations issued on or after the effective date of this 2013 Act by the university may be paid after the university reserves sufficient funds each biennium to satisfy any payment or reserve requirements relating to bonds, certificates of participation, financing agreements or other agreements for the borrowing of moneys issued by the State of Oregon for the benefit of the university, credit enhancement devices or agreements for exchange of interest rates entered into in connection with those borrowings and loans to the university funded by state general obligation bonds.

(b) The university may pledge all or a portion of its remaining rents, revenues, receipts,
appropriations or other income to secure revenue bonds issued under section 99 of this 2013
Act, credit enhancement devices or agreements for exchange of interest rates related to
such revenue bonds, or other obligations issued by the university, but only to the extent
that:

37 (A) Such holders have no rights, liens or other interests with respect to such rents, re-38 venues, receipts, appropriations or other income of the university that are on parity with or are senior or superior to the rights granted to the State of Oregon and the holders of 39 bonds, certificates of participation, financing agreements or other agreements for the bor-40 rowing of moneys issued by the State Treasurer for the benefit of the university, credit en-41 42hancement devices or agreements for exchange of interest rates entered into in connection with those borrowings and loans to the university funded by state general obligation bonds 43 issued prior to the effective date of this 2013 Act; and 44

45 (B) The State Board of Higher Education, the Oregon Department of Administrative

1 Services or the State of Oregon is granted a lien or other security interest in the rents, re-2 venues, receipts, appropriations or other income of the university that is superior to any lien

3 or other security interest granted to the holders of obligations issued by the university.

(4)(a) The principal, interest and any premium on any bonds, certificates of participation, 4 financing agreements or other agreements for the borrowing of moneys issued prior to or 5 on or after the effective date of this 2013 Act by the State of Oregon for the benefit of the 6 university, and any credit enhancement devices or agreements for exchange of interest rates 7 entered into in connection with those borrowings, shall be paid from the sources specified in 8 9 the laws and documents authorizing the bond, certificate of participation, financing agreement or other agreement for the borrowing of moneys, credit enhancement device or 10 agreement for exchange of interest rates. The university must pay any other expenses and 11 12 liabilities, including but not limited to closing costs, legal expenses, costs of settling claims, judgments, federal arbitrage rebates and penalties and expenses arising from an inquiry, 13 audit or other action by a federal or state regulatory body, except to the extent that the li-14 15 ability or expense results from the negligence or willful misconduct of a state agency.

(b) Pursuant to ORS chapter 180, on behalf of the State Treasurer or any other state agency, the Attorney General shall appear, commence, prosecute or defend any action, suit, cause or proceeding arising from any bonds, certificates of participation, financing agreements or other agreements for the borrowing of moneys, and any credit enhancement devices or agreements for exchange of interest rates entered into in connection with those borrowings, issued by the State of Oregon for the benefit of the university.

22(5) Any amounts deposited with the State Treasurer, the Controller of the Oregon Uni-23versity System, or the Oregon Department of Administrative Services or its designated agents, in any debt service in reserve accounts for the debt service associated with any 24 25bonds, certificates of participation, financing agreements or other agreements for the borrowing of moneys issued prior to the effective date of this 2013 Act by the State of Oregon 2627on behalf of the State Board of Higher Education for the benefit of the university shall remain with the State Treasurer, the Controller of the Oregon University System, or the 28Oregon Department of Administrative Services or its designated agents, until such time as 2930 the bonds, certificates of participation, financing agreements or other agreements for the 31 borrowing of moneys, for which such debt service in reserve accounts has been established, have been retired or defeased. 32

33 <u>SECTION 99.</u> (1) Except as otherwise provided by this section, the Portland State Uni 34 versity Board of Directors may issue and sell revenue bonds in accordance with ORS chapter

SECTION 101. Refunding bonds and advance refunding bonds of the same character and 3 tenor as those replaced by them may be issued by Portland State University pursuant to ORS 4 287A.360 to 287A.380. 5

In addition to, and not in limitation of, the means of satisfying state gen-6 eral obligation bond obligations under ORS 291.445, Portland State University, promptly upon 7 the discovery of any shortfall in moneys available to the university for the payment when 8 9 due of amounts under any bonds, certificates of participation, financing agreements or other agreements for the borrowing of moneys issued prior to the effective date of this 2013 Act 10 by the State of Oregon on behalf of the State Board of Higher Education for equipment or 11 12 projects for the benefit of the university, shall notify in writing the Legislative Assembly, or if the Legislative Assembly is not in session, the Emergency Board, of the existence and 13 amount of the shortfall. The Legislative Assembly or the Emergency Board, as the case may 14 15 be, may allocate funds to satisfy the payment of any such amount. By enacting this section, the Legislative Assembly acknowledges its current intention to allocate, from funds other 16 than those appropriated or otherwise made available to the Oregon University System or to 17 18 the Oregon Department of Administrative Services for direct allocation to the university, 19 funds to pay such amount. 25SECTION 104. In order to provide funds for the purposes specified in Article XI-F(1) of the Oregon Constitution, the Portland State University Board of Directors may request the 2627State Treasurer to issue bonds in accordance with the provisions of ORS chapter 286A.

SECTION 105. If the electors of this state authorize the issuance of bonds for the benefit 28of Portland State University individually or in its capacity as a public university, the 2930 Portland State University Board of Directors may request the State Treasurer to issue bonds 31 for such purposes in accordance with the provisions of ORS chapter 286A.

SECTION 106. If the Portland State University Board of Directors requests the State 32Treasurer to issue bonds pursuant to sections 103 to 105 of this 2013 Act, the board shall be 33 34 a related agency under ORS 286A.001 to 286A.195 for issuance or administration of the bonds. SECTION 107. As used in sections 107 to 111 of this 2013 Act: 35

(1) "Credit enhancement agreement" means any agreement or contractual relationship 36 37 between Portland State University and any bank, trust company, insurance company, surety 38 bonding company, pension fund or other financial institution providing additional credit on or security for a financing agreement or certificates of participation authorized by sections 39

40 107 to 111 of this 2013 Act.

(2) "Financing agreement" means a lease-purchase agreement, an installment sale 41 agreement, a loan agreement, a note agreement, short-term promissory notes, commercial 42papers, lines of credit or similar obligations or any other agreement to finance real or per-43 sonal property that is or will be owned and operated by the university, or to refinance pre-44 viously executed financing agreements. 45

1 (3) "Personal property" means tangible personal property, software and fixtures.

2 (4) "Property rights" means, with respect to personal property, the rights of a secured 3 party under ORS chapter 79, and, with respect to real property, the rights of a trustee or 4 lender under a lease authorized by section 110 (1)(d) of this 2013 Act.

5 (5) "Software" means software and training and maintenance contracts related to the 6 operation of computing equipment.

SECTION 108. (1) Subject to the limitations of section 99 of this 2013 Act, Portland State 7 University may enter into financing agreements in accordance with sections 107 to 111 of this 8 9 2013 Act, upon such terms as the university finds to be advantageous. Amounts payable by the university under a financing agreement shall be limited to funds available for such pur-10 poses under section 99 of this 2013 Act and specifically pledged, budgeted for or otherwise 11 12 made available by the university. If there are insufficient funds available to pay amounts due 13 under a financing agreement, the lender may exercise any property rights that the university has granted to it in the financing agreement against the property that was purchased with 14 15 the proceeds of the financing agreement, and may apply the amounts so received toward 16 payments scheduled to be made by the university under the financing agreement.

(2) Subsection (1) of this section does not apply to, and the university may not grant a security interest in, lease as security for or grant any other right under, a financing agreement with respect to any real or personal property that has been financed with general obligation bonds, certificates of participation, financing agreements or other borrowings of the State of Oregon for the benefit of the university unless those obligations of the State of Oregon are fully paid.

23SECTION 109. The Portland State University Board of Directors may delegate to any board member, the president of Portland State University, or the president's designee, the 2425authority to determine maturity dates, principal amounts, redemption provisions, interest rates or methods for determining variable or adjustable interest rates, denominations and 26other terms and conditions of such obligations that are not appropriately determined at the 27time of enactment or adoption of the authorizing resolution. Such leases may grant 6 the trustee or lender the right to evict the university and exclude it from possession of the 7 real property for the term of the lease if the university fails to pay when due the amounts 8 9 scheduled to be paid under a financing agreement, or otherwise defaults under a financing agreement. Upon default, the trustee or lender may sublease the land to third parties and 10 apply any rentals toward payments scheduled to be made under a financing agreement. 11

13 (f) Make pledges for the benefit of trustees and lenders.

(g) Purchase fire and extended coverage or other casualty insurance for property that is acquired or refinanced with proceeds of a financing agreement, assign the proceeds thereof to a lender or trustee to the extent of their interest, and covenant to maintain such insurance while the financing agreement is unpaid, as long as available funds are sufficient to purchase such insurance.

(2) The provisions of subsection (1) of this section do not apply to, and the university may not grant a security interest in, lease as security for or grant any other right under, a financing agreement with respect to any real or personal property that has been financed with general obligation bonds, certificates of participation, financing agreements or other borrowings of the State of Oregon for the benefit of the university unless those obligations of the State of Oregon are fully paid.

25 <u>SECTION 111.</u> A lease or financing agreement under sections 107 to 111 of this 2013 Act 26 does not cause property to be subject to property taxation and is disregarded in determining 27 whether property is exempt from taxation under ORS chapter 307.

SECTION 112. The Portland State University Board of Directors may, in its discretion, 28accept financial assistance and grants, either in the form of money or labor, from the United 2930 States or any of its agencies, subject to the terms and conditions thereof, regardless of any 31 laws of this state in conflict with the regulations of the federal government with respect thereto, and may also accept from others any donation or grant of land or gift of money or 32other valuable gift or thing, for any of the purposes contemplated by Article XI-F(1) and 33 34 Article XI-G of the Oregon Constitution and sections 100 to 111 of this 2013 Act. Unless enjoined by the terms or conditions of any such gift or grant, the board may convert the same, 35 or any of them, into money, through sale or disposal thereof. 36

37 <u>SECTION 113.</u> (1) The Oregon Education Investment Board, in coordination with Portland 38 State University, shall adopt performance benchmarks for the university. The benchmarks 39 must reflect the educational outcomes that the Oregon Education Investment Board expects 40 from the university. The Oregon Education Investment Board may not prescribe how the 41 benchmarks are to be achieved. (2) The transfer of duties, functions and powers to the Portland State University Board of Directors under sections 65 to 114 of this 2013 Act does not affect any action, suit, proceeding or prosecution involving or with respect to such duties, functions and powers begun before and pending at the time of the transfer, except that the university board shall be substituted for the State Board of Higher Education in any such action, suit, proceeding or prosecution.

(3) Any proceeding, action, prosecution or other business or matter undertaken or commenced before the effective date of this 2013 Act by a state officer or agency, with respect to the duties, functions or powers transferred to the university and still pending on the effective date of this 2013 Act, may be conducted and completed by the university in the same manner, under the same terms and conditions and with the same effect as though undertaken, conducted or completed by the former university before the transfer.

34 <u>SECTION 121.</u> Nothing in sections 65 to 114 of this 2013 Act relieves any person of any 35 obligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture or 36 other liability, duty or obligation.

37 <u>SECTION 122.</u> The university is considered to be a continuation of the former university 38 with respect to its duties, functions and powers, and not a new authority for the purpose of 39 succession to all rights and obligations of the former university as constituted at the time 40 of such assignment or transfer, except as otherwise provided in sections 65 to 114 of this 2013 41 Act, with the same force and effect as if such duties, functions and powers had not been 42 assigned or transferred.

For the purpose of administering and enforcing the duties, functions and 2627powers transferred by sections 65 to 114 of this 2013 Act and for the payment of the expenses lawfully incurred by the State Board of Higher Education with respect to the administration 28and enforcement of such duties, functions and powers pertaining to the former university, 29the Portland State University Board of Directors may expend the moneys that are authorized 30 31 to be expended by the State Board of Higher Education for administering and enforcing the duties, functions and powers transferred by sections 65 to 114 of this 2013 Act and that are 32unexpended on the effective date of this 2013 Act. Subject to section 98 of this 2013 Act, the 33 34 university board shall assume and pay all outstanding obligations lawfully incurred by the 35 State Board of Higher Education pertaining to the former university before the effective date of this 2013 Act that are properly charged against amounts authorized by this section to be 36 37 expended by the university board.
