SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires beneficiary under residential trust deed to request resolution conference with grantor for purposes of negotiating foreclosure avoidance measure, unless beneficiary is eligible to claim exemption from requirement. Specifies manner in which beneficiary must request resolution conference. Permits grantor to request resolution conference under certain circumstances.

Specifies documents that beneficiary and grantor must provide and specifies procedure for and duties of beneficiary and grantor with respect to resolution conference.

Requires beneficiary to obtain certificate of compliance after resolution conference in order to foreclose residential trust deed. Specifies conditions under which beneficiary may obtain certificate of compliance.

Changes name of Foreclosure Avoidance Mediation Fund to Foreclosure Avoidance Fund and continuously appropriates moneys in fund to Attorney General for purposes of paying service provider to coordinate program to implement provisions of Act and paying related expenses.

Requires beneficiary to send notice to grantor if beneficiary determines that grantor is not eligible for foreclosure avoidance measure or has not complied with terms of foreclosure avoidance measure.

Becomes operative 91 days after effective date of Act.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to foreclosures of residential trust deeds; creating new provisions; amending ORS 86.735,
3 86.740, 88.010 and 646.607 and sections 2, 4 and 4a, chapter 112, Oregon Laws 2012; repealing
4 sections 2a and 3, chapter 112, Oregon Laws 2012; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. Sections 2, 3, 4, 5 and 6 of this 2013 Act are added to and made a part of**
7 **ORS 86.705 to 86.795.**

8 **SECTION 2. (1)(a) Except as provided in paragraph (b) of this subsection, a beneficiary**
9 **that intends to foreclose a residential trust deed shall first request a resolution conference**
10 **with the grantor before the beneficiary or the trustee files a notice of default under ORS**
11 **86.735 or before the beneficiary brings suit under ORS 88.010.**

12 **(b)(A) The requirement to request or participate in a resolution conference with a**
13 **grantor in accordance with subsection (2) or (3) of this section does not apply to a beneficiary**
14 **if the beneficiary submits to the Attorney General a sworn affidavit that states that during**
15 **the preceding calendar year the beneficiary did not commence or cause an affiliate, subsid-**
16 **iary or agent of the beneficiary to commence more than 100 actions to foreclose a residential**
17 **trust deed by advertisement and sale under ORS 86.735 or by suit under ORS 88.010. A ben-**
18 **eficiary that is a trustee shall include as part of the total number of foreclosure actions that**
19 **the beneficiary commenced in the previous calendar year all foreclosure actions that the**
20 **beneficiary commenced in the beneficiary's capacity as a trustee. A beneficiary that intends**
21 **to claim an exemption under this subparagraph shall submit the affidavit either:**

1 (i) Not later than January 31 in any calendar year in which the beneficiary intends to
 2 claim the exemption for the remainder of the calendar year; or

3 (ii) At the time the beneficiary files a notice of default under ORS 86.735 or brings suit
 4 under ORS 88.010.

5 (B) An exemption under subparagraph (A) of this paragraph expires at the end of the
 6 calendar year in which the beneficiary claims the exemption.

7 (c) A beneficiary that claims an exemption under this subsection is not exempt from the
 8 requirements set forth in section 4a, chapter 112, Oregon Laws 2012.

9 (2) The beneficiary shall request a resolution conference through the service provider.
 10 The beneficiary shall submit the request to the service provider electronically or by mail and
 11 shall submit a processing fee in an amount the Attorney General specifies by rule. The ser-
 12 vice provider shall pay to the Attorney General, for deposit into the Foreclosure Avoidance
 13 Fund established under section 4, chapter 112, Oregon Laws 2012, moneys the service pro-
 14 vider receives from the beneficiary under this subsection. The beneficiary's request under
 15 this subsection must identify the residential trust deed that the beneficiary intends to fore-
 16 close and list the name, title, address, telephone number and other available contact infor-
 17 mation for:

18 (a) The beneficiary;

19 (b) Any agent of the beneficiary that will attend the resolution conference;

20 (c) Any person other than a person identified in paragraph (a) or (b) of this subsection
 21 that will receive, on the beneficiary's behalf, notices or other communications related to the
 22 resolution conference; and

23 (d) The grantor.

24 (3)(a) If a beneficiary does not request a resolution conference under subsection (1) of
 25 this section, a grantor may request a resolution conference with the beneficiary if:

26 (A) The beneficiary or the trustee has not filed a notice of default under ORS 86.735 or
 27 the beneficiary has not commenced a suit under ORS 88.010; and

28 (B) The grantor first obtains from a housing counselor a certification in writing that the
 29 grantor is more than 30 days in default on the obligation that the residential trust deed se-
 30 cures or, if the grantor is not in default, that the grantor has a financial hardship that the
 31 housing counselor believes may qualify the grantor for a foreclosure avoidance measure.

32 (b) A grantor shall request a resolution conference through the service provider. The
 33 grantor shall submit the request to the service provider electronically or by mail and shall
 34 enclose with the request the written certification the housing counselor provides under par-
 35 agraph (a)(B) of this subsection. The Attorney General by rule shall specify the information
 36 that the request must include.

37 (c) A beneficiary that receives a notice from a service provider after the service provider
 38 receives a request from a grantor under paragraph (b) of this subsection is subject to the
 39 requirements set forth in this section and sections 3, 4 and 5 of this 2013 Act and section 4a,
 40 chapter 112, Oregon Laws 2012.

41 (4) A beneficiary that submitted an affidavit in accordance with subsection (1)(b) of this
 42 section may, without waiving the exemption the beneficiary claimed in the affidavit, request
 43 a resolution conference with a grantor. The beneficiary shall submit a request under this
 44 subsection in accordance with the requirements set forth in subsection (2) of this section,
 45 except that submitting the request does not require a processing fee.

1 **SECTION 3.** (1)(a) Within 10 days after a service provider receives a request for a resolu-
 2 tion conference under section 2 of this 2013 Act, the service provider shall schedule the
 3 resolution conference and mail a notice to the beneficiary and to the grantor. The service
 4 provider shall schedule the resolution conference to occur within 75 days after the date on
 5 which the service provider sends the notice.

6 (b) A notice under this subsection must:

7 (A) Specify the date, time and location of the resolution conference;

8 (B) State that the beneficiary and the grantor each must pay the facilitator's fees for the
 9 resolution conference;

10 (C) List and describe the documents that the beneficiary and the grantor must submit
 11 to the service provider;

12 (D) State that the grantor must consult a housing counselor before attending the resolu-
 13 tion conference unless the grantor notifies the service provider that the grantor could not
 14 obtain an appointment with a housing counselor before the date of the resolution conference;

15 (E) State that the grantor may have an attorney or housing counselor present to repre-
 16 sent the grantor at the resolution conference; and

17 (F) Include any other information the Attorney General requires by rule.

18 (2) Within 25 days after the date on which the service provider sends a notice under
 19 subsection (1) of this section:

20 (a) The grantor shall pay a fee to the service provider for the facilitator's services in an
 21 amount the Attorney General specifies by rule. The grantor's fee may not exceed \$200.

22 (b) The grantor shall submit to the service provider:

23 (A) Information about the grantor's income, expenses, debts and other obligations;

24 (B) A description of the grantor's financial hardship, if any;

25 (C) Documents that verify the grantor's income; and

26 (D) Any other information the Attorney General requires by rule.

27 (3) Within 25 days after the service provider makes the information the grantor submit-
 28 ted under subsection (2) of this section available to the beneficiary, the beneficiary shall:

29 (a) Pay a fee to the service provider for the facilitator's services in an amount the At-
 30 torney General specifies by rule; and

31 (b) Submit to the service provider:

32 (A) The residential trust deed and a certified true copy of the promissory note that is
 33 evidence of the obligation that the residential trust deed secures;

34 (B) The name and address of the person that owns the obligation that is secured by the
 35 residential trust deed;

36 (C) A record of the grantor's payment history for the longer of the preceding 12 months
 37 or since the beneficiary last deemed the grantor current on the obligation;

38 (D) An itemized statement that shows:

39 (i) The amount the grantor owes on the obligation;

40 (ii) The amount of fees and charges the beneficiary has assessed; and

41 (iii) The amount the grantor must pay to cure the grantor's default;

42 (E) A document that identifies:

43 (i) Each net present value model that the beneficiary or the beneficiary's agent uses to
 44 evaluate the grantor's eligibility for a foreclosure avoidance measure;

45 (ii) The input values that the beneficiary or the beneficiary's agent uses for each net

1 present value model; and

2 (iii) The output values that each net present value model produces;

3 (F) The appraisal or price opinion the beneficiary relied on most recently to determine
4 the value of the property that is the subject of the residential trust deed;

5 (G) The portion of any pooling agreement, servicing agreement or other agreement that
6 the beneficiary cites as a limitation or prohibition on modifying the terms of the obligation,
7 together with a statement that describes the extent to which the beneficiary sought to have
8 the limitation or prohibition waived;

9 (H) A description of any additional documents the beneficiary requires to evaluate the
10 grantor's eligibility for a foreclosure avoidance measure; and

11 (I) Any other information the Attorney General requires by rule.

12 (4)(a) The service provider may postpone or reschedule a resolution conference that the
13 service provider scheduled under subsection (1) of this section if:

14 (A) The beneficiary and the grantor agree to a new date;

15 (B) The beneficiary or the grantor requests a new date in writing and can show good
16 cause for the request; or

17 (C) The beneficiary does not pay the fee required under subsection (3)(a) of this section
18 by the date the fee is due. The service provider may wait until the beneficiary has paid the
19 fee before rescheduling the resolution conference.

20 (b) The service provider shall cancel a resolution conference that the service provider
21 scheduled under subsection (1) of this section if the grantor does not pay the fee required
22 under subsection (2)(a) of this section by the date the fee is due.

23 (5)(a) A resolution conference conducted in accordance with this section and sections 2,
24 4 and 5 of this 2013 Act is not subject to ORS chapter 36 and does not preclude mediation
25 that a court or another provision of law requires.

26 (b) A facilitator is not subject to a subpoena in any proceeding between a beneficiary and
27 a grantor that is related to and occurs after a resolution conference.

28 (c) A facilitator's act or omission in the course of a resolution conference does not sub-
29 ject the facilitator to civil liability unless the facilitator acted or made an omission in bad
30 faith, with malicious intent or in a manner that exhibited a willful or wanton disregard of
31 the rights, safety or property of another person.

32 (d) Information that a beneficiary or a grantor submits to a service provider under this
33 section is not subject to disclosure under ORS 192.410 to 192.505. A service provider may
34 disclose information that relates to the result of a resolution conference under ORS 192.410
35 to 192.505 if the information does not identify a party that participated in the resolution
36 conference.

37 **SECTION 4.** (1)(a) Except as provided in paragraph (b) of this subsection, a beneficiary
38 that must request a resolution conference with a grantor under section 2 of this 2013 Act
39 shall attend and participate in the resolution conference in person.

40 (b) A beneficiary may send an agent to the resolution conference if the agent attends the
41 resolution conference in person and has complete authority to negotiate on the beneficiary's
42 behalf and commit the beneficiary to a foreclosure avoidance measure or, if the agent who
43 attends the resolution conference in person does not have complete authority, the benefi-
44 cary also requires a person who does have complete authority to participate in the resolution
45 conference by remote communication in accordance with rules that the Attorney General

1 adopts.

2 (2) If the beneficiary agrees to a foreclosure avoidance measure with the grantor, the
 3 beneficiary and the grantor shall sign a written document that sets forth the terms of the
 4 foreclosure avoidance measure.

5 (3) A facilitator may suspend or postpone a resolution conference after the resolution
 6 conference has begun:

7 (a) One time only on the facilitator's initiative or in response to a request for a suspen-
 8 sion or postponement from the beneficiary or the grantor;

9 (b) After a suspension or postponement under paragraph (a) of this subsection only if the
 10 beneficiary and the grantor agree to the additional suspension or postponement; or

11 (c) If the beneficiary or the grantor needs additional time to write or sign a document
 12 that sets forth the terms of a foreclosure avoidance measure.

13 (4) After the resolution conference concludes, the facilitator shall submit to the service
 14 provider a written report that:

15 (a) Lists the date or dates on which the resolution conference occurred;

16 (b) Lists the name, title, address, telephone number and other available contact infor-
 17 mation for each person that participated in the resolution conference, noting whether the
 18 person attended the resolution conference in person or participated by remote communi-
 19 cation;

20 (c) States whether the beneficiary or the agent of the beneficiary who attended the re-
 21 solution conference had complete authority to negotiate and commit to a foreclosure avoid-
 22 ance measure;

23 (d) Summarizes the terms of the foreclosure avoidance measure to which the beneficiary
 24 and the grantor agreed or notes that the beneficiary and the grantor did not agree to a
 25 foreclosure avoidance measure; and

26 (e) Provides any other information the Attorney General requires by rule.

27 **SECTION 5.** (1)(a) The service provider shall issue, within five days after receiving a re-
 28 port from a facilitator under section 4 (4) of this 2013 Act, a certificate of compliance to a
 29 beneficiary that:

30 (A) Complied with sections 2, 3 and 4 of this 2013 Act;

31 (B) Submitted the materials required under section 3 (3) of this 2013 Act to the service
 32 provider;

33 (C) Appeared in person at, or sent an agent in person to, the resolution conference with
 34 complete authority to negotiate and commit to a foreclosure avoidance measure or, if the
 35 beneficiary or agent did not have complete authority, required a person with complete au-
 36 thority to participate in the resolution conference by remote communication in accordance
 37 with rules the Attorney General adopts; and

38 (D) Signed a document that sets forth the terms of any foreclosure avoidance measure
 39 to which the beneficiary and the grantor agreed.

40 (b) A certificate of compliance expires one year after the date on which the service pro-
 41 vider issues the certificate of compliance under paragraph (a) of this subsection.

42 (c) The service provider shall notify a beneficiary that failed to meet a requirement to
 43 which the beneficiary was subject under paragraph (a) of this subsection that the service
 44 provider will not issue a certificate of compliance, explaining in the notice why the service
 45 provider will not issue the certificate of compliance. The service provider shall provide a copy

1 of a notice under this paragraph to the grantor and to the Attorney General.

2 (2) Notwithstanding the requirements set forth in subsection (1) of this section, if a ser-
 3 vice provider cancels a resolution conference under section 3 (4)(b) of this 2013 Act, the
 4 service provider shall issue a certificate of compliance to the beneficiary within five days
 5 after cancelling the resolution conference.

6 **SECTION 6.** (1) The Attorney General shall:

7 (a) Appoint and enter into an agreement with a service provider to coordinate a program
 8 to implement the provisions of sections 2, 3 4 and 5 of this 2013 Act. The Attorney General
 9 shall pay for the service provider’s services from the Foreclosure Avoidance Fund estab-
 10 lished in section 4, chapter 112, Oregon Laws 2012. The appointment and the agreement are
 11 not subject to ORS chapter 279A or 279B.

12 (b) Receive affidavits submitted under section 2 (1)(b) of this 2013 Act and copies of no-
 13 tices sent under section 4a (1), chapter 112, Oregon Laws 2012.

14 (c) Specify the amount a beneficiary must pay as a processing fee to the service provider
 15 under section 2 (2) of this 2013 Act and the amounts that the grantor must pay for the
 16 facilitator’s services under section 3 (2)(a) of this 2013 Act and the beneficiary must pay for
 17 the facilitator’s services under section 3 (3)(a) of this 2013 Act.

18 (d) Adopt rules to implement sections 2, 3, 4 and 5 of this 2013 Act and sections 4 and
 19 4a, chapter 112, Oregon Laws 2012.

20 (2) In addition to and not in lieu of any other penalty provided by law, a beneficiary’s
 21 violation of section 2 (1)(a) or (2), section 3 (3) or section 4 (1) or (2) of this 2013 Act is an
 22 unlawful practice under ORS 646.607 that is subject to enforcement under ORS 646.632.

23 **SECTION 7.** Section 2, chapter 112, Oregon Laws 2012, is amended to read:

24 **Sec. 2.** [(1)] As used in this section and [sections 3 and 4a of this 2012 Act,] sections 2, 3, 4, 5
 25 and 6 of this 2013 Act and sections 4 and 4a, chapter 112, Oregon Laws 2012:

26 (1) “Facilitator” means a person that a service provider selects to conduct a resolution
 27 conference.

28 (2) “Foreclosure avoidance measure” means an agreement between a beneficiary and a grantor
 29 that uses one or more of the following methods to modify an obligation that is secured by a resi-
 30 dential trust deed:

31 (a) The beneficiary defers or forbears from collecting one or more payments due on the obli-
 32 gation.

33 (b) The beneficiary modifies, temporarily or permanently, the payment terms or other terms of
 34 the obligation.

35 (c) The beneficiary accepts a deed in lieu of foreclosure from the grantor.

36 (d) The grantor conducts a short sale.

37 (e) The beneficiary provides the grantor with other assistance that enables the grantor to avoid
 38 a foreclosure.

39 (3) “Housing counselor” means a counselor employed by a nonprofit housing counseling
 40 agency that the Housing and Community Services Department or a successor state agency
 41 approves by rule.

42 (4) “Resolution conference” means a meeting at which a grantor and a beneficiary at-
 43 tempt to negotiate and agree upon a foreclosure avoidance measure.

44 (5) “Service provider” means a person that the Attorney General appoints under section
 45 6 of this 2013 Act to coordinate a program to implement the provisions of sections 2, 3, 4 and

1 **5 of this 2013 Act.**

2 [(2)(a) Except as provided in paragraph (d) of this subsection, a beneficiary that seeks to foreclose
3 a residential trust deed under ORS 86.735 shall enter into mediation with the grantor for the purpose
4 of negotiating a foreclosure avoidance measure in accordance with the provisions of this section.]

5 [(b) The Attorney General shall:]

6 [(A) Appoint a mediation service provider to coordinate a mediation program and shall enter into
7 an agreement to pay the mediation service provider for the mediation service provider's services from
8 the Foreclosure Avoidance Mediation Fund established in section 4 of this 2012 Act. The appointment
9 and the agreement are not subject to ORS chapter 279A or 279B.]

10 [(B) Prescribe qualifications, training and experience requirements for mediators by rule.]

11 [(C) Set the schedule of fees for the mediation by rule.]

12 [(c) The beneficiary and the grantor shall share the cost of the mediation, except that the grantor's
13 portion of the cost may not exceed \$200. The mediator may waive the grantor's portion of the fee in
14 accordance with rules that the Attorney General adopts to describe circumstances that permit a
15 waiver.]

16 [(d) The requirement to enter into mediation with a grantor does not apply:]

17 [(A) To an individual, a financial institution, as defined in ORS 706.008, a mortgage banker, as
18 defined in ORS 86A.100, or a licensee, as defined in ORS 725.010, if the individual, financial institu-
19 tion, mortgage banker or licensee provides to the Attorney General a sworn affidavit that states that
20 during the preceding calendar year the individual, financial institution, mortgage banker or licensee
21 did not commence or cause an affiliate or agent of the individual, financial institution, mortgage banker
22 or licensee to commence more than a total of 250 actions to foreclose a residential trust deed by ad-
23 vertisement and sale under ORS 86.735 or a residential mortgage by suit under ORS 88.010. An indi-
24 vidual, financial institution, mortgage banker or licensee that intends to claim an exemption under this
25 subparagraph shall file the affidavit either:]

26 [(i) Within 30 days after the operative date specified in section 11 of this 2012 Act to claim the
27 exemption for calendar year 2012 and not later than January 31 in any subsequent calendar year in
28 which the individual, financial institution, mortgage banker or licensee intends to claim the exemption;
29 or]

30 [(ii) At the time the individual, financial institution, mortgage banker or licensee files a notice of
31 default under ORS 86.735.]

32 [(B) If the grantor fails to confirm that the grantor will enter into mediation by the date specified
33 under subsection (3)(c) of this section.]

34 [(3) Within 30 days after the date on which the beneficiary caused a notice of mediation to be
35 served or mailed as provided in ORS 86.740, the mediation service provider shall send a notice to the
36 grantor and the beneficiary that:]

37 [(a) Schedules a date, time and location for the mediation. The date must be not earlier than 45
38 days and not later than 90 days after the date on which the notice of mediation was served or mailed
39 as provided in ORS 86.740.]

40 [(b) Identifies and provides contact information for the mediation service provider.]

41 [(c) Specifies a date at least 30 days before the scheduled date of the mediation by which the
42 grantor must contact the mediation service provider to confirm that the grantor will enter into medi-
43 ation. The notice must state that the mediation service provider will deem the grantor to have declined
44 to enter into mediation if the grantor fails to confirm by the specified date.]

45 [(d) Lists the costs of the mediation and specifies the portion of the costs for which the grantor is

1 *responsible.]*

2 *[(e) Provides any other information that the Attorney General requires by rule.]*

3 *[(4)(a) If the grantor confirms by the date specified under subsection (3)(c) of this section that the*
4 *grantor will enter into mediation, the beneficiary or the beneficiary's agent shall appear at the time and*
5 *the location identified in the mediation service provider's notice under subsection (3) of this section with*
6 *the documentation described in paragraph (b) of this subsection.]*

7 *[(b) The beneficiary or the beneficiary's agent must appear in person at the location of the medi-*
8 *ation unless the mediator permits the beneficiary or the beneficiary's agent to appear in another manner*
9 *for good cause shown. The fact that a beneficiary or beneficiary's agent is located outside this state*
10 *does not alone constitute good cause for the purposes of this paragraph. The beneficiary or the*
11 *beneficiary's agent must appear at the mediation with:]*

12 *[(A) The grantor's complete payment history for the obligation that is secured by the residential*
13 *trust deed that the beneficiary seeks to foreclose;]*

14 *[(B) Evidence that the beneficiary is the real party in interest with respect to the obligation, in-*
15 *cluding but not limited to:]*

16 *[(i) A true copy of the original debt instrument that is the basis for the right the beneficiary claims*
17 *to foreclose the trust deed; and]*

18 *[(ii) Documents that show the chain of title for the property that is subject to the residential trust*
19 *deed from the date of the original loan for which the beneficiary seeks foreclosure to the date of the*
20 *notices given under ORS 86.740, including conveyances, endorsements and assignments of the residen-*
21 *tial trust deed, the note and the security instrument, whether recorded or unrecorded;]*

22 *[(C) A copy of the authorization from the beneficiary to the beneficiary's agent, if the beneficiary's*
23 *agent appears at the mediation;]*

24 *[(D) A copy of any of the following documents that apply to the note or obligation that is secured*
25 *by the trust deed:]*

26 *[(i) A servicing agreement the beneficiary entered into with another person; or]*

27 *[(ii) An agreement by means of which the beneficiary pledged as collateral for a security the ben-*
28 *eficiary issued or sold all or a portion of the ownership interest in the note or other obligation; and]*

29 *[(E) Other documentation the Attorney General specifies by rule.]*

30 *[(c) The beneficiary or the beneficiary's agent that enters into mediation with the grantor must have*
31 *or be able to obtain, before the initial mediation session concludes, authority to accept or reject a pro-*
32 *posal for a foreclosure avoidance measure and authority to enter with the grantor into an agreement*
33 *for a foreclosure avoidance measure.]*

34 *[(5)(a) The beneficiary or the beneficiary's agent must enter into mediation in accordance with me-*
35 *diation guidelines the Attorney General establishes by rule.]*

36 *[(b) If the beneficiary or the beneficiary's agent agrees with the grantor on a foreclosure avoidance*
37 *measure, the beneficiary or beneficiary's agent and the grantor shall set forth the terms of the foreclo-*
38 *sure avoidance measure in a written agreement, a copy of which the beneficiary or beneficiary's agent*
39 *shall provide to the Attorney General. The beneficiary may elect to pay the grantor's portion of the cost*
40 *of the mediation or the grantor and the beneficiary may agree to include the cost of the mediation as*
41 *part of and in accordance with any payment plan that is part of the foreclosure avoidance measure.]*

42 *[(c) If the beneficiary or the beneficiary's agent and the grantor do not agree on a foreclosure*

45 *[(6)(a) At the conclusion of the mediation, if the beneficiary has complied with the requirements of*

1 subsections (4) and (5) of this section, the mediation service provider shall provide the beneficiary or
 2 the beneficiary's agent with a certificate of compliance in a form and with contents that the Attorney
 3 General specifies by rule. The certificate must state that the beneficiary has complied with the require-
 4 ments of this section.]

5 [(b) If the grantor does not confirm by the date specified under subsection (3)(c) of this section that
 6 the grantor will enter into mediation, the mediation service provider shall provide the beneficiary or the
 7 beneficiary's agent with a certificate of compliance in a form and with contents that the Attorney
 8 General specifies by rule. The certificate must state that the grantor declined to enter into mediation
 9 with the beneficiary.]

10 [(c) The mediation service provider shall provide a copy of the certificate the mediation service
 11 provider issues under paragraph (a) or (b) of this subsection to the grantor and to the Attorney Gen-
 12 eral.]

13 [(7)(a) A grantor that is at risk of default before the beneficiary or the trustee has filed a notice
 14 of default for recording under ORS 86.735 may notify the beneficiary or trustee in the trust deed or the
 15 beneficiary's or trustee's agent that the grantor wants to enter into mediation. Within 15 days after
 16 receiving the request, the beneficiary or trustee or the beneficiary's or trustee's agent shall respond to
 17 the grantor's request and shall notify the Attorney General and the mediation service provider identi-

 19 for the Attorney General and the mediation service provider.]

 13 *exemption for calendar year 2012 and not later than January 31 in any subsequent calendar year in*
 14 *which the individual, financial institution, mortgage banker or licensee intends to claim the exemption;*
 15 *or]*

16 *[(B) At the time the individual, financial institution, mortgage banker or licensee files a notice of*
 17 *default under ORS 86.735.]*

18 **SECTION 9.** Section 4a, chapter 112, Oregon Laws 2012, is amended to read:

19 **Sec. 4a. [(1)(a)] (1) Whether or not a beneficiary participates in a resolution conference**
 20 **under section 2 of this 2013 Act,** if [a] the beneficiary determines that a grantor of a residential
 21 **trust deed** is not eligible for any foreclosure avoidance measure or that the grantor has not com-
 22 plied with the terms of a foreclosure avoidance measure to which the grantor has agreed, the ben-
 23 eficiary [*or the beneficiary's agent, at least 30 days before the date specified for the trustee's sale in*
 24 *a notice served under ORS 86.740 or 86.755 (2)(b), shall notify the grantor in writing of the*

 8 **person does not retain pursuant to** any right, claim or defense *[asserted]* **the person may assert**
 9 in good faith. This subsection does not create a warranty obligation and does not apply to a dispute
 10 over the quality of real estate, goods or services delivered to a customer;

12 (4) Violates a provision of ORS 646A.725 to 646A.750;

13 (5) Violates ORS 646A.530; *[or]*

14 (6) Employs a collection practice that is unlawful under ORS 646.639[.]; **or**

15 (7) **Is a beneficiary that violates section 2 (1)(a) or (2), section 3 (3) or section 4 (1) or (2)**
 16 **of this 2013 Act.**

17 **SECTION 14. Sections 2a and 3, chapter 112, Oregon Laws 2012, are repealed.**

18 **SECTION 15. (1) Sections 2 to 6 of this 2013 Act, the amendments to ORS 86.735, 86.740,**
