

# House Bill 3502

Sponsored by Representative FREEMAN; Representative HANNA

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Prohibits Department of Transportation from accepting notification of transfer of title unless form contains all required information.

## A BILL FOR AN ACT

1  
2 Relating to vehicle titling; creating new provisions; and amending ORS 803.113.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 803.113 is amended to read:

5 803.113. (1) Except as otherwise provided by rule of the Department of Transportation under  
6 subsection (3) of this section, upon [*receipt*] **acceptance** of a notification of transfer described in  
7 ORS 803.112, the department shall make a notation on its records indicating that it has received  
8 notification that an interest in the vehicle has been transferred. The [*notation shall be made whether*  
9 *or not the form submitted to the*] department **may not accept the notification unless the form**  
10 **submitted to the department** contains all the information required by the department under ORS  
11 803.112[, *so long as there is sufficient information to identify the vehicle*]. Thereafter, until a new title  
12 is issued, when the department is asked to provide the name of the owner of a vehicle as shown on  
13 its records, the department shall provide the name of the transferor and indicate that department  
14 records show a notification of transfer but do not show a title transfer. The department shall also  
15 provide the name of the transferee if it is shown on the form submitted by the transferor under ORS  
16 803.112.

17 (2) Whenever the Oregon Vehicle Code or other statute requires notice to the owner of a motor  
18 vehicle, the person required to provide notice shall provide the notice to the current owner as  
19 shown on the records of the department and to any transferee shown as a result of notification to  
20 the department under ORS 803.112.

21 (3) The department may adopt rules for the implementation of ORS 803.112 and this section.  
22 Rules shall be designed to allow the department to implement ORS 803.112 and this section in a way  
23 that is efficient and convenient for the public and the department. Rules under this section may  
24 include, but need not be limited to, rules authorizing the department to remove information recorded  
25 under this section, specifying circumstances under which information submitted need not be re-  
26 corded and specifying circumstances under which the department provides a receipt of notification  
27 that an interest in a vehicle has been transferred.

28 **SECTION 2.** The amendments to ORS 803.113 by section 1 of this 2013 Act apply to no-  
29 tifications submitted on or after the effective date of this 2013 Act.
