

House Bill 5011

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to State Department of Energy for landscape level planning in facility siting.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from lottery moneys.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2013.

A BILL FOR AN ACT

1
2 Relating to the financial administration of the State Department of Energy; appropriating money;
3 limiting expenditures; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the State Department of Energy for the biennium**
6 **beginning July 1, 2013, out of the General Fund, the amount of \$500,000 for landscape level**
7 **planning in facility siting.**

8 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
9 **\$47,308,983 is established for the biennium beginning July 1, 2013, as the maximum limit for**
10 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
11 **but excluding lottery funds and federal funds, collected or received by the State Department**
12 **of Energy.**

13 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
14 **\$3,437,724 is established for the biennium beginning July 1, 2013, as the maximum limit for**
15 **payment of expenses from lottery moneys allocated from the Administrative Services Eco-**
16 **nomic Development Fund to the State Department of Energy for debt service for the energy**
17 **efficiency and sustainable technology loan program, for the Home Energy Efficiency Program**
18 **and for State Energy Loan Program recapitalization.**

19 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of**
20 **\$2,980,933 is established for the biennium beginning July 1, 2013, as the maximum limit for**
21 **payment of expenses from federal funds collected or received by the State Department of**
22 **Energy.**

23 **SECTION 5. For the biennium beginning July 1, 2013, expenditures by the State Depart-**
24 **ment of Energy for loans for small scale energy loan projects and expenditures by the de-**
25 **partment for debt service are not limited.**

26 **SECTION 6. This 2013 Act being necessary for the immediate preservation of the public**
27 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
