

## HOUSE AMENDMENTS TO HOUSE BILL 5018

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed bill, delete lines 5 through 27 and delete page 2 and insert:

2 “**SECTION 1.** There is appropriated to the Department of Justice, for the biennium be-  
3 ginning July 1, 2013, out of the General Fund, the following amounts for the following pur-  
4 poses:

- 5 (1) Office of the Attorney  
6 General and administration ..... \$ 300,000  
7 (2) Civil Enforcement Division ..... \$ 3,892,716  
8 (3) Criminal Justice Division ..... \$ 8,446,620

12 Conviction ..... \$ 20,006,886  
13 (6) Child Support Division ..... \$ 23,278,185

14 “**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts  
15 are established for the biennium beginning July 1, 2013, as the maximum limit for payment  
16 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-  
17 cluding lottery funds and federal funds, collected or received by the Department of Justice,  
18 for the following purposes:

- 19 (1) Office of the Attorney  
20 General and administration ..... \$ 27,029,413  
21 (2) Appellate Division ..... \$ 17,647,715  
22 (3) Civil Enforcement Division ..... \$ 63,466,524  
23 (4) Criminal Justice Division ..... \$ 9,605,066  
24 (5) Crime Victims’ Services  
25 Division ..... \$ 29,736,924  
26 (6) General Counsel Division ..... \$ 45,021,378  
27 (7) Trial Division ..... \$ 25,682,734  
28 (8) Child Support Division ..... \$ 27,500,431

29 “**SECTION 3.** Notwithstanding any other law limiting expenditures, the following amounts  
30 are established for the biennium beginning July 1, 2013, as the maximum limit for payment  
31 of expenses from federal funds collected or received by the Department of Justice for the  
32 following purposes:

- 33 (1) Civil Enforcement Division ..... \$ 3,246,887  
34 (2) Criminal Justice Division ..... \$ 9,603,735  
35 (3) Crime Victims’ Services

1           **Division ..... \$ 19,081,618**

2           **(4) Child Support Division ..... \$ 82,129,709**

3           **“SECTION 4. For the biennium beginning July 1, 2013, expenditures passed through as**  
4 **special payments for other recipients, primarily district attorneys, for child support federal**  
5 **funds and incentive federal funds and fees, are not limited.**

6           **“SECTION 5. This 2013 Act being necessary for the immediate preservation of the public**  
7 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**  
8 **July 1, 2013.”.**
