- 4 In line 11, delete “\$71,022,345” and insert “\$70,941,780”.
- 5 In line 22, delete “\$2,052,981,887” and insert “\$2,063,406,407”.
- 6 In line 23, delete “Central services” and insert “Central services, statewide assessments and
7 enterprise-wide costs” and delete “\$24,582,544” and insert “\$25,117,290”.

- 14 **“SECTION 5. For the biennium beginning July 1, 2013, the following expenditures by the
15 Oregon Health Authority are not limited:**
- 16 **“(1) Expenditures from the Women, Infants and Children Program food vouchers.**
- 17 **“(2) Expenditures for the federal funds debt service on Build America Bonds.**
- 18 **“(3) Expenditures from the Oregon Medical Insurance Pool Account for payment of
19 claims and third party administration contracts in the Oregon Medical Insurance Pool pro-
20 gram, and for payment of claims and other costs associated with administration and support
21 in the Oregon Reinsurance Program.**
- 22 **“SECTION 6. Notwithstanding any other law limiting expenditures, the amount of
23 \$1,531,997,391 is established for the biennium beginning July 1, 2013, as the maximum limit
24 for payment of expenses by the Public Employees’ Benefit Board from the Public Employees’
25 Revolving Fund for benefit plan premiums and self-insurance.**
- 26 **“SECTION 7. Notwithstanding any other law limiting expenditures, the amount of
27 \$1,628,294,000 is established for the biennium beginning July 1, 2013, as the maximum limit
28 for payment of expenses by the Oregon Educators Benefit Board from the Oregon Educators
29 Revolving Fund for benefit plan premiums and self-insurance.”.**
- 30 In line 26, delete “6” and insert “8”.
