House Bill 5038

CHAPTER

AN ACT

Relating to the financial administration of the Department of State Police; appropriating money; limiting expenditures; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Department of State Police, for the biennium beginning July 1, 2013, out of the General Fund, the following amounts, for the following purposes:

- (1) Patrol services, criminal investigations and gaming enforcement..... \$148,274,995
- (2) Fish and wildlife enforcement... \$ 2,850,099
- (3) Forensic services and State Medical Examiner..... \$ 37,127,219
- (4) Administrative services, criminal justice information services and office of the State Fire Marshal..... \$ 46,442,487

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2013, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Department of State Police, for the following purposes:

- (1) Patrol services, criminal investigations and gaming enforcement..... \$ 26,709,774
- (2) Fish and wildlife enforcement... \$ 23,395,421
- (3) Forensic services and State Medical Examiner..... \$ 564,954
- (4) Administrative services, criminal justice information services and office of the State Fire Marshal..... \$ 40,608,694

SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2013, as the maximum limits for payment

of expenses from federal funds collected or received by the Department of State Police for the following purposes:

- (1) Patrol services, criminal investigations and gaming enforcement..... \$ 1,916,268
- (2) Fish and wildlife enforcement... \$ 2,252,512
- (3) Forensic services and State Medical Examiner..... \$ 1,989,419
- (4) Administrative services, criminal justice information services and office of the State Fire Marshal..... \$ 3,254,602

SECTION 4. Notwithstanding any other law limiting expenditures, and notwithstanding ORS 541.940 (2), the amount of \$6,920,507 is established for the biennium beginning July 1, 2013, as the maximum limit for payment of expenses by the Department of State Police for fish and wildlife enforcement activities from moneys or other revenues allocated to the Parks and Natural Resources Fund and from lottery funds made available to the Parks and Natural Resources Fund under Article XV, section 4 (8), of the Oregon Constitution.

SECTION 5. This 2013 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect July 1, 2013.
