

## SENATE AMENDMENTS TO SENATE BILL 125

By COMMITTEE ON VETERANS AND EMERGENCY PREPAREDNESS

March 12

1 On page 1 of the printed bill, line 2, delete the first “and”.

2 In line 3, after “183.415” insert “; and declaring an emergency”.

3 On page 2, delete lines 21 and 22 and insert:

4 “(p) A statement that active duty servicemembers have a right to stay proceedings under the  
5 federal Servicemembers Civil Relief Act and may contact the Oregon State Bar or the Oregon Mil-  
6 itary Department for more information. The statement must include the toll-free telephone numbers  
7 for the Oregon State Bar and the Oregon Military Department and the Internet address for the  
8 United States Armed Forces Legal Assistance Legal Services Locator website.”.

9 After line 28, insert:

10 “**SECTION 2.** (1) An agency that, prior to the effective date of this 2013 Act, provided  
11 notice of rights under the federal Servicemembers Civil Relief Act to each party to a con-  
12 tested case under ORS 183.413 is not required to provide the specific information described  
13 in ORS 183.413 (2)(p) in the notice so long as the agency continues to provide notice in the  
14 same manner as it was previously provided.

15 “(2) An agency that, prior to the effective date of this 2013 Act, had preprinted forms  
16 used for providing notice under ORS 183.413 (2) is not required to provide the specific infor-  
17 mation required in ORS 183.413 (2)(p) until the supply of preprinted forms has been ex-  
18 hausted.”.

19 In line 29, delete “2” and insert “3”.

20 Delete lines 42 and 43 and insert:

21 “(f) A statement that active duty servicemembers have a right to stay proceedings under the  
22 federal Servicemembers Civil Relief Act and may contact the Oregon State Bar or the Oregon Mil-  
23 itary Department for more information. The statement must include the toll-free telephone numbers  
24 for the Oregon State Bar and the Oregon Military Department and the Internet address for the  
25 United States Armed Forces Legal Assistance Legal Services Locator website.

26 “**SECTION 4.** (1) An agency that, prior to the effective date of this 2013 Act, provided  
27 notice of rights under the federal Servicemembers Civil Relief Act to each party to a con-  
28 tested case under ORS 183.415 is not required to provide the specific information described  
29 in ORS 183.415 (2)(f) in the notice so long as the agency continues to provide notice in the  
30 same manner as it was previously provided.

31 “(2) An agency that, prior to the effective date of this 2013 Act, had preprinted forms  
32 used for providing notice under ORS 183.415 (2) is not required to provide the specific infor-  
33 mation required in ORS 183.415 (2)(f) until the supply of preprinted forms has been ex-  
34 hausted.”.

35 In line 44, delete “3” and insert “5” and delete “2” and insert “3”.

1 After line 45, insert:

2 **SECTION 6. This 2013 Act being necessary for the immediate preservation of the public**  
3 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**  
4 **on its passage.”**
