

Senate Bill 135

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Commissioner of the Bureau of Labor and Industries Brad Avakian)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Abolishes Wage and Hour Commission. Transfers duties, functions and powers of commission to Bureau of Labor and Industries.

Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

WAGE AND HOUR COMMISSION ABOLISHED

10 **SECTION 1. (1) The Wage and Hour Commission is abolished. On the effective date of**
11 **this section, the tenure of office of the members of the Wage and Hour Commission ceases.**

12 **(2) All the duties, functions and powers of the Wage and Hour Commission are imposed**
13 **upon, transferred to and vested in the Bureau of Labor and Industries.**

RECORDS, PROPERTY, EMPLOYEES

17 **SECTION 2. (1) The chairperson of the Wage and Hour Commission shall:**

18 **(a) Deliver to the Commissioner of the Bureau of Labor and Industries all records and**
19 **property within the jurisdiction of the Wage and Hour Commission that relate to the duties,**
20 **functions and powers transferred by section 1 of this 2013 Act; and**

21 **(b) Transfer to the Bureau of Labor and Industries those employees engaged primarily**
22 **in the exercise of the duties, functions and powers transferred by section 1 of this 2013 Act.**

23 **(2) The Commissioner of the Bureau of Labor and Industries shall take possession of the**
24 **records and property, and shall take charge of the employees and employ them in the exer-**
25 **cise of the duties, functions and powers transferred by section 1 of this 2013 Act, without**
26 **reduction of compensation but subject to change or termination of employment or compen-**
27 **sation as provided by law.**

28 **(3) The Governor shall resolve any dispute between the Wage and Hour Commission and**
29 **the Bureau of Labor and Industries relating to transfers of records, property and employees**
30 **under this section, and the Governor's decision is final.**

UNEXPENDED REVENUES

3 **SECTION 3.** (1) The unexpended balances of amounts authorized to be expended by the
4 Wage and Hour Commission for the biennium beginning July 1, 2011, from revenues dedi-
5 cated, continuously appropriated, appropriated or otherwise made available for the purpose
6 of administering and enforcing the duties, functions and powers transferred by section 1 of
7 this 2013 Act are transferred to and are available for expenditure by the Bureau of Labor and
8 Industries for the biennium beginning July 1, 2011, for the purpose of administering and en-
9 forcing the duties, functions and powers transferred by section 1 of this 2013 Act.

10 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
11 expenditures by the Wage and Hour Commission remain applicable to expenditures by the
12 Bureau of Labor and Industries under this section.

ACTION, PROCEEDING, PROSECUTION

16 **SECTION 4.** The transfer of duties, functions and powers to the Bureau of Labor and
17 Industries by section 1 of this 2013 Act does not affect any action, proceeding or prosecution
18 involving or with respect to such duties, functions and powers begun before and pending at
19 the time of the transfer, except that the Bureau of Labor and Industries is substituted for
20 the Wage and Hour Commission in the action, proceeding or prosecution.

LIABILITY, DUTY, OBLIGATION

24 **SECTION 5.** (1) Nothing in sections 1 to 8 of this 2013 Act, the amendments to statutes
25 by sections 10 to 28 of this 2013 Act or the repeal of statutes by section 9 of this 2013 Act
26 relieves a person of a liability, duty or obligation accruing under or with respect to the du-
27 ties, functions and powers transferred by section 1 of this 2013 Act. The Bureau of Labor and
28 Industries may undertake the collection or enforcement of any such liability, duty or obli-
29 gation.

30 (2) The rights and obligations of the Wage and Hour Commission legally incurred under
31 contracts, leases and business transactions executed, entered into or begun before the ef-
32 fective date of section 1 of this 2013 Act are transferred to the Bureau of Labor and Indus-
33 tries. For the purpose of succession to these rights and obligations, the Bureau of Labor and
34 Industries is a continuation of the Wage and Hour Commission and not a new authority.

38 **SECTION 6.** Notwithstanding the transfer of duties, functions and powers by section 1
39 of this 2013 Act, the rules of the Wage and Hour Commission in effect on the effective date
40 of section 1 of this 2013 Act continue in effect until superseded or repealed by rules adopted
41 by the Bureau of Labor and Industries. References in rules of the Wage and Hour Commis-
42 sion to the Wage and Hour Commission or an officer or employee of the commission are
43 considered to be references to the Bureau of Labor and Industries or an officer or employee
44 of the bureau.

REFERENCES

SECTION 7. Whenever, in any uncodified law or resolution of the Legislative Assembly or in any rule, document, record or proceeding authorized by the Legislative Assembly, reference is made to the Wage and Hour Commission or an officer or employee of the commission, the reference is considered to be a reference to the Bureau of Labor and Industries or an officer or employee of the bureau.

NAME CHANGE

SECTION 8. For the purpose of harmonizing and clarifying statute sections published in Oregon Revised Statutes, the Legislative Counsel may substitute for words designating the “Wage and Hour Commission” or its officers, wherever they occur in Oregon Revised Statutes, words designating the “Bureau of Labor and Industries” or its officers.

The [*commission*] **bureau** may require [*that*] **the business to produce** the annual employment certificates and lists of minors employed [*in such factories, workshops, or mercantile establishments, shall be produced for their*] **for** inspection.

(2) The [*commission*] **bureau** shall bring complaints for offenses under ORS 653.310, 653.315, 653.320 and 653.340 to the attention of the proper district attorney who shall prosecute such offenses.

 7 or public or private works, [shall] **may not** refuse to allow an inspector or employee of the Bureau
 8 of Labor and Industries to enter.
