9	"(b) A certified registered nurse anesthetist may prescribe prescription drugs under
10	paragraph (a) of this subsection only:
11	"(A) For a supply of not more than 10 days with no refills; and
12	"(B) For an individual for whom the certified registered nurse anesthetist has, at the
13	time of the prescription, established a client or patient record.
14	"(2) For the purpose of authorizing certified registered nurse anesthetists to prescribe
15	prescription drugs, the board shall adopt rules establishing:
16	"(a) That the scope of practice of a certified registered nurse anesthetist includes the
17	authority to prescribe prescription drugs.
18	"(b) Educational requirements for certified registered nurse anesthetists applying for the
19	authority to prescribe prescription drugs. Educational requirements adopted under this sub-
20	section must include:
21	"(A) At least 45 contact hours in pharmacology; and
22	"(B) Clinical education in pharmacotherapeutics, including management of patients that
23	is congruent with the specialty role sought.
24	"(c) The form and manner of applying for and renewing the authority to prescribe pre-
25	scription drugs.
26	"(d) Application and renewal fees.
27	"(e) Record keeping requirements for certified registered nurse anesthetists who pre-
28	scribe prescription drugs that are the same as the record keeping requirements for phar-
29	macies licensed under ORS chapter 689.
30	"(3) In accordance with ORS chapter 183, the board may deny, suspend or revoke the
31	authority to prescribe prescription drugs under this section if the board finds that a certified

"SECTION 3. Nothing in section 2 of this 2013 Act affects the authority of a certified registered nurse anesthetist, as defined in ORS 678.245, to select, order and administer con-

trolled substances in connection with the delivery of anesthesia services. A certified regis-
