SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes liability of candidate's treasurer for default or violation that occurs in performance of certain duties. Requires Secretary of State to send notice of civil penalty for failure to file campaign finance statements only to candidate. Removes requirement for periodic examination and investigation of randomly selected campaign finance statements.

Removes requirement to file statement of expenditure deficit.

Requires political committee or petition committee that expects neither aggregate contributions nor aggregate expenditures to exceed \$3,500 to file certificate with Secretary of State.

Removes requirement that candidate file statement or affidavit for contributions from out-of-state political committees upon request.

[Removes requirement that certain corporations file reports regarding shareholders.]

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 260.005 is amended to read:

7 260.005. As used in this chapter:

8 (1)(a) "Candidate" means:

9 (A) An individual whose name is printed on a ballot, for whom a declaration of candidacy,
10 nominating petition or certificate of nomination to public office has been filed or whose name is
11 expected to be or has been presented, with the individual's consent, for nomination or election to
12 public office;

13 (B) An individual who has solicited or received and accepted a contribution, made an expendi-
14 ture, or given consent to an individual, organization, political party or political committee to solicit
15 or receive and accept a contribution or make an expenditure on the individual's behalf to secure
16 nomination or election to any public office at any time, whether or not the office for which the in-
17 dividual will seek nomination or election is known when the solicitation is made, the contribution
18 is received and retained or the expenditure is made, and whether or not the name of the individual
19 is printed on a ballot; or

20 (C) A public office holder against whom a recall petition has been completed and filed.

21 (b) For purposes of this section and ORS 260.035 to 260.156, "candidate" does not include a
22 candidate for the office of precinct committeeperson.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted.
New sections are in **boldfaced** type.

1 (2) "Committee director" means any person who directly and substantially participates in
2 decision-making on behalf of a political committee concerning the solicitation or expenditure of
3 funds and the support of or opposition to candidates or measures. The officers of a political party
4 shall be considered the directors of any political party committee of that party, unless otherwise
5 provided in the party's bylaws.

6 (3) Except as provided in ORS 260.007, "contribute" or "contribution" includes:

7 (a) The payment, loan, gift, forgiving of indebtedness, or furnishing without equivalent compen-
8 sation or consideration, of money, services other than personal services for which no compensation
9 is asked or given, supplies, equipment or any other thing of value:

10 (A) For the purpose of influencing an election for public office or an election on a measure, or
11 of reducing the debt of a candidate for nomination or election to public office or the debt of a pol-
12 itical committee; or

13 (B) To or on behalf of a candidate, political committee or measure;

14 (b) Any unfulfilled pledge, subscription, agreement or promise, whether or not legally enforcea-
15 ble, to make a contribution; and

16 (c) The excess value of a contribution made for compensation or consideration of less than
17 equivalent value.

18 (4) "Controlled committee" means a political committee that, in connection with the making of
19 contributions or expenditures:

20 (a) Is controlled directly or indirectly by a candidate or a controlled committee; or

21 (b) Acts jointly with a candidate or controlled committee.

22 (5) "Controlled directly or indirectly by a candidate" means:

23 (a) The candidate, the candidate's agent, a member of the candidate's immediate family or any
24 other political committee that the candidate controls has a significant influence on the actions or
25 decisions of the political committee; or

26 (b) The candidate's principal campaign committee and the political committee both have the
27 candidate or a member of the candidate's immediate family as a treasurer or director.

28 (6) "County clerk" means the county clerk or the county official in charge of elections.

29 (7) "Elector" means an individual qualified to vote under section 2, Article II of the Oregon
30 Constitution.

31 (8) Except as provided in ORS 260.007, "expend" or "expenditure" includes the payment or fur-
32 nishing of money or anything of value or the incurring or repayment of indebtedness or obligation
33 by or on behalf of a candidate, political committee or person in consideration for any services,
34 supplies, equipment or other thing of value performed or furnished for any reason, including support
35 of or opposition to a candidate, political committee or measure, or for reducing the debt of a can-
36 didate for nomination or election to public office. "Expenditure" also includes contributions made
37 by a candidate or political committee to or on behalf of any other candidate or political committee.

38 (9) "Filing officer" means:

39 (a) The Secretary of State:

40 (A) Regarding a candidate for public office;

41 (B) Regarding a statement required to be filed under ORS 260.118;

42 (C) Regarding any measure; or

43 (D) Regarding any political committee.

44 (b) In the case of an irrigation district formed under ORS chapter 545, "filing officer" means:

45 (A) The county clerk, regarding any candidate for office or any measure at an irrigation district

1 formation election where the proposed district is situated wholly in one county;

2 (B) The county clerk of the county in which the office of the secretary of the proposed irrigation
3 district will be located, regarding any candidate for office or any measure at an irrigation district
4 formation election where the proposed district is situated in more than one county; or

5 (C) The secretary of the irrigation district for any election other than an irrigation district
6 formation election.

7 (10) "Independent expenditure" means an expenditure by a person for a communication in sup-
8 port of or in opposition to a clearly identified candidate or measure that is not made with the co-
9 operation or with the prior consent of, or in consultation with, or at the request or suggestion of,
10 a candidate or any agent or authorized committee of the candidate, or any political committee or
11 agent of a political committee supporting or opposing a measure. For purposes of this subsection:

12 (a) "Agent" means any person who has:

13 (A) Actual oral or written authority, either express or implied, to make or to authorize the
14 making of expenditures on behalf of a candidate or on behalf of a political committee supporting or
15 opposing a measure; or

16 (B) Been placed in a position within the campaign organization where it would reasonably ap-
17 pear that in the ordinary course of campaign-related activities the person may authorize expen-
18 ditures.

19 (b)(A) "Clearly identified" means, with respect to candidates:

20 (i) The name of the candidate involved appears;

21 (ii) A photograph or drawing of the candidate appears; or

22 (iii) The identity of the candidate is apparent by unambiguous reference.

23 (B) "Clearly identified" means, with respect to measures:

24 (i) The ballot number of the measure appears;

25 (ii) A description of the measure's subject or effect appears; or

26 (iii) The identity of the measure is apparent by unambiguous reference.

27 (c) "Communication in support of or in opposition to a clearly identified candidate or measure"
28 means:

29 (A) The communication, taken in its context, clearly and unambiguously urges the election or
30 defeat of a clearly identified candidate for nomination or election to public office, or the passage
31 or defeat of a clearly identified measure;

32 (B) The communication, as a whole, seeks action rather than simply conveying information; and

33 (C) It is clear what action the communication advocates.

34 (d) "Made with the cooperation or with the prior consent of, or in consultation with, or at the
35 request or suggestion of, a candidate or any agent or authorized committee of the candidate, or any
36 political committee or agent of a political committee supporting or opposing a measure":

37 (A) Means any arrangement, coordination or direction by the candidate or the candidate's agent,
38 or by any political committee or agent of a political committee supporting or opposing a measure,
39 prior to the publication, distribution, display or broadcast of the communication. An expenditure
40 shall be presumed to be so made when it is:

41 (i) Based on information about the plans, projects or needs of the candidate, or of the political
42 committee supporting or opposing a measure, and provided to the expending person by the candidate
43 or by the candidate's agent, or by any political committee or agent of a political committee sup-
44 porting or opposing a measure, with a view toward having an expenditure made; or

45 (ii) Made by or through any person who is or has been authorized to raise or expend funds, who

1 is or has been an officer of a political committee authorized by the candidate or by a political
2 committee or agent of a political committee supporting or opposing a measure, or who is or has been
3 receiving any form of compensation or reimbursement from the candidate, the candidate's principal
4 campaign committee or agent or from any political committee or agent of a political committee
5 supporting or opposing a measure.

6 (B) Does not mean providing to the expending person upon request a copy of this chapter or any
7 rules adopted by the Secretary of State relating to independent expenditures.

8 (11) "Initiative petition" means a petition to initiate a measure for which a prospective petition
9 has been filed but that is not yet a measure.

10 (12) "Judge" means judge of the Supreme Court, Court of Appeals, circuit court or the Oregon
11 Tax Court.

12 (13) "Mass mailing" means more than 200 substantially similar pieces of mail, but does not in-
13 clude a form letter or other mail that is sent in response to an unsolicited request, letter or other
14 inquiry.

15 (14) "Measure" includes any of the following submitted to the people for their approval or re-
16 jection at an election:

17 (a) A proposed law.

18 (b) An Act or part of an Act of the Legislative Assembly.

19 (c) A revision of or amendment to the Oregon Constitution.

20 (d) Local, special or municipal legislation.

21 (e) A proposition or question.

22 (15) "Occupation" means:

23 (a) The nature of an individual's principal business; and

24 (b) If the individual is employed by another person, the business name and address, by city and
25 state, of the employer.

26 (16) "Person" means an individual, corporation, limited liability company, labor organization,
27 association, firm, partnership, joint stock company, club, organization or other combination of indi-
28 viduals having collective capacity.

29 (17) "Petition committee" means an initiative, referendum or recall petition committee organized
30 under ORS 260.118.

31 (18) "Political committee" means a combination of two or more individuals, or a person other
32 than an individual, that has:

33 (a) Received a contribution for the purpose of supporting or opposing a candidate, measure or
34 political party; or

35 (b) Made an expenditure for the purpose of supporting or opposing a candidate, measure or
36 political party. For purposes of this paragraph, an expenditure does not include:

37 (A) A contribution to a candidate or political committee that is required to report the contri-
38 bution on a statement filed under ORS 260.057[,] **or** 260.076 [*or 260.102*] or a certificate filed under
39 ORS 260.112; or

40 (B) An independent expenditure for which a statement is required to be filed by a person under
41 ORS 260.044.

42 (19) "Public office" means any national, state, county, district, city office or position, except a
43 political party office, that is filled by the electors.

44 (20) "Recall petition" means a petition to recall a public officer for which a prospective petition
45 has been filed but that is not yet a measure.

1 (21) "Referendum petition" means a petition to refer a measure for which a prospective petition
2 has been filed but that is not yet a measure.

3 (22) "Regular district election" means the regular district election described in ORS 255.335.

4 (23) "State office" means the office of Governor, Secretary of State, State Treasurer, Attorney
5 General, Commissioner of the Bureau of Labor and Industries, state Senator, state Representative,
6 judge or district attorney.

7 **SECTION 2.** ORS 260.037 is amended to read:

8 260.037. [(1) A candidate may serve as the candidate's own treasurer or may appoint and certify
9 to the filing officer the name and address of a treasurer.]

10 [(2) A candidate's treasurer shall perform all the duties prescribed for the candidate under ORS
11 260.005 and 260.035 to 260.156.]

12 [(3)] The candidate[, in addition to the treasurer,] is personally responsible for the performance
13 of the duties referred to in [subsection (2) of this section] **ORS 260.035 (2)**. Any default or violation
14 by the treasurer shall be conclusively considered a default or violation by the candidate. Any default
15 or violation by the [person] **individual** designated by the candidate or treasurer under ORS 260.039,
16 260.042 or 260.057 is conclusively considered a default or violation by the candidate [or treasurer].

17 **SECTION 3.** ORS 260.044 is amended to read:

18 260.044. (1) A person shall file a statement of independent expenditures if the person makes in-
19 dependent expenditures in a total amount of more than \$750 in a calendar year. The statement shall
20 be filed with the Secretary of State.

21 (2) A statement described in subsection (1) of this section shall be filed not later than seven
22 calendar days after the total amount of independent expenditures exceeds \$750 in a calendar year.
23 The accounting period for the statement required by subsection (1) of this section begins on the date
24 that an independent expenditure is made. The statement shall specify the candidate or measure
25 supported or opposed by the independent expenditure. The secretary by rule shall prescribe the form
26 of the statement.

27 (3) Notwithstanding ORS 260.005 (18), a person who solicits and receives a contribution or con-
28 tributions is a political committee and shall file a statement of organization under ORS 260.042 and
29 the statements required by ORS 260.057 or 260.076.

30 (4) For purposes of this section:

31 (a) An independent expenditure does not include a contribution to a candidate or political
32 committee that is required to report the contribution on a statement filed under ORS 260.057[,] **or**
33 260.076 [or 260.102] or a certificate filed under ORS 260.112;

34 (b) An independent expenditure does not include a contribution to a candidate who is not re-
35 quired to file a statement of organization under ORS 260.043; and

36 (c) A person is not a political committee under subsection (3) of this section if all contributions
37 received by the person are:

38 (A) Designated to an identified candidate or political committee;

39 (B) Delivered by the person to the designated candidate or political committee not later than
40 seven business days after the contribution is received; and

41 (C) Required to be reported as contributions by a candidate or political committee on a state-
42 ment filed under ORS 260.057[,] **or** 260.076 [or 260.102] or a certificate filed under ORS 260.112.

43 **SECTION 4.** ORS 260.055 is amended to read:

44 260.055. (1) Each candidate, other than a candidate for political party office, the treasurer of
45 each political committee and the treasurer of each petition committee shall keep detailed accounts.

1 The accounts shall be current as of not later than the seventh calendar day after the date of re-
 2 ceiving a contribution or making an expenditure with respect to all contributions received and all
 3 expenditures made by or on behalf of the candidate or committee that are required to be reported
 4 under ORS 260.057, 260.076 or 260.078. Subject to ORS 260.085, the accounts shall list all information
 5 required to be reported under ORS 260.083.

6 (2) Accounts kept by a candidate or the treasurer of a political committee may be inspected
 7 under reasonable circumstances at any time before the election to which the accounts refer or
 8 during the period specified for retention of the accounts under subsection (3) of this section by any
 9 opposing candidate or the treasurer of any political committee for the same electoral contest. The
 10 right of inspection may be enforced by writ of mandamus issued by any court of competent juris-
 11 diction. The treasurers of political committees supporting a candidate may be joined with the can-
 12 didate as defendants in a mandamus proceeding.

13 (3) Accounts kept by a candidate or treasurer shall be preserved by the candidate or treasurer
 14 for at least two years after the date the statement of the contribution or expenditure is filed under
 15 ORS 260.057.

16 *[(4)(a) If a candidate, political committee or petition committee intends to discontinue the statement
 17 of organization of the candidate or committee and close accounts, the candidate or committee shall file
 18 with the Secretary of State a notice of intent. Upon receipt of the notice, the secretary shall examine
 19 each statement filed by the candidate or committee under ORS 260.044, 260.057, 260.083, 260.102,
 20 260.112 or 260.118 to determine whether the statement is sufficient.]*

21 *[(b) Not later than 90 days after receipt of the notice of intent, the secretary shall notify the can-
 22 didate, political committee or petition committee that the statements are sufficient or that a statement
 23 is insufficient or otherwise may violate a law or rule. The notice shall include a description of the
 24 provisions of ORS 260.407.]*

25 *[(c) If, after a candidate, political committee or petition committee files a notice of intent to dis-
 26 continue the statement of organization of the candidate or committee and close accounts, the candidate
 27 or committee files an additional statement under ORS 260.044, 260.057, 260.083, 260.102, 260.112 or
 28 260.118, the secretary has 90 days following the date the additional statement is filed to examine the
 29 statement and send a notification described in paragraph (b) of this subsection.]*

30 *[(d) When a candidate, political committee or petition committee files the last statement under ORS
 31 260.057, the secretary shall conduct a final review. If the secretary determines that all statements filed
 32 are sufficient, the secretary shall notify the candidate, political committee or petition committee. Upon
 33 receipt of the notice, the candidate or committee may discontinue the statement of organization of the
 34 candidate, political committee or petition committee and close accounts.]*

35 **SECTION 5.** ORS 260.057 is amended to read:

36 260.057. (1) The Secretary of State by rule shall adopt an electronic filing system to be used by:

37 (a) All candidates and political committees to file with the secretary statements of contributions
 38 received and expenditures made by the candidates and political committees, as described in ORS
 39 260.083.

40 (b) Treasurers of a petition committee organized under ORS 260.118 to file with the secretary
 41 statements of contributions received and expenditures made by the treasurers *[and]* **or** chief
 42 petitioners as described in ORS 260.083.

43 (2)(a) A candidate for nomination or election at any primary or general election or a political
 44 committee supporting or opposing a candidate or measure at any primary or general election shall
 45 file a statement described in subsection (1) of this section not later than seven calendar days after

1 a contribution is received or an expenditure is made. This paragraph applies to contributions re-
2 ceived and expenditures made during the period beginning on the 42nd calendar day before the date
3 of any primary election and ending on the date of the primary election and the period beginning on
4 the 42nd calendar day before the date of any general election and ending on the date of the general
5 election.

6 (b) For any special election, the secretary by rule may establish a period during which a candi-
7 dicate for nomination or election at the special election or a political committee supporting or op-
8 posing a candidate or measure at the special election must file a statement described in subsection
9 (1) of this section not later than seven calendar days after a contribution is received or an expend-
10 iture is made.

11 (3) Except as provided in subsection (4) of this section, during a period not described in sub-
12 section (2) of this section, a candidate or political committee shall file a statement described in
13 subsection (1) of this section not later than 30 calendar days after a contribution is received or an
14 expenditure is made.

15 (4)(a) If a candidate for nomination or election at any primary election or a political committee
16 supporting or opposing a candidate or measure at any primary election receives a contribution or
17 makes an expenditure prior to the 42nd calendar day before the date of the primary election and the
18 candidate or political committee has not filed a statement of the contribution or expenditure under
19 subsection (3) of this section by the 43rd calendar day before the date of the primary election, the
20 candidate or political committee shall file a statement described in subsection (1) of this section not
21 later than the 35th calendar day before the date of the primary election.

22 (b) If a candidate for nomination or election at any general election or a political committee
23 supporting or opposing a candidate or measure at any general election receives a contribution or
24 makes an expenditure prior to the 42nd calendar day before the date of the general election and the
25 candidate or political committee has not filed a statement of the contribution or expenditure under
26 subsection (3) of this section by the 43rd calendar day before the date of the general election, the
27 candidate or political committee shall file a statement described in subsection (1) of this section not
28 later than the 35th calendar day before the date of the general election.

29 (5) The electronic filing system shall be provided free of charge by the secretary and:

30 (a) Accept electronic files that conform to the format prescribed by the secretary by rule; or

31 (b) Be compatible with any other electronic filing application provided or approved by the sec-
32 retary.

33 (6)(a) Except as provided in paragraph (b) of this subsection, the secretary shall make all data
34 filed electronically under this section and ORS 260.118 and all information filed with the secretary
35 under ORS [260.045,] 260.049[,] **or** 260.085 [or 260.102] available on the Internet to the public free
36 of charge according to a schedule adopted by the secretary by rule. The secretary shall make the
37 data available in a searchable database that is easily accessible by the public. When the secretary
38 makes data or information available on the Internet under this subsection, the secretary shall dis-
39 play any contribution received from a person or political committee with an out-of-state address in
40 a different colored font than a contribution received from a person or political committee with an
41 in-state address.

42 (b) The secretary may not make data that are filed electronically under this section or ORS
43 260.118 available to the public under this section, unless the data are required to be listed under
44 ORS 260.083. The secretary may not disclose under ORS 192.410 to 192.505 any data that are filed
45 electronically under this section or ORS 260.118, unless the data are required to be listed under ORS

1 260.083.

2 (7)(a) Except as provided in paragraph (b) of this subsection, each statement required by this
3 section shall be signed and certified as true by the candidate or treasurer required to file it. Sig-
4 natures shall be supplied in the manner specified by the secretary by rule.

5 (b) A candidate or treasurer may designate an individual to sign and certify as true a statement
6 required by this section. The designation must be filed in writing with the secretary and must be
7 renewed for each two-year period beginning January 1 of an even-numbered year.

8 (8) This section does not apply to:

9 (a) Candidates for federal office;

10 (b) Candidates who are not required to file a statement of organization under ORS 260.043; or

11 (c) Candidates, political committees or petition committees that file certificates under ORS
12 260.112.

13 **SECTION 6.** ORS 260.076 is amended to read:

14 260.076. (1) A legislative official, statewide official or candidate therefor, or the official's or
15 candidate's principal campaign committee, shall file statements showing contributions received by
16 or on behalf of the official, candidate or committee during the period beginning January 1 and end-
17 ing upon adjournment of the regular session of the Legislative Assembly, or during any special
18 session of the Legislative Assembly.

19 (2) The Governor, Governor-elect or a candidate for Governor, or the principal campaign com-
20 mittee of the Governor, Governor-elect or candidate, shall file statements showing contributions re-
21 ceived by or on behalf of the Governor, Governor-elect, candidate or committee during the period
22 beginning January 1 and ending 30 business days following adjournment of the regular session of the
23 Legislative Assembly, or during any special session of the Legislative Assembly.

24 (3) A person or political committee affiliated with a political party, caucus of either house of the
25 Legislative Assembly, legislative official, statewide official or the Governor, Governor-elect or can-
26 didate for Governor shall file statements showing contributions received by the person or committee
27 on behalf of a legislative official, statewide official or candidate therefor, during the period begin-
28 ning January 1 and ending upon adjournment of the regular session of the Legislative Assembly, or
29 during any special session of the Legislative Assembly.

30 (4) A person or political committee affiliated with a political party, caucus of either house of the
31 Legislative Assembly, legislative official, statewide official or the Governor, Governor-elect or can-
32 didate for Governor shall file statements showing contributions received by the person or committee
33 on behalf of the Governor, Governor-elect or candidate for Governor, during the period beginning
34 January 1 and ending 30 business days following adjournment of the regular session of the Legisla-
35 tive Assembly, or during any special session of the Legislative Assembly.

36 (5) A statement described in subsections (1) to (4) of this section shall be filed with the Secretary
37 of State on a form prescribed by the secretary. For contributions received during the period begin-
38 ning on January 1 and ending on the first day of the regular session, a statement shall be filed not
39 later than two business days after the first day of the regular session. For contributions received
40 on or after the first day of the regular session, a statement shall be filed not later than two business
41 days after the date a contribution is received. For contributions received during any special session
42 of the Legislative Assembly, a statement shall be filed not later than two business days after the
43 date a contribution is received.

44 [(6) If a statement has been filed under subsections (1) to (4) of this section, the next statement filed
45 by the Governor, Governor-elect, official, candidate, principal campaign committee or other political

1 *committee under ORS 260.057 shall include the contributions reported in statements filed under this*
2 *section.]*

3 *[(7) This section applies notwithstanding the filing of a certificate under ORS 260.112.]*

4 [(8)] (6) As used in this section:

5 (a) "Legislative official" means any member or member-elect of the Legislative Assembly.

6 (b) "Statewide official" means the Secretary of State or Secretary of State-elect, State Treasurer
7 or State Treasurer-elect, Attorney General or Attorney General-elect and the Commissioner of the
8 Bureau of Labor and Industries or the Commissioner-elect of the Bureau of Labor and Industries.

9 **SECTION 7.** ORS 260.112 is amended to read:

10 260.112. (1)(a) A candidate or a treasurer of a political committee who expects neither the ag-
11 gregate contributions to be received nor the aggregate expenditures to be made by or on behalf of
12 the candidate or political committee to exceed [~~\$3,000~~] **\$3,500** in total amount during the calendar
13 year shall file a certificate to that effect with the Secretary of State. The candidate or treasurer
14 shall make the certificate according to the best of the knowledge or belief of the candidate or
15 treasurer. A candidate or treasurer filing a certificate under this section is not required to file
16 statements under ORS 260.057.

17 (b) A treasurer of a petition committee organized under ORS 260.118 who expects neither the
18 aggregate contributions to be received nor the aggregate expenditures to be made by a chief
19 petitioner or the treasurer to exceed [~~\$3,000~~] **\$3,500** in total amount during the calendar year shall
20 file a certificate to that effect with the Secretary of State. The treasurer shall make the certificate
21 according to the best of the knowledge or belief of the treasurer. A treasurer filing a certificate
22 under this section is not required to file statements under ORS 260.118.

23 (2) A certificate described in subsection (1) of this section shall be filed:

24 (a) By a candidate, not sooner than the date [*on which*] **that** the candidate [*files a declaration*
25 *of candidacy or nominating petition, accepts a nomination or is nominated to fill a vacancy in a nom-*
26 *ination or in a partisan elective office,*] **files a statement of organization under ORS 260.039**, and
27 not later than seven calendar days after the candidate receives a contribution or makes an ex-
28 penditure.

29 (b) By a treasurer of a political committee, not sooner than the date that the political committee
30 files a statement of organization under ORS 260.042, and not later than seven calendar days after
31 the political committee receives a contribution or makes an expenditure.

32 (c) By a treasurer of a petition committee, not sooner than the date that [*a chief petitioner or*
33 *the treasurer*] **the petition committee** files a statement of organization under ORS 260.118, and not
34 later than seven calendar days after [*a chief petitioner or the treasurer*] **the petition committee**
35 receives a contribution or makes an expenditure.

36 (3) A candidate, political committee or petition committee under this section must keep contri-
37 bution and expenditure records during the calendar year.

38 (4) If at any time following the filing of a certificate under this section and during the calendar
39 year either the aggregate contributions or aggregate expenditures exceed [~~\$3,000~~] **\$3,500**, the can-
40 didate or treasurer shall do all of the following:

41 (a) File a statement under ORS 260.057 or 260.118 within seven calendar days after either the
42 aggregate contributions or aggregate expenditures exceed [~~\$3,000~~] **\$3,500**. The statement must reflect
43 all contributions received and expenditures made by or on behalf of the candidate, political com-

2 (6) As used in this section, "contribution" and "expenditure" include a contribution or expendi-
3 ture to or on behalf of an initiative, referendum or recall petition.

5 260.205. (1) A filing officer shall inspect each statement filed under ORS 260.057, 260.083,
6 [260.102,] 260.112 or 260.118 not later than the 10th business day after the filing deadline or the 10th

8 (2) A filing officer immediately shall notify a person required to file a statement with the filing
