SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires that construction contractor license application filed by limited partnership include name and address of certain limited partnership members. Requires reporting changes in names and addresses of certain limited partnership members. Deletes redundant disclosure requirement.

Creates residential locksmith services contractor license, *[and]* home inspector services contractor license **and home services contractor license**. Imposes bond, insurance and responsible managing individual requirements for requirements for residential locksmith services contractor and home inspector services contractor. **Imposes bond and insurance requirements for home services contractor**. Exempts residential locksmith services contractor, *[and]* home inspector services contractor **and home services contractor** from residential contractor continuing education requirement.

Provides that independent contractor utilizing one or more workers supplied by worker leasing company is licensed in nonexempt construction contractor class. Provides for sanctions against construction contractor licensed in exempt class that utilizes one or more workers supplied by worker leasing company.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 701.046 is amended to read:

6 701.046. (1) Except as provided in subsection (2) of this section, an applicant for a construction
7 contractor license must submit the application on a form prescribed by the Construction Contractors
8 Board. The application shall include, but not be limited to, the following information:

9 (a) The endorsement being sought.

10 (b) A list of construction debts involving the applicant, or an owner or officer of the applicant,
11 if the order, award, penalty or judgment that establishes the debt was issued within the preceding
12 five years.

13 (c) For each person described in paragraphs (h), *[and]* (i) **and (j)** of this subsection, a Social
14 Security number.

15 (d) Workers' compensation insurance account number, if the applicant is required to have
16 workers' compensation insurance.

17 (e) Unemployment insurance account number, if the applicant is required to have unemployment
18 insurance.

19 (f) State withholding tax account number, if the applicant is required to withhold state income

6 years preceding the application date that requires the person to pay money to another person or to
7 a public body if the order remains unsatisfied on the application date.

8 (C) A court action against the person in any state pending on the application date that alleges
9 the person owes money to another person or to a public body.

10 (D) An action by an administrative agency in any state pending on the application date that
11 seeks an order that the person pay money to another person or to a public body.

12 (E) A conviction for a crime listed in ORS 701.098 (1)(i) entered within five years preceding the
13 application date.

14 (F) An indictment for a crime listed in ORS 701.098 (1)(i) filed within five years preceding the

17 under ORS 670.600.

18 (2) Subsection (1)(h), [and] (i) **and (j)** of this section does not apply if the applicant is a company
19 that offers securities registered with the United States Securities and Exchange Commission for sale
20 to the general public.

21 (3) The application described in subsection (1) of this section must be accompanied by proof
22 satisfactory to the board that the applicant:

23 (a) Is in compliance with ORS 701.091.

24 (b) Has the legal capacity to enter into contracts.

25 (4) Subsection (3)(a) of this section does not apply to an applicant for licensing with endorsement
26 solely as a residential or commercial developer.

27 (5) An applicant shall conform to the information provided by the applicant on the application
28 and to the terms of the application.

29 **SECTION 2.** ORS 701.114 is amended to read:

30 701.114. (1) Except as provided in this subsection, a contractor licensed under this chapter shall
31 immediately notify the Construction Contractors Board of any change in the identity, name or ad-
32 dress of a person who holds a position with the contractor that is described in ORS 701.046 (1)(h),
33 [or] (i) **or (j)** or of a responsible managing individual for the contractor as defined in ORS 701.091.
34 A contractor described in ORS 701.046 (2) is not required to report a change in the identity, name
35 or address of a person described in ORS 701.046 (1)(h), [or] (i) **or (j)**.

36 (2) Except as provided in this subsection, if a partner or joint venturer departs from a contrac-
37 tor that is a partnership or joint venture, the contractor must obtain a new license before continu-
38 ing to conduct activities that require a license under this chapter. A contractor described in ORS
39 701.046 (2) that is a partnership or joint venture is not required to obtain a new license upon de-
40 parture of a partner or joint venturer.

43 **SECTION 4.** (1) A residential locksmith services contractor license authorizes the holder
44 to operate a business providing the services of locksmiths as defined in ORS 701.475 for res-
45 idential or small commercial structures, but does not authorize the holder to engage in other

1 contractor activities.

2 (2) Notwithstanding ORS 701.126, the Construction Contractors Board may not impose a
3 continuing education requirement for a residential locksmith services contractor. This sub-
4 section does not exempt a responsible managing individual for the business from compliance
5 with any continuing education requirements established by the board under ORS 701.485 for
6 a certified locksmith.

7 (3) Notwithstanding ORS 701.122, the board may not require a residential locksmith ser-
8 vices contractor or the responsible managing individual for the business to take a test
9 measuring the knowledge of the contractor or responsible managing individual regarding
10 business practices and laws affecting construction contractors.

11 **SECTION 5.** (1) A home inspector services contractor license authorizes the holder to
12 operate a business providing the services of home inspectors as defined in ORS 701.005, but
13 does not authorize the holder to engage in other contractor activities.

14 (2) Notwithstanding ORS 701.126, the Construction Contractors Board may not impose a
15 continuing education requirement for a home inspector services contractor. This subsection
16 does not exempt a responsible managing individual for the business from compliance with
17 any continuing education requirements established by the board under ORS 701.350 for a
18 certified home inspector.

19 (3) Notwithstanding ORS 701.122, the board may not require a home inspector services
20 contractor or the responsible managing individual for the business to take a test measuring
21 the knowledge of the contractor or responsible managing individual regarding business
22 practices and laws affecting construction contractors.

23 **SECTION 5a.** (1) As used in this section, “home” and “home service agreement” have the
24 meanings given those terms in ORS 731.164.

25 (2) A home services contractor license authorizes the holder to operate a business pro-
26 viding service, repair or replacement for homes through a licensed contractor under a home
27 service agreement.

28 (3) Notwithstanding ORS 701.126, the Construction Contractors Board may not impose a
29 continuing education requirement for a home services contractor.

30 (4) Notwithstanding ORS 701.122, the board may not require a home services contractor
31 to take a test measuring the knowledge of the contractor or responsible managing individual
32 regarding business practices and laws affecting construction contractors.
