SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes State Board of Examiners for Engineering and Land Surveying to suspend, revoke or refuse to issue, restore or renew certificate or permit, or to issue reprimand, for failing to pay civil penalty or fee in manner prescribed by board or for failing to meet any other term of final order of board.

2 Relating to the State Board of Examiners for Engineering and Land Surveying; creating new pro-
3 visions; amending ORS 672.200; and repealing 672.205.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 672.200 is amended to read:

6 672.200. The State Board of Examiners for Engineering and Land Surveying may **suspend, re-**
7 **voke or** refuse to issue, restore or renew[, *or may suspend or revoke*] a certificate or permit, or
8 **may** reprimand [*any*] **an** individual enrolled as an intern or holding a certificate or permit:

9 (1) For [*violation of*] **violating** any provision of ORS 672.045;

10 (2) For gross negligence, negligence or incompetence in the practice of engineering, land sur-
11 veying or photogrammetric mapping;

12 (3) **Subject to ORS 670.280**, for conviction of a felony[, *or*];

13 (4) **For conviction** of a misdemeanor involving the practice of engineering, land surveying or
14 photogrammetric mapping;

15 (5) **For failing to pay a civil penalty or fee in the manner prescribed by a final order of**
16 **the board, or for failing to meet any other term of a final order of the board;** or

17 [*(4)*] (6) For [*any violation of the rules*] **violating a rule** of professional conduct prescribed by
18 the board.

19 **SECTION 2.** The amendments to ORS 672.200 by section 1 of this 2013 Act apply to final
20 orders issued by the State Board of Examiners for Engineering and Land Surveying on or
21 after the effective date of this 2013 Act.

22 **SECTION 3.** ORS 672.205 is repealed.
