SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes references to Eastern Oregon Training Center and references to operation of state training center by Department of Human Services. Prescribes rights of persons with developmental disabilities who are receiving developmental disability services from department. Requires department to promote dispute resolution procedures for individuals receiving developmental disability services. Authorizes department to contract with providers of developmental disability services.

Declares emergency, effective on passage.

12 **Be It Enacted by the People of the State of Oregon:**

13 **SECTION 1. (1) As used in this section:**

14 (a) **“Facility” means any of the following that are licensed or certified by the Department**
15 **of Human Services or that contract with the department for the provision of services:**

16 (A) **A health care facility as defined in ORS 442.015;**

17 (B) **A domiciliary care facility as defined in ORS 443.205;**

18 (C) **A residential facility as defined in ORS 443.400; or**

19 (D) **An adult foster home as defined in ORS 443.705.**

20 (b) **“Person” means an individual who has a developmental disability as defined in ORS**
21 **427.005 and receives services from a program or facility.**

22 (c) **“Program” means a community developmental disabilities program as described in**
23 **ORS 430.662 and agencies with which the department or the program contracts to provide**
24 **services.**

25 (d) **“Service” means a community-based service described in ORS 427.007.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **(2) While receiving developmental disability services, every person shall have the right**
2 **to:**

3 **(a) Be free from abuse or neglect and to report any incident of abuse or neglect without**
4 **being subject to retaliation.**

5 **(b) Be free from seclusion or personal, chemical or mechanical restraints unless an im-**
6 **minent risk of physical harm to the person or others exists and only for as long as the im-**
7 **minent risk continues.**

8 **(c) Not receive services without informed voluntary written consent except in a medical**
9 **emergency or as otherwise permitted by law.**

10 **(d) Not participate in experimentation without informed voluntary written consent.**

11 **(e) A humane environment that affords reasonable privacy and the ability to engage in**
12 **private communications with people of the individual's choosing through personal visits,**
13 **mail, telephone or electronic means.**

14 **(f) Visit with family members, friends, advocates and legal and medical professionals.**

15 **(g) Participate regularly in the community and use community resources.**

16 **(h) Not be required to perform labor, except personal housekeeping duties, without rea-**
17 **sonable and lawful compensation.**

18 **(i) Seek a meaningful life by choosing from available services and enjoying the benefits**
19 **of community involvement and community integration in a manner that is least restrictive**
20 **to the person's liberty considering the person's preferences and age.**

21 **(j) An individualized written service plan, services based upon that plan and periodic re-**
22 **view and reassessment of service needs.**

23 **(k) Ongoing participation in the planning of services, including the right to participate**
24 **in the development and periodic revision of the plan for services, the right to be provided**
25 **with an explanation of all service considerations in a manner that ensures meaningful indi-**
26 **vidual participation and the right to invite others of the person's choosing to participate in**
27 **the plan for services.**

28 **(L) Not be involuntarily terminated or transferred from services without prior notice,**
29 **notification of available sources of necessary continued services and exercise of a grievance**
30 **procedure.**

31 **(m) Be informed at the start of services and annually thereafter of the rights guaranteed**
32 **by this section, the contact information for the protection and advocacy system described in**
33 **ORS 192.517 (1), and the procedures for filing grievances, hearings or appeals if services have**
34 **been or are proposed to be reduced, eliminated or changed.**

35 **(n) Be encouraged and assisted in exercising all legal rights.**

36 **(o) Assert grievances with respect to infringement of the rights described in this section,**
37 **including the right to have such grievances considered in a fair, timely and impartial griev-**
38 **ance procedure without any form of retaliation or punishment.**

39 **(p) Manage the person's own money and financial affairs unless that right has been taken**
40 **away by court order or other legal procedure.**

41 **(q) Keep and use personal property and have a reasonable amount of personal storage**
42 **space.**

43 **(3) The rights described in this section are in addition to, and do not limit, all other**
44 **statutory and constitutional rights that are afforded all citizens including, but not limited**
45 **to, the right to exercise religious freedom, vote, marry, have or not have children, own and**

1 **dispose of property, enter into contracts and execute documents.**

2 (4) **A person who is receiving developmental disability services has the right under ORS**
3 **430.212 to be informed and to have the person’s guardian and any representative designated**
4 **by the person be informed that a family member has contacted the department to determine**
5 **the location of the person, and to be informed of the name and contact information, if**
6 **known, of the family member.**

7 (5) **The rights described in this section may be asserted and exercised by the person, the**
8 **person’s guardian and any representative designated by the person.**

9 (6) **Nothing in this section may be construed to alter any legal rights and responsibilities**
10 **between parent and child.**

11 (7) **The department shall adopt rules concerning the rights described in this section that**
12 **are consistent with the findings and directives set forth in ORS 427.007.**

13 **SECTION 2. The Department of Human Services shall promote dispute resolution proce-**
14 **dures for persons receiving developmental disability services from the department, including**
15 **but not limited to grievance procedures, contested case hearings and mediation. An individ-**
16 **ual who files a grievance may also use other dispute resolution procedures.**

17 **SECTION 3. ORS 427.005 is amended to read:**

18 427.005. As used in this chapter:

19 (1) “Adaptive behavior” means the effectiveness or degree with which an individual meets the
20 standards of personal independence and social responsibility expected for age and cultural group.

21 (2) “Care” means:

22 (a) Supportive services, including, but not limited to, provision of room and board;

23 (b) Supervision;

24 (c) Protection; and

25 (d) Assistance in bathing, dressing, grooming, eating, management of money, transportation or
26 recreation.

27 (3) “Community developmental disabilities program director” means the director of an entity
28 that provides services described in ORS 430.664 to persons with intellectual disabilities or other
29 developmental disabilities.

30 (4) “Developmental disability” means an intellectual disability, autism, cerebral palsy, epilepsy
31 or other neurological condition diagnosed by a qualified professional that:

32 (a) Originates before an individual is 22 years of age, or 18 years of age for an intellectual dis-
33 ability;

34 (b) Originates in and directly affects the brain and is expected to continue indefinitely;

35 (c) Results in a significant impairment in adaptive behavior as measured by a qualified profes-
36 sional;

37 (d) Is not attributed primarily to other conditions including, but not limited to, a mental or
38 emotional disorder, sensory impairment, substance abuse, personality disorder, learning disability
39 or attention deficit hyperactivity disorder; and

40 (e) Requires training and support similar to that required by an individual with an intellectual
41 disability.

42 (5) “Director of the facility” means [*the superintendent of a state training center, or*] the person
43 in charge of care, treatment and training programs at [*other facilities*] **a facility.**

44 (6) “Facility” means a [*state training center, community hospital,*] group home, activity center,
45 [*intermediate care facility,*] community mental health clinic[,], or [*such*] other facility or program [*as*]

1 **that** the Department of Human Services approves to provide necessary services to persons with in-
2 tellectual disabilities or other developmental disabilities.

3 (7) “Incapacitated” means a person is unable, without assistance, to properly manage or take
4 care of personal affairs, **including but not limited to financial and medical decision-making**, or
5 is incapable, without assistance, of self-care.

6 (8) “Independence” means the extent to which persons with intellectual disabilities or other
7 developmental disabilities exert control and choice over their own lives.

8 (9) “Integration” means:

9 (a) Use by persons with intellectual disabilities or other developmental disabilities of the same
10 community resources that are used by and available to other persons;

11 (b) Participation by persons with intellectual disabilities or other developmental disabilities in
12 the same community activities in which persons without disabilities participate, together with reg-
13 ular contact with persons without disabilities; and

14 (c) Residence by persons with intellectual disabilities or other developmental disabilities in
15 homes or in home-like settings that are in proximity to community resources, together with regular
16 contact with persons without disabilities in their community.

17 (10)(a) “Intellectual disability” means significantly subaverage general intellectual functioning,
18 defined as intelligence quotients under 70 as measured by a qualified professional and existing con-
19 currently with significant impairment in adaptive behavior, that is manifested before the individual
20 is 18 years of age.

21 (b) An individual with intelligence quotients of 70 through 75 may be considered to have an in-
22 tellectual disability if there is also significant impairment in adaptive behavior, as diagnosed and
23 measured by a qualified professional.

24 (c) The impairment in adaptive behavior must be directly related to the intellectual disability.

25 (d) Intellectual disability is synonymous with mental retardation.

26 (11) “Intellectual functioning” means functioning as assessed by one or more of the individually
27 administered general intelligence tests developed for the purpose.

28 (12) “Minor” means an unmarried person under 18 years of age.

29 (13) “Physician” means a person licensed by the Oregon Medical Board to practice medicine and
30 surgery.

31 (14) “Productivity” means **regular** engagement in income-producing work, **preferable compet-**
32 **itive employment with supports and accommodations to the extent necessary**, by a person
33 with an intellectual disability or another developmental disability which is measured through im-
34 provements in income level, employment status or job advancement or engagement by a person with
35 an intellectual disability or another developmental disability in work contributing to a household
36 or community.

37 [(15) “Resident” means a person admitted to a state training center either voluntarily or after
38 commitment to the department.]

39 (15) “**Service coordination**” means **person-centered planning, case management, procur-**
40 **ing, coordinating and monitoring of services under an individualized support plan to establish**
41 **desired outcomes, determine needs and identify resources for a person with developmental**
42 **disabilities and advocating for the person.**

43 (16) “Significantly subaverage” means a score on a test of intellectual functioning that is two
44 or more standard deviations below the mean for the test.

45 [(17) “State training center” means any facility that is an intermediate care facility for the mentally

1 *retarded as defined in 42 U.S.C. 1396d(d).]*

2 ~~[(18)]~~ (17) “Training” means:

3 (a) The systematic, planned maintenance, development or enhancement of self-care, social or
4 independent living skills; or

5 (b) The planned sequence of systematic interactions, activities, structured learning situations
6 or education designed to meet each ~~[resident’s]~~ **person’s** specified needs in the areas of physical,
7 emotional, intellectual and social growth.

8 ~~[(19)]~~ (18) “Treatment” means the provision of specific physical, mental, social interventions and
9 therapies *[which]* **that** halt, control or reverse processes that cause, aggravate or complicate mal-
10 functions or dysfunctions.

11 **SECTION 4.** ORS 427.007 is amended to read:

12 427.007. (1) The Legislative Assembly finds and declares that *[a significant number of persons*
13 *with intellectual disabilities or other developmental disabilities currently reside in state-operated hos-*
14 *pitals and training centers or lack needed services simply because appropriate community-based ser-*
15 *vices, including residential facilities, day programs, home care and other support, care and training*
16 *programs, do not exist. The Legislative Assembly further finds that]* families are the major providers
17 of support, care, training and other services to their members with intellectual disabilities or other
18 developmental disabilities who live at home, and many of these families experience exceptionally
19 high financial outlays and extraordinary physical and emotional challenges due to the unavailability
20 of appropriate family support services. Such services pertain to the needs of the person with a dis-
21 ability, the needs of other family members related to their care-giving and nurturing capacity, and
22 specialized needs for environmental accommodation to reduce dependency of the family member with
23 an intellectual disability or another developmental disability. Therefore, the Department of Human
24 Services is directed to facilitate, **provide or contract for** *[the development of]* appropriate
25 community-based services, including family support, residential facilities, day programs, home care
26 and other necessary support, care and training programs, in an orderly and systematic manner. *[The*
27 *role of state-operated hospitals and training centers in Oregon shall be as specialized back-up facilities*
28 *to a primary system of community-based services for persons with intellectual disabilities or other de-*
29 *velopmental disabilities.]*

30 (2) In carrying out the directive in subsection (1) of this section, the department shall develop
31 a biennial plan in conjunction with the budgeting process for review by each Legislative Assembly.
32 In developing this plan, the department shall meet with and consider the input of representatives
33 from the following constituencies: Consumer organizations, parent-family organizations, advocacy
34 organizations, unions representing *[workers in state-operated hospitals and training centers,]* **personal**
35 **support workers and adult foster home providers**, community provider organizations, state and
36 local education officials and community *[mental health departments or]* **developmental disabilities**
37 programs. Such plans shall include, where appropriate:

38 *[(a) Proposals for the decrease in the number of persons with intellectual disabilities or other de-*
39 *velopmental disabilities to be served in state-operated hospitals and training centers at a steady and*
40 *planned rate until such time that the Legislative Assembly shall determine that each person served in*
41 *programs or facilities operated or supported by the department is being served according to the best*
42 *contemporary professional practices in the least restrictive environment, with preference given to the*
43 *community-based setting over the institutional. However, no person shall be moved from any facility*
44 *until a comprehensive assessment of the person’s medical, treatment, training and support service needs*
45 *has been completed, the move determined to be in the person’s best interest and appropriate service*

1 *alternatives procured.]*

2 [(b)] (a) Proposals for the orderly development of community-based services, including family
 3 support, residential facilities, day programs, home care and other necessary support, care and
 4 training programs, to accommodate persons [*coming out of state-operated hospitals and training cen-*
 5 *ters*] **eligible for and needing developmental disability services** and to serve persons already in
 6 the community waiting for services. The proposals [*shall include services developed for persons in the*
 7 *community waiting for services that are at least equal in number to those services developed for those*
 8 *coming out of state-operated hospitals and training centers, and*] shall include services for [*all*] persons
 9 who are leaving the public education system[, *in order to further prevent unnecessary*
 10 *institutionalization of persons with intellectual disabilities or other developmental disabilities*]. Funding
 11 for these services shall be commensurate with individual need. These proposals may include pro-
 12 visions for an array of both publicly and privately operated services and shall include specific im-
 13 plementation plans requiring that new services developed are designed to significantly increase the
 14 independence, productivity and integration into the community of persons with intellectual disabili-
 15 ties or other developmental disabilities.

16 [(c)] (b) Proposals for the location of community-based services for persons with intellectual
 17 disabilities or other developmental disabilities in proximity to family, friends, supportive services
 18 and home communities whenever possible.

19 (3) In further carrying out the directive in subsection (1) of this section, the department shall
 20 develop monitoring and evaluation systems [*which*] **that** ensure competent management, program
 21 quality and cost-effectiveness of community-based services. Such systems shall include, where ap-
 22 propriate:

23 (a) A comprehensive system of [*case management which assures*] **service coordination that**
 24 **ensures** an orderly movement of persons with intellectual disabilities or other developmental disa-
 25 bilities [*from state-operated hospitals and training centers to community-based services, and*] between
 26 community-based service alternatives, and [*assures*] **ensures** an effective system of service delivery
 27 to persons with intellectual disabilities or other developmental disabilities living in the community,
 28 based on individualized planning and close cooperation with consumers, families and guardians.

29 (b) An annual progress assessment of every person with an intellectual disability or another
 30 developmental disability served in programs or facilities operated or supported by the department.
 31 This assessment shall measure the degree to which a family with a member with an intellectual
 32 disability or another developmental disability demonstrates enhanced care-giving and nurturing ca-
 33 pacities, and the degree to which the independence, productivity and integration into the community
 34 of each person with an intellectual disability or another developmental disability has been increased
 35 as a result of receiving such services. The overall results of these assessments shall annually be
 36 aggregated and analyzed for each program or facility operated or supported by the department, and
 37 shall be made available for public inspection and review by the Legislative Assembly.

38 (c) [*The development of*] Specific standards for each component within the array of services[,] for
 39 persons with intellectual disabilities or other developmental disabilities, either operated or sup-
 40 ported by the department [*and assure*], **that ensure** the competent management, program quality
 41 and cost-effectiveness of such services.

42 (4) Subject to available funds, the department shall ensure that each family with a member with
 43 an intellectual disability or another developmental disability has access to family support services,
 44 and that each person with an intellectual disability or another developmental disability living in the
 45 community, including those leaving the public education system, has access to community-based

1 services necessary to enable the person to strive to achieve independence, productivity and inte-
2 gration. Specific services proposed for the person shall be identified in an individual [*habilitation*]
3 **support** plan or in a family support service plan.

4 (5) Subject to available funds, the department shall determine the content of individual [*habili-*
5 *tation*] **support** plans and family support service plans, and the process whereby such plans are de-
6 veloped and updated.

7 [(6) *The department shall establish grievance procedures for mediation of disputes concerning el-*
8 *igibility for or appropriateness of services in individual cases.*]

9 **SECTION 5.** ORS 427.104 is amended to read:

10 427.104. The Department of Human Services, with funds appropriated for that purpose by the
11 legislature, [*shall establish and operate a Developmental Disability Diagnosis and Evaluation Service*
12 *for people with intellectual disabilities or other developmental disabilities. The Developmental Disabil-*
13 *ity Diagnosis and Evaluation Service shall provide all or part of diagnostic evaluations, as defined in*
14 *ORS 427.105, when complete evaluations are not available through community developmental disabili-*
15 *ties programs, and the Developmental Disability Diagnosis and Evaluation Service]* shall:

16 (1) **Contract with each community developmental disabilities program to determine the**
17 **eligibility of individuals to receive developmental disability services;**

18 [(1)] (2) Provide consultation and training to community developmental disabilities programs in
19 [*the development of local diagnosis and evaluation services*] **determining eligibility for develop-**
20 **mental disability services;**

21 [(2)] (3) Develop and periodically revise [*department standards and procedures for diagnosis and*
22 *evaluation*] **rules for determining eligibility for developmental disability** services;

23 [(3)] (4) Coordinate diagnostic evaluations statewide to minimize duplication of tests and exam-
24 inations; **and**

25 [(4) *Approve applications for admission to a state training center;*]

26 [(5) *Provide necessary information to the State Training Center Review Board when a decision of*
27 *the Developmental Disability Diagnosis and Evaluation Service regarding admission to a state training*
28 *center is appealed by the person, the parents or legal guardian of the person;*]

29 [(6)] (5) Provide consultation to appropriate agencies and individuals regarding persons evalu-
30 ated **to receive developmental disability services.**]; *and*]

31 [(7) *Process and coordinate all placements of residents from state training centers.*]

32 **SECTION 6.** ORS 427.105 is amended to read:

33 427.105. (1) Pursuant to rules of the Department of Human Services, a diagnostic evaluation
34 [*shall*] **conducted to determine eligibility for developmental disability services may** include, but
35 **is** not [*be*] limited to, the following:

36 (a) A social history;

37 (b) A psychological evaluation, including an appropriate individual test of intellectual capacity,
38 an academic achievement test, a social development assessment and an adaptive behavior assess-
39 ment; **and**

40 (c) A medical evaluation including, **if practicable**, prenatal, natal, early postnatal and other
41 past and family history.], [*a complete physical examination including tests of visual function, and any*
42 *specialized examinations necessary;*]

43 [(d) *A speech and hearing screening; and*]

44 [(e) *A dental screening.*]

45 (2) The diagnostic evaluation shall also attempt to determine the existence of [*related conditions*

1 *such as*] **a developmental disability, such as an intellectual disability**, epilepsy, cerebral palsy[,]
2 **or** autism, and specific learning disorders and to outline the most appropriate services for the
3 treatment and training of the person, whether those services are immediately available or not.

4 (3) A facility approved by the department to conduct diagnostic evaluations may contract with
5 qualified persons to perform components of the evaluation.

6 **SECTION 7.** ORS 427.215 is amended to read:

7 427.215. For the purposes of ORS [427.061 and] 427.235 to 427.290, a person with an intellectual
8 disability is in need of commitment for residential care, treatment and training if the person is ei-
9 ther:

10 (1) Dangerous to self or others; or

11 (2) Unable to provide for the person's basic personal needs and not receiving care as is neces-
12 sary for the health, safety or habilitation of the person.

13 **SECTION 8.** ORS 427.235 is amended to read:

14 427.235. (1) Any two persons may notify the court having probate jurisdiction for the county or
15 the circuit court, if it is not the probate court but its jurisdiction has been extended to include
16 commitment of a person with an intellectual disability under ORS 3.275, that a person within the
17 county has an intellectual disability and is in need of commitment for residential care, treatment
18 and training. Such notice shall be in writing and sworn to before an officer qualified to administer
19 an oath and shall set forth the facts sufficient to show the need for investigation. The circuit court
20 shall forward notice to the community developmental disabilities program director in the county if
21 it finds the notice sufficient to show the need for investigation. The director or the designee of the
22 director shall immediately investigate to determine whether the person has an intellectual disability
23 and is in need of commitment for residential care, treatment and training. [*However, if the petition*
24 *for commitment is from a state training center, the duties of the community developmental disabilities*
25 *program director under ORS 427.235 to 427.290 shall be the responsibility of the superintendent of the*
26 *state training center or the designee of the superintendent.*]

27 (2) Any person who acts in good faith shall not be held civilly liable for making of the notifi-
28 cation under subsection (1) of this section.

29 (3) Any investigation conducted by the community developmental disabilities program director
30 or the designee of the director under subsection (1) of this section shall commence with an interview
31 or examination of the person alleged to have an intellectual disability, where possible, in the home
32 of the person or other place familiar to the person. Further investigation if warranted shall include
33 a diagnostic evaluation as [*defined*] **described** in ORS 427.105 and may also include interviews with
34 the person's relatives, neighbors, teachers and physician. The investigation shall also determine if
35 any alternatives to commitment are available. The investigator shall also determine and recommend
36 to the court whether the person is incapacitated and in need of a guardian or conservator.

37 (4) The investigation report shall be submitted to the court within 30 days of receipt of notice
38 from the court. A copy of the investigation report and diagnostic evaluation, if any, shall also be
39 made available to the [*Developmental Disability Diagnosis and Evaluation Service*] **Department of**
40 **Human Services** and to the person alleged to have an intellectual disability and, if the person is
41 a minor or incapacitated, to the parents or guardian of the person as soon as possible after its
42 completion but in any case prior to a hearing held under ORS 427.245.

43 (5) Any person conducting an evaluation or investigation under this section shall in no way be
44 held civilly liable for conducting the investigation or performing the diagnostic evaluation.

45 (6) If requested by a person conducting an investigation under this section, a physician who has

1 examined the person alleged to have an intellectual disability may, with patient authorization or in
2 response to a court order, provide any relevant information the physician has regarding the person
3 alleged to have an intellectual disability.

4 **SECTION 9.** ORS 427.290 is amended to read:

5 427.290. After hearing all of the evidence, and reviewing the findings of the investigation and
6 other examiners, the court shall determine whether the person has an intellectual disability and
7 because of the intellectual disability is either dangerous to self or others or is unable to provide for
8 the personal needs of the person and is not receiving care as is necessary for the health, safety or
9 habilitation of the person. If in the opinion of the court the person is not in need of commitment for
10 residential care, treatment and training, the person shall be discharged. If in the opinion of the court
11 the person has, by clear and convincing evidence, an intellectual disability and is in need of com-
12 mitment for residential care, treatment and training, the court may order as follows:

13 (1) If the person can give informed consent and is willing and able to participate in treatment
14 and training on a voluntary basis, and the court finds that the person will do so, the court shall
15 order release of the person and dismiss the case.

16 (2) If a relative, a friend or legal guardian of the person requests that the relative, friend or

45 (p) Employees of the Department of State Lands for the purposes of identifying, locating and

1 publishing lists of taxpayers entitled to unclaimed refunds as required by the provisions of chapter
2 694, Oregon Laws 1993. The information shall be limited to the taxpayer's name, address and the
3 refund amount.

4 (q) In addition to the disclosure allowed under ORS 305.225, state or local law enforcement
5 agencies to assist in the investigation or prosecution of the following criminal activities:

6 (A) Mail theft of a check, in which case the information that may be disclosed shall be limited

8 amount of the check and the date printed on the check.

37 (3)(a) Each officer or employee of the department and each person described or referred to in
38 subsection (2)(a), [(e) to (k)] **(b), (f) to (L)** or (n) to (q) of this section to whom disclosure or access
39 to the tax information is given under subsection (2) of this section or any other provision of state
40 law, prior to beginning employment or the performance of duties involving such disclosure or access,
41 shall be advised in writing of the provisions of ORS 314.835 and 314.991, relating to penalties for the
42 violation of ORS 314.835, and shall as a condition of employment or performance of duties execute
