## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes governing boards for University of Oregon and Portland State University. Vests governing boards with certain duties, rights and powers. Establishes time frame in which Oregon State University may elect to establish governing board.

Establishes time frame in which Oregon State University may elect to establish governing board. Establishes process by which other universities in Oregon University System may [seek to] establish governing boards.

Requires public universities to continue to participate in all shared services until at least July 1, 2014, and listed shared services until at least July 1, 2015.

Establishes Special Committee on [Regional and Technical Universities] University Governance and Operations to make recommendations to Legislative Assembly on [future governance at regional and technical universities and shared services operations among Oregon's public universities] issues of administration within state post-secondary education system and coordination of operations, academic programs and shared services within system.

Establishes Work Group on University Shared Services to assist special committee in making legislative recommendations for shared services among Oregon's public universities. Becomes operative on July 1, 2014.

Declares emergency, effective on passage.

4	Be It Enacted by the People of the State of Oregon:
5	
6	ESTABLISHMENT AND INDEPENDENCE OF GOVERNING BOARDS
7	
8	SECTION 1. (1) The Legislative Assembly finds that the State of Oregon will benefit from
9	having public universities with governing boards that:
10	(a) Provide transparency, public accountability and support for the university.
11	(b) Are close to and closely focused on the individual university.
12	(c) Do not negatively impact public universities that do not have governing boards.
13	(d) Lead to greater access and affordability for Oregon residents and do not disadvantage
14	Oregon students relative to out-of-state students.
15	(e) Act in the best interests of both the university and the State of Oregon as a whole.
16	(f) Promote the academic success of students in support of the mission of all education
17	beyond high school as described in ORS 351.009.
18	(2) The Legislative Assembly also finds that:
19	(a) Even with universities with governing boards, there are economy-of-scale benefits to
20	having a coordinated university system.
21	(b) Even with universities with governing boards, shared services may continue to be
22	shared among universities.
23	(c) Legal title to all real property, whether acquired before or after the creation of a
24	governing board, through state funding, revenue bonds or philanthropy, shall be taken and
25	held in the name of the State of Oregon, acting by and through the governing board.
26	(d) The Legislative Assembly has a responsibility to monitor the success of governing
27	boards at fulfilling their missions, their compacts and the principles stated in this section.
28	SECTION 2. As used in sections 1 to 23 of this 2013 Act:
29	(1) "Governing board" means a governing board established by a university under section
30	3 of this 2013 Act that manages the affairs of the university by exercising and carrying out
31	all of the powers, rights and duties that are expressly conferred upon the board by law, or
32	that are implied by law or are incident to such powers, rights and duties.
33	(2) "State bonds" means "bonds" as defined in ORS 286A.001 that are issued by the State
34	Treasurer.
35	(3) "University with a governing board" means a public university listed in section 3 of
36	this 2013 Act that has established a governing board.
37	SECTION 2a. A university with a governing board is a governmental entity performing
38	governmental functions and exercising governmental powers. A university with a governing
39	board is not considered a unit of local or municipal government or a state agency, board,
40	commission or institution for purposes of state statutes or constitutional provisions.
41	SECTION 2b. (1) A university with a governing board is created to carry out public
42	missions and services in keeping with principles of public accountability and fundamental
43	public policy, guided by the legislative findings in ORS 351.001 and 351.003 and consistent with
44	the goals and mission described in ORS 351.006 and 351.009.
45	(2) A university with a governing board is an independent public body with statewide

A university with a governing 1 board shall exercise and carry out all of the powers, rights and privileges, within and outside 2 this state, that are expressly conferred upon the university with a governing board, or that 3 are implied by law or are incident to such powers, rights and duties. 4 SECTION 3. 42 <u>SECTION 5.</u> (1) On an annual basis, the Higher Education Coordinating Commission shall 43 submit to the Legislative Assembly an evaluation of each university with a governing board. 44 The commission may make recommendations to the Legislative Assembly regarding the 45 ability of the university to meet academic goals and fulfill its fiduciary responsibilities.

(2) The evaluation must include: 1 2 (a) A report on the university's achievement of outcomes, measures of progress, goals and targets as described in the university's achievement compact with the Oregon Education 3 **Investment Board;** 4 (b) An assessment of the university's progress toward achieving the mission of all edu-5 cation beyond high school as described in ORS 351.009; and 6 (c) An assessment as to how well the establishment of a governing board at the univer-7 sity comports with the findings set forth in section 1 of this 2013 Act. 8 9 SECTION 6. (1) A governing board for a public university must be formed and maintained 10 as provided in this section. (2)(a) Except as provided in subsection (3) of this section, the Governor shall appoint all 11 12 of the 11 to 15 members of the governing board, subject to confirmation by the Senate in the manner provided in ORS 171.562 and 171.565. 13 (b) The governing board must include one person who is a student enrolled at the uni-14 15 versity. The student shall be a voting member of the board. 16(c) The governing board must include one person who is a member of the faculty of the university and one person who is a member of the nonfaculty staff of the university. For 17 18 each appointment made under this paragraph, the Governor may appoint the person as either a voting or nonvoting member of the governing board. 19 (3) The president of the university shall be an ex officio nonvoting member of the gov-20erning board. 2122(4)(a) Except as provided in paragraph (b) of this subsection, the term of office for each appointed member of the governing board is four years. 23(b) The term of office of each student, faculty and nonfaculty staff member of the gov-24 25erning board is two years. (c) A member of the governing board may not be appointed to serve more than two 2627consecutive full terms. (d) The Governor may remove any appointed member of the governing board at any time 28for cause, after notice and public hearing, but may not remove more than three members 2930 within a period of four years, unless it is for corrupt conduct in office. 31 (e) Vacancies shall be filled by appointment by the Governor for the remainder of the 32unexpired term. (5) The governing board shall select one of its members as chairperson and another as 33 34 vice chairperson for such terms and with duties and powers as the board considers necessary 35 for the performance of the functions of those offices. The governing board shall adopt bylaws concerning how a quorum is constituted and when a quorum is necessary. 36 37 (6) The governing board shall meet at least once quarterly, and may meet at the call of 38 the chairperson or a majority of the voting members of the board. SECTION 7. Notwithstanding the term of office specified in section 6 of this 2013 Act, the 39 initial term of a member appointed to a governing board by the Governor may be adjusted 40 so that one-half, as nearly as possible, of the members of the board are appointed biennially. 41 SECTION 8. (1) A university with a governing board shall enter into an achievement 42 compact with the Oregon Education Investment Board for each fiscal year. 43 (2) The governing board shall adopt a mission statement for the university, and shall 44 forward the statement to an office designated by the Higher Education Coordinating Com-45

1 mission as being responsible for university coordination.

2 (3) A university with a governing board shall submit any significant change in the 3 university's academic programs to an office designated by the Higher Education Coordinating 4 Commission as being responsible for university coordination. The office shall establish a 5 process for reviewing the program change and submitting it to the Higher Education Coor-6 dinating Commission for approval. The commission shall establish, by rule, what constitutes 7 a significant change to a university's academic program. The commission shall further en-8 sure that approved programs:

(a) Are consistent with the mission statement of the university;

(b) Do not unnecessarily duplicate academic programs offered by Oregon's other public
 universities;

(c) Are not located in a geographic area that will cause undue hardship to Oregon's other
 public universities; and

(d) Are allocated among Oregon's public universities to maximize the achievement of
 statewide needs and requirements.

(4)(a) On or before April 1 of each even-numbered year, each university listed in ORS 352.002 must submit to an office designated by the Higher Education Coordinating Commission as being responsible for university coordination a funding request applicable to the biennium beginning on July 1 of the following year. On or before May 1 of each evennumbered year, the office shall consolidate the funding requests from public universities listed in ORS 352.002 and submit the consolidated funding requests to the commission.

(b) Pursuant to ORS 351.052, the Higher Education Coordinating Commission shall submit
 a funding request to the Governor on behalf of all public universities listed in ORS 352.002.

(c) The Governor's biennial budget submitted to the Legislative Assembly may include
 funding requests from public universities, including universities with governing boards.

(5) As part of a funding request submitted under subsection (4) of this section, a university with a governing board may request, and appropriations may include, funding for education and general operations, statewide public services, state-funded debt service, capital improvements, deferred maintenance, special initiatives and investments. Any moneys appropriated to pay debt service for state bonds must be held by the State Treasurer pursuant to an agreement entered into by the State Treasurer and a university with a governing board under section 15 (2) of this 2013 Act.

(6) A public university listed in ORS 352.002 that wishes to request the issuance of state 33 34 bonds, including a university with a governing board that elects to remain eligible to receive proceeds of state bonds under section 20 of this 2013 Act, must make a request to this effect 35 to an office designated by the Higher Education Coordinating Commission as being respon-36 37 sible for university coordination. The office shall establish a process for reviewing the re-38 quest to issue state bonds and submit the request to the commission. The commission shall decide whether, and in what manner, to make a request for the issuance of state bonds to 39 the Legislative Assembly. 40

(7)(a) Each public university listed in ORS 352.002, including universities with governing
boards, shall respond to a request for data from the Legislative Assembly or other state body
by submitting the requested information to an office designated by the Higher Education
Coordinating Commission as being responsible for university coordination. The office shall
consolidate the data received from public universities and provide the data to the commis-

sion. The commission shall be responsible for providing the data to the Legislative Assembly
 or other requesting entity.

- 3 (b) As used in this subsection, "data" means any information that, as of the effective 4 date of this 2013 Act, is collected by an office designated by the Higher Education Coordi-5 nating Commission as being responsible for university coordination from each university and 6 reported to the Legislative Assembly or any other state entity, including but not limited to 7 retention and graduation rates and demographic information on students.
- 8 <u>SECTION 9.</u> (1)(a) In consultation with the Governor, or the Governor's designee, the 9 governing board shall appoint and employ a president of the university.
- (b) The governing board shall prescribe the president's compensation and terms and
   conditions of employment.
- (2) The president of the university is the president of the faculty. The president is also the executive and governing officer of the university, except as otherwise provided by statute or action of the governing board. Subject to the supervision of the governing board, the president of the university has authority to direct the affairs of the university.
- (3) Except in the case of an interim or acting president, the hiring committee for the
   president of a university with a governing board shall include representatives of the university
   sity community and at least one other president of a public university based in Oregon.

(4) The governing board is responsible for the reappointment or removal of the president
 of the university.

- (5) A university with a governing board may appoint and employ any instructional, ad ministrative, professional, trade, occupational and other personnel as are necessary or ap propriate and establish their compensation and terms and conditions of employment, subject
   to the limitations set forth in section 14 (1) and (2) of this 2013 Act.
- 25 <u>SECTION 10.</u> (1) Except as set forth in this section, the governing board may authorize, 26 establish, eliminate, collect, manage, use in any manner and expend all revenue derived from 27 tuition and mandatory enrollment fees.
- (2) The governing board shall establish a process for determining tuition and mandatory
   enrollment fees. The process must provide for participation of enrolled students and the re cognized student government of the university.
- (3) The governing board shall request that the president of the university transmit to the board the joint recommendation of the president and the recognized student government before the board authorizes, establishes or eliminates any incidental fees for programs under the supervision or control of the board and found by the board to be advantageous to the cultural or physical development of students.
- (4) In determining tuition and mandatory enrollment fees for undergraduate students
   who are enrolled in a degree program and are qualified to pay resident tuition:
- (a) The governing board may not increase the total of tuition and mandatory enrollment
   fees by more than five percent annually unless the board first receives approval from:
- 40
- (A) The Higher Education Coordinating Commission; or
- 41 (B) The Legislative Assembly.
- (b) The governing board shall attempt to limit annual increases in tuition and mandatory
  enrollment fees for undergraduate students who are enrolled in a degree program and have
  established residency in Oregon to a percentage that is not greater than the percentage increase in the Higher Education Price Index, as compiled by the Commonfund Institute.

(5) The governing board may not delegate authority to determine tuition and mandatory 1 2 enrollment fees for undergraduate students who are enrolled in a degree program and are qualified to pay resident tuition.

SECTION 11. (1) A university with a governing board may:

(a) Acquire, receive, hold, keep, pledge, control, convey, manage, use, lend, expend and 5 invest all moneys, appropriations, gifts, bequests, stock and revenue from any source. 6

(b) Borrow money for the needs of the university in such amounts and for such time and 7 upon such terms as may be determined by the university or the governing board. 8

9 (c) Make any and all contracts and agreements, enter into any partnership, joint venture or other business arrangement and create and participate fully in the operation of any 10 business structure, including but not limited to the development of business structures and 11 12 networks with any public or private government, nonprofit or for-profit person or entity, 13 that in the judgment of the university or the governing board is necessary or appropriate.

(d) Establish, collect and use charges, fines and fees for services, facilities, operations 14 15 and programs.

16(e) Purchase, receive, subscribe for or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock 17 18 or other equity or interests in or obligations of any other entity. The State of Oregon may not have any proprietary or other interest in investments or funds referenced in this para-19 graph. 20

(f) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-2122trol, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, issue, im-23prove, develop, use, expend and dispose of personal property, including intellectual property, of any nature, tangible or intangible. 24

(g) Establish employee benefit plans of any type, subject to ORS 351.094.

(h) Take, hold, grant, pledge or dispose of mortgages, liens and other security interests 2627on real and personal property.

(i) Spend all available moneys without appropriation or expenditure limitation approval 28from the Legislative Assembly, except for moneys received by a university with a governing 2930 board pursuant to a funding request submitted under section 8 (4) of this 2013 Act and the 31 proceeds of state bonds issued for the benefit of a university with a governing board. The proceeds of state bonds issued for the benefit of a university with a governing board must 32be held pursuant to an agreement entered into by the State Treasurer and a university with 33 34 a governing board under section 15 (2) of this 2013 Act. The provisions of ORS 351.450, 351.455 and 351.460 do not apply to state bonds issued for the benefit of a university with a governing 35 board pursuant to Article XI-F(1) or XI-G of the Oregon Constitution. 36

37 (j) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-38 trol, convey, mortgage, pledge or otherwise encumber, sell, manage, operate, lease, leasepurchase, license, lend, invest in, improve, develop, use, expend and dispose of real property. 39 (k) Erect, construct, improve, remodel, develop, repair, maintain, equip, furnish, lease, 40

lend, convey, sell, manage, operate, use and dispose of any building, structure, land or 41 project. 42

(L) Acquire, by condemnation or otherwise, private property that is necessary or con-43 venient. The right to acquire property by condemnation shall be exercised as provided by 44 **ORS** chapter 35. 45

1 (m) Establish policies for the organization, administration and development of the uni-2 versity which, to the extent set forth in those policies, shall have the force of law and may 3 be enforced through university procedures that include an opportunity for appeal and in any 4 court of competent jurisdiction.

(n) Sue in its own name, be sued in its own name and issue and enforce subpoenas in its
own name.

(o) Hire or retain attorneys for the provision of all legal services. A university with a
governing board shall reimburse the State Treasurer for legal fees incurred in connection
with state bonds issued at the request of the university.

(p) Purchase any and all insurance, operate a self-insurance program or otherwise ar range for the equivalent of insurance coverage of any nature and the indemnity and defense
 of its officers, agents and employees or other persons designated by the university.

(q) Subject to the procedures set forth in section 8 of this 2013 Act, establish, supervise
and control academic and other programs, units of operation and standards, qualifications,
policies and practices relating to university matters such as admissions, curriculum, grading,
student conduct, credits, scholarships and the granting of academic degrees, certificates and
other forms of recognition.

(r) Enforce and recover any fees, charges and fines, including but not limited to tuition
 and mandatory enrollment fees.

(s) Make available and perform any and all services on such terms as the governing board
 considers appropriate.

(t) Delegate and provide for the further delegation of any and all powers and duties,
 subject to the limitations expressly set forth in law.

(2) The budget for a university with a governing board shall be prepared in accordance
 with generally accepted accounting principles and adopted by the governing board in ac cordance with ORS 192.610 to 192.710.

(3) A governing board or university with a governing board may perform any other acts
that in the judgment of the board or university are required, necessary or appropriate to
accomplish the rights and responsibilities granted to the board or university by law.

30 SECTION 12. (1) Legal title to all real property acquired by a university with a governing 31 board shall be taken and held in the name of the State of Oregon, acting by and through the governing board. Legal title to all real property conveyed to a university with a governing 32board is considered to be conveyed to and vested in the State of Oregon, acting by and 33 34 through the governing board. Authorized conveyances of all real property, other than university lands, acquired by or vested in the State of Oregon for the use or benefit of the 35 university must be executed in the name of the State of Oregon, acting by and through the 36 37 governing board, by the chairperson of the governing board.

38 (2) The governing board has custody and control of and shall care for all real property used for university purposes. Management, maintenance, encumbrance, disposal and pres-39 ervation of all real property used for university purposes, whether the real property is ac-40 quired before or after the establishment of a governing board, is the responsibility of the 41 governing board. Unless the governing board has granted prior consent, real property taken 42and held under this section may only be encumbered by the State of Oregon in accordance 43 with state law and in a manner that would not impair the financial condition of the univer-44 sity or the rights of the holders of any obligations of the university issued or incurred under 45

any master indenture or other financing agreement. 1

2 (3) Unless the State Treasurer has granted prior consent, real or personal property held in the name of the State of Oregon, or in which the State of Oregon has an ownership or 3 other legal interest, that was acquired, constructed, improved with or otherwise directly 4 benefited by the proceeds of outstanding state bonds, may not be: 5

(a) Used by a governing board in a manner that would give rise to private business use; 6 7 or

8 (b) Sold, transferred, encumbered, leased or otherwise disposed of by a governing board. 9 The reference to leases in this paragraph does not apply to residential leases that a governing board enters into with students, faculty or employees of the university. 10

11 12 SECTION 13. (1) A governing board may, in its sole discretion, do all of the following:

(a) Police, control and regulate traffic and parking of vehicles on university property.

13 (b) Establish a police department and commission one or more employees as police officers in the manner and with all of the privileges and immunities set forth in ORS 352.383. 14 15 When a governing board establishes a police department and commissions one or more employees as police officers, the president of the university, in cooperation with the chief of the 16 police department, shall establish a process by which the university will receive and respond 17 18 to complaints involving the policies of the police department and the conduct of the police officers. 19

(c) Commission special campus security officers who, when acting in the scope of their 20employment, shall have stop and frisk authority as set forth in ORS 131.605 to 131.625 and 2122probable cause arrest authority and the accompanying immunities as set forth in ORS 23133.310 and 133.315. Special campus security officers may not be authorized to carry firearms as police officers and, except as provided in subsection (2) of this section, may not be con-2425sidered police officers for purposes of ORS 181.610, 238.005, 243.005 or 243.736.

(2) A university with a governing board, acting by and through its special campus secu-27rity officers, is a criminal justice agency for purposes of rules adopted pursuant to ORS 181.730 (3). 28

10 <u>SECTION 164.</u> Notwithstanding ORS 62.720, 321.185, 351.506, 351.507, 351.508, 351.532, 11 352.560, 567.010, 567.025, 567.030 and 759.445 and section 1, chapter 39, Oregon Laws 2012, and 12 section 6, chapter 79, Oregon Laws 2012, if the president of Oregon State University notifies 13 the Governor that the university will become a university with a governing board in the 14 manner set forth in section 168 or 168a of this 2013 Act, any moneys provided or transferred 15 by law to the Oregon University System or State Board of Higher Education for the benefit 16 of or use by Oregon State University shall be provided directly to Oregon State University.

17 <u>SECTION 165.</u> Notwithstanding ORS 196.438, 351.350, 352.230, 352.239, 352.247, 352.610, 18 526.225, 542.710, 561.364, 566.210, 567.005, 567.035, 567.210, 567.260, 567.455, 567.505, 567.510 and 19 567.580, if the president of Oregon State University notifies the Governor that the university 20 will become a university with a governing board in the manner set forth in section 168 or 21 168a of this 2013 Act, the university shall act independently, rather than under the direction, 22 control or management of the State Board of Higher Education.

23 <u>SECTION 165a.</u> Notwithstanding ORS 352.221 and 352.223 and section 16, chapter 761, 24 Oregon Laws 2007, section 7, chapter 2, Oregon Laws 2009, and section 18, chapter 904, 25 Oregon Laws 2009, if the Oregon Institute of Technology becomes a university with a gov-26 erning board in the manner set forth in section 168a of this 2013 Act, any moneys provided 27 or transferred by law to the Oregon University System or State Board of Higher Education 28 for the benefit of or use by the Oregon Institute of Technology shall be provided directly to 29 the Oregon Institute of Technology.

## ESTABLISHMENT OF SPECIAL COMMITTEE AND WORK GROUP

32 33

34 <u>SECTION 166.</u> (1) The Special Committee on University Governance and Operations is 35 established, consisting of 10 members appointed as follows:

(a) The President of the Senate shall appoint four members from among members of the
 Senate.

(b) The Speaker of the House of Representatives shall appoint four members from among
 members of the House of Representatives.

40 (c) The Governor shall appoint two members who are members of the Oregon Education
 41 Investment Board.

42 (2) The special committee shall review, discuss and analyze:

(a) Issues of administration within the state post-secondary education system with an
 emphasis on four-year public universities; and

45 (b) Coordination of operations, academic programs, shared services and other elements

of that system, after considering the recommendations of the Work Group on University
 Shared Services established under section 166a of this 2013 Act.

3 (3) The special committee may recommend legislation on the future relationship between
 4 Oregon's institutions of post-secondary education.

(4) The special committee shall evaluate options related to institutional governance as 5 Oregon's public universities transition to new governing boards, with a focus on how best to 6 coordinate academic services among the universities in order to increase student access, 7 affordability and success in pursuit of the mission described in ORS 351.009. Options may 8 9 include the role of a chancellor or an academic leader, the composition of the interim State Board of Higher Education between July 1, 2014, and June 30, 2015, or the composition and 10 authorities of a consortium board for universities that do not request institutional governing 11 12boards.

(5) With respect to university governance, any legislation recommended by the special
 committee shall:

(a) Take into consideration the unique mission associated with each of Oregon's seven
 public universities and identify how these missions can best be accomplished and sustained
 over the next 10 years; and

(b) Ensure that the public missions of Oregon's public universities, including access and
 affordability for residents of this state, are maintained and enhanced.

(6) With respect to university operations, any legislation recommended by the special
 committee shall define the operating arrangements between the institutions in order to en sure:

(a) That all post-secondary institutions, including public universities listed in ORS 352.002
 and Oregon's 17 community colleges, are able to achieve the goals and mission described in
 ORS 351.006 and 351.009; and

(b) The achievement of cost efficiencies, economies of scale, cost effectiveness, account ability, administrative streamlining and the ability to provide the best quality education
 possible for the amount of state moneys spent.

(7)(a) Any shared services legislation recommended by the special committee must fur ther consider the recommended shared services model provided by the Work Group on Uni versity Shared Services under section 166a (11) of this 2013 Act.

(b) The shared services subject to review by the special committee shall include, but are
not limited to, risk management, cash management, asset management, treasury services,
payroll, employee benefits, accounting, auditing, purchasing and contracting, information
technology and any other administrative function that might benefit from the sharing or
pooling of public university resources.

(8) A majority of the members of the special committee constitutes a quorum for the
 transaction of business.

(9) Official action by the special committee requires the approval of a majority of the
 members of the committee.

(10) The special committee shall elect two of its members to serve as cochairpersons, one
 of whom is from the Senate and one of whom is from the House of Representatives.

(11) If there is a vacancy for any cause, the appointing authority shall make an appoint ment to become immediately effective.

45 (12) The special committee shall meet at times and places specified by the call of the

1 cochairpersons or of a majority of the members of the committee.

2 (13) The special committee may adopt rules necessary for the operation of the commit-3 tee.

4 (14)(a) The special committee shall convene and begin work no later than September 15,
5 2013.

6 (b) The special committee shall submit interim recommendations to the Governor and 7 Legislative Assembly no later than January 15, 2014, for consideration during the 2014 regu-8 lar legislative session.

9 (c) The special committee shall continue to meet and submit final recommendations to 10 the Governor and Legislative Assembly, if necessary, no later than November 15, 2014, for 11 consideration during the 2015 regular legislative session.

(15) The Legislative Administration Committee shall provide staff support to the special
 committee.

(16) Members of the special committee who are not members of the Legislative Assembly
 are not entitled to compensation.

(17) All agencies of state government, as defined in ORS 174.111, and public universities listed in ORS 352.002 are directed to assist the special committee in the performance of its duties and, to the extent permitted by laws relating to confidentiality, to furnish such information and advice as the members of the committee consider necessary to perform their duties.

(18) The special committee may accept contributions of funds and assistance from any
 source, public or private, for the purposes of the consultation with national experts required
 for the activities described in subsections (2) to (7) of this section.

24 <u>SECTION 166a.</u> (1) The Work Group on University Shared Services is established, con-25 sisting of the presidents of the seven public universities listed in ORS 352.002 or the 26 presidents' designees.

(2) The work group shall develop a shared services model that delivers efficient and effective administrative operations to participating post-secondary institutions in a manner
 that focuses on quality, responsiveness and customer service and that seeks to achieve cost
 savings, economies of scale, accountability, transparency and streamlining.

(3) In developing a shared services model under subsection (2) of this section, the services that the work group must consider include, but are not limited to, risk management, cash management, asset management, treasury services, payroll, employee benefits, accounting, auditing, purchasing and contracting, information technology and any other administrative function that might benefit from the sharing or pooling of public university resources.

(4) In recommending how to achieve a shared services enterprise for the public univer sities listed in ORS 352.002, the work group shall:

(a) Recommend an appropriate entity to facilitate the sharing of services among the
public universities listed in ORS 352.002 after universities with governing boards are established;

42 (b) Recommend how the shared services coordinating entity described in paragraph (a)
43 of this subsection will be managed;

44 (c) Determine the financial impact that will be caused, both cumulatively and individ-45 ually, for each university that establishes a governing board and leaves the Oregon Univer1 sity System;

2 (d) Recommend a mechanism to mitigate or eliminate the negative financial impact 3 caused by universities establishing governing boards and leaving the Oregon University Sys-4 tem, or require universities establishing governing boards and leaving the Oregon University 5 System to remain in each shared service. In determining this mechanism, the work group 6 must consider the appropriateness of assessments or reductions of appropriations; and

7 (e) Identify services that should remain shared among public universities listed in ORS 8 352.002 after the establishment of universities with governing boards. In determining whether 9 a service should remain shared, the work group must consider the economies of scale 10 achieved by sharing the service, the benefit to the public in sharing the service and the 11 positive and negative financial impact on each public university if one or more universities 12 with governing boards either stops or continues to participate in the service.

(5) The State Board of Higher Education and the office of the Chancellor of the Oregon
 University System shall assist the work group in developing the work group's recommen dations. The work group may seek and accept consulting or other technical assistance from
 any source in preparing its recommendations.

(6) A majority of the members of the work group constitutes a quorum for the trans action of business.

(7) Official action by the work group requires the approval of a majority of the members
 of the work group.

(8) The work group shall elect one of its members to serve as chairperson.

(9) The work group shall meet at times and places specified by the call of the chairperson
or of a majority of the members of the work group.

24 (10) The work group may adopt rules necessary for the operation of the work group.

(11)(a) The work group shall submit a first draft of its recommended shared services
 model to the Special Committee on University Governance and Operations established in
 section 166 of this 2013 Act no later than December 15, 2013.

(b) The work group shall finalize and submit its recommended shared services model to
 the special committee no later than September 15, 2014.

30 (12) The Oregon University System shall provide staff support to the work group.

31 (13) Members of the work group are not entitled to compensation.

(14) All agencies of state government, as defined in ORS 174.111, are directed to assist
the work group in the performance of its duties and, to the extent permitted by laws relating
to confidentiality, to furnish such information and advice as the members of the work group
consider necessary to perform their duties.

# **OPERATIVE DATE AND TRANSITIONAL PROVISIONS**

41 <u>SECTION 168.</u> (1) Notwithstanding the operative date set forth in section 171 of this 2013 42 Act, the Governor shall appoint all of the members of the Board of Trustees of the Univer-43 sity of Oregon and all of the members of the Board of Trustees of Portland State University 44 by August 19, 2013, so that these appointees may be confirmed by the Senate in the manner 45 provided in ORS 171.562 and 171.565 by September 30, 2013.

1 (2) If the president of Oregon State University notifies the Governor by August 1, 2013, 2 the university will become a university with a governing board:

3 (a) Within two weeks after receiving the notification, the Governor shall inform the
4 President of the Senate, the Speaker of the House of Representatives and the Legislative
5 Counsel of the notification; and

6 (b) The Governor shall appoint all of the members of the Board of Trustees of Oregon 7 State University in the same manner and time frame as set forth in subsection (1) of this 8 section.

9 (3) If the president of Oregon State University notifies the Governor between August 2, 10 2013, and January 1, 2014, that the university will become a university with a governing 11 board, the Board of Trustees of Oregon State University shall be established in the manner 12 set forth in section 168a of this 2013 Act.

<u>SECTION 168a.</u> (1) If the president of Oregon State University notifies the Governor be tween August 2, 2013, and January 1, 2014, that the university will become a university with
 a governing board:

(a) Within two weeks after receiving the notification, the Governor shall inform the
President of the Senate, the Speaker of the House of Representatives and the Legislative
Counsel of the notification; and

(b) Not later than February 1, 2014, the Governor shall appoint all of the members of the
 governing board in the manner set forth in section 6 of this 2013 Act.

(2)(a) If the president of Eastern Oregon University, Oregon Institute of Technology,
 Southern Oregon University or Western Oregon University determines that the university
 should become a university with a governing board, the president shall notify the Governor
 and the State Board of Higher Education of the university's intent. Notification under this
 subsection must occur during the period beginning March 1, 2014, and ending June 1, 2015.

(b) Within 45 days of receiving notification under this subsection from a university president, the State Board of Higher Education shall decide whether or not to endorse the university's decision. If the board endorses the request, the board shall immediately communicate any endorsement to the Governor.

(b) Upon receiving notification that the State Board of Higher Education has endorsed a
 university's decision to become a university with a governing board, the Governor shall:

(A) Inform the President of the Senate, the Speaker of the House of Representatives and
 the Legislative Counsel of that the university will become a university with a governing
 board; and

(B) Not later than six months after receiving the notification, appoint all of the members
 of the governing board in the manner set forth in section 6 of this 2013 Act.

(3) Notwithstanding section 169 of this 2013 Act, if Eastern Oregon University, Oregon
Institute of Technology, Southern Oregon University or Western Oregon University become
a university with a governing board under subsection (2) of this section, the president of that
university shall take over administrative responsibilities for the university from the State
Board of Higher Education on either July 1, 2015 or when the Governor appoints the members of the governing board, whichever date comes later.

43 <u>SECTION 169.</u> Except as provided in section 168a of this 2013 Act, the State Board of 44 Higher Education shall continue to have jurisdiction over the operations of a university with 45 a governing board as defined in section 2 of this 2013 Act through June 30, 2014. However,

1 the governing board shall propose funding requests pursuant to section 8 of this 2013 Act and

2 ORS 351.052, as amended by section 42 of this 2013 Act, and shall prepare budgets, in coop-

eration with the Higher Education Coordinating Commission, for the biennium beginning July
1, 2015.

5 <u>SECTION 170.</u> (1) Except as otherwise expressly provided in this section, all persons 6 employed by a university with a governing board, as defined in section 2 of this 2013 Act, on 7 the effective date of this 2013 Act shall continue their employment with the university and 8 shall retain any seniority, contractual rights or tenure granted prior to the effective date 9 of this 2013 Act. Nothing in this section shall affect any term or condition of any collective 10 bargaining agreement in effect on the effective date of this 2013 Act.

(2) All of the duties, functions, powers and lawfully incurred rights and obligations of the 11 12State Board of Higher Education that pertain to a university with a governing board are 13 transferred to and vested in the governing board. The transfer shall include but not be limited to all applicable contractual rights and obligations and title to all applicable records, 14 15property, supplies and materials, including equipment, books and papers. For the purpose of 16succession to these rights and obligations, the governing board is considered to be a continuation of the State Board of Higher Education and not a new authority, and the governing 17 18 board must exercise such rights and fulfill such obligations as if they had not been assigned or transferred, except as otherwise provided by law. 19

(3) All unexpended moneys, including but not limited to General Fund appropriations,
gifts, bequests, other funds, assessments, liability and worker's compensation reserves and
premiums that are appropriated to, held, managed or invested by or on behalf of or otherwise
available to a university with a governing board, are appropriated and transferred to the
university.

(4) A university with a governing board shall conduct and complete any proceeding,
action, prosecution or other matter that the university commenced before the effective date
of this 2013 Act and that is pending on the effective date of this 2013 Act.

(5) The transfer of duties, functions and powers to a governing board or university with
 a governing board does not affect any action, suit or proceeding relating to the university,
 except that the university shall be substituted for the State Board of Higher Education and
 the State of Oregon in any such action, suit or proceeding.

(6) Any action, proceeding or other matter that was commenced by a state agency, a
state officer, the State Board of Higher Education or an officer or employee of the State
Board of Higher Education before the effective date of this 2013 Act and relates to the governing board or university with a governing board and is still pending on the effective date
of this 2013 Act shall be conducted and completed by the governing board or university.

(7) Nothing in this 2013 Act relieves any person, public entity or private entity of any
obligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture, rule,
policy, document, record or proceeding.

(8) Notwithstanding any other provision of this section, the lawfully adopted rules and policies of the State Board of Higher Education pertaining to a university with a governing board that are in effect on the effective date of this 2013 Act continue in effect until lawfully superseded or repealed by the standards or policies of the governing board or the university. References in rules or policies of the State Board of Higher Education to the state board or an officer or employee of the state board are considered to be references to the governing

1 board or an officer or employee of a university with a governing board.

2 <u>SECTION 171.</u> Sections 2, 2a, 2b, 3, 5, 8 to 18, 164, 165, 169 and 170 of this 2013 Act, the 3 amendments to statutes and session laws by sections 24, 25, 28 to 37 and 40 to 162 of this 2013 4 Act and the repeal of statutes by section 163 of this 2013 Act become operative on July 1, 5 2014.

6 <u>SECTION 172.</u> The State Board of Higher Education and a university with a governing 7 board as defined in section 2 of this 2013 Act may take any action before the operative date 8 specified in section 171 of this 2013 Act that is necessary for the State Board of Higher Ed-9 ucation and the university to exercise, on and after the operative date specified in section 10 171 of this 2013 Act, all of the duties, functions and powers conferred on the State Board of 11 Higher Education and university by this 2013 Act.

12 <u>SECTION 172a.</u> This 2013 Act is intended to preserve the autonomy of the universities 13 listed in ORS 352.002 whether they are governed by a university governing board or a uni-14 versity consortium board.

#### CAPTIONS

18 <u>SECTION 173.</u> The unit captions used in this 2013 Act are provided only for the conven-19 ience of the reader and do not become part of the statutory law of this state or express any 20 legislative intent in the enactment of this 2013 Act.

#### EMERGENCY CLAUSE

24 <u>SECTION 174.</u> This 2013 Act being necessary for the immediate preservation of the public 25 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 26 on its passage.
