SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes governing boards for University of Oregon and Portland State University. Vests governing boards with certain duties, rights and powers.

Establishes time frame in which Oregon State University may elect to establish governing board.

Establishes process by which other universities in Oregon University System may establish governing boards.

Requires public universities to continue to participate in all shared services until at least July 1, 2014, and listed shared services until at least July 1, 2015.

Establishes Special Committee on University Governance and Operations to make recommendations to Legislative Assembly on issues of administration within state post-secondary education system and coordination of operations, academic programs and shared services within system.

Establishes Work Group on University Shared Services to assist special committee in making legislative recommendations for shared services among Oregon's public universities.

Becomes operative on July 1, 2014.

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

7 **ESTABLISHMENT AND INDEPENDENCE OF GOVERNING BOARDS**

8
9 **SECTION 1.** (1) The Legislative Assembly finds that the State of Oregon will benefit from
10 having public universities with governing boards that:

- 11 (a) Provide transparency, public accountability and support for the university.
- 12 (b) Are close to and closely focused on the individual university.
- 13 (c) Do not negatively impact public universities that do not have governing boards.
- 14 (d) Lead to greater access and affordability for Oregon residents and do not disadvantage
15 Oregon students relative to out-of-state students.
- 16 (e) Act in the best interests of both the university and the State of Oregon as a whole.
- 17 (f) Promote the academic success of students in support of the mission of all education
18 beyond high school as described in ORS 351.009.

19 (2) The Legislative Assembly also finds that:

- 20 (a) Even with universities with governing boards, there are economy-of-scale benefits to
21 having a coordinated university system.
- 22 (b) Even with universities with governing boards, shared services may continue to be
23 shared among universities.
- 24 (c) Legal title to all real property, whether acquired before or after the creation of a
25 governing board, through state funding, revenue bonds or philanthropy, shall be taken and
26 held in the name of the State of Oregon, acting by and through the governing board.
- 27 (d) The Legislative Assembly has a responsibility to monitor the success of governing
28 boards at fulfilling their missions, their compacts and the principles stated in this section.

29 **SECTION 2.** As used in sections 1 to 23 of this 2013 Act:

30 (1) "Governing board" means a governing board established by a university under section
31 3 of this 2013 Act that manages the affairs of the university by exercising and carrying out
32 all of the powers, rights and duties that are expressly conferred upon the board by law, or
33 that are implied by law or are incident to such powers, rights and duties.

34 (2) "State bonds" means "bonds" as defined in ORS 286A.001 that are issued by the State
35 Treasurer.

36 (3) "University with a governing board" means a public university listed in section 3 of
37 this 2013 Act that has established a governing board.

38 **SECTION 2a.** A university with a governing board is a governmental entity performing
39 governmental functions and exercising governmental powers. A university with a governing
40 board is not considered a unit of local or municipal government or a state agency, board,
41 commission or institution for purposes of state statutes or constitutional provisions.

42 **SECTION 2b.** (1) A university with a governing board is created to carry out public
43 missions and services in keeping with principles of public accountability and fundamental
44 public policy, guided by the legislative findings in ORS 351.001 and 351.003 and consistent with
45 the goals and mission described in ORS 351.006 and 351.009.

1 (2) A university with a governing board is an independent public body with statewide
2 purposes and missions and without territorial boundaries. A university with a governing
3 board shall exercise and carry out all of the powers, rights and privileges, within and outside
4 this state, that are expressly conferred upon the university with a governing board, or that
5 are implied by law or are incident to such powers, rights and duties.

6 **SECTION 3.** (1) A governing board is established for each of the following public univer-
7 sities:

8 (a) University of Oregon;

9 (b) Portland State University;

10 (c) Oregon State University, if the president of Oregon State University notifies the
11 Governor that the university will become a university with a governing board in the manner
12 set forth in section 168 or 168a of this 2013 Act;

13 (d) Eastern Oregon University, if Eastern Oregon University becomes a university with
14 a governing board in the manner set forth in section 168a of this 2013 Act;

15 (e) Oregon Institute of Technology, if Oregon Institute of Technology becomes a univer-
16 sity with a governing board in the manner set forth in section 168a of this 2013 Act;

17 (f) Southern Oregon University, if Southern Oregon University becomes a university with
18 a governing board in the manner set forth in section 168a of this 2013 Act; and

19 (g) Western Oregon University, if Western Oregon University becomes a university with
20 a governing board in the manner set forth in section 168a of this 2013 Act.

21 (2)(a) The University of Oregon governing board shall be known as the Board of Trustees
22 of the University of Oregon.

23 (b) The Portland State University governing board shall be known as the Board of Trus-
24 tees of Portland State University.

25 (c) The Oregon State University governing board shall be known as the Board of Trustees
26 of Oregon State University, if the president of Oregon State University notifies the Governor
27 that the university will become a university with a governing board in the manner set forth
28 in section 168 or 168a of this 2013 Act.

29 (d) The Eastern Oregon University governing board shall be known as the Board of
30 Trustees of Eastern Oregon University, if Eastern Oregon University becomes a university
31 with a governing board in the manner set forth in section 168a of this 2013 Act.

32 (e) The Oregon Institute of Technology governing board shall be known as the Board of
33 Trustees of the Oregon Institute of Technology, if the Oregon Institute of Technology be-
34 comes a university with a governing board in the manner set forth in section 168a of this
35 2013 Act.

36 (f) The Southern Oregon University governing board shall be known as the Board of
37 Trustees of Southern Oregon University, if Southern Oregon University becomes a university
38 with a governing board in the manner set forth in section 168a of this 2013 Act.

39 (g) The Western Oregon University governing board shall be known as the Board of
40 Trustees of Western Oregon University, if Western Oregon University becomes a university
41 with a governing board in the manner set forth in section 168a of this 2013 Act.

42 **NOTE:** Section 4 was deleted by amendment. Subsequent sections were not renumbered.

43 **SECTION 5.** (1) On an annual basis, the Higher Education Coordinating Commission shall
44 submit to the Legislative Assembly an evaluation of each university with a governing board.
45 The commission may make recommendations to the Legislative Assembly regarding the

1 ability of the university to meet academic goals and fulfill its fiduciary responsibilities.

2 (2) The evaluation must include:

3 (a) A report on the university's achievement of outcomes, measures of progress, goals
4 and targets as described in the university's achievement compact with the Oregon Education
5 Investment Board;

6 (b) An assessment of the university's progress toward achieving the mission of all edu-
7 cation beyond high school as described in ORS 351.009; and

8 (c) An assessment as to how well the establishment of a governing board at the univer-
9 sity comports with the findings set forth in section 1 of this 2013 Act.

10 **SECTION 6.** (1) A governing board for a public university must be formed and maintained
11 as provided in this section.

12 (2)(a) Except as provided in subsection (3) of this section, the Governor shall appoint all
13 of the 11 to 15 members of the governing board, subject to confirmation by the Senate in the
14 manner provided in ORS 171.562 and 171.565.

15 (b) The governing board must include one person who is a student enrolled at the uni-
16 versity. The student shall be a voting member of the board.

17 (c) The governing board must include one person who is a member of the faculty of the
18 university and one person who is a member of the nonfaculty staff of the university. For
19 each appointment made under this paragraph, the Governor may appoint the person as ei-
20 ther a voting or nonvoting member of the governing board.

21 (3) The president of the university shall be an ex officio nonvoting member of the gov-
22 erning board.

23 (4)(a) Except as provided in paragraph (b) of this subsection, the term of office for each
24 appointed member of the governing board is four years.

25 (b) The term of office of each student, faculty and nonfaculty staff member of the gov-
26 erning board is two years.

27 (c) A member of the governing board may not be appointed to serve more than two
28 consecutive full terms.

29 (d) The Governor may remove any appointed member of the governing board at any time
30 for cause, after notice and public hearing, but may not remove more than three members
31 within a period of four years, unless it is for corrupt conduct in office.

32 (e) Vacancies shall be filled by appointment by the Governor for the remainder of the
33 unexpired term.

34 (5) The governing board shall select one of its members as chairperson and another as
35 vice chairperson for such terms and with duties and powers as the board considers necessary
36 for the performance of the functions of those offices. The governing board shall adopt bylaws
37 concerning how a quorum is constituted and when a quorum is necessary.

38 (6) The governing board shall meet at least once quarterly, and may meet at the call of
39 the chairperson or a majority of the voting members of the board.

40 **SECTION 7.** Notwithstanding the term of office specified in section 6 of this 2013 Act, the
41 initial term of a member appointed to a governing board by the Governor may be adjusted
42 so that one-half, as nearly as possible, of the members of the board are appointed biennially.

43 **SECTION 8.** (1) A university with a governing board shall enter into an achievement
44 compact with the Oregon Education Investment Board for each fiscal year.

45 (2) The governing board shall adopt a mission statement for the university, and shall

1 forward the statement to an office designated by the Higher Education Coordinating Com-
2 mission as being responsible for university coordination.

3 (3) A university with a governing board shall submit any significant change in the
4 university's academic programs to an office designated by the Higher Education Coordinating
5 Commission as being responsible for university coordination. The office shall establish a
6 process for reviewing the program change and submitting it to the Higher Education Coordinating
7 Commission for approval. The commission shall establish, by rule, what constitutes
8 a significant change to a university's academic program. The commission shall further en-
9 sure that approved programs:

10 (a) Are consistent with the mission statement of the university;

11 (b) Do not unnecessarily duplicate academic programs offered by Oregon's other public
12 universities;

13 (c) Are not located in a geographic area that will cause undue hardship to Oregon's other
14 public universities; and

15 (d) Are allocated among Oregon's public universities to maximize the achievement of
16 statewide needs and requirements.

17 (4)(a) On or before April 1 of each even-numbered year, each university listed in ORS
18 352.002 must submit to an office designated by the Higher Education Coordinating Commis-
19 sion as being responsible for university coordination a funding request applicable to the
20 biennium beginning on July 1 of the following year. On or before May 1 of each even-
21 numbered year, the office shall consolidate the funding requests from public universities
22 listed in ORS 352.002 and submit the consolidated funding requests to the commission.

23 (b) Pursuant to ORS 351.052, the Higher Education Coordinating Commission shall submit
24 a funding request to the Governor on behalf of all public universities listed in ORS 352.002.

25 (c) The Governor's biennial budget submitted to the Legislative Assembly may include
26 funding requests from public universities, including universities with governing boards.

27 (5) As part of a funding request submitted under subsection (4) of this section, a uni-
28 versity with a governing board may request, and appropriations may include, funding for
29 education and general operations, statewide public services, state-funded debt service, capital
30 improvements, deferred maintenance, special initiatives and investments. Any moneys ap-
31 propriated to pay debt service for state bonds must be held by the State Treasurer pursuant
32 to an agreement entered into by the State Treasurer and a university with a governing board
33 under section 15 (2) of this 2013 Act.

34 (6) A public university listed in ORS 352.002 that wishes to request the issuance of state
35 bonds, including a university with a governing board that elects to remain eligible to receive
36 proceeds of state bonds under section 20 of this 2013 Act, must make a request to this effect
37 to an office designated by the Higher Education Coordinating Commission as being respon-
38 sible for university coordination. The office shall establish a process for reviewing the re-
39 quest to issue state bonds and submit the request to the commission. The commission shall
40 decide whether, and in what manner, to make a request for the issuance of state bonds to
41 the Legislative Assembly.

42 (7)(a) Each public university listed in ORS 352.002, including universities with governing
43 boards, shall respond to a request for data from the Legislative Assembly or other state body
44 by submitting the requested information to an office designated by the Higher Education
45 Coordinating Commission as being responsible for university coordination. The office shall

1 consolidate the data received from public universities and provide the data to the commis-
2 sion. The commission shall be responsible for providing the data to the Legislative Assembly
3 or other requesting entity.

4 (b) As used in this subsection, “data” means any information that, as of the effective
5 date of this 2013 Act, is collected by an office designated by the Higher Education Coordi-
6 nating Commission as being responsible for university coordination from each university and
7 reported to the Legislative Assembly or any other state entity, including but not limited to
8 retention and graduation rates and demographic information on students.

9 **SECTION 9.** (1)(a) In consultation with the Governor, or the Governor’s designee, the
10 governing board shall appoint and employ a president of the university.

11 (b) The governing board shall prescribe the president’s compensation and terms and
12 conditions of employment.

13 (2) The president of the university is the president of the faculty. The president is also
14 the executive and governing officer of the university, except as otherwise provided by statute
15 or action of the governing board. Subject to the supervision of the governing board, the
16 president of the university has authority to direct the affairs of the university.

17 (3) Except in the case of an interim or acting president, the hiring committee for the
18 president of a university with a governing board shall include representatives of the univer-
19 sity community and at least one other president of a public university based in Oregon.

20 (4) The governing board is responsible for the reappointment or removal of the president
21 of the university.

22 (5) A university with a governing board may appoint and employ any instructional, ad-
23 ministrative, professional, trade, occupational and other personnel as are necessary or ap-
24 propriate and establish their compensation and terms and conditions of employment, subject
25 to the limitations set forth in section 14 (1) and (2) of this 2013 Act.

26 **SECTION 10.** (1) Except as set forth in this section, the governing board may authorize,
27 establish, eliminate, collect, manage, use in any manner and expend all revenue derived from
28 tuition and mandatory enrollment fees.

29 (2) The governing board shall establish a process for determining tuition and mandatory
30 enrollment fees. The process must provide for participation of enrolled students and the re-
31 cognized student government of the university.

32 (3) The governing board shall request that the president of the university transmit to the
33 board the joint recommendation of the president and the recognized student government
34 before the board authorizes, establishes or eliminates any incidental fees for programs under
35 the supervision or control of the board and found by the board to be advantageous to the
36 cultural or physical development of students.

37 (4) In determining tuition and mandatory enrollment fees for undergraduate students
38 who are enrolled in a degree program and are qualified to pay resident tuition:

39 (a) The governing board may not increase the total of tuition and mandatory enrollment
40 fees by more than five percent annually unless the board first receives approval from:

41 (A) The Higher Education Coordinating Commission; or

42 (B) The Legislative Assembly.

43 (b) The governing board shall attempt to limit annual increases in tuition and mandatory
44 enrollment fees for undergraduate students who are enrolled in a degree program and have
45 established residency in Oregon to a percentage that is not greater than the percentage in-

1 **crease in the Higher Education Price Index, as compiled by the Commonfund Institute.**

2 **(5) The governing board may not delegate authority to determine tuition and mandatory**
3 **enrollment fees for undergraduate students who are enrolled in a degree program and are**
4 **qualified to pay resident tuition.**

5 **SECTION 11. (1) A university with a governing board may:**

6 **(a) Acquire, receive, hold, keep, pledge, control, convey, manage, use, lend, expend and**
7 **invest all moneys, appropriations, gifts, bequests, stock and revenue from any source.**

8 **(b) Borrow money for the needs of the university in such amounts and for such time and**
9 **upon such terms as may be determined by the university or the governing board.**

10 **(c) Make any and all contracts and agreements, enter into any partnership, joint venture**
11 **or other business arrangement and create and participate fully in the operation of any**
12 **business structure, including but not limited to the development of business structures and**
13 **networks with any public or private government, nonprofit or for-profit person or entity,**
14 **that in the judgment of the university or the governing board is necessary or appropriate.**

15 **(d) Establish, collect and use charges, fines and fees for services, facilities, operations**
16 **and programs.**

17 **(e) Purchase, receive, subscribe for or otherwise acquire, own, hold, vote, use, sell,**
18 **mortgage, lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock**
19 **or other equity or interests in or obligations of any other entity. The State of Oregon may**
20 **not have any proprietary or other interest in investments or funds referenced in this para-**
21 **graph.**

22 **(f) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-**
23 **trol, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, issue, im-**
24 **prove, develop, use, expend and dispose of personal property, including intellectual property,**
25 **of any nature, tangible or intangible.**

26 **(g) Establish employee benefit plans of any type, subject to ORS 351.094.**

27 **(h) Take, hold, grant, pledge or dispose of mortgages, liens and other security interests**
28 **on real and personal property.**

29 **(i) Spend all available moneys without appropriation or expenditure limitation approval**
30 **from the Legislative Assembly, except for moneys received by a university with a governing**
31 **board pursuant to a funding request submitted under section 8 (4) of this 2013 Act and the**
32 **proceeds of state bonds issued for the benefit of a university with a governing board. The**
33 **proceeds of state bonds issued for the benefit of a university with a governing board must**
34 **be held pursuant to an agreement entered into by the State Treasurer and a university with**
35 **a governing board under section 15 (2) of this 2013 Act. The provisions of ORS 351.450, 351.455**
36 **and 351.460 do not apply to state bonds issued for the benefit of a university with a governing**
37 **board pursuant to Article XI-F(1) or XI-G of the Oregon Constitution.**

38 **(j) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-**
39 **trol, convey, mortgage, pledge or otherwise encumber, sell, manage, operate, lease, lease-**
40 **purchase, license, lend, invest in, improve, develop, use, expend and dispose of real property.**

41 **(k) Erect, construct, improve, remodel, develop, repair, maintain, equip, furnish, lease,**
42 **lend, convey, sell, manage, operate, use and dispose of any building, structure, land or**
43 **project.**

44 **(L) Acquire, by condemnation or otherwise, private property that is necessary or con-**
45 **venient. The right to acquire property by condemnation shall be exercised as provided by**

1 **ORS chapter 35.**

2 (m) Establish policies for the organization, administration and development of the uni-
3 versity which, to the extent set forth in those policies, shall have the force of law and may
4 be enforced through university procedures that include an opportunity for appeal and in any
5 court of competent jurisdiction.

6 (n) Sue in its own name, be sued in its own name and issue and enforce subpoenas in its
7 own name.

8 (o) Hire or retain attorneys for the provision of all legal services. A university with a
9 governing board shall reimburse the State Treasurer for legal fees incurred in connection
10 with state bonds issued at the request of the university.

11 (p) Purchase any and all insurance, operate a self-insurance program or otherwise ar-
12 range for the equivalent of insurance coverage of any nature and the indemnity and defense
13 of its officers, agents and employees or other persons designated by the university.

14 (q) Subject to the procedures set forth in section 8 of this 2013 Act, establish, supervise
15 and control academic and other programs, units of operation and standards, qualifications,
16 policies and practices relating to university matters such as admissions, curriculum, grading,
17 student conduct, credits, scholarships and the granting of academic degrees, certificates and
18 other forms of recognition.

19 (r) Enforce and recover any fees, charges and fines, including but not limited to tuition
20 and mandatory enrollment fees.

21 (s) Make available and perform any and all services on such terms as the governing board
22 considers appropriate.

23 (t) Delegate and provide for the further delegation of any and all powers and duties,
24 subject to the limitations expressly set forth in law.

25 (2) The budget for a university with a governing board shall be prepared in accordance
26 with generally accepted accounting principles and adopted by the governing board in ac-
27 cordance with ORS 192.610 to 192.710.

28 (3) A governing board or university with a governing board may perform any other acts
29 that in the judgment of the board or university are required, necessary or appropriate to
30 accomplish the rights and responsibilities granted to the board or university by law.

31 **SECTION 12.** (1) Legal title to all real property acquired by a university with a governing
32 board shall be taken and held in the name of the State of Oregon, acting by and through the
33 governing board. Legal title to all real property conveyed to a university with a governing
34 board is considered to be conveyed to and vested in the State of Oregon, acting by and
35 through the governing board. Authorized conveyances of all real property, other than uni-
36 versity lands, acquired by or vested in the State of Oregon for the use or benefit of the
37 university must be executed in the name of the State of Oregon, acting by and through the
38 governing board, by the chairperson of the governing board.

39 (2) The governing board has custody and control of and shall care for all real property
40 used for university purposes. Management, maintenance, encumbrance, disposal and pres-
41 ervation of all real property used for university purposes, whether the real property is ac-
42 quired before or after the establishment of a governing board, is the responsibility of the
43 governing board. Unless the governing board has granted prior consent, real property taken
44 and held under this section may only be encumbered by the State of Oregon in accordance
45 with state law and in a manner that would not impair the financial condition of the univer-

1 sity or the rights of the holders of any obligations of the university issued or incurred under
2 any master indenture or other financing agreement.

3 (3) Unless the State Treasurer has granted prior consent, real or personal property held
4 in the name of the State of Oregon, or in which the State of Oregon has an ownership or
5 other legal interest, that was acquired, constructed, improved with or otherwise directly
6 benefited by the proceeds of outstanding state bonds, may not be:

7 (a) Used by a governing board in a manner that would give rise to private business use;
8 or

9 (b) Sold, transferred, encumbered, leased or otherwise disposed of by a governing board.
10 The reference to leases in this paragraph does not apply to residential leases that a govern-
11 ing board enters into with students, faculty or employees of the university.

12 **SECTION 13.** (1) A governing board may, in its sole discretion, do all of the following:

13 (a) Police, control and regulate traffic and parking of vehicles on university property.

14 (b) Establish a police department and commission one or more employees as police offi-
15 cers in the manner and with all of the privileges and immunities set forth in ORS 352.383.
16 When a governing board establishes a police department and commissions one or more em-
17 ployees as police officers, the president of the university, in cooperation with the chief of the
18 police department, shall establish a process by which the university will receive and respond
19 to complaints involving the policies of the police department and the conduct of the police
20 officers.

21 (c) Commission special campus security officers who, when acting in the scope of their
22 employment, shall have stop and frisk authority as set forth in ORS 131.605 to 131.625 and
23 probable cause arrest authority and the accompanying immunities as set forth in ORS
24 133.310 and 133.315. Special campus security officers may not be authorized to carry firearms
25 as police officers and, except as provided in subsection (2) of this section, may not be con-
26 sidered police officers for purposes of ORS 181.610, 238.005, 243.005 or 243.736.

27 (2) A university with a governing board, acting by and through its special campus secu-
28 rity officers, is a criminal justice agency for purposes of rules adopted pursuant to ORS
29 181.730 (3).

30 **SECTION 14.** (1) A university with a governing board shall engage in collective bargaining
31 with local bargaining organizations of the employees of the university.

32 (2) A university with a governing board shall participate in a collective bargaining part-
33 nership with other public universities in this state for the purpose of engaging in collective
34 bargaining with existing statewide bargaining organizations of the employees of the public
35 university. The collective bargaining partnership shall be established by written agreement.

36 (3) Subject to the authority of the Secretary of State to audit public accounts, a univer-
37 sity with a governing board may conduct an independent audit if the governing board con-
38 siders the audit advisable. Subject to ORS 297.250, the independent audit is subject to the
39 exclusive discretion and control of the university. The independent audit is subject to dis-
40 closure pursuant to ORS 192.410 to 192.505.

41 **SECTION 14a.** (1) Notwithstanding sections 10, 11 and 169 of this 2013 Act, the amend-
42 ments to ORS 243.107 and 351.094 by sections 88 and 113 of this 2013 Act and the operative
43 date set forth in section 171 of this 2013 Act, a university with a governing board shall con-
44 tinue to participate with other public universities listed in ORS 352.002 in all shared admin-
45 istrative services relating to:

1 (a) Employee benefits, including but not limited to group insurance or deferred compen-
2 sation plans authorized by ORS 351.094;

3 (b) Collective bargaining with any statewide bargaining unit that includes employees of
4 two or more public universities listed in ORS 352.002; and

5 (c) Risk management, the purchase of insurance or the management of a self-insurance
6 program authorized by ORS 351.096 or section 11 of this 2013 Act.

7 (2) The shared administrative services listed in subsection (1) of this section must be
8 done under the same terms, conditions, funding model and policy frameworks as those that
9 exist on the effective date of this 2013 Act until July 1, 2015. On and after July 1, 2015, public
10 universities listed in ORS 352.002 may choose to participate in shared services under an al-
11 ternative shared services model.

12 (3) Two or more public universities listed in ORS 352.002, including universities with
13 governing boards, may participate in shared services not described in subsection (1) of this
14 section, including but not limited to shared services involving legal services and information
15 technology.

16 (4) Pursuant to section 1 of this 2013 Act, and in order to ensure that the establishment
17 of universities with governing boards does not negatively impact public universities that do
18 not have governing boards, if a university with a governing board stops participating in a
19 service shared by two or more public universities listed in ORS 352.002, including but not
20 limited to the shared services listed in this section, and the withdrawal from the service has
21 a negative effect on the remaining public universities, the Higher Education Coordinating
22 Commission shall compensate universities suffering a negative impact through either re-
23 duction of appropriations made to the university with a governing board or any other method
24 found to be appropriate by the commission.

25 (5) The office of the Chancellor of the Oregon University System shall coordinate public
26 university shared services described in this section until a new entity to coordinate shared
27 services is operational.

28 **SECTION 15.** (1) All moneys collected or received by a university with a governing board,
29 placed to the credit of the governing board and remaining unexpended and unobligated on
30 July 1, 2014, or the date that the board is established, whichever is later, and all moneys
31 collected or received by a university with a governing board after that date, may be:

32 (a) Deposited into one or more accounts established by the board in depositories insured
33 by the Federal Deposit Insurance Corporation or the National Credit Union Share Insurance
34 Fund, and the governing board shall ensure that sufficient collateral secures any amount of
35 funds on deposit that exceeds the limits of the coverage of the Federal Deposit Insurance
36 Corporation or the National Credit Union Share Insurance Fund; or

37 (b) Held, kept, pledged, controlled, conveyed, managed, used, loaned, expended and in-
38 vested as set forth in sections 10 and 11 of this 2013 Act.

39 (2) Upon a request by the State Treasurer, a university with a governing board shall en-
40 ter into a written agreement with the state that provides for the State Treasurer to receive,
41 hold, keep, manage and invest any amounts under the control of the university that the
42 State Treasurer determines should be held by the State Treasurer to provide for payment
43 of state bonds and other state obligations that are to be paid from appropriations described
44 in section 8 (5) of this 2013 Act, revenues of the university or other moneys under the control
45 of the university. The agreement may, at the request of the State Treasurer, require the

1 university to pay the costs incurred by the State Treasurer in connection with entering into
2 and carrying out the agreement.

3 (3) Upon a request by a university with a governing board, the State Treasurer may re-
4 ceive, hold, keep, manage and invest any or all moneys, appropriations, gifts, bequests or
5 revenues of the university from any source in accordance with an agreement entered into
6 between the State Treasurer and the university and with the policies and procedures estab-
7 lished by the State Treasurer, including the recoupment of costs incurred by the State
8 Treasurer in carrying out these tasks.

9 (4) As used in this section, “depository” has the meaning given that term in ORS 295.001.

10 **SECTION 16.** (1) The following entities are not subject to any provision of law enacted
11 after January 1, 2013, that is unique to governmental entities unless the following entities
12 are expressly named:

13 (a) A university with a governing board; and

14 (b) Any not-for-profit organization or other entity if the equity of the entity is owned or
15 controlled exclusively by a university with a governing board and if the organization or entity
16 is created by the university to advance any of the university’s statutory missions.

17 (2) Notwithstanding subsection (1) of this section, the provisions of ORS 30.260 to 30.460,
18 33.710, 33.720, 200.005 to 200.025, 200.045 to 200.090, 236.605 to 236.640, 276.080, 279.835, 279.840,
19 279.850 and 297.040 and ORS chapters 35, 190, 192 and 244 apply to a university with a gov-
20 erning board under the same terms as they apply to public bodies other than the state.

21 (3) Except as otherwise provided by law, the provisions of ORS 35.550 to 35.575, 180.060,
22 180.210 to 180.235, 184.305 to 184.345, 190.480, 190.490, 200.035, 243.696, 357.805 to 357.895 and
23 656.017 (2) and ORS chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291,
24 292, 293, 294, 295 and 297 do not apply to a university with a governing board.

25 (4) Notwithstanding subsections (1) and (3) of this section, ORS 240.167, 279C.600 to
26 279C.625, 279C.800, 279C.810, 279C.825, 279C.830, 279C.835, 279C.840, 279C.845, 279C.850, 279C.855,
27 279C.860, 279C.865, 279C.870 and 292.043 apply to a university with a governing board under
28 the same terms as they apply to public bodies other than the state.

29 (5) Notwithstanding subsection (2) of this section, ORS 190.430 and 192.105 do not apply
30 to a university with a governing board or any organization or other entity described in sub-
31 section (1) of this section.

32 (6) Except as set forth in subsection (3) of this section, ORS 243.650 to 243.782 apply to
33 a university with a governing board under the same terms as they apply to the state.

34 (7) ORS 351.065, 351.067, 351.642, 351.643, 351.644, 351.646, 351.656, 351.658, 352.012 and
35 352.375 apply to a university with a governing board, except that the board or university shall
36 exercise the responsibilities and authorities of the State Board of Higher Education or the
37 Oregon University System.

38 (8) A university with a governing board and its agents and employees remain subject to
39 all statutes and administrative rules of this state that create rights, benefits or protections
40 in favor of military veterans, service members and families of service members to the same
41 extent as an agency of this state would be subject to such statutes and administrative rules.

42 (9) ORS 351.692, 351.695 and 351.697 apply to a governing board, except that the board has
43 the responsibilities and authorities with respect to the university it governs that the State
44 Board of Higher Education and the Oregon University System have with respect to the public
45 universities identified in ORS 351.011. A university with a governing board may not issue a

1 tax credit certificate under ORS 351.692, 351.695 and 351.697 that will cause the public uni-
2 versities listed in ORS 352.002 to owe the General Fund more than \$6 million at any one time
3 under ORS 351.692, 351.695 and 351.697.

4 (10) If state bonds are issued for the benefit of a university with a governing board, the
5 university shall have the powers and duties of a related agency as defined in ORS 286A.001
6 to the extent necessary for the issuance of such state bonds and the administration of the
7 proceeds of the state bonds.

8 (11) Nothing in this section may be construed so that statutory provisions that are not
9 set forth in this section apply to a university with a governing board.

10 **SECTION 17.** A university with a governing board may open, establish, lay out and dedi-
11 cate to the public use any streets through lands owned by or used for the university. When
12 such streets are opened, established and laid out, they are declared to be dedicated to the
13 public use. The university may declare that it is the road authority pursuant to ORS 810.010
14 (4) for any or all roads through lands owned by or used for the university.

15 **SECTION 18.** The president and professors constitute the faculty and as such have the
16 immediate government and discipline of a university with a governing board and the students
17 therein, except as otherwise provided by law or action of the governing board. The faculty
18 may, subject to the supervision of the governing board and section 8 of this 2013 Act, pre-
19 scribe the course of study to be pursued in the university and the textbooks to be used.

20
21 **BONDING AUTHORITY OF GOVERNING BOARDS**

22
23 **SECTION 19.** As used in sections 19 to 23 of this 2013 Act:

24 (1) "Bond-related costs" means:

25 (a) The costs of paying the principal of, the interest on and the premium, if any, on re-
26 venue bonds.

27 (b) The costs and expenses of issuing, administering and maintaining revenue bonds, in-
28 cluding, but not limited to, the costs and expenses of:

29 (A) Redeeming revenue bonds.

30 (B) Paying amounts due in connection with credit enhancement devices or agreements
31 for exchange of interest rates.

32 (C) Paying the fees, administrative costs and expenses of a university with a governing
33 board related to revenue bonds, including, but not limited to, the costs of consultants, bond
34 trustees, remarketing agents, escrow agents, arbitrage rebate consultants, calculation
35 agents and advisers retained by the university.

36 (c) The costs of funding reserves for the revenue bonds.

37 (d) Capitalized interest for the revenue bonds.

38 (e) Rebates or penalties due to the United States in connection with the revenue bonds.

39 (f) Any other costs or expenses that a university with a governing board determines are
40 necessary or desirable in connection with issuing and maintaining the revenue bonds.

41 (2) "Credit enhancement device" means an agreement or contractual relationship be-
42 tween a university with a governing board and a bank, trust company, insurance company,
43 surety bonding company, pension fund or other financial institution or entity providing ad-
44 ditional credit on or security for a revenue bond.

45 (3) "For the benefit of a university with a governing board" means, in relation to state

1 **bonds:**

2 (a) Before the effective date of this 2013 Act, the portion of the proceeds of the state
3 bonds that was used to finance property, projects or liabilities on behalf of the State Board
4 of Higher Education and for the benefit of a university with a governing board in pursuing
5 the purposes and missions of the university.

6 (b) On or after the effective date of this 2013 Act, the portion of the proceeds of the state
7 bonds a university with a governing board is eligible to receive under section 20 of this 2013
8 Act to finance property, projects or liabilities on behalf of and for the benefit of a university
9 with a governing board in pursuing the purposes and missions of the university.

10 (4) "Obligation" means:

11 (a) A revenue bond;

12 (b) The commitment of a university with a governing board in connection with a credit
13 enhancement device; or

14 (c) An agreement for exchange of interest rates.

15 (5) "Operative document" means a bond declaration, trust agreement, indenture, security
16 agreement or other document in which a university with a governing board makes a pledge.

17 (6) "Pledge" means:

18 (a) To create a lien on revenue or property.

19 (b) A lien created on revenue or property.

20 (7) "Revenue" means tuition, fees, charges, rents, revenues, interest, dividends, receipts
21 and other income of a university with a governing board, except moneys received by the
22 university from taxes collected by the State of Oregon.

23 (8) "Revenue bond":

24 (a) Means a contractual undertaking or instrument of a university with a governing
25 board to repay borrowed moneys, which undertaking or instrument is secured by a pledge
26 of all or part of the revenue of the university.

27 (b) Does not mean a credit enhancement device or a state bond.

28 **SECTION 20.** (1) A university with a governing board may elect to remain eligible to re-
29 ceive proceeds of state bonds. If a university with a governing board requests the State
30 Treasurer to issue state bonds for the benefit of the university with a governing board that
31 are authorized under Article XI-F(1) or XI-Q of the Oregon Constitution or ORS 283.085 to
32 283.092, and the state bonds are intended to be repaid in whole or in part by university re-
33 venues or other moneys under the control of the university, the State Treasurer must review
34 and approve all plans to issue revenue bonds of the university and to execute other obli-
35 gations related to the revenue bonds.

36 (2) The State Treasurer shall limit the scope of review and approval under subsection (1)
37 of this section to consideration of periodic cash flow projections and other information nec-
38 cessary to determine the sufficiency of the cash flow of the university with a governing board
39 to pay any loans from state agencies funded with the proceeds of state bonds and to pay
40 costs for:

41 (a) State bonds issued for the benefit of the university with a governing board pursuant
42 to Article XI-F(1) or XI-Q of the Oregon Constitution or ORS 283.085 to 283.092; and

43 (b) Revenue bonds issued pursuant to sections 19 to 23 of this 2013 Act.

44 (3) A university with a governing board that issues revenue bonds of the university, or
45 executes other obligations related to the revenue bonds, without the approval of the State

1 Treasurer as provided in subsection (2) of this section is not eligible to receive proceeds of
2 the state bonds described in subsection (1) of this section and that are intended to be repaid
3 in whole or in part by university revenues or other moneys under the control of the uni-
4 versity on or after the effective date of this 2013 Act.

5 (4) For the purposes of ORS chapter 286A, a university with a governing board has the
6 powers and duties of a related agency as described in section 16 (10) of this 2013 Act with
7 respect to state bonds that:

8 (a) Were issued before the effective date of this 2013 Act for the benefit of a university
9 with a governing board and that remain outstanding; and

10 (b) Are authorized under ORS 286A.035 and issued on or after the effective date of this
11 2013 Act for the benefit of a university with a governing board.

12 **SECTION 21. (1) A university with a governing board:**

13 (a) May issue revenue bonds for any lawful purpose of the university in accordance with
14 ORS chapter 287A.

15 (b) May issue under ORS 287A.360 to 287A.380 refunding bonds of the same character and
16 tenor as the revenue bonds replaced.

17 (2) For the purposes of ORS 271.390 and ORS chapter 287A, a university with a governing
18 board is a public body.

19 (3) ORS 287A.150 does not apply to revenue bonds issued by a university with a governing
20 board.

21 (4) A university with a governing board:

22 (a) May grant leases of real property held by a trustee or lender for a term that ends
23 on the date on which all amounts due under the operative documents have been paid, or
24 provision for payment has been made, or for a term of up to 20 years after the last scheduled
25 payment under the operative documents, whichever is sooner. The leases may grant the
26 trustee or lender the right to evict the university and exclude the university from possession
27 of the real property for the term of the lease if the university fails to pay when due the
28 amounts scheduled to be paid under the operative documents or otherwise defaults under the
29 operative documents. Upon default, the trustee or lender may sublease the real property to
30 third parties and apply any rents to payments scheduled to be made under the operative
31 documents.

32 (b) May not mortgage, pledge or grant a security interest in, or otherwise encumber, real
33 or personal property that has been pledged or leased to provide security for, or acquired,
34 constructed, improved with, or otherwise directly benefited by, the proceeds of outstanding
35 state bonds, except as provided in section 12 (3) of this 2013 Act.

36 (5) Revenue bonds and other obligations authorized by this section:

37 (a) Are revenue bonds or obligations of a political subdivision of the State of Oregon.

38 (b) Are not an indebtedness or obligation of the State of Oregon and are not a charge
39 upon revenue or property of the State of Oregon, except as provided in subsection (4) of this
40 section.

41 (c) Are not a charge upon any revenue or property of a university with a governing board
42 unless the revenue or property is pledged to secure the revenue bonds or other obligations.

43 (d) Are not payable from, and may not be secured by a pledge of or lien on, any amounts
44 a university with a governing board is required to:

45 (A) Deposit with the State Treasurer pursuant to section 15 (2) of this 2013 Act; or

1 **(B) Pay to the State Treasurer pursuant to a schedule described in section 23 of this 2013**
2 **Act.**

3 **NOTE:** Section 22 was deleted by amendment. Subsequent sections were not renumbered.

4 **SECTION 23. (1) Sections 19 to 23 of this 2013 Act do not impair the obligations, as de-**
5 **defined in ORS 286A.100, or agreements of the State of Oregon or the State Board of Higher**
6 **Education with respect to state bonds issued before the effective date of this 2013 Act for**
7 **the benefit of a university with a governing board.**

8 **(2) A university with a governing board and the Oregon University System shall take all**
9 **actions necessary to ensure full compliance with the operative documents executed with re-**
10 **spect to state bonds issued before, on or after the effective date of this 2013 Act by the State**
11 **Treasurer for the benefit of the university with a governing board.**

12 **(3) The State Treasurer and the Oregon University System shall promptly provide a uni-**
13 **versity that acquires a governing board with a schedule of outstanding state bonds and other**
14 **obligations for which the university must pay, including the payment dates and amounts, or**
15 **methods for determining the amounts. The schedule must include amounts sufficient to pay**
16 **principal, interest and premium, if any, on the state bonds, and to pay administrative and**
17 **other costs of the State of Oregon that are related to the state bonds or other obligations.**
18 **If the State Treasurer issues state bonds for the benefit of a university with a governing**
19 **board on or after the effective date of this 2013 Act that are intended to be repaid in whole**
20 **or in part by university revenues or other moneys under the control of the university, the**
21 **schedule shall be amended to include such state bonds and the amounts to be paid by the**
22 **university. In the absence of manifest error, the schedule provided by the State Treasurer**
23 **and the Oregon University System to a university with a governing board is binding on the**
24 **university. The university with a governing board shall pay the amounts specified in the**
25 **schedule provided by the State Treasurer and the Oregon University System on or before the**
26 **dates specified in the schedule from the legally available revenue of the university and on a**
27 **pari passu basis with the payment of any revenue bonds of the university issued pursuant**
28 **to section 21 of this 2013 Act.**

29 **(4) At the request of the State Treasurer, a university with a governing board shall pro-**
30 **vide the State Treasurer with periodic cash flow projections and other information that allow**
31 **the State Treasurer to review and approve the sufficiency of the university's cash flow to**
32 **pay amounts specified in the schedule described in subsection (3) of this section and to pay**
33 **amounts owed under loans from state agencies that were funded with the proceeds of state**
34 **bonds.**

35 **(5) Moneys deposited with the State Treasurer, the Controller of the Oregon University**
36 **System or the Oregon Department of Administrative Services in a debt service reserve ac-**
37 **count or otherwise for the portion of the debt service associated with obligations entered**
38 **into before the effective date of this 2013 Act for the benefit of a university with a governing**
39 **board must remain with the State Treasurer, the Controller of the Oregon University System**
40 **or the Oregon Department of Administrative Services until the obligations have been retired**
41 **or defeased. Earnings on moneys described in this subsection must be credited to the ac-**
42 **count or fund in which the moneys are held.**

43 **(6) The principal, interest, premium, if any, and any issuance costs of state bonds issued**
44 **before, on or after the effective date of this 2013 Act for the benefit of a university with a**
45 **governing board, and any related credit enhancement device or interest rate exchange**

1 agreement, shall be paid from the sources identified in the laws and operative documents
 2 authorizing the state bonds. The university with a governing board for which the state bonds
 3 were issued shall pay any other expenses and liabilities, including, but not limited to, legal
 4 expenses arising from an inquiry, audit or other action by a federal or state regulatory body,
 5 unless the expense or liability results solely from the negligence or willful misconduct of a
 6 state agency.

7 (7) Pursuant to ORS chapter 180, on behalf of the State Treasurer or any other state
 8 agency, the Attorney General shall appear, commence, prosecute or defend any action, suit,
 9 matter, cause or proceeding arising from any state bond issued for the benefit of a university
 10 with a governing board and any related credit enhancement device or interest rate exchange
 11 agreement. As soon as practicable after a governing board is established by a university
 12 pursuant to section 3 of this 2013 Act, the university with a governing board and the State
 13 Treasurer shall enter into an agreement that addresses reimbursement of reasonable costs
 14 and expenses associated with the legal representation of the State Treasurer in connection
 15 with state bonds issued for the benefit of the university with a governing board before, on
 16 or after the effective date of this 2013 Act and any other topic necessary for the Department
 17 of Justice to provide legal representation to the State Treasurer in connection with state
 18 bonds issued for the benefit of the university with a governing board and to provide repre-
 19 sentation related to funds and accounts or services provided under section 15 of this 2013
 20 Act.

21 (8) A university with a governing board shall assume responsibility, in accordance with
 22 agreements entered into with the Department of Justice and the State Treasurer, for the
 23 indemnity and defense of university officers, agents and employees with regard to, as appli-
 24 cable, claims asserted and actions commenced in connection with state bonds issued for the
 25 benefit of the university with a governing board.

4 **(e) Eastern Oregon University.**

5 **(2)** The State Board of Higher Education, on behalf of the Oregon University System, shall ex-

8 **(3)** The Oregon University System is an instrumentality of the state and a government entity
9 performing governmental functions and exercising governmental powers. Notwithstanding the status
10 of the Oregon University System as an instrumentality of the state, the Oregon University System
11 is not eligible to request or receive legal services from the Attorney General and the Department
12 of Justice pursuant to ORS chapter 180, except as otherwise expressly provided by law.

13 **(4)** The Oregon University System is not considered a unit of local or municipal government.

14 **(5) Subsections (1) to (4) of this section apply only to listed public universities that do**
15 **not become a university with a governing board under section 3, 168 or 168a of this 2013 Act.**

16 **SECTION 26. A public university that becomes a university with a governing board under**
17 **section 168 or 168a of this 2013 Act is not considered to be a public university listed in ORS**
18 **351.011.**

20 **SECTION 28.** ORS 287A.001 is amended to read:

21 287A.001. As used in this chapter:

22 **(1)** “Advance refunding bond” means a bond all or part of the proceeds of which are to be used

24 **(2)** “Agreement for exchange of interest rates” means a contract, or an option or forward com-
25 mitment to enter into a contract, for an exchange of interest rates for related bonds that provides

28 **(b)** Provisions to hedge payment, rate, spread or similar exposure including, but not limited to,

35 **(6)** “Credit enhancement device”:

36 **(a)** Means a letter of credit, line of credit, standby bond purchase agreement, bond insurance

17 offices, departments or activities prior to July 1, 1975, shall be maintained in the files designated.
18 However, if a faculty member requests access to those files, the anonymity of the contributor of

13 value, and which gives its user an opportunity to obtain a business advantage over competitors who

18 (d) Persons employed and paid from federal funds received under a federal program intended
19 primarily to alleviate unemployment. However, any such person shall be considered an "employee"
20 if not otherwise excluded by paragraphs (a) to (c) of this subsection and the public employer elects
21 to have the person so considered by an irrevocable written notice to the board.

22 (e) Persons who are employees of a railroad, as defined in ORS 824.020, and who, as such em-
23 ployees, are included in a retirement plan under federal railroad retirement statutes. This paragraph
24 shall be deemed to have been in effect since the inception of the system.

25 (9) "Final average salary" means whichever of the following is greater:

26 (a) The average salary per calendar year paid by one or more participating public employers to
27 an employee who is an active member of the system in three of the calendar years of membership
28 before the effective date of retirement of the employee, in which three years the employee was paid
29 the highest salary. The three calendar years in which the employee was paid the largest total salary
30 may include calendar years in which the employee was employed for less than a full calendar year.
31 If the number of calendar years of active membership before the effective date of retirement of the
32 employee is three or fewer, the final average salary for the employee is the average salary per cal-
33 endar year paid by one or more participating public employers to the employee in all of those years,
34 without regard to whether the employee was employed for the full calendar year.

35 (b) One-third of the total salary paid by a participating public employer to an employee who is
36 an active member of the system in the last 36 calendar months of active membership before the ef-
37 fective date of retirement of the employee.

38 (10) "Firefighter" does not include a volunteer firefighter, but does include:

39 (a) The State Fire Marshal, the chief deputy fire marshal and deputy state fire marshals; and

40 (b) An employee of the State Forestry Department who is certified by the State Forester as a
41 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
42 fires as described in ORS 477.064.

43 (11) "Fiscal year" means 12 calendar months commencing on July 1 and ending on June 30 fol-
44 lowing.

45 (12) "Fund" means the Public Employees Retirement Fund.

1 (13) "Inactive member" means a member who is not employed in a qualifying position, whose
2 membership has not been terminated in the manner described by ORS 238.095 and who is not retired
3 for service or disability.

4 (14) "Institution of higher education" means a public university listed in ORS 352.002, the
5 Oregon Health and Science University and a community college, as defined in ORS 341.005.

6 (15) "Member" means a person who has established membership in the system and whose mem-
7 bership has not been terminated as described in ORS 238.095. "Member" includes active, inactive
8 and retired members.

9 (16) "Member account" means the regular account and the variable account.

10 (17) "Normal retirement age" means:

11 (a) For a person who establishes membership in the system before January 1, 1996, as described
12 in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or firefighter
13 or 58 years of age if the employee retires at that age as other than a police officer or firefighter.

14 (b) For a person who establishes membership in the system on or after January 1, 1996, as de-
15 scribed in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or
16 firefighter or 60 years of age if the employee retires at that age as other than a police officer or
17 firefighter.

18 (18) "Pension" means annual payments for life derived from contributions by one or more public
19 employers.

20 (19) "Police officer" includes:

21 (a) Employees of institutions defined in ORS 421.005 as Department of Corrections institutions
22 whose duties, as assigned by the Director of the Department of Corrections, include the custody of
23 persons committed to the custody of or transferred to the Department of Corrections and employees
24 of the Department of Corrections who were classified as police officers on or before July 27, 1989,
25 whether or not such classification was authorized by law.

26 (b) Employees of the Department of State Police who are classified as police officers by the
27 Superintendent of State Police.

28 (c) Employees of the Oregon Liquor Control Commission who are classified as liquor enforce-
29 ment inspectors by the administrator of the commission.

30 (d) Sheriffs and those deputy sheriffs or other employees of a sheriff whose duties, as classified
31 by the sheriff, are the regular duties of police officers or corrections officers.

32 (e) Police chiefs and police personnel of a city who are classified as police officers by the
33 council or other governing body of the city.

34 (f) Police officers who are commissioned by a university under ORS 352.383 and who are clas-
35 sified as police officers by the university.

36 (g) Parole and probation officers employed by the Department of Corrections, parole and pro-
37 bation officers who are transferred to county employment under ORS 423.549 and adult parole and
38 probation officers, as defined in ORS 181.610, who are classified as police officers for the purposes
39 of this chapter by the county governing body. If a county classifies adult parole and probation offi-
40 cers as police officers for the purposes of this chapter, and the employees so classified are repres-
41 ented by a labor organization, any proposal by the county to change that classification or to cease
42 to classify adult parole and probation officers as police officers for the purposes of this chapter is
43 a mandatory subject of bargaining.

44 (h) Police officers appointed under ORS 276.021 or 276.023.

45 (i) Employees of the Port of Portland who are classified as airport police by the Board of Com-

1 missioners of the Port of Portland.

2 (j) Employees of the State Department of Agriculture who are classified as livestock police of-
3 ficers by the Director of Agriculture.

4 (k) Employees of the Department of Public Safety Standards and Training who are classified by
5 the department as other than secretarial or clerical personnel.

6 (L) Investigators of the Criminal Justice Division of the Department of Justice.

7 (m) Corrections officers as defined in ORS 181.610.

8 (n) Employees of the Oregon State Lottery Commission who are classified by the Director of the
9 Oregon State Lottery as enforcement agents pursuant to ORS 461.110.

10 (o) The Director of the Department of Corrections.

11 (p) An employee who for seven consecutive years has been classified as a police officer as de-
12 fined by this section, and who is employed or transferred by the Department of Corrections to fill
13 a position designated by the Director of the Department of Corrections as being eligible for police
14 officer status.

15 (q) An employee of the Department of Corrections classified as a police officer on or prior to
16 July 27, 1989, whether or not that classification was authorized by law, as long as the employee
17 remains in the position held on July 27, 1989. The initial classification of an employee under a sys-
18 tem implemented pursuant to ORS 240.190 does not affect police officer status.

19 (r) Employees of a school district who are appointed and duly sworn members of a law
20 enforcement agency of the district as provided in ORS 332.531 or otherwise employed full-time as
21 police officers commissioned by the district.

22 (s) Employees at youth correction facilities and juvenile detention facilities under ORS 419A.050,
23 419A.052 and 420.005 to 420.915 who are required to hold valid Oregon teaching licenses and who
24 have supervisory, control or teaching responsibilities over juveniles committed to the custody of the
25 Department of Corrections or the Oregon Youth Authority.

26 (t) Employees at youth correction facilities as defined in ORS 420.005 whose primary job de-
27 scription involves the custody, control, treatment, investigation or supervision of juveniles placed
28 in such facilities.

29 (u) Employees of the Oregon Youth Authority who are classified as juvenile parole and pro-
30 bation officers.

31 (20) "Prior service credit" means credit provided under ORS 238.442 or under ORS 238.225 (2)
32 to (6) (1999 Edition).

33 (21) "Public employer" means the state, one of its agencies, any city, county, or municipal or
34 public corporation, any political subdivision of the state or any instrumentality thereof, or an agency
35 created by one or more such governmental organizations to provide governmental services. For
36 purposes of this chapter, such agency created by one or more governmental organizations is a gov-
37 ernmental instrumentality and a legal entity with power to enter into contracts, hold property and
38 sue and be sued.

39 (22) "Qualifying position" means one or more jobs with one or more participating public em-
40 ployers in which an employee performs 600 or more hours of service in a calendar year, excluding
41 any service in a job for which a participating public employer does not provide benefits under this
42 chapter pursuant to an application made under ORS 238.035.

43 (23) "Regular account" means the account established for each active and inactive member un-
44 der ORS 238.250.

45 (24) "Retired member" means a member who is retired for service or disability.

1 (25) "Retirement credit" means a period of time that is treated as creditable service for the
2 purposes of this chapter.

3 (26)(a) "Salary" means the remuneration paid an employee in cash out of the funds of a public
4 employer in return for services to the employer, plus the monetary value, as determined by the
5 Public Employees Retirement Board, of whatever living quarters, board, lodging, fuel, laundry and
6 other advantages the employer furnishes the employee in return for services.

7 (b) "Salary" includes but is not limited to:

8 (A) Payments of employee and employer money into a deferred compensation plan, which are
9 deemed salary paid in each month of deferral;

10 (B) The amount of participation in a tax-sheltered or deferred annuity, which is deemed salary
11 paid in each month of participation;

12 (C) Retroactive payments described in ORS 238.008; and

13 (D) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
14 652.190.

15 (c) "Salary" or "other advantages" does not include:

16 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
17 employer;

18 (B) Payments for insurance coverage by an employer on behalf of employee or employee and
19 dependents, for which the employee has no cash option;

20 (C) Payments made on account of an employee's death;

21 (D) Any lump sum payment for accumulated unused sick leave;

22 (E) Any accelerated payment of an employment contract for a future period or an advance
23 against future wages;

24 (F) Any retirement incentive, retirement severance pay, retirement bonus or retirement
25 gratuitous payment;

26 (G) Payments for periods of leave of absence after the date the employer and employee have
27 agreed that no future services qualifying pursuant to ORS 238.015 (3) will be performed, except for
28 sick leave and vacation;

29 (H) Payments for instructional services rendered to public universities [*of the Oregon University*
30 *System*] **listed in ORS 352.002** or the Oregon Health and Science University when such services are
31 in excess of full-time employment subject to this chapter. A person employed under a contract for
32 less than 12 months is subject to this subparagraph only for the months to which the contract per-
33 tains; or

34 (I) Payments made by an employer for insurance coverage provided to a domestic partner of an
35 employee.

36 (27) "School year" means the period beginning July 1 and ending June 30 next following.

37 (28) "System" means the Public Employees Retirement System.

38 (29) "Variable account" means the account established for a member who participates in the
39 Variable Annuity Account under ORS 238.260.

40 (30) "Vested" means being an active member of the system in each of five calendar years.

41 (31) "Volunteer firefighter" means a firefighter whose position normally requires less than 600
42 hours of service per year.

43 **SECTION 110.** ORS 238.200 is amended to read:

44 238.200. (1)(a) An active member of the Public Employees Retirement System shall contribute to
45 the Public Employees Retirement Fund and there shall be withheld from salary of the member six

1 percent of that salary as an employee contribution.

2 (b) Notwithstanding paragraph (a) of this subsection, an employee who is an active member of

15 (c) An employee of the State Forestry Department who is certified by the State Forester as a
16 professional wildland firefighter and whose primary duties include the abatement of uncontrolled

18 (6) “Fund” means the Public Employees Retirement Fund.

19 (7)(a) “Hour of service” means:

20 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
21 by a participating public employer for performance of duties in a qualifying position; and

22 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
23 during which an employee does not perform duties but for which the employee is directly or indi-

32 those funds. Retirement and death benefits shall be provided under the plan by the purchase of
33 annuity contracts, fixed or variable or a combination thereof, or by contracts for investments in
34 mutual funds.

35 (2) An administrative or academic employee [*of the Oregon University System*] may elect to par-
36 ticipate in the Optional Retirement Plan upon completion of:

37 (a) Six hundred hours of employment, or the equivalent as determined by the State Board of
38 Higher Education **or the governing board**; and

39 (b) Six months of employment that is not interrupted by more than 30 consecutive working days.

40 (3) An administrative or academic employee may make an irrevocable election to participate in
41 the Optional Retirement Plan within six months after being employed. An election under this sub-
42 section is effective on the first day of the month following the completion of the requirements of
43 subsection (2) of this section.

44 (4) An administrative or academic employee who does not elect to participate in the Optional
45 Retirement Plan:

1 (a) Remains or becomes a member of the Public Employees Retirement System in accordance
2 with ORS chapters 238 and 238A; or

3 (b) Continues to be assisted by the State Board of Higher Education **or governing board** under
4 ORS 243.920 if the employee is being so assisted.

5 (5) Except as provided in subsection (6) of this section, employees who elect to participate in the

10 (6)(a) An administrative or academic employee who elects to participate in the Optional Retirement

12 is not vested shall be considered by the Public Employees Retirement Board to be a terminated
13 member under the provisions of ORS 238.095 as of the effective date of the election, and the amount
14 credited to the member account of the member shall be transferred directly to the Optional Retirement
15 Plan by the Public Employees Retirement Board in the manner provided by subsection (7) of
16 this section.

17 (b) An administrative or academic employee who elects to participate in the Optional Retirement
18 Plan, who has creditable service under ORS chapter 238 as defined by ORS 238.005 and who is
19 vested shall be considered to be an inactive member by the Public Employees Retirement Board and
20 shall retain all the rights, privileges and options under ORS chapter 238 unless the employee makes
21 a written request to the Public Employees Retirement Board for a transfer of the amounts credited
22 to the member account of the member to the Optional Retirement Plan. A request for a transfer
23 must be made at the time the member elects to participate in the Optional Retirement Plan. Upon
24 receiving the request, the Public Employees Retirement Board shall transfer all amounts credited
25 to the member account of the member directly to the Optional Retirement Plan, and shall terminate
26 all rights, privileges and options of the employee under ORS chapter 238.

27 (c) An administrative or academic employee who elects to participate in the Optional Retirement
28 Plan, and who is not a vested member of the pension program of the Oregon Public Service Retirement
29 Plan as described in ORS 238A.115 on the date that the election becomes effective, shall be
30 considered to be a terminated member of the pension program by the Public Employees Retirement
31 Board as of the effective date of the election.

32 (d) An administrative or academic employee who elects to participate in the Optional Retirement
33 Plan, and who is a vested member of the pension program of the Oregon Public Service Retirement
34 Plan as described in ORS 238A.115 on the date that the election becomes effective, shall be consid-
35 ered an inactive member of the pension program by the Public Employees Retirement Board as of
36 the effective date of the election. An employee who is subject to the provisions of this paragraph
37 retains all the rights, privileges and options of an inactive member of the pension program. If the
38 actuarial equivalent of the employee's benefit under the pension program at the time that the
39 election becomes effective is \$5,000 or less, the employee may make a written request to the Public
40 Employees Retirement Board for a transfer of the employee's interest under the pension program to
41 the Optional Retirement Plan. The request must be made at the time the member elects to partic-
42 ipate in the Optional Retirement Plan. Upon receiving the request, the Public Employees Retirement
43 Board shall transfer the amount determined to be the actuarial equivalent of the employee's benefit
44 under the pension program directly to the Optional Retirement Plan, and shall terminate the mem-
45 bership of the employee in the pension program.

1 (e) An administrative or academic employee who elects to participate in the Optional Retirement
2 Plan, and who is a vested member of the individual account program of the Oregon Public Service
3 Retirement Plan as described in ORS 238A.320 on the date that the election becomes effective, shall
4 be considered an inactive member of the individual account program by the Public Employees Re-
5 tirement Board as of the effective date of the election. An employee who is subject to the provisions
6 of this paragraph retains all the rights, privileges and options of an inactive member of the indi-
7 vidual account program. An administrative or academic employee who elects to participate in the
8 Optional Retirement Plan, and who is a member of the individual account program of the Oregon
9 Public Service Retirement Plan, may make a written request to the Public Employees Retirement
10 Board that all amounts in the member's employee account, rollover account and employer account,
11 to the extent the member is vested in those accounts under ORS 238A.320, be transferred to the
12 Optional Retirement Plan. The request must be made at the time the member elects to participate
13 in the Optional Retirement Plan. Upon receiving the request, the Public Employees Retirement
14 Board shall transfer the amounts directly to the Optional Retirement Plan, and shall terminate the
15 membership of the employee in the individual account program upon making the transfer.

40 interest be contingent, conditional or otherwise, for authority to sell, exchange, convey or lease all
41 or any part of such real property. The resolution is prima facie evidence that such real property is
42 not needed for public use, or that the sale, exchange, conveyance or lease will further the public
43 interest. The action shall be commenced and prosecuted to final determination in the same manner
44 as an action not triable by right to a jury. The complaint shall contain a description of such real
45 property, a statement of the nature of the restrictions, qualifications or limitations, and a statement

1 that the defendants claim some interest therein. The court shall make such judgment as it shall
2 deem proper, taking into consideration the limitations, qualifications or restrictions, the resolution
3 and all other matters pertinent thereto. Neither costs nor disbursements may be recovered against
4 any defendant.

41 **ESTABLISHMENT OF SPECIAL COMMITTEE**
42 **AND WORK GROUP**
43

44 **SECTION 166.** (1) **The Special Committee on University Governance and Operations is**
45 **established, consisting of 10 members appointed as follows:**

1 (a) The President of the Senate shall appoint four members from among members of the
2 Senate.

3 (b) The Speaker of the House of Representatives shall appoint four members from among
4 members of the House of Representatives.

5 (c) The Governor shall appoint two members who are members of the Oregon Education
6 Investment Board.

7 (2) The special committee shall review, discuss and analyze:

8 (a) Issues of administration within the state post-secondary education system with an
9 emphasis on four-year public universities; and

10 (b) Coordination of operations, academic programs, shared services and other elements
11 of that system, after considering the recommendations of the Work Group on University
12 Shared Services established under section 166a of this 2013 Act.

13 (3) The special committee may recommend legislation on the future relationship between
14 Oregon's institutions of post-secondary education.

15 (4) The special committee shall evaluate options related to institutional governance as
16 Oregon's public universities transition to new governing boards, with a focus on how best to
17 coordinate academic services among the universities in order to increase student access,
18 affordability and success in pursuit of the mission described in ORS 351.009. Options may
19 include the role of a chancellor or an academic leader, the composition of the interim State
20 Board of Higher Education between July 1, 2014, and June 30, 2015, or the composition and
21 authorities of a consortium board for universities that do not request institutional governing
22 boards.

23 (5) With respect to university governance, any legislation recommended by the special
24 committee shall:

25 (a) Take into consideration the unique mission associated with each of Oregon's seven
26 public universities and identify how these missions can best be accomplished and sustained

28 (b) Ensure that the public missions of Oregon's public universities, including access and
29 affordability for residents of this state, are maintained and enhanced.

30 (6) With respect to university operations, any legislation recommended by the special
31 committee shall define the operating arrangements between the institutions in order to en-

33 (a) That all post-secondary institutions, including public universities listed in ORS 352.002

44 payroll, employee benefits, accounting, auditing, purchasing and contracting, information

2 (8) A majority of the members of the special committee constitutes a quorum for the
3 transaction of business.

4 (9) Official action by the special committee requires the approval of a majority of the
5 members of the committee.

6 (10) The special committee shall elect two of its members to serve as cochairpersons, one
7 of whom is from the Senate and one of whom is from the House of Representatives.

8 (11) If there is a vacancy for any cause, the appointing authority shall make an appoint-
9 ment to become immediately effective.

10 (12) The special committee shall meet at times and places specified by the call of the
11 cochairpersons or of a majority of the members of the committee.

12 (13) The special committee may adopt rules necessary for the operation of the commit-
13 tee.

14 (14)(a) The special committee shall convene and begin work no later than September 15,

16 (b) The special committee shall submit interim recommendations to the Governor and

32 source, public or private, for the purposes of the consultation with national experts required

34 **SECTION 166a.** (1) The Work Group on University Shared Services is established, con-
35 sisting of the presidents of the seven public universities listed in ORS 352.002 or the
36 presidents' designees.

37 (2) The work group shall develop a shared services model that delivers efficient and ef-
38 fective administrative operations to participating post-secondary institutions in a manner
39 that focuses on quality, responsiveness and customer service and that seeks to achieve cost
40 savings, economies of scale, accountability, transparency and streamlining.

41 (3) In developing a shared services model under subsection (2) of this section, the ser-
42 vices that the work group must consider include, but are not limited to, risk management,
43 cash management, asset management, treasury services, payroll, employee benefits, ac-
44 counting, auditing, purchasing and contracting, information technology and any other ad-
45 ministrative function that might benefit from the sharing or pooling of public university

1 resources.

2 (4) In recommending how to achieve a shared services enterprise for the public univer-
3 sities listed in ORS 352.002, the work group shall:

4 (a) Recommend an appropriate entity to facilitate the sharing of services among the
5 public universities listed in ORS 352.002 after universities with governing boards are estab-
6 lished;

7 (b) Recommend how the shared services coordinating entity described in paragraph (a)
8 of this subsection will be managed;

9 (c) Determine the financial impact that will be caused, both cumulatively and individ-
10 ually, for each university that establishes a governing board and leaves the Oregon Univer-
11 sity System;

12 (d) Recommend a mechanism to mitigate or eliminate the negative financial impact
13 caused by universities establishing governing boards and leaving the Oregon University Sys-
14 tem, or require universities establishing governing boards and leaving the Oregon University
15 System to remain in each shared service. In determining this mechanism, the work group
16 must consider the appropriateness of assessments or reductions of appropriations; and

17 (e) Identify services that should remain shared among public universities listed in ORS
18 352.002 after the establishment of universities with governing boards. In determining whether
19 a service should remain shared, the work group must consider the economies of scale
20 achieved by sharing the service, the benefit to the public in sharing the service and the
21 positive and negative financial impact on each public university if one or more universities
22 with governing boards either stops or continues to participate in the service.

23 (5) The State Board of Higher Education and the office of the Chancellor of the Oregon
24 University System shall assist the work group in developing the work group's recommen-
25 dations. The work group may seek and accept consulting or other technical assistance from
26 any source in preparing its recommendations.

27 (6) A majority of the members of the work group constitutes a quorum for the trans-
28 action of business.

29 (7) Official action by the work group requires the approval of a majority of the members
30 of the work group.

31 (8) The work group shall elect one of its members to serve as chairperson.

32 (9) The work group shall meet at times and places specified by the call of the chairperson
33 or of a majority of the members of the work group.

34 (10) The work group may adopt rules necessary for the operation of the work group.

35 (11)(a) The work group shall submit a first draft of its recommended shared services
36 model to the Special Committee on University Governance and Operations established in
37 section 166 of this 2013 Act no later than December 15, 2013.

38 (b) The work group shall finalize and submit its recommended shared services model to
39 the special committee no later than September 15, 2014.

40 (12) The Oregon University System shall provide staff support to the work group.

41 (13) Members of the work group are not entitled to compensation.

42 (14) All agencies of state government, as defined in ORS 174.111, are directed to assist
43 the work group in the performance of its duties and, to the extent permitted by laws relating
44 to confidentiality, to furnish such information and advice as the members of the work group
45 consider necessary to perform their duties.

1 **SECTION 167.** Sections 166 and 166a of this 2013 Act are repealed on the date of the
2 convening of the 2016 regular session of the Legislative Assembly as specified in ORS 171.010.

3
4 **OPERATIVE DATE AND TRANSITIONAL PROVISIONS**

5
6 **SECTION 168.** (1) Notwithstanding the operative date set forth in section 171 of this 2013
7 Act, the Governor shall appoint all of the members of the Board of Trustees of the Univer-
8 sity of Oregon and all of the members of the Board of Trustees of Portland State University
9 by August 19, 2013, so that these appointees may be confirmed by the Senate in the manner
10 provided in ORS 171.562 and 171.565 by September 30, 2013.

11 (2) If the president of Oregon State University notifies the Governor by August 1, 2013,
12 the university will become a university with a governing board:

13 (a) Within two weeks after receiving the notification, the Governor shall inform the
14 President of the Senate, the Speaker of the House of Representatives and the Legislative
15 Counsel of the notification; and

16 (b) The Governor shall appoint all of the members of the Board of Trustees of Oregon
17 State University in the same manner and time frame as set forth in subsection (1) of this
18 section.

19 (3) If the president of Oregon State University notifies the Governor between August 2,
20 2013, and January 1, 2014, that the university will become a university with a governing
21 board, the Board of Trustees of Oregon State University shall be established in the manner
22 set forth in section 168a of this 2013 Act.

23 **SECTION 168a.** (1) If the president of Oregon State University notifies the Governor be-
24 tween August 2, 2013, and January 1, 2014, that the university will become a university with
25 a governing board:

26 (a) Within two weeks after receiving the notification, the Governor shall inform the
27 President of the Senate, the Speaker of the House of Representatives and the Legislative
28 Counsel of the notification; and

29 (b) Not later than February 1, 2014, the Governor shall appoint all of the members of the
30 governing board in the manner set forth in section 6 of this 2013 Act.

31 (2)(a) If the president of Eastern Oregon University, Oregon Institute of Technology,
32 Southern Oregon University or Western Oregon University determines that the university
33 should become a university with a governing board, the president shall notify the Governor
34 and the State Board of Higher Education of the university's intent. Notification under this
35 subsection must occur during the period beginning March 1, 2014, and ending June 1, 2015.

36 (b) Within 45 days of receiving notification under this subsection from a university
37 president, the State Board of Higher Education shall decide whether or not to endorse the
38 university's decision. If the board endorses the request, the board shall immediately com-
39 municate any endorsement to the Governor.

40 (b) Upon receiving notification that the State Board of Higher Education has endorsed a
41 university's decision to become a university with a governing board, the Governor shall:

42 (A) Inform the President of the Senate, the Speaker of the House of Representatives and
43 the Legislative Counsel of that the university will become a university with a governing
44 board; and

45 (B) Not later than six months after receiving the notification, appoint all of the members

1 of the governing board in the manner set forth in section 6 of this 2013 Act.

2 (3) Notwithstanding section 169 of this 2013 Act, if Eastern Oregon University, Oregon
3 Institute of Technology, Southern Oregon University or Western Oregon University become
4 a university with a governing board under subsection (2) of this section, the president of that
5 university shall take over administrative responsibilities for the university from the State
6 Board of Higher Education on either July 1, 2015 or when the Governor appoints the mem-
7 bers of the governing board, whichever date comes later.

8 **SECTION 169.** Except as provided in section 168a of this 2013 Act, the State Board of
9 Higher Education shall continue to have jurisdiction over the operations of a university with
10 a governing board as defined in section 2 of this 2013 Act through June 30, 2014. However,
11 the governing board shall propose funding requests pursuant to section 8 of this 2013 Act and
12 ORS 351.052, as amended by section 42 of this 2013 Act, and shall prepare budgets, in coop-
13 eration with the Higher Education Coordinating Commission, for the biennium beginning July
14 1, 2015.

15 **SECTION 170.** (1) Except as otherwise expressly provided in this section, all persons
16 employed by a university with a governing board, as defined in section 2 of this 2013 Act, on
17 the effective date of this 2013 Act shall continue their employment with the university and
18 shall retain any seniority, contractual rights or tenure granted prior to the effective date
19 of this 2013 Act. Nothing in this section shall affect any term or condition of any collective
20 bargaining agreement in effect on the effective date of this 2013 Act.

21 (2) All of the duties, functions, powers and lawfully incurred rights and obligations of the
22 State Board of Higher Education that pertain to a university with a governing board are
23 transferred to and vested in the governing board. The transfer shall include but not be lim-
24 ited to all applicable contractual rights and obligations and title to all applicable records,
25 property, supplies and materials, including equipment, books and papers. For the purpose of
26 succession to these rights and obligations, the governing board is considered to be a contin-
27 uation of the State Board of Higher Education and not a new authority, and the governing
28 board must exercise such rights and fulfill such obligations as if they had not been assigned
29 or transferred, except as otherwise provided by law.

30 (3) All unexpended moneys, including but not limited to General Fund appropriations,
31 gifts, bequests, other funds, assessments, liability and worker's compensation reserves and
32 premiums that are appropriated to, held, managed or invested by or on behalf of or otherwise
33 available to a university with a governing board, are appropriated and transferred to the
34 university.

35 (4) A university with a governing board shall conduct and complete any proceeding,
36 action, prosecution or other matter that the university commenced before the effective date
37 of this 2013 Act and that is pending on the effective date of this 2013 Act.

38 (5) The transfer of duties, functions and powers to a governing board or university with
39 a governing board does not affect any action, suit or proceeding relating to the university,
40 except that the university shall be substituted for the State Board of Higher Education and
41 the State of Oregon in any such action, suit or proceeding.

42 (6) Any action, proceeding or other matter that was commenced by a state agency, a
43 state officer, the State Board of Higher Education or an officer or employee of the State
44 Board of Higher Education before the effective date of this 2013 Act and relates to the gov-
45 erning board or university with a governing board and is still pending on the effective date

1 of this 2013 Act shall be conducted and completed by the governing board or university.

2 (7) Nothing in this 2013 Act relieves any person, public entity or private entity of any
3 obligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture, rule,
4 policy, document, record or proceeding.

5 (8) Notwithstanding any other provision of this section, the lawfully adopted rules and
6 policies of the State Board of Higher Education pertaining to a university with a governing
7 board that are in effect on the effective date of this 2013 Act continue in effect until lawfully
8 superseded or repealed by the standards or policies of the governing board or the university.
9 References in rules or policies of the State Board of Higher Education to the state board or
10 an officer or employee of the state board are considered to be references to the governing
11 board or an officer or employee of a university with a governing board.

12 SECTION 171. Sections 2, 2a, 2b, 3, 5, 8 to 18, 164, 165, 169 and 170 of this 2013 Act, the
13 amendments to statutes and session laws by sections 24, 25, 28 to 37, 40 to 162 and 176 to 178
14 of this 2013 Act and the repeal of statutes by section 163 of this 2013 Act become operative
15 on July 1, 2014.

16 SECTION 172. The State Board of Higher Education and a university with a governing
17 board as defined in section 2 of this 2013 Act may take any action before the operative date
18 specified in section 171 of this 2013 Act that is necessary for the State Board of Higher Ed-
19 ucation and the university to exercise, on and after the operative date specified in section
20 171 of this 2013 Act, all of the duties, functions and powers conferred on the State Board of
21 Higher Education and university by this 2013 Act.

22 SECTION 172a. This 2013 Act is intended to preserve the autonomy of the universities
23 listed in ORS 352.002 whether they are governed by a university governing board or a uni-
24 versity consortium board.

45 (3) The council shall meet quarterly to:

2 that relate to economic development and improving the economy in Oregon; and

3 (b) Discuss and recommend to the Legislative Assembly methods for creating certainty for the
4 development process.

5 **SECTION 177. If Senate Bill 267 becomes law, section 123c of this 2013 Act (amending**
6 **ORS 284.706) is repealed and ORS 284.706, as amended by sections 21 and 31, chapter 90,**
7 **Oregon Laws 2012, and sections 4 and 5, chapter 230, Oregon Laws 2013 (Enrolled Senate Bill**
8 **267), is amended to read:**

9 284.706. (1) There is created the Oregon Innovation Council consisting of the following voting
10 members:

11 (a) The Governor or the Governor's designated representative, who shall be chairperson of the
12 council.

13 (b) Five members appointed by the Governor who are engaged in the operations of Oregon
14 traded sector industries or Oregon growth businesses.

15 (c) One member appointed by the Governor who is a representative of an Oregon-based, gener-
16 ally accredited, not-for-profit private institution of higher education.

29 the Senate.

30 (c) Members of the Legislative Assembly appointed to the council are nonvoting members and
31 may act in an advisory capacity only.

32 (3) The following persons, or their representatives, shall serve as ex officio, nonvoting members
33 of the council:

34 (a) The presiding officer of the Oregon Business Development Commission.

35 (b) The chairperson of the [*State Board of Higher Education*] **Higher Education Coordinating**
36 **Commission.**

37 (c) The chairperson of the State Board of Education.

9 (9) The council may establish committees and delegate to the committees duties as the council
10 considers desirable.

11 (10) The Oregon Business Development Department shall provide staff support to the council.

12 (11) Members of the council who are members of the Legislative Assembly are entitled to com-
13 pensation and expense reimbursement as provided in ORS 171.072.

14 (12) Members of the council who are not members of the Legislative Assembly are entitled to
15 compensation and expenses incurred by them in the performance of their official duties in the man-
16 ner and amounts provided for in ORS 292.495. Claims for compensation and expenses of members
17 of the council who are public officers shall be paid out of funds appropriated to the public agency
18 that employs the member. Claims for compensation and expenses of members of the council who are
19 not public officers shall be paid out of funds appropriated to the Oregon Business Development De-
20 partment for that purpose.

21 (13) All agencies of state government, as defined in ORS 174.111, are directed to assist the
22 council in the performance of its duties and, to the extent permitted by laws relating to
23 confidentiality, to furnish such information and advice as the members of the council consider nec-
24 essary to perform their duties.

25 **SECTION 178. If House Bill 2148 becomes law, section 135 of this 2013 Act (amending ORS**
26 **341.440) is repealed and ORS 341.440, as amended by section 36, chapter 1, Oregon Laws 2013**
27 **(Enrolled House Bill 2148), is amended to read:**

28 341.440. (1) A community college district may contract with another community college district,
29 a common or union high school district, an education service district, [*the Oregon University*
30 *System*] **a public university listed in ORS 352.002**, the Oregon Health and Science University, a

10 to 180.235, 184.305 to 184.345, 190.480, 190.490, 200.035, 243.696, 357.805 to 357.895 and 656.017 (2)
11 and ORS chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291, 292, 293, 294, 295
12 and 297 do not apply to a university with a governing board.

13 (4) Notwithstanding subsections (1) and (3) of this section, ORS 240.167, 279C.600 to 279C.625,
14 279C.800, 279C.810, 279C.825, 279C.830, 279C.835, 279C.840, 279C.845, 279C.850, 279C.855, 279C.860,
15 279C.865, 279C.870 and 292.043 apply to a university with a governing board under the same terms
16 as they apply to public bodies other than the state.

17 (5) Notwithstanding subsection (2) of this section, ORS 190.430 and 192.105 do not apply to a
18 university with a governing board or any organization or other entity described in subsection (1)
19 of this section.

20 (6) Except as set forth in subsection (3) of this section, ORS 243.650 to 243.782 apply to a uni-
21 versity with a governing board under the same terms as they apply to the state.

22 (7) ORS 351.065, 351.067, 351.642, 351.643, 351.644, 351.646, 351.656, 351.658, 352.012 and 352.375
23 apply to a university with a governing board, except that the board or university shall exercise the
24 responsibilities and authorities of the State Board of Higher Education, **the Higher Education**
25 **Coordinating Commission** or the Oregon University System.

26 (8) A university with a governing board and its agents and employees remain subject to all
27 statutes and administrative rules of this state that create rights, benefits or protections in favor of
28 military veterans, service members and families of service members to the same extent as an agency
29 of this state would be subject to such statutes and administrative rules.

30 (9) ORS 351.692, 351.695 and 351.697 apply to a governing board, except that the board has the
31 responsibilities and authorities with respect to the university it governs that the State Board of
32 Higher Education and the Oregon University System have with respect to the public universities
33 identified in ORS 351.011. A university with a governing board may not issue a tax credit certificate
34 under ORS 351.692, 351.695 and 351.697 that will cause the public universities listed in ORS 352.002
35 to owe the General Fund more than \$6 million at any one time under ORS 351.692, 351.695 and
36 351.697.

37 (10) If state bonds are issued for the benefit of a university with a governing board, the uni-
38 versity shall have the powers and duties of a related agency as defined in ORS 286A.001 to the ex-

41 (11) Nothing in this section may be construed so that statutory provisions that are not set forth
42 in this section apply to a university with a governing board.
