# Senate Bill 278

Sponsored by Senator BEYER (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Portland State University as independent public university, governed by university board of directors.

Directs Portland State University Board of Directors to set enrollment fees and tuition, purchase and manage property, develop contract policies and set personnel rules.

Removes sunset for Oregon Education Investment Board.

Becomes operative July 1, 2014.

21 Be It Enacted by the People of the State of Oregon:

22 <u>SECTION 1.</u> (1) Portland State University is established as a public university and shall 23 exercise and carry out all of the powers, rights and duties that are expressly conferred upon 24 the university that are implied by law or incident to such powers, rights and duties.

(2) The university is an instrumentality of state government, performing governmental
 functions and exercising governmental powers. The university is independent, has statewide
 purposes and is without territorial boundaries. The university is a state institution of higher
 education, but is not an agency, department or division of the state, a unit of local or mu-

- 1 nicipal government or part of the executive branch.
- 2 (3) The university shall be governed by the Portland State University Board of Directors.

3 (4) The board may exercise authority over matters of university concern to the fullest

4 extent allowed by Constitutions and laws of the United States and this state.

5 <u>SECTION 2.</u> (1) The Portland State University Board of Directors shall consist of 15 6 members as follows:

(a) Eight members appointed by the Governor and confirmed by the Senate in the man ner prescribed in ORS 171.562 and 171.565, including:

9 (A) One student enrolled at the university; and

10 (B) One faculty member of the university.

(b) One member who is a nonstudent member of the State Board of Higher Education,
 appointed by the State Board of Higher Education.

(c) Five members appointed by the Portland State University Board of Directors, includ ing one member who is a member of the university foundation's board of directors.

(d) The president of Portland State University, who shall be a nonvoting member.

(e) The Portland State University Board of Directors may appoint other nonvoting
 members as it deems necessary in the best interests of the university.

(2)(a) Except for the president of the university, the term of office of each nonstudent
 member is four years. The term of office of the student member is two years.

(b) Before the expiration of the term of a member, the appointing authority shall appoint
 a successor whose term begins on July 1 next following. A member is eligible for reappoint ment for one additional term.

(c) If there is a vacancy for any cause, the appointing authority shall make an appointment to become effective for the remainder of the unexpired term. For members appointed
by the Governor, the board shall nominate a slate of candidates whenever a vacancy occurs
or is announced and shall forward the names of the recommended candidates to the Governor for consideration.

(d) A student enrolled at the university may not be appointed to, or continue to serve
on, the board unless the student is in good standing pursuant to bylaws or policies of the
board.

(3) Except as provided in subsection (1) of this section, a voting member may not be an
 employee of the university, the Oregon University System or the State of Oregon.

(4) The board shall select one of its members as the chairperson, another as vice chairperson and another as secretary, for such terms and with such duties and powers as the
board considers necessary for performance of the functions of those offices. The board shall
adopt bylaws for its governance, including provisions specifying how a quorum is constituted
and when a quorum is necessary.

(5) The board shall meet at least once every three months on the university's campus.
Board members may participate in the meeting electronically as provided in ORS 192.610 to
192.690. Each board shall meet at such other times and places specified by the chairperson
or by a majority of the members of that board.

42 (6) An appointing authority may remove any member appointed by the authority at any
43 time for cause, after notice and public hearing.

44 <u>SECTION 3.</u> Notwithstanding the terms of office specified in section 2 of this 2013 Act, 45 of the members first appointed to the Portland State University Board of Directors, other

than the president of the university: 1 2 (1) Four members appointed by the Governor, including the student member, and three members appointed by the board shall serve for terms ending June 30, 2015; and 3 (2) The following shall serve for terms ending June 30, 2017: 4  $\mathbf{5}$ (a) Four members appointed by the Governor, including the faculty member; (b) Two members appointed by the board, including the member of the university 6 foundation's board of directors; and 7 (c) The member appointed by the State Board of Higher Education. 8 9 SECTION 4. The Governor and the State Board of Higher Education shall appoint members to the Portland State University Board of Directors as described in section 2 of this 2013 10 Act no later than July 15, 2014. These board members shall appoint the board members de-11 12 scribed in section 2 (1)(c) of this 2013 Act no later than 60 days after confirmation of the 13 gubernatorial appointees by the Senate. SECTION 5. The Portland State University Board of Directors may: 14 15 (1) Control and provide for, subject to the conditions of this section, the custody and occupation of the grounds, buildings, books, papers and documents belonging to Portland 16 State University. 17 18 (2) Manage, control and apply all property of any nature given to or appropriated for the use, support or benefit of the university, according to the terms and conditions of such gift 19 or appropriation. Moneys received under this section shall be deposited in an account desig-20nated by Portland State University. Interest earned by the account shall be credited to the 2122account. 23(3) Design, acquire, erect, improve, repair, maintain, lease, renovate, demolish, equip, furnish and dispose of buildings, structures and lands necessary for carrying out the powers, 24

25 rights and duties of the board.

(4) Acquire, receive, hold, control, convey, sell, manage, operate, lease, lend, license,
 improve and develop any and all property, real or personal:

(a) Given to the university by private donors, whether such gifts are made to the uni versity, the State Board of Higher Education or to the State of Oregon; or

(b) Acquired by any other method or from any source for the benefit of the university,
 except for any structure, equipment or asset encumbered by a certificate of participation.

(5) Exercise the power of eminent domain for the condemnation of property of any kind
 and all water rights, easements and appurtenances thereto that the university considers
 necessary for carrying out the powers, rights and duties of the board.

(6) Take and hold mortgages on real and personal property acquired by way of gift or
 arising out of transactions entered into in accordance with the powers, rights and duties of
 the board.

(7) Institute, maintain and participate in suits and actions and other judicial proceedings, in the name of the State of Oregon, for the foreclosure of mortgages described in subsection (6) of this section or for the purpose of carrying into effect any and all of the powers, rights and duties of the board. Except as otherwise provided by ORS 30.260 to 30.300, the board has the authority to defend and indemnify its employees, officers and agents when they are acting in good faith within the course and scope of their duties for public purposes.

44 (8) Acquire, receive, hold, control, sell, manage, operate, lease, license or lend any goods,
 45 supplies, materials, equipment, services and information technology for the use, support or

1 benefit of the university.

2 (9) With the approval of the State Treasurer, request that the Oregon Department of 3 Administrative Services enter into financing agreements in accordance with ORS 283.085 to 4 283.092 on behalf of the university. Portland State University shall be considered a state 5 agency for purposes of ORS 286A.730 to 286A.750.

6 (10) Own, control and operate Oregon University System motor vehicles for use by the 7 university. The board shall establish requirements governing the use and operation of uni-8 versity motor vehicles.

9 (11) Hire or retain attorneys for the provision of legal services, including but not limited 10 to general advice, representation in litigation and representation in appellate matters. The 11 board shall reimburse the State Treasurer for legal fees incurred in connection with bor-12 rowings done at the request of the board.

(12) Request that the Chancellor of the Oregon University System seek issuance by the
 State Treasurer of bonds for the support or benefit of the university.

(13) Purchase any insurance, operate a self-insurance program, enter into an agreement
 with the Oregon University System or otherwise arrange for the equivalent of insurance
 coverage of any nature.

(14) Acquire, purchase, manage, develop, license or dispose of intellectual property of any
 kind.

(15) Exercise any other power, duty or responsibility necessary or convenient to matters
 of university concern.

22 <u>SECTION 6.</u> (1) In consultation with the State Board of Higher Education and the 23 Chancellor of the Oregon University System, the Portland State University Board of Direc-24 tors shall appoint a president of Portland State University.

(2) The president of the university is the president of the faculty and is the chief executive officer of the university. The president of the university has authority to direct the affairs and operation of the university, subject to the policies and direction of the Portland
State University Board of Directors.

(3) The Portland State University Board of Directors may delegate to the president any
 of the powers, duties or functions granted to the board.

<u>SECTION 7.</u> The president and professors of Portland State University constitute the faculty of the university and have the immediate government and discipline of the university and the students therein. The faculty may, subject to the supervision of the Portland State University Board of Directors, prescribe the course of study to be pursued at the university and the textbooks to be used.

36 <u>SECTION 8.</u> (1) The Portland State University Board of Directors shall set enrollment 37 fees for Portland State University. Enrollment fees include tuition for education and ser-38 vices and any other charges found by the board to be necessary to carry out the educational 39 program of the university.

(2) The board shall establish enrollment fees for the university. The process of establishing the fees must provide for participation of enrolled students and the recognized student government of the university.

(3) The university may offer fee remissions to its students, including remissions offered
on the basis of need, from any authorized source of revenue. Moneys appropriated from the
General Fund may not be used to fund fee remissions to students of the university.

1 <u>SECTION 9.</u> (1) The Portland State University Board of Directors shall implement a 2 personnel system for Portland State University and may engage in collective bargaining with 3 the employees and shall have payroll authority.

4 (2)(a) The board shall establish competitive procedures for the purchasing, procurement 5 and contracting of goods, services and information technology for the benefit of the univer-6 sity. The board may also establish exemptions from the competitive procedures when ap-7 propriate.

8 (b) The board shall ensure that the hourly rate of wage paid by any contractor upon all 9 public improvements contracts undertaken for the board are not less than the rate of wage as determined by the Bureau of Labor and Industries for an hour's work in the same trade 10 or occupation in the locality where such labor is performed. Claims or disputes arising under 11 12this subsection shall be decided by the Commissioner of the Bureau of Labor and Industries. (c) The board shall adopt policies and procedures that achieve results equal to or better 13 than the standards existing on July 17, 1995, regarding affirmative action, pay equity for 14 15 comparable work, recycling, the provision of workers' compensation insurance to workers 16 on contract and the participation of emerging small businesses and businesses owned by minorities and women. 17

18 (3) The board may:

(a) Appoint and employ a president, as provided in section 6 of this 2013 Act, and other
 officers and prescribe their compensation and tenure of office or employment.

(b) Demand and receive the interest described in ORS 352.510 and all sums due and accruing for admission and tuition, and apply the interest and sums accruing for admission and tuition, or so much thereof as is necessary, to the payment of the compensation under paragraph (a) of this subsection and other current expenses.

(c) Prescribe incidental fees for programs under the supervision or control of the board that are found by the board, upon its own motion or upon recommendation of the recognized student government, to be advantageous to the cultural or physical development of students. Fees realized in excess of amounts allocated and exceeding required reserves shall be considered surplus incidental fees and shall be allocated for programs under the control of the board and found to be advantageous to the cultural or physical development of students by the president upon the recommendation of the recognized student government.

(d) Upon recommendation of the recognized student government, collect optional fees for
student activities other than those described in paragraph (c) of this subsection or section
8 of this 2013 Act as authorized by the president. The payment of such fees is optional for
the student and is not a prerequisite of enrollment.

(e) Confer, consistent with the mission and programs of the university and on the rec ommendation of the faculty, such degrees as usually are conferred by public universities, or
 as the faculty deems appropriate.

39 (f) Prescribe the qualifications for admission.

40 (g) Contract to provide health services to students at student health centers.

41 (h) Provide health services at student health centers to any of the following:

42 (A) Dependents of students.

43 (B) Staff.

44 (C) Faculty.

45 (4) The board shall:

(a) Supervise the general course of instruction at the university, and the research, ex-1 2 tension, educational and other activities.

3 (b) Adopt rules and bylaws for university governance, including governance of the faculty, teachers, students and employees. 4

 $\mathbf{5}$ (c) Maintain cultural and physical development services and facilities for the university and may, in connection with the services and facilities, cooperate and enter into agreements 6 7 with any person or governmental agency.

(d) Provide health services at student health centers to students.

9 (e) Prescribe and collect charges.

10

(f) Adopt rules relating to the creation, use, custody and disclosure, including access, of student education records that are consistent with the requirements of applicable state and 11 12federal law. Whenever a student has attained 18 years of age or is attending the university, the permission or consent required of and the rights accorded to a parent of the student 13 regarding education records shall thereafter be required of and accorded only to the student. 14

15 (g) Provide opportunities for part-time students to obtain complete undergraduate degrees at unconventional times, which include but are not limited to early morning and noon 16 hours, evenings and weekends. In administering these degree programs, the university may 17 18 use any educational facility available for the use of the university.

19 SECTION 10. (1) The Portland State University Board of Directors may purchase such real property as the board, in its sole discretion, deems necessary for the present or future 20development of Portland State University. The board may enter into contracts of purchase 2122or agreements that the board deems necessary in carrying out this authorization.

23(2) The board may apply any funds toward the purchase of property authorized under this section. The board may mortgage or pledge any property so purchased, or its contracts to 24 purchase, or in relation thereto, together with the income from such property, to secure the 25payment of the purchase price. 26

27(3) The board may purchase real property or undertake capital construction projects that do not require the use of moneys appropriated from state funds or obtained through general 28obligation bonds for purposes consistent with the promotion and enhancement of public 2930 higher education.

31 (4) Legal title to all real property acquired by the university shall be taken and held in the name of the State of Oregon. Legal title to all real property conveyed to the university 32is deemed to be conveyed to and vested in the State of Oregon. Authorized conveyances of 33 34 all real property, other than university lands, acquired by or vested in the State of Oregon 35for the use or benefit of the university shall be executed in the name of the State of Oregon by the president of the university or the chairperson of the board. 36

37 (5) The university shall have custody and control of and shall care for all real property 38 used for university purposes. Management, maintenance and preservation of all real property used for university purposes is the responsibility of the university. 39

SECTION 11. (1) Portland State University shall develop contract policies that support 40 openness, impartiality and competition in the awarding of contracts in accordance with ORS 41 279A.015. 42

(2) The university shall also develop contract policies that are designed to encourage af-43 firmative action, recycling, inclusion of art in public buildings, the purchase of goods and 44 services from individuals with disabilities, the protection of workers through the payment 45

of prevailing wages as determined by the Bureau of Labor and Industries, the provision of workers' compensation insurance to workers on contracts and the participation of emerging small businesses and businesses owned by women and minorities.

4 (3) The Portland State University Board of Directors shall have the authority to enact 5 policies, appropriate for the use of the university, governing public contracting and may de-6 vise and publish forms for use in carrying out the policies.

SECTION 12. (1) As used in this section:

8 (a) "Direct labor" includes all work required for preparation, processing and packing, but
 9 not supervision, administration, inspection or shipping.

(b) "Individual with a disability" means an individual who, because of the nature of the
 individual's disability, is not able to participate fully in competitive employment, and for
 whom specialized employment opportunities must be provided.

(c) "Qualified nonprofit agency for individuals with disabilities" means a nonprofit activ ity center or rehabilitation facility:

(A) Organized under the laws of the United States or of this state and operated in the
 interest of individuals with disabilities, and the net income of which does not inure in whole
 or in part to the benefit of any shareholder or other individual;

(B) That complies with any applicable occupational health and safety standards required
by the laws of the United States or of this state; and

(C) That in the manufacture of products and in the provision of services during the fiscal
 year employs individuals with disabilities for not less than 75 percent of the work hours of
 direct labor required for the manufacture or provision of the products or services.

(2) The Portland State University Board of Directors shall further the policy of this state to encourage and assist individuals with disabilities in achieving maximum personal independence through useful and productive gainful employment by ensuring an expanded and constant market for sheltered workshop and activity center products and services, thereby enhancing the dignity of individuals with disabilities and their capacity for self-support and minimizing their dependence on welfare and need for costly institutionalization.

(3) It is the duty of Portland State University to:

(a) Determine the price of all products manufactured and services offered for sale to the
 university by any qualified nonprofit agency for individuals with disabilities. The price shall
 recover for the workshops the cost of raw materials, labor, overhead, delivery costs and a
 margin held in reserve for inventory and equipment replacement;

(b) Revise such prices from time to time in accordance with changing cost factors;

(c) Make such rules regarding specifications, time of delivery and other relevant matters
 of procedure as shall be necessary; and

(d) Utilize prices and specifications, in its discretion, established by the Oregon Depart ment of Administrative Services.

(4) The university shall establish and publish a list of sources or potential sources of products produced by a qualified nonprofit agency for individuals with disabilities and the services provided by any such agency that the university determines are suitable for its procurement. The university, in its discretion, may utilize any list established and published by the department.

(5) If the university intends to procure any product or service on the procurement list,
 the university shall procure such product or service at the price established by the university

1 from a qualified nonprofit agency for individuals with disabilities, provided the product or

2 service is of the appropriate specifications and is available at the location and within the 3 period required by the university.

4 (6) It is the intent of the Legislative Assembly that there be close cooperation among the 5 board, the university and qualified nonprofit agencies for individuals with disabilities. The 6 university, on behalf of the board, is authorized to enter into such contractual agreements, 7 cooperative working relationships or other arrangements as may be necessary for effective 8 coordination and efficient realization of the objectives of this section.

<u>SECTION 13.</u> (1) Except as otherwise provided in sections 1 to 18 of this 2013 Act and
ORS chapters 351 and 352, the provisions of ORS chapters 182, 240, 270, 273, 276, 278, 279A,
279B, 279C, 282, 283, 291 and 292 and ORS 180.060, 180.160, 180.210, 180.220, 180.225 and 180.230
do not apply to Portland State University.

(2) Notwithstanding subsection (1) of this section, the provisions of ORS 182.100, 182.109,
240.167, 276.073 to 276.090, 279A.065 (2), 279B.055 (3), 279C.380 (1)(a) and (3), 279C.600 to
279C.625, 279C.800, 279C.810, 279C.825, 279C.830, 279C.835, 279C.840, 279C.845, 279C.850, 279C.855,
279C.860, 279C.865, 279C.870, 283.085 to 283.092, 291.200, 291.201 to 291.222, 291.223, 291.224 (2)
and (6), 291.226, 291.272 to 291.278, 291.322 to 291.334, 291.405, 291.407, 291.445, 292.043 and
292.044 apply to Portland State University.

(3) Notwithstanding subsection (1) of this section, ORS 273.413 to 273.456 apply to any
 structure, equipment or asset owned by Portland State University that is encumbered by a
 certificate of participation.

(4) Notwithstanding subsection (6) of this section:

(a) The provisions of ORS chapters 35, 190, 192, 244 and 297 and ORS 30.260 to 30.460,
184.480, 184.483, 184.486, 184.488, 200.005 to 200.025, 200.045 to 200.090, 200.100 to 200.120, 200.160
to 200.200, 236.605 to 236.640, 243.650 to 243.782, 243.800, 243.820, 243.830, 243.850, 243.910 to
243.945, 307.090 and 307.112 apply to Portland State University under the same terms as they
apply to other public bodies other than the State of Oregon.

(b) The provisions of ORS chapter 286A and ORS 293.115, 293.117, 293.130, 293.169, 293.171,
293.205 to 293.225, 293.250, 293.265 to 293.280, 293.285, 293.295, 293.321, 293.353, 293.375, 293.406,
293.465 to 293.485, 293.490, 293.495, 293.525, 293.701 to 293.820, 293.875, 293.880 and 293.990 apply
to Portland State University under the same terms as they apply to state agencies with
moneys held by the State Treasurer.

(5) Notwithstanding subsections (1) and (6) of this section, Portland State University and
its agents and employees remain subject to all statutes and administrative rules of this state
that create rights, benefits or protections in favor of military veterans, service members and
families of service members to the same extent as an agency of this state would be subject
to such statutes and administrative rules.

(6) In carrying out the duties, functions and powers imposed by law upon Portland State
 University, the Portland State University Board of Directors may contract with any public
 agency for the performance of such duties, functions and powers as the board considers ap propriate.

42 <u>SECTION 14.</u> The Portland State University Board of Directors may, in its discretion, 43 accept financial assistance and grants, either in the form of money or labor, from the United 44 States or any of its agencies, subject to the terms and conditions thereof, regardless of any 45 laws of this state in conflict with the regulations of the federal government with respect 1 thereto, and may also accept from others any donation, grant of land, gift of money or other

2 valuable gift or thing, for any of the purposes described in Article XI-F(1) and Article XI-G

3 of the Oregon Constitution, ORS 351.160 to 351.190, 351.345 to 351.460, 351.500 and 351.505.

4 Unless enjoined by the terms or conditions of any such gift or grant, the board may convert

5 the same, or any of them, into money, through sale or disposal thereof.

6 <u>SECTION 15.</u> (1) The Portland State University Board of Directors is not required to seek 7 expenditure limitation approval from the Legislative Assembly to spend any available mon-8 eys, including but not limited to moneys from enrollment fees, tuition or other revenues 9 collected.

(2) The board shall adopt a budget on a regular schedule.

SECTION 16. Portland State University shall conduct independent audits if the audits are considered advisable by the university. Subject to ORS 297.250, the audits are at the exclusive discretion and control of the university. The audits are subject to disclosure pursuant to ORS 192.410 to 192.505.

15 <u>SECTION 17.</u> The Portland State University Board of Directors may open, establish, lay 16 out and dedicate to the public use such streets through the lands situated within the corpo-17 rate limits of the City of Portland, owned by or belonging to Portland State University, upon 18 such terms and conditions as may be agreed upon by the board and the common council of 19 the City of Portland. When such streets are so opened, laid out and established, they hereby 20 are declared to be dedicated to the public use and are further declared to be public streets 21 of the City of Portland.

<u>SECTION 18.</u> (1) The Portland State University Board of Directors shall provide group insurance to employees of Portland State University through the Public Employees' Benefit Board or may elect to provide alternative group health and welfare insurance benefit plans to employees of the university if the same level of benefits is available at a lower cost than through the Public Employees' Benefit Board.

(2) For the purposes of ORS 243.555 to 243.575, if the Portland State University Board of
Directors chooses not to provide the benefit plans offered through the Public Employees'
Benefit Board, the Portland State University Board of Directors may have the authority
granted to the Public Employees' Benefit Board under ORS 243.555 to 243.575 for the administration of an appropriate expense reimbursement plan.

(3) The Portland State University Board of Directors shall offer one or more deferred compensation plans to employees of the university.
