SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law. Takes effect on 91st day following adjournment sine die.

Be It Enacted by the People of the State of Oregon: 6

7 SECTION 1. ORS 238A.005, as amended by section 1, chapter 31, Oregon Laws 2012, is amended to read: 8

9 238A.005. For the purposes of this chapter:

10 (1) "Active member" means a member of the pension program or the individual account program of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position. 11

12 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the

13 payment or series of payments replaced, computed on the basis of interest rate and mortality assumptions adopted by the board. 14

(3) "Board" means the Public Employees Retirement Board. 15

(4) "Eligible employee" means a person who performs services for a participating public em-16 ployer, including elected officials other than judges. "Eligible employee" does not include: 17

- (a) Persons engaged as independent contractors; 18
- 19 (b) Aliens working under a training or educational visa;

20 (c) Persons, other than workers in the Industries for the Blind Program under ORS 346.190, 21provided sheltered employment or make-work by a public employer;

22(d) Persons categorized by a participating public employer as student employees;

23(e) Any person who is an inmate of a state institution;

24 (f) Employees of foreign trade offices of the Oregon Business Development Department who live and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g); 25

26 (g) An employee actively participating in an alternative retirement program established under 27 ORS 353.250 or an optional retirement plan established under ORS 341.551;

28 (h) Employees of the Oregon University System who are actively participating in an optional 29 retirement plan offered under ORS 243.800;

(i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003, 30

1 for membership in the system under the provisions of ORS chapter 238 or other law;

2 (j) Any person who belongs to a class of employees who are not eligible to become members of 3 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

4 (k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who 5 continues to receive retirement benefits while employed; and

(5) "Firefighter" means:

8 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
9 duties include the fighting of fires;

(b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;and

(c) An employee of the State Forestry Department who is certified by the State Forester as a
 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
 fires as described in ORS 477.064.

15 (6) "Fund" means the Public Employees Retirement Fund.

16 (7)(a) "Hour of service" means:

(A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
by a participating public employer for performance of duties in a qualifying position; and

(B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave during which an employee does not perform duties but for which the employee is directly or indirectly paid or entitled to payment by a participating public employer for services in a qualifying position, as long as the hour is within the number of hours regularly scheduled for the performance of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave.

(b) "Hour of service" does not include any hour for which payment is made or due under a plan maintained solely for the purpose of complying with applicable workers' compensation laws or unemployment compensation laws.

(8) "Inactive member" means a member of the pension program or the individual account program of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
is not a retired member and who is not employed in a qualifying position.

(9) "Individual account program" means the defined contribution individual account program of
 the Oregon Public Service Retirement Plan established under ORS 238A.025.

(10) "Institution of higher education" means a public university listed in ORS 352.002, the
 Oregon Health and Science University or a community college, as defined in ORS 341.005.

(11) "Member" means an eligible employee who has established membership in the pension pro gram or the individual account program of the Oregon Public Service Retirement Plan and whose
 membership has not been terminated under ORS 238A.110 or 238A.310.

(12) "Participating public employer" means a public employer as defined in ORS 238.005 that
 provides retirement benefits for employees of the public employer under the system.

(14) "Police officer" means a police officer as described in ORS 238.005.

excluding any service in a job for which benefits are not provided under the Oregon Public Service

1 Retirement Plan pursuant to ORS 238A.070 (2).

2 (16) "Retired member" means a pension program member who is receiving a pension as provided
3 in ORS 238A.180 to 238A.195.

4 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the 5 participating public employer, including remuneration in the form of living quarters, board or other 6 items of value, to the extent the remuneration is includable in the employee's taxable income under 7 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection, 8 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether 9 those amounts are includable in taxable income.

10 (b) "Salary" includes the following amounts:

(A) Payments of employee and employer money into a deferred compensation plan that are madeat the election of the employee.

(B) Contributions to a tax-sheltered or deferred annuity that are made at the election of theemployee.

(D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
election of the employee and that is not included in the taxable income of the employee by reason

(F) The amount of an employee contribution to the individual account program that is paid by
the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
(1) and (2)(a).

(G) The amount of an employee contribution to the individual account program that is not paidby the employer under ORS 238A.335.

(H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
 652.190.

30 (c) "Salary" does not include the following amounts:

(A) Travel or any other expenses incidental to employer's business which is reimbursed by theemployer.

33 (B) Payments made on account of an employee's death.

34 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid 35 leave.

36 (D) Any severance payment, accelerated payment of an employment contract for a future period 37 or advance against future wages.

(E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

(F) Payment for a leave of absence after the date the employer and employee have agreed thatno future services in a qualifying position will be performed.

(G) Payments for instructional services rendered to public universities of the Oregon University
System or the Oregon Health and Science University when those services are in excess of full-time
employment subject to this chapter. A person employed under a contract for less than 12 months is
subject to this subparagraph only for the months covered by the contract.

3 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is 4 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a 5 fraction, the numerator of which is the number of months in the determination period and the de-6 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate 7 cost-of-living adjustments authorized by the Internal Revenue Service.

26 <u>SECTION 27.</u> ORS 657.010, as amended by section 27, chapter 31, Oregon Laws 2012, is 27 amended to read:

28 657.010. As used in this chapter, unless the context requires otherwise:

(1) "Base year" means the first four of the last five completed calendar quarters preceding thebenefit year.

31 (2) "Benefits" means the money allowances payable to unemployed persons under this chapter.

(3) "Benefit year" means a period of 52 consecutive weeks commencing with the first week with respect to which an individual files an initial valid claim for benefits, and thereafter the 52 consecutive weeks period beginning with the first week with respect to which the individual next files an initial valid claim after the termination of the individual's last preceding benefit year except that the benefit year shall be 53 weeks if the filing of an initial valid claim would result in overlapping any quarter of the base year of a previously filed initial valid claim.

(4) "Calendar quarter" means the period of three consecutive calendar months ending on March
31, June 30, September 30 or December 31, or the approximate equivalent thereof, as the Director
of the Employment Department may, by regulation, prescribe.

(5) "Contribution" or "contributions" means the taxes, as defined in subsection (13) of this section, that are the money payments required by this chapter, or voluntary payments permitted, to be
made to the Unemployment Compensation Trust Fund.

44 (6) "Educational institution," including an institution of higher education as defined in sub-45 section (9) of this section, means an institution:

1 (a) In which participants, trainees or students are offered an organized course of study or 2 training designed to transfer to them knowledge, skills, information, doctrines, attitudes or abilities

3 from, by or under the guidance of an instructor or teacher;

4 (b) That is accredited, registered, approved, licensed or issued a permit to operate as a school 5 by the Department of Education or other government agency, or that offers courses for credit that 6 are transferable to an approved, registered or accredited school;

(c) In which the course or courses of study or training that it offers may be academic, technical,
trade or preparation for gainful employment in a recognized occupation; and

9 (d) In which the course or courses of study or training are offered on a regular and continuing 10 basis.

(7) "Employment office" means a free public employment office or branch thereof, operated by
 this state or maintained as a part of a state-controlled system of public employment offices.

(8) "Hospital" means an organization that has been licensed, certified or approved by the Oregon
Health Authority as a hospital.

15 (9) "Institution of higher education" means an educational institution that:

(a) Admits as regular students only individuals having a certificate of graduation from a high
 school, or the recognized equivalent of such a certificate;

18 (b) Is legally authorized in this state to provide a program of education beyond high school;

(c) Provides an educational program for which it awards a bachelor's or higher degree, or provides a program that is acceptable for full credit toward such a degree, a program of post-graduate or post-doctoral studies, or a program of training to prepare students for gainful employment in a recognized occupation; and

23 (d) Is a public or other nonprofit institution.

(10) "Internal Revenue Code" means the federal Internal Revenue Code, as amended and in effect on December 31, [2011] 2012.

(11) "Nonprofit employing unit" means an organization, or group of organizations, described in
 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section 501(a)
 of the Internal Revenue Code.

(12) "State" includes, in addition to the states of the United States of America, the District of
Columbia and Puerto Rico. However, for all purposes of this chapter the Virgin Islands shall be
considered a state on and after the day on which the United States Secretary of Labor first approves
the Virgin Islands' law under section 3304(a) of the Federal Unemployment Tax Act as amended by
Public Law 94-566.

(13) "Taxes" means the money payments to the Unemployment Compensation Trust Fund re quired, or voluntary payments permitted, by this chapter.

(14) "Valid claim" means any claim for benefits made in accordance with ORS 657.260 if the
 individual meets the wages-paid-for-employment requirements of ORS 657.150.

(15) "Week" means any period of seven consecutive calendar days ending at midnight, as the
director may, by regulation, prescribe. The director may by regulation prescribe that a "week" shall
be "in," "within," or "during" the calendar quarter that includes the greater part of such week.

41 <u>SECTION 28.</u> (1) Except as provided in subsections (2) and (3) of this section, the 42 amendments to statutes by sections 1 to 27 of this 2013 Act apply to transactions or activities 43 occurring on or after January 1, 2013, in tax years beginning on or after January 1, 2013.

(2) The effective and applicable dates, and the exceptions, special rules and coordination
 with the Internal Revenue Code, as amended, relative to those dates, contained in the Middle

1 Class Tax Relief and Job Creation Act of 2012 (P.L. 112-96) and other federal law amending 2 the Internal Revenue Code and enacted before January 1, 2013, apply for Oregon personal 3 income and corporate excise and income tax purposes, to the extent they can be made ap-4 plicable, in the same manner as they are applied under the Internal Revenue Code and re-5 lated federal law.

6 (3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before 7 January 1, 2013, and the deficiency or any portion thereof is attributable to any retroactive 8 treatment under the amendments to ORS 305.230, 305.494, 305.690, 307.130, 307.147, 308A.450, 9 310.140, 310.630, 310.800, 314.011, 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 10 25 of this 2013 Act, then any interest or penalty assessed under ORS chapter 305, 314, 315, 11 316, 317 or 318 with respect to the deficiency or portion thereof shall be canceled.

(b) If a refund is due any taxpayer for a tax year beginning before January 1, 2013, and the refund or any portion thereof is due the taxpayer on account of any retroactive treatment under the amendments to ORS 305.230, 305.494, 305.690, 307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 314.011, 315.004, 316.012, 317.010, 317.097 and 348.841 by sections 11 to 25 of this 2013 Act, then notwithstanding ORS 305.270 or 314.415 or other law, the refund or portion thereof shall be paid without interest.

(c) Any changes required because of the amendments to ORS 305.230, 305.494, 305.690,
307.130, 307.147, 308A.450, 310.140, 310.630, 310.800, 314.011, 315.004, 316.012, 317.010, 317.097 and
348.841 by sections 11 to 25 of this 2013 Act for a tax year beginning before January 1, 2013,
shall be made by filing an amended return within the time prescribed by law.

(d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,
the Department of Revenue shall make any changes under paragraph (c) of this subsection
on the return to which the changes relate within the period specified for issuing a notice of
deficiency or claiming a refund as otherwise provided by law with respect to that return, or
within one year after a return for a tax year beginning on or after January 1, 2013, and before January 1, 2014, is filed, whichever period expires later.
