## C-Engrossed Senate Bill 421

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes district attorney to initiate commitment proceeding when person with mental disorder has committed certain violent or sexual acts and is extremely dangerous and in need of commitment. Authorizes court to commit person to jurisdiction of Psychiatric Security Review Board for maximum period of 24 months. Authorizes court to further commit person for additional 24 months upon certification or hearing at end of initial commitment. Requires board to hold hearing six months after initial commitment and further commitment to determine status of commitment. Authorizes state hospital or other treatment facility to request hearing to determine status of commitment. Provides for representation of person by counsel and other rights at commitment, further commitment and status hearings. Provides for conditional release of person under certain circumstances. Allows board to order return of person to state hospital for specified reasons. Specifies when person may be discharged from jurisdiction of board. Provides for tolling of statute of limitations during commitment.

Appropriates moneys from General Fund to Oregon Health Authority for certain biennial expenses.

Appropriates moneys from General Fund to Psychiatric Security Review Board for certain biennial expenses.

Declares emergency, effective on passage.

### A BILL FOR AN ACT

2 Relating to civil commitments; creating new provisions; amending ORS 426.095, 426.110, 426.135,  
3 426.160, 426.241 and 426.250 and section 69, chapter 360, Oregon Laws 2013 (Enrolled Senate  
4 Bill 426); repealing sections 23, 25, 31, 35 and 45, chapter 360, Oregon Laws 2013 (Enrolled  
5 Senate Bill 426); appropriating money; and declaring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. Sections 2 and 3 of this 2013 Act are added to and made a part of ORS**  
8 **chapter 426.**

9 **SECTION 2. (1) For the purposes of this section and section 3 of this 2013 Act:**

10 **(a) A person is "extremely dangerous" if the person:**

11 **(A) Is at least 18 years of age;**

12 **(B) Is exhibiting symptoms or behaviors of a mental disorder substantially similar to**  
13 **those that preceded the act described in subsection (3)(a)(C) of this section; and**

14 **(C) Because of a mental disorder:**

15 **(i) Presents a serious danger to the safety of other persons by reason of an extreme risk**  
16 **that the person will inflict grave or potentially lethal physical injury on other persons; and**

17 **(ii) Unless committed, will continue to represent an extreme risk to the safety of other**

1 persons in the foreseeable future.

2 (b) "Mental disorder" does not include:

3 (A) A disorder manifested solely by repeated criminal or otherwise antisocial conduct;

4 or

5 (B) A disorder constituting solely a personality disorder.

6 (c) A mental disorder is "resistant to treatment" if, after receiving care from a licensed  
7 psychiatrist and exhausting all reasonable psychiatric treatment, or after refusing psychiat-  
8 ric treatment, the person continues to be significantly impaired in the person's ability to  
9 make competent decisions and to be aware of and control extremely dangerous behavior.

10 (2)(a) A district attorney may petition the court to initiate commitment proceedings de-  
11 scribed in this section if there is reason to believe a person is an extremely dangerous  
12 mentally ill person. The petition shall immediately be served upon the person.

13 (b) The person shall be advised in writing of:

14 (A) The allegation that the person is an extremely dangerous mentally ill person and may  
15 be committed to the jurisdiction of the Psychiatric Security Review Board for a maximum  
16 period of 24 months; and

17 (B) The right to a hearing to determine whether the person is an extremely dangerous  
18 mentally ill person, unless the person consents to the commitment by waiving the right to  
19 a hearing in writing after consultation with legal counsel.

20 (c) A person against whom a petition described in this subsection is filed shall have the  
21 following:

22 (A) The right to obtain suitable legal counsel possessing skills and experience  
23 commensurate with the nature of the allegations and complexity of the case and, if the per-  
24 son is without funds to retain legal counsel, the right to have the court appoint legal counsel;

25 (B) The right to subpoena witnesses and to offer evidence on behalf of the person at the  
26 hearing;

27 (C) The right to cross-examine any witnesses who appear at the hearing; and

28 (D) The right to examine all reports, documents and information that the court consid-  
29 ers, including the right to examine the reports, documents and information prior to the  
30 hearing, if available.

31 (d) The court shall appoint an examiner as described in ORS 426.110 to evaluate the per-  
32 son.

33 (3)(a) Upon receipt of a petition filed under subsection (2) of this section, the court shall  
34 schedule a hearing. At the hearing, the court shall order the person committed as an ex-  
35 tremely dangerous mentally ill person under the jurisdiction of the Psychiatric Security Re-  
36 view Board for a maximum of 24 months if the court finds, by clear and convincing evidence,  
37 that:

38 (A) The person is extremely dangerous;

39 (B) The person suffers from a mental disorder that is resistant to treatment; and

40 (C) Because of the mental disorder that is resistant to treatment, the person committed  
41 one of the following acts:

42 (i) Caused the death of another person;

43 (ii) Caused serious physical injury to another person by means of a dangerous weapon;

44 (iii) Caused physical injury to another person by means of a firearm as defined in ORS  
45 166.210 or an explosive as defined in ORS 164.055;

1 (iv) Engaged in oral-genital contact with a child under 14 years of age;

2 (v) Forcibly compelled sexual intercourse, oral-genital contact or the penetration of an-  
3 other person's anus or vagina; or

4 (vi) Caused a fire or explosion that damaged the protected property of another, as those  
5 terms are defined in ORS 164.305, or placed another person in danger of physical injury, and  
6 the fire or explosion was not the incidental result of normal and usual daily activities.

7 (b) The court shall further commit the person to a state hospital for custody, care and  
8 treatment if the court finds, by clear and convincing evidence, that the person cannot be  
9 controlled in the community with proper care, medication, supervision and treatment on  
10 conditional release.

11 (c) The court shall specify in the order whether any person who would be considered a  
12 victim as defined in ORS 131.007 of the act described in paragraph (a)(C) of this subsection,  
13 if the act had been criminally prosecuted, requests notification of any order or hearing,  
14 conditional release, discharge or escape of the person committed under this section.

15 (d) The court shall be fully advised of all drugs and other treatment known to have been  
16 administered to the alleged extremely dangerous mentally ill person that may substantially  
17 affect the ability of the person to prepare for, or to function effectively at, the hearing.

18 (e) The provisions of ORS 40.230, 40.235, 40.240, 40.250 and 179.505 do not apply to the use  
19 of the examiner's report and the court may consider the report as evidence.

20 (4) The findings of the court that a person committed an act described in subsection  
21 (3)(a)(C) of this section may not be admitted in a criminal prosecution.

22 (5) A person committed under this section shall remain under the jurisdiction of the  
23 board for a maximum of 24 months unless the board conducts a hearing and makes the  
24 findings described in subsection (6)(d) of this section.

25 (6)(a) The board shall hold a hearing six months after the initial commitment described  
26 in subsection (3) of this section, and thereafter six months after a further commitment de-  
27 scribed in section 3 of this 2013 Act, to determine the placement of the person and whether  
28 the person is eligible for conditional release or early discharge. The board shall provide  
29 written notice of the hearing to the person, the person's legal counsel and the office of the  
30 district attorney who filed the initial petition under subsection (2) of this section within a  
31 reasonable time prior to the hearing. The board shall further notify the person of the fol-  
32 lowing:

33 (A) The nature of the hearing and possible outcomes;

34 (B) The right to appear at the hearing and present evidence;

35 (C) The right to be represented by legal counsel and, if the person is without funds to  
36 retain legal counsel, the right to have the court appoint legal counsel;

37 (D) The right to subpoena witnesses;

38 (E) The right to cross-examine witnesses who appear at the hearing; and

39 (F) The right to examine all reports, documents and information that the board consid-  
40 ers, including the right to examine the reports, documents and information prior to the  
41 hearing if available.

42 (b) If the board determines at the hearing that the person still suffers from a mental  
43 disorder that is resistant to treatment and continues to be extremely dangerous, and that  
44 the person cannot be controlled in the community with proper care, medication, supervision  
45 and treatment if conditionally released, the person shall remain committed to a state hospi-

1 tal.

2 (c) If the board determines at the hearing that the person still suffers from a mental  
3 disorder that is resistant to treatment and continues to be extremely dangerous, but finds  
4 that the person can be controlled in the community with proper care, medication, super-  
5 vision and treatment if conditionally released, the board shall conditionally release the per-  
6 son.

7 (d) If the board determines at the hearing that the person no longer suffers from a  
8 mental disorder that is resistant to treatment or is no longer extremely dangerous, the  
9 board shall discharge the person. The discharge of a person committed under this section  
10 does not preclude commitment of the person pursuant to ORS 426.005 to 426.390.

11 (7)(a) At any time during the commitment to a state hospital, the superintendent of the  
12 state hospital may request a hearing to determine the status of the person's commitment  
13 under the jurisdiction of the board. The request shall be accompanied by a report setting  
14 forth the facts supporting the request. If the request is for conditional release, the request  
15 shall be accompanied by a verified conditional release plan. The hearing shall be conducted  
16 as described in subsection (6) of this section.

17 (b) The board may make the findings described in subsection (6)(c) of this section and  
18 conditionally release the person without a hearing if the office of the district attorney who  
19 filed the initial petition under subsection (2) of this section does not object to the conditional  
20 release.

21 (c) At any time during conditional release, a state or local mental health facility provid-  
22 ing treatment to the person may request a hearing to determine the status of the person's  
23 commitment under the jurisdiction of the board. The hearing shall be conducted as described  
24 in subsection (6) of this section.

25 (8)(a) If the board orders the conditional release of a person under subsection (6)(c) of  
26 this section, the board shall order conditions of release that may include a requirement to  
27 report to any state or local mental health facility for evaluation. The board may further re-  
28 quire cooperation with, and acceptance of, psychiatric or psychological treatment from the  
29 facility. Conditions of release may be modified by the board from time to time.

30 (b) When a person is referred to a state or local mental health facility for an evaluation  
31 under this subsection, the facility shall perform the evaluation and submit a written report  
32 of its findings to the board. If the facility finds that treatment of the person is appropriate,  
33 the facility shall include its recommendations for treatment in the report to the board.

34 (c) Whenever treatment is provided to the person by a state or local mental health fa-  
35 cility under this subsection, the facility shall furnish reports to the board on a regular basis  
36 concerning the progress of the person.

37 (d) Copies of all reports submitted to the board pursuant to this subsection shall be fur-  
38 nished to the person and to the person's legal counsel, if applicable. The confidentiality of  
39 these reports is determined pursuant to ORS 192.501 to 192.505.

40 (e) The state or local mental health facility providing treatment to the person under this  
41 subsection shall comply with the conditional release order and any modifications of the con-  
42 ditions ordered by the board.

43 (9)(a) If at any time while the person is conditionally released it appears that the person  
44 has violated the terms of the conditional release, the board may order the person returned  
45 to a state hospital for evaluation or treatment. A written order of the board is sufficient

1 warrant for any law enforcement officer to take the person into custody. A sheriff, municipal  
2 police officer, parole or probation officer or other peace officer shall execute the order, and  
3 the person shall be returned to the state hospital as soon as practicable.

4 (b) The director of a state or local mental health facility providing treatment to a person  
5 under subsection (8) of this section may request that the board issue a written order for a  
6 person on conditional release to be taken into custody if there is reason to believe that the  
7 person can no longer be controlled in the community with proper care, medication, super-  
8 vision and treatment.

9 (c) Within 30 days following the return of the person to a state hospital, the board shall  
10 conduct a hearing to determine if, by a preponderance of the evidence, the person is no  
11 longer fit for conditional release. The board shall provide written notice of the hearing to the  
12 person, the person's legal counsel and the office of the district attorney who filed the initial  
13 petition under subsection (2) of this section within a reasonable time prior to the hearing.  
14 The notice shall advise the person of the nature of the hearing, the right to have the court  
15 appoint legal counsel and the right to subpoena witnesses, examine documents considered  
16 by the board and cross-examine all witnesses who appear at the hearing.

17 (10)(a) If the person had unadjudicated criminal charges at the time of the person's initial  
18 commitment under this section and the state hospital or the state or local mental health  
19 facility providing treatment to the person intends to recommend discharge of the person at  
20 an upcoming hearing, the superintendent of the state hospital or the director of the facility  
21 shall provide written notice to the board and the district attorney of the county where the  
22 criminal charges were initiated of the discharge recommendation at least 45 days before the  
23 hearing. The notice shall be accompanied by a report describing the person's diagnosis and  
24 the treatment the person has received.

25 (b) Upon receiving the notice described in this subsection, the district attorney may re-  
26 quest an order from the court in the county where the criminal charges were initiated for  
27 an evaluation to determine if the person is fit to proceed in the criminal proceeding. The  
28 court may order the state hospital or the state or local mental health facility providing  
29 treatment to the person to perform the evaluation. The hospital or facility shall provide  
30 copies of the evaluation to the district attorney, the person and the person's legal counsel,  
31 if applicable.

32 (c) The person committed under this section may not waive an evaluation ordered by the  
33 court to determine if the person is fit to proceed with the criminal proceeding as described  
34 in this subsection.

35 (11) The board shall make reasonable efforts to notify any person described in subsection  
36 (3)(c) of this section of any order or hearing, conditional release, discharge or escape of the  
37 person committed under this section.

38 (12) The board shall adopt rules to carry out the provisions of this section and section 3  
39 of this 2013 Act.

40 (13) Any time limitation described in ORS 131.125 to 131.155 does not run during a com-  
41 mitment described in this section or a further commitment described in section 3 of this 2013  
42 Act.

43 **SECTION 3.** (1)(a) At the end of the 24-month period of commitment described in section  
44 2 of this 2013 Act, any person who remains committed under the jurisdiction of the Psychi-  
45 atric Security Review Board shall be discharged, unless the board certifies to the court in

1 the county where the state hospital or state or local mental health facility providing treat-  
2 ment to the person is located that the person is still extremely dangerous and suffers from  
3 a mental disorder that is resistant to treatment. The board, pursuant to its rules, may del-  
4 egate to the superintendent of the state hospital or the director of the state or local mental  
5 health facility providing treatment to the person the responsibility for making the certif-  
6 ication. If the certification is made, the person will not be released.

7 (b) The board may additionally certify that the person cannot be controlled in the com-  
8 munity with proper care, medication, supervision and treatment on conditional release and  
9 must be committed to a state hospital. The board, pursuant to its rules, may delegate to the  
10 superintendent of the state hospital or the director of the state or local mental health fa-  
11 cility providing treatment to the person the responsibility for making the additional certif-  
12 ication.

13 (2) The certification shall immediately be served upon the person by the superintendent  
14 of the state hospital or the director of the state or local mental health facility providing  
15 treatment to the person. The superintendent or director shall inform the court in writing  
16 that service has been made and the date thereof.

17 (3) The certification shall advise the person of all the following:

18 (a) That the board, hospital or facility has requested that commitment be continued for  
19 an additional 24 months.

20 (b) That the person may protest this further commitment within 14 days, and that, if the  
21 person does not protest, the commitment will be continued for a maximum of 24 months.

22 (c) That the person may consult with legal counsel when deciding whether to protest the  
23 further commitment and that legal counsel will be provided for the person without cost if  
24 the person is without funds to retain legal counsel.

25 (d) That the person may protest a further period of commitment either orally or in  
26 writing by signing the form accompanying the certification.

27 (e) That if the person does protest a further period of commitment, the person is entitled  
28 to a hearing before the court to determine whether commitment should be continued.

29 (f) That the person is entitled to have a psychologist or psychiatrist, other than a mem-  
30 ber of the staff at the facility where the person is being treated, examine the person and  
31 report to the court the results of the examination at the hearing.

32 (g) That the person may subpoena witnesses and offer evidence on behalf of the person  
33 at the hearing.

34 (h) That if the person is without funds to retain legal counsel or an examining psychol-  
35 ogist or psychiatrist for the hearing, the court will appoint legal counsel or an examining  
36 psychologist or psychiatrist.

37 (4) The person serving the certification shall read and deliver the certification to the  
38 person and ask whether the person protests a further period of commitment. The person  
39 may protest a further period of commitment and request a hearing either orally or by sign-  
40 ing a simple protest form to be given to the person with the certification. If the person does  
41 not protest a further period of commitment within 14 days of service of the certification, the  
42 board, hospital or facility shall so notify the court, and the court shall, without further  
43 hearing, order the commitment of the person to the jurisdiction of the board for a maximum  
44 of 24 months. The court shall further order that the person be committed to a state hospital  
45 if a certification under subsection (1)(b) of this section has been made.

1 (5) When the person protests a further period of commitment and requests a hearing,  
2 the board, hospital or facility shall immediately notify the court, and the court shall have the  
3 person brought before it and shall again advise the person that the board, hospital or facility  
4 has requested that commitment be continued for an additional period of time and that if the  
5 person does not protest this commitment the commitment will be continued for a maximum  
6 of 24 months. The person shall also be informed of the rights set forth in subsection (3) of  
7 this section.

8 (6) If the person requests a hearing under subsections (4) and (5) of this section, the  
9 following provisions apply as described:

10 (a) The hearing shall be conducted as promptly as possible and at a time and place as the  
11 court may direct.

12 (b) If the person requests a continuance in order to prepare for the hearing or to obtain  
13 legal counsel to represent the person, the court may grant postponement and detention  
14 during postponement as described in ORS 426.095 (2)(c).

15 (c) The person has the right to representation by or appointment of legal counsel subject  
16 to ORS 135.055, 151.216 and 151.219.

17 (d) If the person requests an examination by a psychologist or psychiatrist and is without  
18 funds to retain a psychologist or psychiatrist for purposes of the examination, the court shall  
19 appoint a psychologist or psychiatrist, other than a member of the staff from the facility  
20 where the person is being treated, to examine the person at no expense to the person and  
21 to report to the court the results of the examination.

22 (e) The provisions of ORS 40.230, 40.235, 40.240, 40.250 and 179.505 do not apply to the use  
23 of medical records from the current period of commitment or to testimony related to such  
24 records or period of commitment in connection with hearings under this section. The court  
25 may consider as evidence such reports and testimony.

26 (f) The court shall then conduct a hearing. The court may take judicial notice of the  
27 findings regarding the act described in section 2 (3)(a)(C) of this 2013 Act made by the court  
28 at the initial commitment. If, after hearing the evidence and reviewing the recommendations  
29 of the board and the state hospital or the state or local mental health facility providing  
30 treatment to the person, in the opinion of the court the person is still extremely dangerous  
31 and suffering from a mental disorder that is resistant to treatment by clear and convincing  
32 evidence, the court may order commitment to the jurisdiction of the board for an additional  
33 maximum of 24 months. The court shall further commit the person to a state hospital for  
34 custody, care and treatment if the court finds, by clear and convincing evidence, that the  
35 person cannot be controlled in the community with proper care, medication, supervision and  
36 treatment on conditional release.

37 (g) At the end of the 24-month period, the person shall be discharged unless the board,  
38 hospital or facility again certifies to the committing court that the person is still an ex-  
39 tremely dangerous mentally ill person and in need of further treatment, in which event the  
40 procedures set forth in this section shall be followed.

41 **SECTION 4.** ORS 426.095 is amended to read:

42 426.095. The following is applicable to a commitment hearing held by a court under ORS 426.070:

43 (1) The hearing may be held in a hospital, the person's home or in some other place convenient  
44 to the court and the allegedly mentally ill person.

45 (2) The court shall hold the hearing at the time established according to the following:

1 (a) Except as provided by paragraph (b) or (c) of this subsection, a hearing shall be held five  
2 judicial days from the day a court under ORS 426.070 issues a citation provided under ORS 426.090.

3 (b) Except as provided by paragraph (c) of this subsection, if a person is detained by a warrant  
4 of detention under ORS 426.070, a hearing shall be held within five judicial days of the commence-  
5 ment of detention.

6 (c) If requested under this paragraph, the court, for good cause, may postpone the hearing for  
7 not more than five judicial days in order to allow preparation for the hearing. The court may make  
8 orders for the care and custody of the person during a postponement as it deems necessary. If a  
9 person is detained before a hearing under ORS 426.070, 426.180, 426.228, 426.232 or 426.233 **or sec-**  
10 **tion 3 of this 2013 Act** and the hearing is postponed under this paragraph, the court, for good  
11 cause, may allow the person to be detained during the postponement if the postponement is re-  
12 quested by the person or the legal counsel of the person. Any of the following may request a  
13 postponement under this paragraph:

14 (A) The allegedly mentally ill **person or extremely dangerous mentally ill** person.

15 (B) The legal counsel or guardian of the allegedly mentally ill **person or extremely dangerous**  
16 **mentally ill** person.

17 (C) The person representing the state's interest.

18 (3) The allegedly mentally ill person and the person representing the state's interest shall have  
19 the right to cross-examine all the following:

20 (a) Witnesses.

21 (b) The person conducting the investigation.

22 (c) The examining physicians or other qualified persons recommended by the Oregon Health  
23 Authority who have examined the person.

24 (4) The provisions of ORS 40.230, 40.235, 40.240 and 40.250 shall not apply to and the court may  
25 consider as evidence any of the following:

26 (a) Medical records for the current involuntary prehearing period of detention.

27 (b) Statements attributed by the maker of the medical records or the investigation report to  
28 witnesses concerning their own observations in the absence of objection or if such persons are  
29 produced as witnesses at the hearing available for cross-examination.

30 (c) The testimony of any treating physicians, nurses or social workers for the prehearing period  
31 of detention. Any treating physician, nurse or social worker who is subpoenaed as a witness for the  
32 proceeding shall testify as an expert witness under the provisions of ORS 40.410, 40.415, 40.420 and  
33 40.425 and is subject to treatment as an expert witness in the payment of witness fees and costs.

34 (d) The investigation report prepared under ORS 426.074. Subject to the following, the investi-  
35 gation report shall be introduced in evidence:

36 (A) Introduction of the report under this paragraph does not require the consent of the allegedly  
37 mentally ill person.

38 (B) Upon objection by any party to the action, the court shall exclude any part of the investi-  
39 gation report that may be excluded under the Oregon Evidence Code on grounds other than those  
40 set forth in ORS 40.230, 40.235, 40.240 or 40.250.

41 (C) Neither the investigation report nor any part thereof shall be introduced into evidence under  
42 this paragraph unless the investigator is present during the proceeding to be cross-examined or un-  
43 less the presence of the investigator is waived by the allegedly mentally ill person or counsel for  
44 the allegedly mentally ill person.

45 **SECTION 5.** ORS 426.110 is amended to read:



1       426.110. The following requirements relating to the appointment of examiners for purposes of a  
2 hearing under ORS 426.095 **or sections 2 and 3 of this 2013 Act** apply as described:

3       (1) The judge shall appoint one qualified examiner. If requested, the judge shall appoint one  
4 additional qualified examiner. A request for an additional examiner under this subsection must be  
5 made in writing and must be made by the allegedly mentally ill person or the attorney for the  
6 allegedly mentally ill person.

7       (2) To be qualified for purposes of this section, an examiner must meet all of the following  
8 qualifications:

9       (a) The person must agree to be an examiner.

10       (b) The person must be one of the following:

11       (A) A physician licensed by the Oregon Medical Board who is competent to practice psychiatry  
12 as provided by the Oregon Health Authority **or the Psychiatric Security Review Board** by rule.

13       (B) Certified **by the authority or the Psychiatric Security Review Board** as a mental health  
14 examiner qualified to make examinations for involuntary commitment proceedings [*by the*  
15 *authority*]. The authority **or the Psychiatric Security Review Board** may establish, by rule, re-  
16 quirements for certification as a mental health examiner for purposes of this subparagraph.

17       (3) The cost of examiners under this section shall be paid as provided under ORS 426.250.

18       **SECTION 6.** ORS 426.135 is amended to read:

19       426.135. If a person determined to be mentally ill as provided in ORS 426.130, **or determined**  
20 **to be an extremely dangerous mentally ill person under section 2 or 3 of this 2013 Act**, appeals  
21 the determination or disposition based thereon, and is determined to be financially eligible for ap-  
22 pointed counsel at state expense, upon request of the person or upon its own motion, the court shall  
23 appoint suitable legal counsel to represent the person. The compensation for legal counsel and costs  
24 and expenses necessary to the appeal shall be determined and paid by the public defense services

1       **Sec. 3.** (1)(a) At the end of the 24-month period of commitment described in section 2 of this 2013  
2 Act, any person who remains committed under the jurisdiction of the Psychiatric Security Review  
3 Board shall be discharged, unless the board certifies to the court in the county where the state

19 psychologist or psychiatrist, other than a member of the staff from the facility where the person is  
20 being treated, to examine the person at no expense to the person and to report to the court the  
21 results of the examination.

22 (e) The provisions of ORS 40.230, 40.235, 40.240, 40.250 and 179.505 do not apply to the use of  
23 medical records from the current period of commitment or to testimony related to such records or  
24 period of commitment in connection with hearings under this section. The court may consider as  
25 evidence such reports and testimony.

26 (f) The court shall then conduct a hearing. The court may take judicial notice of the findings  
27 regarding the act described in section 2 (3)(a)(C) of this 2013 Act made by the court at the initial  
28 commitment. If, after hearing the evidence and reviewing the recommendations of the board and the  
29 state hospital or the state or local mental health facility providing treatment to the person, in the  
30 opinion of the court the person is still extremely dangerous and suffering from a mental disorder  
31 that is resistant to treatment by clear and convincing evidence, the court may order commitment  
32 to the jurisdiction of the board for an additional maximum of 24 months. The court shall further  
33 commit the person to a state hospital for custody, care and treatment if the court finds, by clear  
34 and convincing evidence, that the person cannot be controlled in the community with proper care,  
35 medication, supervision and treatment on conditional release.

36 (g) At the end of the 24-month period, the person shall be discharged unless the board, hospital  
37 or facility again certifies to the committing court that the person is still an extremely dangerous  
38 [*mentally ill*] person **with mental illness** and in need of further treatment, in which event the pro-  
39 cedures set forth in this section shall be followed.

40 **SECTION 15.** If Senate Bill 426 becomes law, ORS 426.095, as amended by section 4 of this 2013  
41 Act, is amended to read:

42 426.095. The following is applicable to a commitment hearing held by a court under ORS 426.070:

43 (1) The hearing may be held in a hospital, the person's home or in some other place convenient  
44 to the court and the [*allegedly mentally ill*] person **alleged to have a mental illness**.

45 (2) The court shall hold the hearing at the time established according to the following:

1 (a) Except as provided by paragraph (b) or (c) of this subsection, a hearing shall be held five  
2 judicial days from the day a court under ORS 426.070 issues a citation provided under ORS 426.090.

3 (b) Except as provided by paragraph (c) of this subsection, if a person is detained by a warrant  
4 of detention under ORS 426.070, a hearing shall be held within five judicial days of the commence-

7 not more than five judicial days in order to allow preparation for the hearing. The court may make  
8 orders for the care and custody of the person during a postponement as it deems necessary. If a

10 tion 3 of this 2013 Act and the hearing is postponed under this paragraph, the court, for good cause,  
11 may allow the person to be detained during the postponement if the postponement is requested by  
12 the person or the legal counsel of the person. Any of the following may request a postponement  
13 under this paragraph:

14 (A) The *[allegedly mentally ill person or extremely dangerous mentally ill]* person **alleged to have**  
15 **a mental illness or the person alleged to be an extremely dangerous person with mental ill-**  
16 **ness.**

17 (B) The legal counsel or guardian of the *[allegedly mentally ill person or extremely dangerous*  
18 *mentally ill]* person.

19 (C) The *[person]* **individual** representing the state's interest.

20 (3) The *[allegedly mentally ill]* person **alleged to have a mental illness** and the *[person]* **indi-**  
21 **vidual** representing the state's interest shall have the right to cross-examine all the following:

22 (a) Witnesses.

23 (b) The *[person]* **individual** conducting the investigation.

24 (c) The examining physicians or other qualified *[persons]* **professionals** recommended by the  
25 Oregon Health Authority who have examined the person.

26 (4) The provisions of ORS 40.230, 40.235, 40.240 and 40.250 shall not apply to and the court may  
27 consider as evidence any of the following:

28 (a) Medical records for the current involuntary prehearing period of detention.

29 (b) Statements attributed by the maker of the medical records or the investigation report to  
30 witnesses concerning their own observations in the absence of objection or if such *[persons]* **indi-**  
31 **viduals** are produced as witnesses at the hearing available for cross-examination.

32 (c) The testimony of any treating physicians, nurses or social workers for the prehearing period  
33 of detention. Any treating physician, nurse or social worker who is subpoenaed as a witness for the  
34 proceeding shall testify as an expert witness under the provisions of ORS 40.410, 40.415, 40.420 and  
35 40.425 and is subject to treatment as an expert witness in the payment of witness fees and costs.

36 (d) The investigation report prepared under ORS 426.074. Subject to the following, the investi-  
37 gation report shall be introduced in evidence:

38 (A) Introduction of the report under this paragraph does not require the consent of the *[allegedly*  
39 *mentally ill]* person **alleged to have a mental illness.**

40 (B) Upon objection by any party to the action, the court shall exclude any part of the investi-  
41 gation report that may be excluded under the Oregon Evidence Code on grounds other than those  
42 set forth in ORS 40.230, 40.235, 40.240 or 40.250.

43 (C) Neither the investigation report nor any part thereof shall be introduced into evidence under  
44 this paragraph unless the investigator is present during the proceeding to be cross-examined or un-  
45 less the presence of the investigator is waived by the *[allegedly mentally ill]* person **alleged to have**

1 **a mental illness** or counsel for the [*allegedly mentally ill*] person.

2 **SECTION 16.** If Senate Bill 426 becomes law, ORS 426.110, as amended by section 5 of this 2013  
3 Act, is amended to read:

4 426.110. The following requirements relating to the appointment of examiners for purposes of a  
5 hearing under ORS 426.095 or sections 2 and 3 of this 2013 Act apply as described:

6 (1) The judge shall appoint one qualified examiner. If requested, the judge shall appoint one  
7 additional qualified examiner. A request for an additional examiner under this subsection must be  
8 made in writing and must be made by the [*allegedly mentally ill*] person **alleged to have a mental**  
9 **illness** or the attorney for the [*allegedly mentally ill*] person.

21 [(3)] (4) The cost of examiners under this section shall be paid as provided under ORS 426.250.

24 426.135. If a person determined to be [*mentally ill*] **a person with mental illness** as provided

27 *thereon*], and is determined to be financially eligible for appointed counsel at state expense, upon

29 resent the person. The compensation for legal counsel and costs and expenses necessary to the ap-  
30 peal shall be determined and paid by the public defense services executive director as provided in
