

## SENATE AMENDMENTS TO SENATE BILL 450

By COMMITTEE ON HEALTH CARE AND HUMAN SERVICES

- 1 On page 1 of the printed bill, line 5, delete “13” and insert “20”.
- 2 In line 10, delete “four persons” and insert “seven members”.
- 3 In line 14, delete “and”.
- 4 In line 16, delete the period and insert a semicolon.
- 5 After line 16, insert:
- 6 “(E) One person with expertise in the delivery of services to seniors and persons with disabili-
- 7 ties;
- 8 “(F) One person who represents an organization that advocates for persons with disabilities; and
- 9 “(G) One person with expertise in the delivery of services to persons with developmental disa-
- 10 bilities.”.
- 11 In line 21, delete “member” and insert “person”.
- 12 In line 23, after “appoint” delete the rest of the line and delete lines 24 through 27 and insert
- 13 “one person with expertise in assisting individuals on probation or post-prison supervision to secure
- 14 housing and to find and maintain employment.”.
- 15 After line 29, insert:
- 16 “(g) The Governor shall appoint five members including:
- 17 “(A) One person recommended by the Association of Oregon Counties;
- 18 “(B) One person who represents a labor organization that represents Department of Human
- 19 Services employees;
- 20 “(C) One person who represents the Early Learning Council established by section 4, chapter
- 21 519, Oregon Laws 2011;
- 22 “(D) One person who has experience working with or for a coordinated care organization, as
- 23 defined in ORS 414.025; and
- 24 “(E) One person with experience in workforce placement and retraining programs that help
- 25 Oregonians return to stable employment.”.
- 26 On page 2, line 2, after “(a)” insert “(A)”.
- 27 After line 4, insert:
- 28 “(B) As used in this paragraph, ‘delivery of human services’ includes, but is not limited to:
- 29 “(i) The determination of eligibility for human services programs;
- 30 “(ii) Enrolling individuals in human services programs and making referrals to other appropriate
- 31 programs;
- 32 “(iii) Ongoing case management; and
- 33 “(iv) Providing assistance to individuals who are transitioning out of programs.”.
- 34 After line 10, insert:
- 35 “(e) Investigate how to improve information systems and the feasibility of creating a shared

1 database.

2 “(f) Investigate ways to use existing facilities more efficiently.”.

3 In line 28, after “a” insert “preliminary” and after “report” delete the rest of the line.

4 In line 29, delete “include recommendations for legislation,”.

5 In line 31, after the period insert “The task force shall submit a final report of its findings under  
6 subsection (2) of this section, and may include recommendations for legislation, to the appropriate  
7 interim committees of the Legislative Assembly no later than June 1, 2014.”.

8 In line 32, delete “Department of Human” and insert “Oregon Department of Administrative”.

9 In line 37, delete “Department of Human” and insert “the Oregon Department of  
10 Administrative”.

11 In line 42, delete “2014” and insert “2015”.
