

SENATE AMENDMENTS TO SENATE BILL 483

- 1 On page 1 of the printed bill, delete lines 13 through 26.
- 2 On page 2, delete lines 1 through 10 and insert:
- 3 “(3) ‘Health care provider’ means a person practicing within the scope of the person’s license,
4 registration or certification to practice as:
- 5 “(a) A psychologist under ORS 675.030 to 675.070, 675.085 and 675.090;
- 6 “(b) An occupational therapist under ORS 675.230 to 675.300;
- 7 “(c) A physician under ORS 677.100 to 677.228;
- 8 “(d) An emergency medical services provider under ORS chapter 682;
- 9 “(e) A podiatric physician and surgeon under ORS 677.820 to 677.840;
- 10 “(f) A registered nurse under ORS 678.010 to 678.410;
- 11 “(g) A dentist under ORS 679.060 to 679.180;
- 12 “(h) A dental hygienist under ORS 680.040 to 680.100;
- 13 “(i) A denturist under ORS 680.515 to 680.535;
- 14 “(j) An audiologist or speech-language pathologist under ORS 681.250 to 681.350;
- 15 “(k) An optometrist under ORS 683.040 to 683.155 and 683.170 to 683.220;
- 16 “(L) A chiropractor under ORS 684.040 to 684.105;
- 17 “(m) A naturopath under ORS 685.060 to 685.110, 685.125 and 685.135;
- 18 “(n) A massage therapist under ORS 687.011 to 687.250;
- 19 “(o) A direct entry midwife under ORS 687.405 to 687.495;
- 20 “(p) A physical therapist under ORS 688.040 to 688.145;
- 21 “(q) A medical imaging licensee under ORS 688.445 to 688.525;
- 22 “(r) A pharmacist under ORS 689.151 and 689.225 to 689.285;
- 23 “(s) A physician assistant under ORS 677.505 to 677.525; or
- 24 “(t) A professional counselor or marriage and family therapist under ORS 675.715 to 675.835.”
- 25 In line 16, before the comma insert “or a location operated by a health care facility”.
- 26 In line 24, before the comma insert “or a location operated by a health care facility”.
- 27 After line 43, insert:
- 28 “(6) An inmate as defined in ORS 30.642 may not file a notice of adverse health care incident
29 under this section.”
- 30 On page 4, line 38, delete “Malpractice” and insert “Professional liability”.
- 31 On page 5, after line 17, insert:
- 32 “(4) Except as provided in section 4 of this 2013 Act, evidence that a party participated or did
33 not participate in the notice, discussion and mediation process under sections 2, 3 and 5 of this 2013
34 Act is inadmissible in any adjudicatory proceeding.”
- 35 In line 18, delete “(4)” and insert “(5)”.

1 On page 6, line 9, after “outcomes” insert “and disseminate information about those practices”.

2 On page 9, line 3, after “requirements” insert “and policy provisions”.

3 In line 5, after “Requirements” insert “and policy provisions”.

4 In line 43, delete “12” and insert “14”.

5 On page 10, delete lines 7 through 10 and insert:

6 “(c) The Governor shall appoint 10 members, including:

7 “(A) At least three members who are physicians licensed under ORS chapter 677 and in active

8 practice;

9 “(B) At least three members who are trial lawyers;

10 “(C) One member who is a representative of the hospital industry; and

11 “(D) One member who is an advocate for patient safety.”.

12 On page 11, delete lines 1 through 6 and insert:

13 **“SECTION 18. On or before October 1, 2018, the Task Force on Resolution of Adverse**

14 **Health Care Incidents shall report to an appropriate committee or interim committee of the**

15 **Legislative Assembly. The report must evaluate whether any improvements to the process**

16 **are necessary.”.**

17 In line 10, delete “Two” and insert “Three”.

18 In line 12, delete “Three” and insert “Four”.
