**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys to Department of Education to be expended for purpose of awarding grants under Career and Technical Education Revitalization Grant Program.

Declares emergency, effective July 1, 2013.

**A BILL FOR AN ACT**

2 Relating to the Career and Technical Education Revitalization Grant Program; appropriating money;  
3 and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other provision of law, the General Fund appropriation**  
6 **made to the Department of Education to be distributed as grants-in-aid, for program costs**  
7 **and to purchase services under section 2 (6), chapter \_\_, Oregon Laws 2013 (Enrolled Senate**  
8 **Bill 5518), for the biennium beginning July 1, 2013, is increased by \$7,500,000, which may be**  
9 **expended for the purpose of awarding grants under the Career and Technical Education**  
10 **Revitalization Grant Program established by ORS 344.075.**

11 **SECTION 2. This 2013 Act being necessary for the immediate preservation of the public**  
12 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**  
13 **July 1, 2013.**
