

Senate Bill 532

Sponsored by COMMITTEE ON VETERANS AND EMERGENCY PREPAREDNESS

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies list of state agencies required to designate liaison for emergency preparedness and response. Requires that liaison be individual with authority during emergency to allocate agency resources and assets.

2 Relating to emergency services; amending ORS 401.054.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 401.054 is amended to read:

5 401.054. (1) **Each of** the following state agencies shall designate [*a person within each*] **an in-**
6 **dividual within the** agency to act as a liaison with the Office of Emergency Management:

7 [*(a) The Department of Transportation;*]

8 [*(b) The State Department of Agriculture;*]

9 [*(c) The Department of Environmental Quality;*]

10 [*(d) The Department of Human Services;*]

11 [*(e) The State Department of Energy;*]

12 [*(f) The Oregon Department of Administrative Services;*]

13 [*(g) The Department of State Police;*]

14 [*(h) The State Department of Geology and Mineral Industries;*]

15 [*(i) The Oregon Health Authority; and*]

16 [*(j) The Oregon Military Department.*]

17 **(a) The Department of Consumer and Business Services;**

18 **(b) The Department of Corrections;**

19 **(c) The Department of Environmental Quality;**

20 **(d) The Department of Human Services;**

21 **(e) The Department of Justice;**

22 **(f) The Department of Land Conservation and Development;**

23 **(g) The Department of State Police;**

24 **(h) The Department of Transportation;**

25 **(i) The Judicial Department;**

26 **(j) The Oregon Department of Administrative Services;**

27 **(k) The Oregon Department of Aviation;**

28 **(L) The Oregon Health Authority;**

8 **(2) Each state agency required to designate a liaison under this section shall designate**
9 **an individual who has authority during an emergency to allocate resources and assets of the**
10 **agency.**

11 [(2)] **(3)** Each [*person*] **individual** designated as a liaison under subsection (1) of this section
12 shall assist in the coordination of the functions of the [*person's*] **individual's** agency that relate to
13 emergency preparedness and response with similar functions of the Office of Emergency Manage-
14 ment.
