

# Senate Bill 5519

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Department of Education for State School Fund.

Limits biennial expenditures from lottery moneys allocated from Administrative Services Economic Development Fund to department for State School Fund.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department for State School Fund.

Prohibits, for biennium, specified uses of moneys from State School Fund. Specifies, for 2013 and 2014 fiscal years, total amount that department may spend from State School Fund.

Appropriates moneys from General Fund to Department of Education for Local Option Equalization Grants Account.

Declares emergency, effective July 1, 2013.

## A BILL FOR AN ACT

1  
2 Relating to state financial administration; appropriating money; limiting expenditures; and declaring  
3 an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri-**  
6 **ated to the Department of Education, for the biennium beginning July 1, 2013, out of the**  
7 **General Fund, the amount of \$5,834,629,855 for the State School Fund.**

8 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**  
9 **\$314,547,564 is established for the biennium beginning July 1, 2013, as the maximum limit for**  
10 **payment of expenses from lottery moneys allocated from the Administrative Services Eco-**  
11 **nomic Development Fund to the Department of Education for the State School Fund.**

12 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$400,826**  
13 **is established for the biennium beginning July 1, 2013, as the maximum limit for payment of**  
14 **expenses by the Department of Education from fees, moneys or other revenues, including**  
15 **Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received**  
16 **by the Department of Education for the State School Fund.**

17 **SECTION 4. Notwithstanding ORS 327.008 and 327.013, for the biennium beginning July**  
18 **1, 2013, the Department of Education may not expend any moneys from the State School**  
19 **Fund for the administration of ORS 326.133 and 326.136.**

20 **SECTION 5. (1) The Department of Education may not spend more than \$3,013,293,340**  
21 **from the State School Fund for the fiscal year beginning July 1, 2013.**

22 **(2) The Department of Education may not spend more than \$3,136,284,905 from the State**  
23 **School Fund for the fiscal year beginning July 1, 2014.**

24 **SECTION 6. In addition to and not in lieu of any other appropriation, there is appropri-**  
25 **ated to the Department of Education, for the biennium beginning July 1, 2013, out of the**

1 **General Fund, the amount of \$2,222,581 for the Local Option Equalization Grants Account.**

2 **SECTION 7. This 2013 Act being necessary for the immediate preservation of the public**  
3 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**  
4 **July 1, 2013.**
