## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Oregon Military Department for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and federal service agreement reimbursements, but excluding lottery funds and other federal funds, collected or received by department for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Declares emergency, effective July 1, 2013.

## A BILL FOR AN ACT

2 Relating to the financial administration of the Oregon Military Department; appropriating money;

3 limiting expenditures; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> There are appropriated to the Oregon Military Department, for the biennium 6 beginning July 1, 2013, out of the General Fund, the following amounts, for the following

- 8 (1) Administration......\$ 4.377.683 Operations......\$ 9 **(2)** 6,685,513 10 (3) Emergency management...... \$ 2,111,025 11 (4) Community support ...... \$ 199.909 12 (5) **Capital debt service**

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2013, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and reimbursements from federal service agreements, but excluding lottery funds and federal funds not described in this section, collected or received by the Oregon Military Department, for the following purposes:

- 20 (1) Administration...... \$ 1,869,500
- 21 (2) Operations...... \$ 4,764,015
- 22 (3) Emergency management...... \$ 84,801,046
- 23 (4) Community support ...... \$ 1,856,495
- 24 (5) Capital debt service
- 25 and related costs...... \$ 107,355

26 <u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, the following amounts 27 are established for the biennium beginning July 1, 2013, as the maximum limits for payment
