

Senate Bill 567

Sponsored by Senator HASS (at the request of Oregon Save Our Schools)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs State Board of Education to appoint Chief Privacy Officer to be responsible for ensuring that student information contained in student education records is adequately protected.

Directs education entity to provide certain information to students, parents, legal guardians and teachers related to personal data collected by education entity.

Allows student, parent or legal guardian to agree to provide, or refuse to provide, personal data or to agree to provide personal data but request that data not be shared.

Declares emergency, effective July 1, 2013.

A BILL FOR AN ACT

2 Relating to student education records; creating new provisions; amending ORS 326.565, 326.580 and
3 338.115; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) The State Board of Education shall appoint a Chief Privacy Officer who**
6 **shall serve at the pleasure of the board. The Chief Privacy Officer must be certified by a**
7 **professional association as demonstrating an understanding of privacy laws and the legal**
8 **requirements for the transfer of personal data.**

9 **(2) The Chief Privacy Officer is responsible for ensuring that information contained in**
10 **student education records is adequately protected by:**

11 **(a) Recommending to the board standards for:**

12 **(A) The creation, use, custody and disclosure of student education records that are con-**
13 **sistent with the requirements of state and federal law;**

14 **(B) The content and format of electronic student records that are consistent with the**
15 **requirements of state and federal law; and**

16 **(C) The ability of a student or a parent or legal guardian of a student to access and to**
17 **correct student records in a manner that is consistent with the requirements of state and**
18 **federal law.**

19 **(b) Issuing an assessment of any data system, program or contract involving personally**
20 **identifiable information from student education records that:**

21 **(A) Is about a student or a parent or guardian of a student; and**

22 **(B) Is not required to be collected under federal law, not required for recordkeeping**
23 **purposes or not required for the administration of a school, a school district or an education**
24 **service district, as determined under rules adopted by the board.**

25 **(c) Making assessments issued under paragraph (b) of this subsection available on the**
26 **website of the Department of Education.**

27 **(d) Imposing sanctions against any school, school district or education service district for**
28 **any disclosure of personally identifiable information from a student's records that is pro-**

1 **hibited by the rules of the board.**

2 (e) **Administering the Oregon electronic student record program described in ORS**
 3 **326.580.**

4 (f) **Any other duties related to student education records assigned by the board.**

5 (3) **When developing standards as provided by subsection (2)(a) of this section, the Chief**
 6 **Privacy Officer shall ensure that the disclosure of personally identifiable information is**
 7 **minimized to the greatest extent practicable as allowed under state and federal law.**

8 **SECTION 2.** ORS 326.565 is amended to read:

9 326.565. (1) The State Board of Education, **in consultation with the Chief Privacy Officer,**
 10 shall adopt by rule standards for the creation, use, custody and disclosure, including access, of stu-
 11 dent education records that are consistent with the requirements of applicable state and federal law.

12 (2) The [state] board shall distribute the rules that are adopted to all school districts. The school
 13 districts shall make those rules available to the public schools in the district and to the public.

14 (3) The [state] board may differentiate the standards applicable to persons 18 years of age or
 15 older or enrolled in post-secondary institutions.

16 (4) The standards shall include requirements under which public and private schools and edu-
 17 cation service districts transfer student education records pursuant to ORS 326.575.

18 **SECTION 3.** ORS 326.580 is amended to read:

19 326.580. (1) As used in this section, “educational institution” means:

20 (a) An “educational institution” as defined in ORS 326.575.

21 (b) A state agency.

22 (c) A local correctional facility.

23 (2) The State Board of Education [may], **in consultation with the Chief Privacy Officer, shall**
 24 **adopt by rule standards for the content and format of an Oregon electronic student record. An**
 25 **Oregon electronic student record may be used to transfer student record information from one edu-**
 26 **cational institution to another.**

27 (3) The board may define the Oregon electronic student record to constitute a full and complete
 28 copy of the official student permanent record, student education record and certificate of immu-
 29 nization status that are required by state and federal law.

30 (4) The standards established by the board shall include procedures and criteria for participation
 31 in the Oregon electronic student record program by educational institutions. An educational insti-
 32 tution may apply to the Department of Education for a certificate of participation in the Oregon
 33 electronic student record program.

34 (5) An educational institution that is approved for participation in the Oregon electronic student
 35 record program by the Department of Education:

36 (a) Shall not be required to forward by mail or other means physical items such as original
 37 documents or photocopies to a receiving educational institution that also is approved for partic-
 38 ipation in the program. This paragraph does not apply to special education records that are specifi-
 39 cally required by federal law to be physically transferred.

40 (b) May elect to designate the Oregon electronic student record as the official student record.

41 (c) Shall retain the official student record in compliance with state and federal law.

42 **SECTION 4. (1) As used in this section:**

43 (a) **“Education entity” means a school district, the schools of a school district or an ed-**
 44 **ucation service district.**

45 (b) **“Personal data” means:**

1 (A) Personally identifiable information about a student or a parent or guardian of a stu-
2 dent; and

3 (B) Any other information that is personal, including health records, discipline records,
4 birth dates and socioeconomic data.

5 (2)(a) An education entity shall provide information to students and the parents or legal
6 guardians of students about the purposes for which personal data collected by the education
7 entity will be used. The information must be provided:

8 (A) Within one week of the beginning of the school year or one week of the student en-
9 rolling in a school served by the education entity; and

10 (B) At any other time when the education entity collects personal data.

11 (b) An education entity shall provide information to the teachers employed by the edu-
12 cation entity about the purposes for which personal data collected by the education entity
13 will be used. The information must be provided:

14 (A) Within one week of the beginning of the school year; and

15 (B) At any other time when the education entity collects personal data and the education
16 entity determines that teachers should receive information about the personal data collected.

17 (3) Information provided by the education entity under subsection (2) of this section must
18 include a description of the personal data collected, an identification of who will use the
19 personal data and an explanation of why the personal data will be used.

20 (4) A student, parent or legal guardian may:

21 (a) Agree to provide, or refuse to provide, personal data if the data is not required to be
22 collected for:

23 (A) A purpose required by state or federal law;

24 (B) Recordkeeping purposes of the education entity; or

25 (C) The administration of the education entity, as determined under rules adopted by the
26 State Board of Education.

27 (b) Agree to provide personal data but request in writing that the personal data not be
28 shared with any other public or private entity.

29 **SECTION 5.** Section 4 of this 2013 Act first applies to the 2013-2014 school year.

16 (2) Notwithstanding subsection (1) of this section, a charter may specify that statutes and rules

20 “public school” include public charter school as those terms are used in that statute or rule.

39 **SECTION 8. This 2013 Act being necessary for the immediate preservation of the public**
40 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
41 **July 1, 2013.**
