

Senate Bill 592

Sponsored by COMMITTEE ON JUDICIARY (at the request of Oregon Law Commission)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Revises Oregon Uniform Trust Code.
Declares emergency, effective on passage.

2 Relating to the Oregon Uniform Trust Code; creating new provisions; amending ORS 130.010,
3 130.045, 130.170, 130.195, 130.200, 130.215, 130.305, 130.310, 130.315, 130.525, 130.555, 130.610,
4 130.615, 130.625, 130.630, 130.635, 130.650, 130.655, 130.710, 130.725, 130.730 and 130.735; and de-
5 claring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 130.010 is amended to read:

8 130.010. For the purposes of this chapter:

9 (1) "Ascertainable standard" means an ascertainable standard relating to an individual's health,
10 education, support or maintenance within the meaning of section 2041(b)(1)(A) or 2514(c)(1) of the
11 Internal Revenue Code, as in effect on January 1, 2006.

12 (2) "Beneficiary" means a person that:

13 (a) Has a present or future beneficial interest in a trust, whether vested or contingent; or

14 (b) Holds a power of appointment over trust property in a capacity other than that of trustee.

15 (3) "Charitable trust" means a trust, or portion of a trust, described in ORS 130.170 (1).

16 (4) "Conservator" means a person appointed by a court to administer the estate of a minor or
17 adult individual.

18 (5) "Environmental law" means a federal, state or local law, rule, regulation or ordinance re-
19 lating to protection of the environment.

20 (6) "Financial institution" has the meaning given that term in ORS 706.008.

21 (7) "Financially incapable" has the meaning given that term in ORS 125.005. "Financially capa-
22 ble" means not financially incapable.

23 (8) "Guardian" means a person appointed by a court to make decisions regarding the support,
24 care, education, health and welfare of a minor or adult individual. "Guardian" does not include a
25 guardian ad litem.

26 (9) "Interests of the beneficiaries" means the beneficial interests provided in the terms of a
27 trust.

28 (10) "Permissible distributee" means a beneficiary who is currently eligible to receive distrib-
29 utions of trust income or principal, whether the distribution is mandatory or discretionary.

30 (11) "Person" means an individual, corporation, business trust, partnership, limited liability
31 company, association, joint venture, public body as defined in ORS 174.109 or any other legal or

1 commercial entity.

2 (12) "Power of withdrawal" means a presently exercisable general power of appointment, other
3 than a power exercisable by a trustee that is limited by an ascertainable standard or that is
4 exercisable by another person only upon consent of the trustee or a person holding an adverse in-
5 terest.

6 (13) "Property" means anything that may be the subject of ownership, whether real or personal,
7 legal or equitable, or any interest therein.

8 (14) "Qualified beneficiary" means a beneficiary who:

9 (a) Is a permissible distributee on the date the beneficiary's qualification is determined;

10 (b) Would be a permissible distributee if the interests of all permissible distributees described
11 in paragraph (a) of this subsection terminated on the date the beneficiary's qualification is deter-
12 mined; or

13 (c) Would be a permissible distributee if the trust terminated on the date the beneficiary's
14 qualification is determined.

15 **(15) "Remote interest beneficiary" means a beneficiary, other than a qualified benefi-
16 ciary, whose beneficial interest in the trust at the time the determination of interest is made
17 is contingent upon the termination of the qualified beneficiary interest, the secondary bene-
18 ficiary interest and any other beneficiary interest that precedes the interest of the remote
19 interest beneficiary.**

20 [(15)] (16) "Revocable trust" means a trust that can be revoked by the settlor without the con-
21 sent of the trustee or a person holding an adverse interest.

22 **(17) "Secondary beneficiary" means a beneficiary who, at the time the determination of
23 interest is made, shall become a qualified beneficiary on the termination of the interest of
24 a qualified beneficiary.**

25 [(16)] (18) "Settlor" means a person, including a testator, who creates a trust or contributes
26 property to a trust. If more than one person creates or contributes property to a trust, each person
27 is a settlor of the portion of the trust property attributable to that person's contribution and of the
28 portion as to which that person has the power to revoke or withdraw.

29 [(17)] (19) "Spendthrift provision" means a term of a trust that restrains both voluntary and in-
30 voluntary transfer of a beneficiary's interest.

31 [(18)] (20) "State" means a state of the United States, the District of Columbia, Puerto Rico, the
32 United States Virgin Islands or any territory or insular possession subject to the jurisdiction of the
33 United States. "State" includes an Indian tribe or band recognized by federal law or formally ac-
34 knowledged by a state.

35 [(19)] (21) "Terms of a trust" means the manifestation of the settlor's intent regarding a trust's
36 provisions as expressed in the trust instrument or as may be established by other evidence that
37 would be admissible in a judicial proceeding.

38 [(20)] (22) "Trust instrument" means an instrument executed by a settlor that contains terms
39 of the trust, including any amendments to the instrument.

40 [(21)] (23) "Trustee" means an original trustee, an additional trustee, a successor trustee or a
41 cotrustee.

42 **SECTION 2.** ORS 130.045 is amended to read:

43 130.045. (1) For purposes of this section, "interested persons" means:

44 (a) Any settlor of a trust who is living[.];

45 (b) All **qualified** beneficiaries [*of the trust who have an interest in the subject of the*

1 *agreement*,];

2 (c) Any acting trustee of the trust[.]; and

3 (d) The Attorney General if the trust is a charitable trust [*subject to the enforcement or super-*
4 *visory powers of the state or the Attorney General under the provisions of ORS 128.610 to 128.750*].

5 **(2) If the trust or a portion of the trust is a charitable trust and is irrevocable, and the**
6 **settlor retains a power to change the beneficiaries of the charitable trust during the settlor's**
7 **lifetime or upon the settlor's death, the Attorney General shall be substituted as the sole**
8 **interested person to represent all charitable trust beneficiaries whose beneficial interests are**
9 **subject to the settlor's retained power.**

10 [(2)] (3)(a) Except as otherwise provided in subsection [(3)] (4) of this section, interested persons
11 may enter into a [*binding*] nonjudicial settlement agreement with respect to any matter involving a
12 trust.

13 **(b) If the agreement is not filed with the court under subsection (6) of this section, the**
14 **agreement is binding on all parties to the agreement.**

15 **(c) If the agreement is filed with the court, the agreement is binding as provided in**
16 **subsections (6) and (7) of this section unless, after the filing of objections and a hearing, the**
17 **court does not approve the agreement. If the court does not approve the agreement, the**
18 **agreement is not binding on any beneficiary or party to the agreement.**

19 [(3)] (4) A nonjudicial settlement agreement is valid only to the extent the agreement does not
20 violate a material purpose of the trust and includes terms and conditions that could be properly
21 approved by the court under this chapter or other applicable law.

22 [(4)] (5) Matters that may be resolved by a nonjudicial settlement agreement include:

23 (a) The interpretation or construction of the terms of the trust or other writings that affect the
24 trust.

25 (b) The approval of a trustee's report or accounting.

26 (c) Direction to a trustee to refrain from performing a particular act or the grant to a trustee
27 of any necessary or desirable power.

28 (d) The resignation or appointment of a trustee **or cotrustee** and the determination of a
29 trustee's compensation.

30 (e) Transfer of a trust's principal place of administration.

31 (f) Liability of a trustee for an action or failure to act relating to the trust.

32 (g) Determining classes of creditors, beneficiaries, heirs, next of kin or other persons.

33 (h) Resolving disputes arising out of the administration or distribution of the trust.

34 (i) Modifying the terms of the trust, including extending or reducing the period during which the
35 trust operates.

36 [(5)(a)] (6)(a) Any interested person may file a settlement agreement entered into under this
37 section, or a memorandum summarizing the provisions of the agreement, with the circuit court for
38 any county where trust assets are located or where the trustee administers the trust.

39 (b) After collecting the fee provided for in subsection [(7)] (8) of this section, the clerk shall
40 enter the agreement or memorandum of record in the court's register.

41 (c) Within five days after the filing of an agreement or memorandum under this subsection, the
42 person making the filing must serve a notice of the filing and a copy of the agreement or memo-
43 randum on each [*person interested in*] **beneficiary of** the trust whose address is known at the time
44 of the filing **and who is not a party to the agreement**. Service may be made personally, or by
45 registered or certified mail, return receipt requested. The notice of filing shall be substantially in

9 You are hereby notified that the attached document was filed by the undersigned in the above
10 entitled court on the _____ day of _____, _____. Unless you file objections to the agreement
11 within [120] **60** days after that date, the agreement will be approved and will be binding on all
12 [*persons interested in the trust*] **beneficiaries and parties to the agreement.**

13 If you file objections within the [120-day] **60-day** period, the court will fix a time and place for
14 a hearing. At least 10 days before the date of that hearing, you must serve a copy of your objections
15 and give notice of the time and place of the hearing to all [*persons interested in the trust*] **benefici-**
16 **aries and parties to the agreement.** See ORS 130.045.

21 (d) Proof of mailing of the notices required under this subsection must be filed with the court.
22 Proof of service may be made by a certificate of service in the form provided by ORCP 7 F, by a
23 signed acceptance of service or by a return receipt from the postal authorities.

24 (e) If no objections are filed with the court within [120] **60** days after the filing of the agreement
25 or memorandum, the agreement is effective and binding on all [*persons interested in the trust*] **ben-**
26 **eficiaries who received notice under paragraph (c) of this subsection and all beneficiaries who**
27 **waived notice under subsection (7)(e) of this section.**

28 [(6)(a)] **(7)(a)** If objections are filed with the court within [120] **60** days after the filing of a
29 settlement agreement or memorandum under this section, the clerk of the court shall collect the fee
30 provided in subsection [(7)] **(8)** of this section. Upon the filing of objections, the court shall fix a
31 time and place for a hearing. The person filing the objections must serve a copy of the objections
32 on all [*persons interested in the trust*] **beneficiaries who are parties to the agreement and all**
33 **beneficiaries who received notice under subsection (6)(c) of this section,** and give notice to
34 those persons of the time and place fixed by the court for a hearing. Service must be made at least
35 10 days before the date set by the court for the hearing. Service of the objections may be made
36 personally or by registered or certified mail, return receipt requested.

37 (b) Proof of mailing of objections must be filed with the court. Proof of service may be made by
38 a certificate of service in the form provided by ORCP 7 F, by a signed acceptance of service or by
39 a return receipt from the postal authorities.

40 (c) The court shall approve an agreement entered into under this section after a hearing upon
41 objections filed under this subsection unless:

42 (A) The agreement does not reflect the signatures of all persons required by this section;

43 (B) The agreement is not authorized by this section; or

44 (C) Approval of the agreement would not be equitable **to beneficiaries who are not interested**
45 **persons and who are not parties to the agreement.**

1 (d) An agreement approved by the court after a hearing is binding on all [*persons interested in*
 2 *the trust*] **beneficiaries and parties to the agreement.**

3 (e) [*Persons interested in the trust*] **Beneficiaries entitled to notice under subsection (6)(c)**
 4 **of this section** may waive the notice [*required under subsection (5) of this section. If all persons in-*
 5 *terested in the trust waive the notice, the agreement is effective and binding on all persons interested*
 6 *in the trust upon filing of the agreement or memorandum with the court*].

7 [(7)] **(8)** The clerk of the circuit court shall collect in advance the filing fees established under
 8 ORS 21.135 for the filing of an agreement or memorandum of agreement under subsection [(5)] **(6)**
 9 of this section and for the filing of objections under subsection [(6)] **(7)** of this section.

10 **SECTION 3.** ORS 130.170 is amended to read:

11 130.170. (1) A charitable trust is a trust **that:**

12 **(a) Expressly designates one or more charitable organizations, or one or more classes**
 13 **of charitable organizations, to receive distributions as beneficiaries of the trust unless the**
 14 **combined interests of all charitable beneficiaries are negligible or all charitable beneficiaries**
 15 **are remote interest beneficiaries; or**

16 **(b) Is** created for the relief of poverty, the advancement of education or religion, the promotion
 17 of health, governmental or municipal purposes, or other purposes beneficial to the community[. A
 18 *trust is not a charitable trust if the trust contains*], **but that does not contain** contingencies that
 19 make the charitable interest negligible.

20 (2) If the terms of a charitable trust do not indicate a particular charitable purpose or benefi-
 21 ciary, the court may select one or more charitable purposes or beneficiaries. The selection must be
 22 consistent with the settlor's intention to the extent that intent can be ascertained.

23 (3) The settlor of a charitable trust, in addition to other persons authorized by law or the trust
 24 instrument, may maintain a proceeding to enforce the trust.

25 (4) A court may modify or terminate [*any trust of property for charitable purposes*] **a charitable**
 26 **trust** only if the Attorney General is a party to the proceedings.

27 **SECTION 4.** ORS 130.195 is amended to read:

28 130.195. (1) In addition to the methods of termination prescribed by ORS **130.045**, 130.200,
 29 130.205, 130.210 and 130.215, a trust terminates:

30 (a) To the extent the trust is revoked or expires pursuant to the terms of the trust;

31 (b) If no purpose of the trust remains to be achieved; or

32 (c) To the extent one or more of the purposes of the trust have become unlawful, contrary to
 33 public policy or impossible to achieve.

34 (2) A proceeding to approve or disapprove a proposed modification or termination under ORS
 35 130.045, 130.200, 130.205, 130.210, 130.215, 130.220 and 130.225, or trust combination or division under
 36 ORS 130.230, may be commenced by a trustee or beneficiary. A proceeding to approve or disapprove
 37 a proposed modification or termination under ORS 130.200 may be commenced by the settlor. The
 38 settlor of a charitable trust may maintain a proceeding to modify the trust under ORS 130.210.

39 **SECTION 5.** ORS 130.200 is amended to read:

40 130.200. (1) An irrevocable trust may be modified or terminated with approval of the court upon
 41 consent of the settlor and all beneficiaries **who are not remote interest beneficiaries**, even if the
 42 modification or termination is inconsistent with a material purpose of the trust. The Attorney Gen-
 43 eral must consent to any modification or termination of a charitable trust. A settlor's power to
 44 consent to a trust's modification or termination may be exercised by:

45 (a) An agent or attorney-in-fact under a power of attorney only to the extent expressly author-

1 ized by the terms of the trust **or the power of attorney**;

2 (b) The settlor's conservator with the approval of the court supervising the conservatorship if
3 an agent or attorney-in-fact is not authorized by the terms of the trust **or a power of attorney**; or

4 (c) The settlor's guardian with the approval of the court supervising the guardianship if an agent
5 or attorney-in-fact is not authorized by the terms of the trust **or a power of attorney** and a
6 conservator has not been appointed.

7 (2) An irrevocable trust may be terminated upon consent of all [*of the*] beneficiaries **who are**
8 **not remote interest beneficiaries** if the court concludes that continuance of the trust is not nec-
9 essary to achieve any material purpose of the trust. An irrevocable trust may be modified upon
10 consent of all [*of the*] beneficiaries **who are not remote interest beneficiaries** if the court con-
11 cludes that the modification is not inconsistent with a material purpose of the trust. The Attorney
12 General must consent to any modification or termination of a charitable trust.

13 (3) For the purposes of subsections (1) and (2) of this section, a spendthrift provision in the terms
14 of the trust is rebuttably presumed to constitute a material purpose of the trust.

15 (4) Upon termination of a trust under subsection (1) or (2) of this section, the trustee shall dis-
16 tribute the trust property as agreed to by the beneficiaries and, in the case of a charitable trust
17 requiring the Attorney General's consent, as agreed to by the Attorney General.

18 (5) A proposed modification or termination of the trust under subsection (1) or (2) of this section
19 may be approved by the court without the consent of all beneficiaries **who are not remote interest**
20 **beneficiaries** if the court finds that:

21 (a) If all [*of the*] beneficiaries **who are not remote interest beneficiaries** had consented, the
22 trust could have been modified or terminated under this section; and

23 (b) The interests of any beneficiary who does not consent will be adequately protected.

24 (6) A binding nonjudicial settlement agreement relating to modification or termination of a trust
25 may be entered into by all interested persons, as defined in ORS 130.045.

26 **SECTION 6.** ORS 130.215 is amended to read:

27 130.215. (1) After notice to the qualified beneficiaries, a trustee may terminate a trust if the
28 trustee concludes that the value of the trust property is insufficient to justify the cost of adminis-
29 tration. A trustee may not terminate a trust under this section if the trustee is a **qualified** benefi-
30 ciary of the trust or has a duty of support for a **qualified** beneficiary of the trust.

31 (2) The court may modify or terminate a trust, or remove the trustee and appoint a different
32 trustee, if the court finds that the value of the trust property is insufficient to justify the cost of
33 administration.

34 (3) Upon termination of a trust under this section, the trustee shall distribute the trust property
35 in a manner consistent with the purposes of the trust.

36 (4) This section does not apply to an easement for conservation or preservation.

37 **SECTION 7.** ORS 130.305 is amended to read:

38 130.305. (1) A spendthrift provision is valid only if the provision restrains both voluntary and
39 involuntary transfer of a beneficiary's interest.

40 (2) A term of a trust providing that the interest of a beneficiary is held subject to a spendthrift
41 trust, or words of similar import, is sufficient to restrain both voluntary and involuntary transfer
42 of the beneficiary's interest.

43 (3) A beneficiary may not transfer an interest in a trust in violation of a valid spendthrift pro-
44 vision. Except as otherwise provided in ORS 130.300 to 130.325, a creditor or assignee of a benefi-
45 ciary may not reach the interest of a beneficiary or a distribution by the trustee before the

1 distribution is received by the beneficiary.

2 **(4) A settlement agreement entered into under ORS 130.045 is not, by itself, a transfer**
 3 **in violation of a valid spendthrift provision.**

4 **SECTION 8.** ORS 130.310 is amended to read:

5 130.310. (1) As used in this section, “child” means any individual for whose benefit a judgment,
 6 court order or administrative order for child support has been entered in any state, country or other
 7 jurisdiction.

8 (2) Even if a trust contains a spendthrift provision, the holder of a judgment, court order or
 9 administrative order against a beneficiary for support or maintenance of the beneficiary’s child,
 10 spouse or former spouse or a judgment creditor who has provided services for the protection of a
 11 beneficiary’s interest in the trust, may obtain an order from a court of this state authorizing
 12 garnishment or other execution against present or future distributions to or for the benefit of the
 13 beneficiary. The court may issue an order authorizing execution against such amount as the court
 14 determines to be equitable under the circumstances but not more than the amount the trustee
 15 [would have been] is required to distribute to or for the benefit of the beneficiary. Distributions
 16 subject to execution under this subsection include distributions required by the express terms of the
 17 trust, such as mandatory payments of income, and distributions the trustee has otherwise decided
 18 to make, such as through the exercise of discretion.

19 (3) A spendthrift provision is unenforceable against a claim of this state or the United States
 20 to the extent a statute of this state or federal law so provides.

21 **SECTION 9.** ORS 130.315 is amended to read:

22 130.315. (1) Whether or not the terms of a trust contain a spendthrift provision:

23 (a) During the lifetime of the settlor, the property of a revocable trust is subject to claims of
 24 the settlor’s creditors.

25 (b) A creditor or assignee of the settlor of an irrevocable trust may reach the maximum amount
 26 that can be distributed to or for the settlor’s benefit. If an irrevocable trust has more than one
 27 settlor, the amount the creditor or assignee of a particular settlor may reach may not exceed the
 28 settlor’s interest in the portion of the trust attributable to that settlor’s contribution.

29 (c) If a trust was revocable at the settlor’s death, the property of the trust becomes subject to
 30 creditors’ claims as provided in ORS 130.350 to 130.450 when the settlor dies. The payment of claims
 31 is subject to the settlor’s right to direct the priority of the sources from which liabilities of the
 32 settlor are to be paid.

33 **(d) Notwithstanding the provisions of paragraph (b) of this subsection, the assets of an**
 34 **irrevocable trust may not be subject to the claims of an existing or subsequent creditor or**
 35 **assignee of the settlor, in whole or in part, solely because of the existence of a discretionary**
 36 **power granted to the trustee by the terms of the trust or any other provision of law to pay**
 37 **the amount of tax owed directly to the taxing authorities or to reimburse the settlor for any**
 38 **tax on trust income or principal that is payable or has been paid by the settlor under the law**
 39 **imposing the tax.**

40 (2) For the purpose of creditors’ claims, the holder of a power of withdrawal is treated in the
 41 same manner as the settlor of a revocable trust to the extent property of the trust is subject to the
 42 power. The provisions of this subsection apply to the holder of a power of withdrawal only during
 43 the period that the power may be exercised.

44 (3) Upon the lapse, release or waiver of a power of withdrawal, the property of the trust that
 45 is the subject of the lapse, release or waiver becomes subject to claims of creditors of the holder

1 of the power only to the extent the value of the property exceeds the greater of:

2 (a) The amount specified in section 2041(b)(2) or 2514(e) of the Internal Revenue Code, as in
3 effect on *[January 1, 2006, or section 2503(b) of the Internal Revenue Code, as in effect on January*
4 *1, 2006]* **December 31, 2012;**

5 (b) **The amount specified in section 2503(b) of the Internal Revenue Code, as in effect on**
6 **December 31, 2012; or**

7 (c) **Twice the amount specified in section 2503(b) of the Internal Revenue Code, as in ef-**
8 **fect on December 31, 2012, if the donor was married at the time of the transfer to which the**
9 **power of withdrawal applies.**

10 (4) **The assets of an irrevocable trust that are attributable to a contribution to an inter**
11 **vivos marital deduction trust described in section 2523(c) or (f) of the Internal Revenue Code,**
12 **as in effect on December 31, 2012, after the death of the spouse of the settlor of the inter**
13 **vivos marital deduction trust shall be deemed to have been contributed by the settlor's**
14 **spouse and not by the settlor.**

15 (5) **The assets of an irrevocable trust for the benefit of a person, including the settlor,**
16 **are not subject to claims of creditors of the settlor to the extent that the property of the**
17 **trust is subject to a presently exercisable general power of appointment held by a person**
18 **other than the settlor.**

19 [(4)] (6) Subsections (2) and (3) of this section do not apply to a person other than a settlor who
20 is a beneficiary of a revocable or irrevocable trust and who is also a trustee of the trust, if the
21 power to withdraw for the person's own benefit is limited by an ascertainable standard.

22 **SECTION 10.** ORS 130.525 is amended to read:

23 130.525. *[ORS 130.520 to 130.575 apply only to a trust, or a portion of a trust, that comes into*
24 *existence during the settlor's lifetime and is a revocable trust at any time after the trust was created*
25 *and before the death of the settlor.]*

26 (1) **ORS 130.530 and 130.535 apply only to a trust, or portion of a trust:**

27 (a) **That comes into existence during the settlor's lifetime; and**

28 (b) **Is a revocable trust on the occurrence of any of the events described in ORS 130.530**
29 **or 130.535.**

30 (2) **ORS 130.540 to 130.575 apply only to a trust, or a portion of a trust, that comes into**
31 **existence during the settlor's lifetime and that was a revocable trust at the time of the**
32 **settlor's death.**

33 **SECTION 11.** ORS 130.555 is amended to read:

34 130.555. (1) As used in this section, "pretermitted child" means a child of a settlor who *[is born*
35 *or adopted]*, after the execution of the trust instrument, **is born or adopted during the lifetime**
36 **of the settlor or is in gestation at the time of the settlor's death**, who is not *[provided for in*
37 *the trust]* **acknowledged** or mentioned, **either by name or by class**, in the trust instrument **or in**
38 **the settlor's will**, and who survives the settlor.

39 (2) If a settlor has one or more children living when the settlor executes a trust instrument and
40 no provision is made in the trust for any of those children, a pretermitted child is not entitled to
41 any share of the trust estate.

42 (3) If a settlor has one or more children living when the settlor executes a trust instrument and
43 provision is made in the trust for any of those children, a pretermitted child is entitled to share in
44 the trust estate as follows:

45 (a) The pretermitted child may share only in the portion of the trust estate intended to benefit

1 living children.

2 (b) The share of each pretermitted child is equal to the total value of the portion of the trust
3 estate intended to benefit the living children divided by the number of pretermitted children plus the
4 number of living children for whom provision, other than nominal provision, is made in the trust.

5 (c) To the extent possible, the interest of each pretermitted child in the trust estate shall be of
6 the same character, whether equitable or legal, as the interest the settlor gave to the living children
7 under the trust.

8 (4) If a settlor has no child living when the settlor executes a trust instrument, [*a pretermitted*
9 *child is entitled to a*] **the pretermitted children are entitled to the following** share of the trust
10 estate [*as though the settlor had died intestate and had not executed the trust instrument*]:

11 **(a) If the settlor dies leaving a surviving spouse and all pretermitted children are the**
12 **issue of the surviving spouse, the pretermitted children are not entitled to any share of the**
13 **trust estate.**

14 **(b) If the settlor dies leaving a surviving spouse and not all pretermitted children are the**
15 **issue of the surviving spouse, the pretermitted children, as a class, are entitled to one-half**
16 **of the trust estate, with shares of the trust to be divided equally.**

17 **(c) If the settlor dies without leaving a surviving spouse, the pretermitted children are**
18 **entitled to the entire trust estate, with shares of the trust to be divided equally.**

19 (5) A pretermitted child may recover the share of the trust estate to which the child is entitled
20 as follows:

21 (a) If the pretermitted child is entitled to a share of the trust estate under subsection (3) of this
22 section, the share must be recovered from the other children.

23 (b) If the pretermitted child is entitled to a share of the trust estate under subsection (4) of this
24 section, the share must be recovered from the beneficiaries on a pro rata basis, out of the portions
25 of the trust estate passing to those persons under the trust.

26 (c) In reducing the shares of the beneficiaries under this subsection, the character of the dis-
27 positive plan adopted by the settlor in the trust must be preserved to the extent possible.

 2 **accept the delegation of the performance of the function. The delegation and the acceptance**

 33 *designated to receive distributions under the terms of the trust, all noncharitable*] **all** qualified benefi-
 34 ciaries and the Attorney General; or

36 (5) Whether or not a vacancy in a trusteeship exists or is required to be filled, the court may
 37 appoint an additional trustee or special fiduciary whenever the court considers the appointment
 38 necessary for the administration of the trust.

40 130.625. (1) The settlor, a cotrustee or a beneficiary may request that a court remove a trustee,
 41 or a trustee may be removed by a court on its own motion.

10 moving a trustee, the court may order such appropriate relief under ORS 130.800 (2) as may be
11 necessary to protect the trust property or the interests of the beneficiaries.

13 130.630. (1) Unless a cotrustee remains in office or the court otherwise orders, a trustee who

6 130.855, a sale, encumbrance or other transaction involving the investment or management of trust
7 property entered into by the trustee for the trustee's own personal account or that is otherwise af-
8 fected by a conflict between the trustee's fiduciary and personal interests is voidable by a benefi-
9 ciary affected by the transaction unless:

10 (a) The transaction was authorized by the terms of the trust;

11 (b) The transaction was approved by a court;

22 (b) The trustee's descendants, siblings or parents, or their spouses;

23 (c) An agent or attorney of the trustee; or

24 (d) A corporation or other person or enterprise in which the trustee, or a person that owns a
25 significant interest in the trustee, has an interest that might affect the trustee's best judgment.

26 (4) Unless a trustee can establish that the transaction was fair to the beneficiary, a transaction
27 between a trustee and a beneficiary that does not concern trust property but from which the trustee
28 obtains an advantage is voidable by the beneficiary if the transaction occurs during the existence

29 for information related to the administration of the trust from a beneficiary who is not a qualified

 11 wise required to be furnished under this section. A qualified beneficiary may withdraw a waiver at

15 (6) A beneficiary's request for any information under this section must be with respect to a

7 by or affiliated with the trustee. A trustee is entitled to be reimbursed out of the trust property or
8 from property that has been distributed from the trust, with reasonable interest, for an advance of
9 money under this subsection.

10 (6) Continue operation of any proprietorship, partnership, limited liability company, business
11 trust, corporation or other form of business or enterprise in which the trust has an interest, and
12 take any action that may be taken by shareholders, members or property owners, including merging,
13 dissolving or otherwise changing the form of business organization or contributing additional capi-
14 tal.

15 (7) Exercise the rights of an absolute owner of stocks and other securities, including the right
16 to:

17 (a) Vote, or give proxies to vote, with or without power of substitution, or enter into or continue
18 a voting trust agreement;

19 (b) Hold a security in the name of a nominee or in other form without disclosure of the trust
20 so that title may pass by delivery;

21 (c) Pay calls, assessments and other sums chargeable or accruing against the securities, and sell
22 or exercise stock subscription or conversion rights; and

23 (d) Deposit the securities with a depository or other financial institution.

24 (8) Construct, repair, alter or otherwise improve buildings or other structures on real property
25 in which the trust has an interest, demolish improvements, raze existing or erect new party walls
26 or buildings on real property in which the trust has an interest, subdivide or develop land, dedicate
27 land to public use or grant public or private easements, and make or vacate plats and adjust
28 boundaries.

29 (9) Enter into a lease for any purpose as lessor or lessee, including a lease or other arrangement
30 for exploration and removal of natural resources, with or without the option to purchase or renew,
31 even though the period of the lease extends beyond the duration of the trust.

32 (10) Grant an option involving a sale, lease or other disposition of trust property or acquire an
33 option for the acquisition of property, even though the option is exercisable after the trust is ter-
34 minated, and exercise an option so acquired.

35 (11) Insure the property of the trust against damage or loss and insure the trustee, the trustee's
36 agents, and beneficiaries against liability arising from the administration of the trust.

37 (12) Abandon or decline to administer property of no value or property of a value that is not
38 adequate to justify its collection or continued administration.

39 (13) Avoid possible liability for violation of environmental law by:

40 (a) Inspecting or investigating property the trustee holds or has been asked to hold, or property
41 owned or operated by an organization in which the trustee holds or has been asked to hold an in-
42 terest, for the purpose of determining the application of environmental law with respect to the
43 property;

44 (b) Taking action to prevent, abate or otherwise remedy any actual or potential violation of any
45 environmental law affecting property held directly or indirectly by the trustee, whether taken before

1 or after the assertion of a claim or the initiation of governmental enforcement;

2 (c) Declining to accept property into trust or disclaiming any power with respect to property
3 that is or may be burdened with liability for violation of environmental law;

4 (d) Compromising claims against the trust that may be asserted for an alleged violation of en-
5 vironmental law; and

6 (e) Paying the expense of any inspection, review, abatement or remedial action to comply with
7 environmental law.

8 (14) Pay or contest any claim, settle a claim by or against the trust, and release, in whole or
9 in part, a claim belonging to the trust.

10 (15) Pay taxes, assessments, compensation of the trustee and of employees and agents of the
11 trust, and other expenses incurred in the administration of the trust.

12 (16) Exercise elections available under federal, state and local tax laws.

13 (17) Select a mode of payment under any employee benefit or retirement plan, annuity or life
14 insurance payable to the trustee, exercise rights under employee benefit or retirement plans, annu-
15 ities or policies of life insurance, including exercise of the right to indemnification for expenses and
16 against liabilities, and take appropriate action to collect the proceeds.

17 (18) Make loans out of trust property. The trustee may make a loan to a beneficiary on terms
18 and conditions the trustee considers to be fair and reasonable under the circumstances. The trustee
19 may collect loans made to a beneficiary by making deductions from future distributions to the ben-
20 eficiary.

21 (19) Pledge trust property to guarantee loans made by others to the beneficiary.

22 (20) Appoint a trustee to act in another state, country or other jurisdiction with respect to trust
23 property located in the other state, country or other jurisdiction, confer upon the appointed trustee
24 all of the powers and duties of the appointing trustee, require that the appointed trustee furnish
25 security and remove any trustee so appointed.

26 (21) Make a distribution to a beneficiary who is under a legal disability or who the trustee
27 reasonably believes is financially incapable, either:

28 (a) Directly;

29 (b) By application of the distribution for the beneficiary's benefit;

30 (c) By paying the distribution to the beneficiary's conservator or, if the beneficiary does not
31 have a conservator, the beneficiary's guardian;

32 (d) By creating a custodianship under the Uniform Transfers to Minors Act by paying the dis-
33 tribution to a custodian for the beneficiary;

34 (e) By paying the distribution to any existing custodian under the Uniform Transfers to Minors
35 Act;

36 (f) By paying the distribution to an adult relative or other person having legal or physical care
37 or custody of the beneficiary, to be expended on the beneficiary's behalf, if the trustee does not
38 know of a conservator, guardian or custodian for the beneficiary; or

39 (g) By managing the distribution as a separate fund held by the trustee on behalf of the benefi-
40 ciary, subject to the beneficiary's continuing right to withdraw the distribution.

41 (22) On distribution **or payment** of trust property or the division or termination of a trust, make
42 distributions **and payments in cash or in kind, or** in divided or undivided interests, allocate par-
43 ticular assets in proportionate or disproportionate shares, value the trust property for those pur-
44 poses and adjust for resulting differences in valuation.

45 (23) Resolve a dispute concerning the interpretation of the trust or the administration of the

1 trust by mediation, arbitration or other procedure for alternative dispute resolution.

2 (24) Prosecute or defend an action, claim or judicial proceeding in any state, country or other
3 jurisdiction to protect trust property and the trustee in the performance of the trustee's duties.

4 (25) Sign and deliver contracts and other instruments that are useful to achieve or facilitate the
5 exercise of the trustee's powers.

6 (26) On termination of the trust, exercise the powers appropriate to wind up the administration
7 of the trust and distribute the trust property to the persons entitled to the property.

8 (27) Allocate items of income or expense to either trust income or principal, as provided by law,
9 including creation of reserves out of income for depreciation, obsolescence or amortization, or for
10 depletion in mineral or timber properties.

11 (28) Employ persons, including attorneys, auditors, investment advisors or agents, to advise or
12 assist the trustee in the performance of administrative duties. A trustee may act based on the rec-
13 ommendations of professionals without independently investigating the recommendations.

14 (29) Apply for and qualify all or part of the property in the trust estate for special governmental
15 tax programs or other programs that may benefit the trust estate or any of the beneficiaries.

16 (30) Deposit securities in a clearing corporation as provided in ORS 128.100.

17 **SECTION 21.** ORS 130.730 is amended to read:

18 130.730. *[(1) Upon termination or partial termination of a trust, the trustee may send to the bene-*
19 *ficiaries a proposal for distribution. The right of any beneficiary to object to a distribution made pur-*
20 *suant to the proposal terminates if the beneficiary does not notify the trustee of an objection within 30*
21 *days after the proposal was sent, but only if the proposal informed the beneficiary of the right to object*
22 *and the time allowed for objection.]*

23 *[(2) Upon the occurrence of an event terminating or partially terminating a trust, the trustee shall*
24 *proceed expeditiously to distribute the trust property to the persons entitled to the property. The trustee*
25 *may retain a reasonable reserve for the payment of debts, expenses and taxes.]*

26 *[(3) A release by a beneficiary of a trustee from liability for breach of trust is invalid to the*
27 *extent:]*

28 *[(a) The release was induced by improper conduct of the trustee; or]*

29 *[(b) The beneficiary, at the time of the release, did not know of the beneficiary's rights or of the*
30 *material facts relating to the breach.]*

31 **(1) Upon the occurrence of an event, satisfaction of a condition or exercise of a power**
32 **that terminates or partially terminates a trust or creates an obligation for the trustee to**
33 **pay or distribute all or any portion of a trust to a beneficiary, the beneficiary's interest in**
34 **the terminated trust, portion or distribution indefeasibly vests in the beneficiary as of the**
35 **event, satisfaction or exercise, subject to ORS 114.600 to 114.725, rights of creditors and the**
36 **administration and sale of trust property by the trustee. The trustee shall proceed expe-**
37 **ditiously to distribute the trust property to the persons entitled to the property. The trustee**
38 **may retain a reasonable reserve for the payment of debts, fees, expenses and taxes.**

39 **(2) Incidental to a termination or partial termination of a trust, the trustee may request**
40 **that a beneficiary execute a release of the trustee from liability for breach of trust. A release**
41 **under this subsection is invalid to the extent:**

42 **(a) The release was induced by improper conduct of the trustee; or**

43 **(b) The trustee failed to adequately disclose to the beneficiary, at the time of the release,**
44 **the material facts relating to the breach or sufficient information to enable the beneficiary**
45 **to know of a potential claim or to inquire into the existence of a breach or potential claim.**

1 **SECTION 22.** ORS 130.735 is amended to read:

2 130.735. (1) A trust instrument may appoint a person to act as an adviser for the purpose of di-
 3 recting or approving decisions made by the trustee, including decisions related to distribution of
 4 trust assets and to the purchase, sale or exchange of trust investments. The appointment must be
 5 made by a provision of the trust that specifically refers to this section. **The appointment may**
 6 **provide for succession of advisers and for a process for the removal of advisers.** An adviser
 7 shall exercise all authority granted under the trust instrument as a fiduciary unless the trust in-
 8 strument provides otherwise. A person who agrees to act as an adviser is subject to Oregon law and
 9 submits to the jurisdiction of the courts of this state.

10 (2) If a trust instrument provides that a trustee is to follow the direction of an adviser, and that
 11 trustee acts in accordance with the adviser's directions, the trustee is not liable for any loss re-
 12 sulting directly or indirectly from the trustee's decision unless the decision constitutes reckless in-
 13 difference to the purposes of the trust or the interests of the beneficiaries.

14 (3) If a trust instrument provides that a trustee is to make decisions with the approval of an
 15 adviser, and the adviser does not provide approval within a reasonable time after the trustee has
 16 made a request for approval of a decision, the trustee is not liable for any loss resulting directly
 17 or indirectly from the decision unless the decision constitutes reckless indifference to the purposes
 18 of the trust or the interests of the beneficiaries.

19 (4) Except to the extent specifically provided by the trust instrument, a trustee has no duty to
 20 monitor an adviser's conduct, provide advice to the adviser, consult with the adviser or give notice
 21 to any beneficiary or third party about decisions made pursuant to the adviser's direction that the
 22 trustee would have decided differently.

23 (5) Absent clear and convincing evidence to the contrary, all actions taken by a trustee for the
 24 purpose of implementing directions from an adviser, including confirming that the adviser's di-
 25 rections have been carried out and recording and reporting activities requested by the adviser, are
 26 presumed to be administrative actions taken by the trustee solely for the purpose of allowing the
 27 trustee to perform the duties assigned to the trustee under the trust instrument. Administrative
 28 actions taken by a trustee for the purpose of implementing directions from an adviser do not con-
 29 stitute monitoring of the adviser or other participation in decisions that are within the scope of the
 30 adviser's authority.

31 **(6) A court may remove an adviser if the court finds:**

32 **(a) The adviser has committed a serious breach of trust; or**

33 **(b) Removal of the adviser best serves the interests of the beneficiaries because the ad-**
 34 **viser is unfit or unwilling, or has persistently failed to timely and effectively advise the**
 35 **trustee in matters assigned to the adviser in the trust instrument under subsection (1) of**
 36 **this section.**

37 **SECTION 23.** Sections 24 and 25 of this 2013 Act are added to and made a part of ORS
 38 chapter 130.

39 **SECTION 24.** If the occurrence of an event, satisfaction of a condition or exercise of a
 40 power allows or creates an obligation for the trustee to divide a trust or any portion of a
 41 trust into separate shares or portions for the benefit of separate beneficiaries:

42 (1) Each share resulting from the division of the trust will be deemed to be a new trust
 43 for the sole benefit of its beneficiaries;

44 (2) All of the terms of the trust instrument will be applied independently to each new
 45 trust created pursuant to this section except as terms are specifically limited in the trust

1 instrument; and

2 (3) The trust or portion of the trust from which the new trust originates will be deemed
 3 to terminate to the extent of the new trust, subject only to the proper administration of the
 4 terminated trust occasioned by the terminating event, condition or exercise.

5 **SECTION 25.** (1) Prior to a proposed action to be taken by a trustee regarding the ad-
 6 ministration of a trust, the trustee may send the beneficiaries a written notice of the pro-
 7 posed action informing the beneficiaries of the proposed action.

8 (2) The right of a beneficiary receiving a notice of proposed action under subsection (1)
 9 of this section to object to a proposed action described in the notice is barred if the benefi-
 10 ciary does not notify the trustee in writing of an objection within 45 days after the notice
 11 was sent, or within such longer time as may be stated in the notice, but only to the extent
 12 that the notice of proposed action:

13 (a) Clearly informs the beneficiary of the right to object, the manner in which to object
 14 and the date by which the objection must be received by the trustee;

15 (b) States that the beneficiary’s right to object may be barred if the beneficiary does not
 16 object within the time and in the manner allowed for objection; and

17 (c) Adequately provides sufficient information regarding the proposed action to enable
 18 the beneficiary to make an informed decision.

19 (3) If a beneficiary receiving notice does not object as provided in this section, the bene-
 20 fiary will be deemed to have consented to the proposed action and the beneficiary may not
 21 thereafter file an action or other civil proceeding based in tort, contract or otherwise if the
 22 proposed action is taken by the trustee within a reasonable time after the notice was given
 23 under this section. This subsection does not apply to the following:

24 (a) Allowance of the trustee’s compensation;

25 (b) Settlement of trust accounts or the trustee’s report;

26 (c) Sale of trust property to the trustee or sale of the trustee’s property to the trust;

27 (d) Exchange of trust property for property of the trustee;

28 (e) Grant of an option to the trustee to purchase trust property;

29 (f) Allowance, payment or settlement of a trustee’s claim against the trust;

30 (g) Compromise or settlement of a claim, action or proceeding by the trust against the
 31 trustee; or

32 (h) Extension, renewal or modification of the terms of a debt or other obligation of the
 33 trustee owing to or in favor of the trust.

34 (4) The receipt of an objection by the trustee does not prohibit the trustee from taking
 35 the proposed action or sending subsequent notices of proposed actions to the beneficiaries
 36 regarding the same or similar proposed actions.

37 **SECTION 26.** Sections 24 and 25 of this 2013 Act and the amendments to ORS 130.010,
 38 130.045, 130.170, 130.195, 130.200, 130.215, 130.305, 130.310, 130.315, 130.525, 130.555, 130.610,
 39 130.615, 130.625, 130.630, 130.635, 130.650, 130.655, 130.710, 130.725, 130.730 and 130.735 by
 40 sections 1 to 22 of this 2013 Act apply to trust proceedings commenced on or after the ef-
 41 fective date of this 2013 Act.

42 **SECTION 27.** This 2013 Act being necessary for the immediate preservation of the public
 43 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect
 44 on its passage.
