On page 1 of the printed B-engrossed bill, line 2, delete "and". 1 2 In line 3, after "167.348" insert "; and declaring an emergency". On page 2, line 28, delete "7" and insert "6". 3 In line 38, restore the bracketed material and delete the boldfaced material. 4 5 Delete lines 39 through 45 and insert: "(3) Notwithstanding subsection (2) of this section, animal neglect in the second degree is a 6 Class C felony if: 7 "(a) The person committing the offense has previously been convicted of two or more offenses 8 9 under this section, ORS 167.330 or the equivalent laws of another jurisdiction; 10 (b) The offense was part of a criminal episode involving 11 or more animals; or 11 "(c) The person knowingly commits the offense in the immediate presence of a minor child and 12 the person has one or more previous convictions for an offense involving domestic violence as defined in ORS 135.230. For purposes of this paragraph, a minor child is in the immediate presence 13 14 of animal neglect if the neglect is seen or directly perceived in any other manner by the minor child. 15"(4) The Oregon Criminal Justice Commission shall classify animal neglect in the second degree 16 under subsection (3) of this section: 17 "(a) As crime category 6 if 11 to 40 animals were the subject of the neglect. 18 (b) As crime category 7 if more than 40 animals were the subject of the neglect or if the offense 19 is a felony because of circumstances described in subsection (3)(a) or (c) of this section.". 20 On page 3, delete lines 1 through 6. 21In line 12, restore the bracketed material and delete the boldfaced material. In line 14, delete "B" and insert "C". 2223 Delete lines 21 through 24 and insert: 24 "(4) The Oregon Criminal Justice Commission shall classify animal neglect in the first degree 25under subsection (3) of this section: 26 "(a) As crime category 6 if 10 to 40 animals were the subject of the neglect. 27(b) As crime category 7 if more than 40 animals were the subject of the neglect or if the offense 28is a felony because of circumstances described in subsection (3)(a) or (c) of this section.". 29 In line 26, delete "subsection (3)" and insert "subsections (3) and (4)". 30 After line 41, insert: 31 "(3) The animal possession prohibition described in subsection (1) of this section does not apply 32to a person's first conviction if the person is the owner of a commercial livestock operation and the underlying violation of ORS 167.315, 167.320, 167.322, 167.325, 167.330, 167.333, 167.340, 167.355, 33 34 167.365 or 167.428 was committed against livestock.". In line 42, delete "(3)(a)" and insert "(4)(a)". 35

1 On page 7, delete lines 39 and 40 and insert:

"(b) The entity shall pay a reasonable fee, as determined by the enforcing agency, for a license
or an annual renewal of the license to provide for the actual cost of enforcing this section and
section 11 of this 2013 Act.".

5 On page 9, after line 5, insert:

6 "<u>SECTION 12.</u> This 2013 Act being necessary for the immediate preservation of the public
7 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect
8 on its passage.".
