- 4 **“SECTION 1. As used in this section and ORS 419A.253, 419A.255 and 419A.256:**
- 5 **“(1) ‘Person’ means an individual, a public body as defined in ORS 174.109 or a tribe that**
- 6 **has intervened in a juvenile court proceeding pursuant to the Indian Child Welfare Act (25**
- 7 **U.S.C. 1901 et seq.).**
- 8 **“(2) ‘Prospective appellate attorney’ means an attorney designated by the office of public**
- 9 **defense services established under ORS 151.216 to potentially represent a child, ward, youth,**
- 10 **youth offender, or a parent or guardian of a child, ward, youth or youth offender, in a juve-**
- 11 **nile case when the case has been referred to the office of public defense services for appeal.**
- 12 **“(3) ‘Record of the case’ or ‘record of each case’:**
- 13 **“(a) Includes but is not limited to:**
- 14 **“(A) The summons and other process;**
- 15 **“(B) Petitions;**
- 16 **“(C) Papers in the nature of pleadings, answers, motions, affidavits and other papers that**
- 17 **are filed with the court, including supporting documentation;**
- 18 **“(D) Local citizen review board findings and recommendations submitted under ORS**
- 19 **419A.118 or 419B.367;**
- 20 **“(E) Guardianship report summaries filed with the court under ORS 419B.367;**
- 21 **“(F) Orders and judgments of the court, including supporting documentation;**
- 22 **“(G) Transcripts under ORS 419A.256;**
- 23 **“(H) Exhibits and materials offered as exhibits whether or not received in evidence; and**
- 24 **“(I) Other documents that become part of the record of the case by operation of law.**
- 25 **“(b) May include electronic records.**
- 26 **“(4) ‘Supplemental confidential file’:**
- 27 **“(a) Includes reports and other material relating to the child, ward, youth or youth**
- 28 **offender’s history and prognosis, including but not limited to reports filed under ORS**
- 29 **419B.440, that:**
- 30 **“(A) Are not or do not become part of the record of the case; and**
- 31 **“(B) Are not offered or received as evidence in the case.**
- 32 **“(b) May include electronic records.**
- 33 **“SECTION 2. ORS 419A.253 is amended to read:**
- 34 **“419A.253. (1) When, for the purpose of a hearing or proceeding that will result in the entry of**
- 35 **an order or judgment, the juvenile court [*considers*] intends to rely upon information in [a] any**

1 report, [or other material described in ORS 419A.255 (2)] **material or document, including information in the supplemental confidential file**, and no party has offered the report, [or] material
2 **or document** as an exhibit or asked the court to take judicial notice of **a fact or law in** the in-
3 formation pursuant to ORS 40.060 to 40.085 and 40.090, the court shall:

5 “(a) Identify on the record the report, [or] material **or document**, or [the part of] **information**
6 **in** the report, [or] material **or document**, [that the court has considered.] **upon which the court**
7 **intends to rely; and**

8 “(b) Subject to the court’s ruling on objections by the parties, [the court shall] either:

9 “(A) Take judicial notice of **a fact or law in** the information pursuant to ORS 40.060 to 40.085
10 **and 40.090; or**

11 “(B) Cause the report, [or] material **or document**, or [the] **a** part of the report, [or] material
12 **or document**, to be marked and received as an exhibit.

13 “(2) **If the court takes judicial notice of a fact or law under subsection (1) of this section**,
14 the court shall cause a list to be made that reasonably identifies, by reference to [its] **the** source,
15 [information] **any fact or law that is** judicially noticed [under this subsection]. The [list] **court** may
16 [be included] **include the list** in the order or judgment or [may be] set out **the contents of the list**
17 in a separate document attached to the order or judgment.

18 “(3) **An exhibit marked and received under subsection (1) of this section and a list made**
19 **under subsection (2) of this section are part of the record of the case maintained by the clerk**
20 **of the court under ORS 419A.255 (1).**

21 “(4) If an appeal is taken from the order or judgment following the hearing or proceeding and
22 the designation of record on appeal includes exhibits, the court or the trial court administrator shall
23 cause the [exhibits and any report or other materials containing judicially noticed information] **fol-**
24 **lowing** to be transmitted to the appellate court as part of the record **of the case** on appeal[.]:

25 “(a) **Exhibits;**

26 “[2] (b) The list described in subsection [(1)] (2) of this section [is part of the record of the case
27 maintained by the clerk of the court under ORS 419A.255 (1)]; **and**

28 “(c) **Any report, material or document containing judicially noticed facts or law as iden-**
29 **tified on the list made under subsection (2) of this section.**

30 “[3] *Nothing in ORS 419A.255 limits access to any juvenile court records by an appellate court*
31 *reviewing a juvenile court order or judgment. Appellate court rules may establish procedures for ap-*
32 *pellate court access to juvenile court records.]*

33 “**SECTION 3.** ORS 419A.255 is amended to read:

34 “419A.255. (1)(a) The clerk of the court shall keep a record of each case[, *including therein the*
35 *summons and other process, the petition and all other papers in the nature of pleadings, motions, or-*
36 *ders of the court and other papers filed with the court, but excluding reports and other material relat-*
37 *ing to the child, ward, youth or youth offender’s history and prognosis]* **and a supplemental**
38 **confidential file for each case.**

39 “(b) The record of the case shall be withheld from public inspection but is open to inspection
40 by the **following:**

41 “(A) **The judge of the juvenile court and those acting under the judge’s direction;**

42 “(B) **The child[,];**

43 “(C) **The ward[,];**

44 “(D) **The youth[,];**

45 “(E) **The youth offender[, parent, guardian, court appointed special advocate,];**

1 **“(F) The parent or guardian of the child, ward, youth or youth offender;**
2 **“(G) The guardian ad litem for the parent;**
3 **“(H) The surrogate [or];**
4 **“(I) A person allowed to intervene in a proceeding involving the child, ward, youth or youth**
5 **offender[, and their attorneys.];**
6 **“(J) Service providers in the case;**
7 **“(K) The court appointed special advocate and a representative of a CASA Volunteer**
8 **Program as defined in section 3, chapter 97, Oregon Laws 2012;**
9 **“(L) The attorneys or prospective appellate attorneys for any of the persons listed in**
10 **subparagraphs (B) to (K) of this paragraph;**
11 **“(M) The district attorney or assistant attorney general representing a party in the case;**
12 **“(N) The juvenile department;**
13 **“(O) The Department of Human Services;**
14 **“(P) The Oregon Youth Authority; and**
15 **“(Q) Any other person allowed by the court.**
16 **“(c) The [attorneys] following are entitled to copies of the record of the case:**
17 **“(A) The judge of the juvenile court and those acting under the judge’s direction;**
18 **“(B) A party to the extent permitted under ORS 419B.875 (2) or 419C.285 (2);**
19 **“(C) A guardian ad litem for a parent to the same extent the parent is permitted to**
20 **copies under ORS 419B.875 (2) or 419C.285 (2);**
21 **“(D) Persons listed in paragraph (b)(J) to (P) of this subsection; and**
22 **“(E) Any other person allowed by the court.**
23 **“(2)(a) Reports and other material relating to the child, ward, youth or youth offender’s history**
24 **and prognosis in the supplemental confidential file or record of the case are privileged and,**
25 **except at the request of the child, ward, youth or youth offender, [may not be disclosed directly or**
26 **indirectly to anyone other than] shall be withheld from public inspection. Once offered as an**
27 **exhibit, reports and other material relating to the child, ward, youth or youth offender’s**
28 **history and prognosis become part of the record of the case but are subject to paragraph (e)**
29 **of this subsection.**
30 **“(b) A supplemental confidential file is open to inspection by the following:**
31 **“(A) The judge of the juvenile court[,] and those acting under the judge’s direction[.];**
32 **“(B) The parent or guardian of the child or ward in a dependency case;**
33 **“(C) The guardian ad litem for the parent of a child or ward in a dependency case;**
34 **“(D) The parent or guardian of the youth or youth offender in a delinquency case if the**
35 **youth or youth offender consents to, or the court authorizes, inspection;**
36 **“(E) The guardian ad litem for the parent of a youth or youth offender in a delinquency**
37 **case if the youth or youth offender consents to, or the court authorizes, inspection;**
38 **“(F) Service providers in the case; [and]**
39 **“(G) The attorneys [of record] or prospective appellate attorneys for:**
40 **“(i) The child[.];**
41 **“(ii) The ward[.];**
42 **“(iii) The youth; [or]**
43 **“(iv) The youth offender; [or the child, ward, youth or youth offender’s parent, guardian, court**
44 **appointed special advocate,]**
45 **“(v) The parent or guardian of the child, ward, youth or youth offender; or**

1 “(vi) **The guardian ad litem for the parent;**
2 “(H) **The surrogate; [or]**
3 “(I) **A person allowed to intervene in a proceeding involving the child, ward, youth or youth**
4 **offender;**
5 “(J) **The court appointed special advocate and a representative of a CASA Volunteer**
6 **Program as defined in section 3, chapter 97, Oregon Laws 2012;**
7 “(K) **The district attorney or assistant attorney general representing a party in the case;**
8 “(L) **The juvenile department;**
9 “(M) **The Department of Human Services;**
10 “(N) **The Oregon Youth Authority; and**
11 “(O) **Any other person allowed by the court.**

12 “(c) [*Reports and other material relating to a youth offender’s history and prognosis*] **The sup-**
13 **plemental confidential file** in cases under ORS 419C.005 may be disclosed to the superintendent
14 of the school district in which the youth offender resides or the superintendent’s designee.

15 “(d) **The following** [*service providers in the case, school superintendents, superintendents’*
16 *designees and attorneys*] are entitled to [*examine and obtain*] copies of [*any reports or other material*
17 *relating to the child, ward, youth or youth offender’s history and prognosis.*] **material maintained in**
18 **the supplemental confidential file:**

19 “(A) **The judge of the juvenile court and those acting under the judge’s direction;**
20 “(B) **Service providers in the case;**
21 “(C) **School superintendents and their designees in cases under ORS 419C.005;**
22 “(D) **Attorneys designated under subsection (1)(b)(L) of this section;**
23 “(E) **The district attorney or assistant attorney general representing a party in the case;**
24 “(F) **The juvenile department;**
25 “(G) **The Department of Human Services;**
26 “(H) **The Oregon Youth Authority;**
27 “(I) **The court appointed special advocate and a representative of a CASA Volunteer**
28 **Program as defined in section 3, chapter 97, Oregon Laws 2012; and**
29 “(J) **Any other person allowed by the court.**

30 “(e) [*Any service provider in the case, school superintendent, superintendent’s designee or attorney*
31 *who examines or*] **A person that** obtains copies of [*such reports or materials is*] **material in the**
32 **supplemental confidential file pursuant to paragraph (d) of this subsection is** responsible for
33 preserving [*their*] **the confidentiality of the material in the supplemental confidential file.** A
34 service provider, school superintendent or superintendent’s designee who obtains copies of such
35 [*reports or materials shall return the copies to the court*] **material shall destroy the copies** upon the
36 conclusion of [*the service provider’s, superintendent’s or superintendent’s designee’s*] involvement in
37 the case.

38 “(3) Except as otherwise provided in subsection [(7)] (5) of this section, no information appearing
39 in the record of the case or in [*reports or other material relating to the child, ward, youth or youth*
40 *offender’s history or prognosis*] **the supplemental confidential file** may be disclosed to any person
41 not described in subsection (2) of this section without the consent of the court, except for purposes
42 of evaluating the child, ward, youth or youth offender’s eligibility for special education as provided
43 in ORS chapter 343, and no such information may be used in evidence in any proceeding to establish
44 criminal or civil liability against the child, ward, youth or youth offender, whether such proceeding
45 occurs after the child, ward, youth or youth offender has reached 18 years of age or otherwise, ex-

cept for the following purposes:

“(a) In connection with a presentence investigation after guilt has been admitted or established in a criminal court.

“(b) In connection with a proceeding in another juvenile court concerning the child, ward, youth or youth offender or an appeal from the juvenile court.

“(4) If the court finds that the child, ward, youth, youth offender or parent is without financial means to purchase all or a necessary part of the transcript of the evidence or proceedings, the court shall order upon motion the transcript or part thereof to be furnished. The transcript or part thereof furnished under this subsection shall be paid for in the same manner as furnished transcripts are paid for in criminal cases.]

“(4)(a) When a person described in subsection (1)(b)(M), (N), (O) or (P) of this section inspects or obtains copies of reports, materials or documents under this subsection or under subsection (1) or (2) of this section, the person may not use or disclose the reports, materials or documents, except:

“(A) As provided in this subsection or under subsection (1) or (2) of this section;

“(B) In the juvenile court proceeding for which the reports, materials or documents were sought or disclosed;

“(C) With the consent of the court; or

“(D) As provided in ORS 419A.253.

“(b) Nothing in this section prohibits the district attorney or assistant attorney general representing a party in a juvenile court proceeding, the juvenile department, the Department of Human Services, the Oregon Youth Authority or other parties in the proceeding or their attorneys from disclosing to each other reports, materials or documents described in subsections (1) and (2) of this section if the disclosure is reasonably necessary to perform official duties related to the involvement of the child, ward, youth or youth offender with the juvenile court or the juvenile department. A person to whom reports, materials or documents are disclosed under this subsection is subject to subsection (3) of this section.

“(5)(a) Information contained in the supplemental confidential file that, in the professional judgment of the juvenile counselor, caseworker, school superintendent or superintendent’s designee, teacher or detention worker to whom the information in the supplemental confidential file has been provided, indicates a clear and immediate danger to another person or to society shall be disclosed to the appropriate authority and the person who is in danger from the child, ward, youth or youth offender.

“(b) A person that discloses information under paragraph (a) of this subsection has immunity from any liability, civil or criminal, that might otherwise be incurred or imposed for making the disclosure.

“(c) Nothing in this subsection affects the provisions of ORS 146.750, 146.760, 419B.035, 419B.040 and 419B.045. The disclosure of information under this subsection does not make the information admissible in any court or administrative proceeding if it is not otherwise admissible.

“(5) (6) Notwithstanding any other provision of law, and subject to subsection (8) of this section, the following are not confidential and not exempt from disclosure:

“(a) The name and date of birth of the youth or youth offender;

“(b) The basis for the juvenile court’s jurisdiction over the youth or youth offender;

“(c) The date, time and place of any juvenile court proceeding in which the youth or youth

1 offender is involved;

2 “(d) The act alleged in the petition that if committed by an adult would constitute a crime if
3 jurisdiction is based on ORS 419C.005;

4 “(e) That portion of the juvenile court order providing for the legal disposition of the youth or
5 youth offender when jurisdiction is based on ORS 419C.005;

6 “(f) The names and addresses of the youth or youth offender’s parents or guardians; and

7 “(g) The register described in ORS 7.020 when jurisdiction is based on ORS 419C.005.

8 “[6] (7) Notwithstanding any other provision of law, **and subject to subsection (8) of this**
9 **section**, when a youth has been taken into custody under ORS 419C.080, the following information
10 shall be disclosed unless, and only for so long as, there is a clear need to delay disclosure in the
11 course of a specific investigation, including the need to protect the complaining party or the victim:

12 “(a) The youth’s name and age and whether the youth is employed or in school;

13 “(b) The youth offense for which the youth was taken into custody;

14 “(c) The name and age of the adult complaining party and the adult victim, unless the disclosure
15 of such information is otherwise prohibited or restricted;

16 “(d) The identity of the investigating and arresting agency; and

17 “(e) The time and place that the youth was taken into custody and whether there was resist-
18 ance, pursuit or a weapon used in taking the youth into custody.

19 “[7](a) *Information contained in reports and other materials relating to a child, ward, youth or*
20 *youth offender’s history and prognosis that, in the professional judgment of the juvenile counselor,*
21 *caseworker, school superintendent or superintendent’s designee, teacher or detention worker to whom*
22 *the information for the reports or other materials has been provided, indicates a clear and immediate*
23 *danger to another person or to society shall be disclosed to the appropriate authority and the person*
24 *or entity who is in danger from the child, ward, youth or youth offender.]*

25 “[b) *An agency or a person who discloses information under paragraph (a) of this subsection has*
26 *immunity from any liability, civil or criminal, that might otherwise be incurred or imposed for making*
27 *the disclosure.]*

28 “[c) *Nothing in this subsection affects the provisions of ORS 146.750, 146.760, 419B.035, 419B.040*
29 *and 419B.045. The disclosure of information under this section does not make the information admis-*
30 *sible in any court or administrative proceeding if it is not otherwise admissible.]*

31 “(8) [A county juvenile department is the agency responsible for disclosing youth and youth
32 offender records if the records are subject to disclosure.] **Except as provided in ORS 419A.300 and**
33 **420.048, only the juvenile court and the county juvenile department may disclose the infor-**
34 **mation under subsections (6) and (7) of this section if the information is subject to disclo-**
35 **sure, unless otherwise directed by the court.**

36 “(9) **Nothing in this section limits access to any juvenile court records by an appellate**
37 **court reviewing a juvenile court order or judgment. Appellate court rules may establish**
38 **procedures for appellate court access to juvenile records.**

39 “[9] (10) A petition filed under ORS 419B.851 alleging that a child who is a foreign national
40 is within the jurisdiction of the court, or a motion requesting an implementation plan other than
41 return of a ward to the ward’s parent, is subject to disclosure to the consulate for the child or
42 ward’s country as provided under ORS 419B.851 (3).

43 “[10] (11) Nothing in this section prohibits a guardian appointed under ORS 419B.365 or
44 419B.366 from disclosing or providing copies of letters of guardianship when so required to fulfill the
45 duties of a guardian.

1 “[(11)] (12) The court shall cooperate in the sharing of information with a court in another state
2 to facilitate an interstate placement of a child or ward.

3 “**SECTION 4.** ORS 419A.256 is amended to read:

4 “419A.256. (1)(a) Once prepared and filed with the court, a transcript of a juvenile court pro-
5 ceeding is part of the record of the case maintained by the clerk of the court under ORS 419A.255
6 (1) and is subject to the provisions of ORS 419A.255 [(1) and (3)] governing access and disclosure.

7 “(b) Notwithstanding ORS 419A.255, if a transcript, audiotape or videotape has been prepared
8 in any proceeding under ORS chapter 419C, the victim may obtain a copy by paying the actual cost
9 of preparation.

10 “(2) **If the court finds that the child, ward, youth, youth offender or parent or guardian**
11 **of the child, ward, youth or youth offender is without financial means to purchase all or a**
12 **necessary part of the transcript of the evidence or proceedings, the court shall order, upon**
13 **motion, the transcript or part of the transcript to be furnished. The transcript or part of the**
14 **transcript furnished under this subsection must be paid for in the same manner as furnished**
15 **transcripts are paid for in criminal cases.**

16 “[2)] (3) The official audio, video or other recording of a juvenile court proceeding shall be
17 withheld from public inspection but is open to inspection by the [*child, ward, youth, youth offender,*
18 *parent, guardian, court appointed special advocate, surrogate or a person allowed to intervene in a*
19 *proceeding involving the child, ward, youth or youth offender, and their attorneys]* **persons described**
20 **in ORS 419A.255 (1)(b)(A) to (P).**

21 “**SECTION 5.** ORS 419A.257 is amended to read:

22 “419A.257. [(1) *The district attorney or assistant attorney general representing the state in a juve-*
23 *venile court proceeding, the juvenile department, the Department of Human Services and the Oregon*
24 *Youth Authority may inspect and obtain from the court copies of the records, reports and other mate-*
25 *rials described in ORS 419A.255 (1) and (2) to the same extent that attorneys for the other parties and*
26 *the other parties are authorized to inspect and obtain copies of the records, reports and other materials.*
27 *An agency or person that inspects or obtains records, reports or materials under this subsection is*
28 *subject to ORS 419A.255 (3).]*

29 “[2) *Nothing in ORS 419A.255 prohibits the district attorney or assistant attorney general repre-*
30 *senting the state in a juvenile court proceeding, the juvenile department, the Department of Human*
31 *Services, the Oregon Youth Authority or the other parties in the proceeding or their attorneys from*
32 *disclosing to each other records, reports and other materials described in ORS 419A.255 (1) and (2) if*
33 *the disclosure is reasonably necessary to perform official duties related to the involvement of the child,*
34 *ward, youth or youth offender with the juvenile court or juvenile department. An agency or person to*
35 *whom records, reports or materials are disclosed under this subsection is subject to ORS 419A.255*
36 *(3).]*

37 “[3) *An agency or person that inspects or obtains records, reports or materials under subsection*
38 *(1) of this section or to whom records, reports or materials are disclosed under subsection (2) of this*
39 *section may not use or disclose the records, reports or materials except:]*

40 “[*(a) As provided in subsections (1) and (2) of this section;*]

41 “[*(b) In the juvenile court proceeding for which the records, reports or materials were sought or*
42 *disclosed;*]

43 “[*(c) With the consent of the court as provided in ORS 419A.255 (2) or (3); or]*

44 “[*(d) As provided in ORS 419A.253.]*

45 “(1) **Reports and other materials relating to a child, ward, youth or youth offender’s**

1 history and prognosis that are created or maintained by or on behalf of the Oregon Youth
2 Authority or the juvenile department are privileged and, except with the consent of the child,
3 ward, youth or youth offender or with the authorization of the court, shall be withheld from
4 public inspection.

5 “(2) The Oregon Youth Authority and the juvenile department may disclose and provide
6 copies of reports and other materials relating to the child, ward, youth or youth offender’s
7 history and prognosis, if the disclosure is reasonably necessary to perform official duties
8 relating to the involvement of the child, ward, youth or youth offender with the juvenile
9 court or the juvenile department, to the following:

10 “(a) Each other;

11 “(b) The court;

12 “(c) Service providers in the case;

13 “(d) School superintendents and their designees in cases under ORS 419C.005;

14 “(e) Attorneys of record for the child, ward, youth or youth offender;

15 “(f) Attorneys representing a party in the case;

16 “(g) The district attorney or assistant attorney general representing a party in the case;

17 “(h) The Department of Human Services;

18 “(i) The court appointed special advocate; and

19 “(j) The Psychiatric Security Review Board.

20 “(3) A person that obtains copies of reports or other materials under this section is re-
21 sponsible for preserving the confidentiality of the reports or other materials. A service pro-
22 vider, school superintendent or superintendent’s designee who obtains copies of reports or
23 other materials under this section shall destroy the copies upon the conclusion of involve-
24 ment in the case.

25 “(4)(a) Information appearing in reports or other materials relating to the child, ward,
26 youth or youth offender’s history or prognosis may not be disclosed directly or indirectly to
27 any person not described in subsection (2) of this section unless the consent of the child,
28 ward, youth or youth offender or the authorization of the court has been obtained, except
29 for purposes of evaluating the child, ward, youth or youth offender’s eligibility for special
30 education as provided in ORS chapter 343.

31 “(b) Information appearing in reports or other materials may not be used in evidence in
32 any proceeding to establish criminal or civil liability against the child, ward, youth or youth
33 offender, whether the proceeding occurs after the child, ward, youth or youth offender has
34 reached 18 years of age or otherwise, except for the following purposes:

35 “(A) In connection with a presentence investigation after guilt has been admitted or es-
36 tablished in a criminal court.

37 “(B) In connection with a proceeding in another juvenile court concerning the child,
38 ward, youth or youth offender or an appeal from an order or judgment of the juvenile court.

39 “(5)(a) Information contained in reports and other materials relating to a child, ward,
40 youth or youth offender’s history and prognosis that, in the professional judgment of the
41 Oregon Youth Authority, juvenile department, juvenile counselor, caseworker, school super-
42 intendent or superintendent’s designee, teacher or detention worker to whom the informa-
43 tion contained in the reports and other materials has been provided, indicates a clear and
44 immediate danger to another person or to society, shall be disclosed to the appropriate au-
45 thority and the person or entity that is in danger from the child, ward, youth or youth

1 offender.

2 **“(b) An agency or a person that discloses information under paragraph (a) of this sub-**
3 **section has immunity from any liability, civil or criminal, that might otherwise be incurred**
4 **or imposed for making the disclosure.**

5 **“(c) Nothing in this subsection affects the provisions of ORS 146.750, 146.760, 419B.035,**
6 **419B.040 and 419B.045.**

7 **“(6) The disclosure of information under this section does not make the information ad-**
8 **missible in any court or administrative proceeding if it is not otherwise admissible.**

9 **“SECTION 6.** ORS 419B.367 is amended to read:

34 **“(2) In the order appointing the guardian, the court shall require the guardian to file with the**
35 **court a verified written report within 30 days after each anniversary of appointment and may:**

36 **“(a) Specify the frequency and nature of visitation or contact between relatives, including sib-**
37 **lings, and the ward, if the court determines that visitation or contact is in the ward’s best interests;**

38 **“(b) Enter an order for child support pursuant to ORS 419B.400 that complies with ORS 25.275;**
39 **and**

40 **“(c) Make any other order to provide for the ward’s continuing safety and well-being.**

41 **“(3) The report required under subsection (2) of this section must:**

42 **“(a) Contain a summary sheet that:**

43 **“(A) Identifies the written report and includes the date of submission and the name of**

45 **“(B) Is maintained as part of the record of the case under ORS 419A.255 (1); and**

1 **“(b) Be maintained in the supplemental confidential file under ORS 419A.255 (2).**

2 “[(3)(a)] **(4)(a)** Upon timely receipt of a report under subsection (2) of this section, the court
3 shall review the report and [*cause the report to become part of the juvenile court file and*] **maintain**
4 **the report as described in subsection (3) of this section. The court may:**

5 “(A) Direct the local citizen review board to conduct a review;

6 “(B) Subject to the availability of funds, appoint a court visitor and require the visitor to file
7 a report with the court; or

8 “(C) Conduct a court review.

9 “(b) If the court does not receive a report under subsection (2) of this section in a timely man-
10 ner, the court shall:

11 “(A) Direct the local citizen review board to conduct a review;

12 “(B) Subject to the availability of funds, appoint a court visitor and require the visitor to file
13 a report with the court; or

14 “(C) Conduct a court review.

15 “[(4)] **(5)** Except as otherwise limited by the court, a person appointed guardian has legal cus-
16 tody of the ward and the duties and authority of legal custodian and guardian under ORS 419B.373

19 **“SECTION 7.** ORS 419A.015 is amended to read:

20 “419A.015. (1)(a) Once each month, a county juvenile department shall provide to school admin-
21 istrators of schools or of school districts in the county a list of all youth offenders enrolled in a
22 school in the county who are on probation by order of the juvenile court in the county. The de-
23 partment shall include in the list the name and business telephone number of the juvenile counselor
24 assigned to each case.

25 “(b) When a youth offender who is on probation transfers from one school or school district to
26 a different school or school district, the juvenile counselor assigned to the case shall notify the
27 school administrator of the school or of the school district to which the youth offender has trans-
28 ferred of the youth offender’s probation status. The juvenile counselor shall make the notification
29 no later than 72 hours after the juvenile counselor knows of the transfer.

30 “(2) Upon request by the school administrator, the juvenile department shall provide additional
31 information, including the offense that brought the youth offender within the jurisdiction of the ju-
32 venile court and such other information that is subject to disclosure under ORS 419A.255 [(5)] **(6)**.

33 “(3) In addition to the general notification required by subsection (1) of this section, the juvenile
34 department shall notify the school administrator of the specific offense if the act bringing the youth
35 offender within the jurisdiction of the juvenile court involved a firearm or delivery of a controlled
36 substance.

37 “(4) When a school administrator receives any notice under this section, the school administra-
38 tor may disclose the information only to school personnel, as defined in ORS 339.326, who the school
39 administrator determines need the information in order to safeguard the safety and security of the
40 school, students and staff. A person to whom personally identifiable information is disclosed under
41 this subsection may not disclose the information to another person except to carry out the pro-
42 visions of this subsection.

43 “(5) Except as otherwise provided in ORS 192.490, a juvenile department, school district or
44 school administrator, or anyone employed or acting on behalf of a juvenile department, school dis-
45 trict or school administrator, who sends or receives records under this section is not civilly or

1 criminally liable for failing to disclose the information under this section.

4 “**SECTION 8.** ORS 419A.200 is amended to read:

5 “419A.200. (1) Except as provided in ORS 419A.190, any person or entity, including, but not
6 limited to, a party to a juvenile court proceeding under ORS 419B.875 (1) or 419C.285 (1), whose
7 rights or duties are adversely affected by a judgment of the juvenile court may appeal therefrom.
8 An appeal from a circuit court must be taken to the Court of Appeals, and an appeal from a county
9 court must be taken to the circuit court.

10 “(2) If the proceeding is in the circuit court and no record of the proceedings was kept, the
11 court, on motion made not later than 15 days after the entry of the court’s judgment, shall grant a
12 rehearing and shall direct that a record of the proceedings be kept. However, the court may not
13 grant a rehearing in a case barred by ORS 419A.190 without the consent of the child, ward, youth
14 or youth offender affected by such case. If a rehearing is held, the time for taking an appeal runs
15 from the date of entry of the court’s judgment after the rehearing.

16 “(3)(a) The appeal may be taken by causing a notice of appeal, in the form prescribed by ORS
17 19.250, to be served:

18 “(A) On all parties who have appeared in the proceeding;

19 “(B) On the trial court administrator or other person serving as clerk of the juvenile court; and

20 “(C) On the juvenile court transcript coordinator, if a transcript is designated in connection
21 with the appeal.

22 “(b) The original of the notice with proof of service must be filed with:

23 “(A) The Court of Appeals if the appeal is from a circuit court; or

24 “(B) The circuit court if the appeal is from a county court.

25 “(c) The notice must be filed not later than 30 days after the entry of the court’s judgment. On
26 appeal from the county court, the circuit court shall hear the matter de novo and its judgment is
27 appealable to the Court of Appeals in the same manner as if the proceeding had been commenced
28 in the circuit court.

29 “(4) The counsel in the proceeding from which the appeal is being taken shall file and serve
30 those documents necessary to commence an appeal if the counsel is requested to do so by the party
31 the counsel represents. If the party requesting an appeal is represented by court-appointed counsel,
32 court-appointed counsel may discharge the duty to commence an appeal under this subsection by
33 complying with policies and procedures established by the office of public defense services for ap-
34 peals of juvenile court judgments.

36 this section, the appellate court shall grant the person leave to file a notice of appeal after the time
37 limits described in subsection (3) of this section if:

38 “(A) The person shows a colorable claim of error in the proceeding from which the appeal is

40 “(B) The person shows that the failure to file a timely notice of appeal is not personally attrib-
41 utable to the person.

42 “(b) A person other than the state is not entitled to relief under this subsection for failure to
43 file timely notice of cross-appeal when the state appeals pursuant to ORS 419A.208.

44 “(c) The request for leave to file a notice of appeal after the time limits prescribed in subsection
45 (3) of this section must be filed no later than 90 days after entry of the judgment being appealed and

1 must be accompanied by the notice of appeal sought to be filed. A request for leave under this
2 subsection may be filed by mail and is deemed filed on the date of mailing if the request is mailed
3 as provided in ORS 19.260.

4 “(d) The court may not grant relief under this subsection unless the state has notice and op-
5 portunity to respond to the person’s request for relief.

6 “(6) An appeal to the Court of Appeals must be conducted in the same manner as an appeal
7 under ORS chapter 19 except that the court shall advance the appeal on the court’s docket in the
8 same manner as appeals in criminal cases.

9 “(7)(a) Except as provided in ORS 419A.208 (2), or when otherwise ordered by the appellate
10 court, the filing of an appeal does not suspend an order or judgment of the juvenile court nor dis-
11 charge the ward or youth offender from the custody of the person, institution or agency in whose
12 custody the ward or youth offender may have been placed nor preclude the juvenile court after no-
13 tice and hearing from entering such further orders relating to the ward or youth offender’s custody
14 pending final disposition of the appeal as it finds necessary by reason only of matters transpiring
15 subsequent to the order or judgment appealed from. The trial court administrator shall immediately
16 file certified copies of any such order or judgment with the Court of Appeals.

17 “(b) Notwithstanding the filing of an appeal from a jurisdictional or dispositional judgment or

19 adjudication of a petition seeking termination of the parental rights of a parent of the ward who is

29 “(b) Was made after entry of the last appealable judgment or final order preceding entry of the

31 “(9) The district attorney or Attorney General shall represent the state in the appeal.

32 “(10)(a) The court from which an appeal is taken shall prepare and transmit a record on appeal
33 in the manner provided in ORS 19.365, except that, when the appeal is to the circuit court from a
34 county court, the record on appeal shall be prepared and transmitted by the county court to the
35 circuit court.

36 “(b) The court to which an appeal is taken under this section shall keep a record of the case
37 on appeal that includes but is not limited to notices of appeal, briefs, motions, orders of the court
38 and other papers filed with the court on appeal.

15 different school district, the caseworker assigned to the case shall notify the superintendent of the

31 or of the school district to which the youth offender has transferred of the youth offender’s status

34 “(b) When a school administrator receives notification under this section, the school adminis-
35 trator may request the Oregon Youth Authority to provide additional information about the youth
36 offender. The youth authority shall provide additional information, including the offense that
37 brought the youth offender within the jurisdiction of the juvenile court and such other information
38 that is subject to disclosure under ORS 419A.255 [(5)] (6).

39 “(2) The youth authority shall include in the notice the following:

40 “(a) The name and date of birth of the youth offender;

41 “(b) The names and addresses of the youth offender’s parents or guardians;

42 “(c) The name and contact information of the attorney for the youth offender, if known;

43 “(d) The name and contact information of the person giving notice under subsection (1) of this
44 section or the person’s designated representative to contact for further information about the notice;

45 “(e) The specific offense that brought the youth offender within the jurisdiction of the juvenile

1 court and whether it involved a firearm or the delivery of a controlled substance, a violation of ORS
2 163.355 to 163.445 or 163.465 or any other offense if the youth authority or juvenile court believes
3 the youth offender represents a risk to other students or school staff; and

4 “(f) Any terms of probation.

5 “(3) Except as otherwise provided in ORS 192.490, the youth authority, a school district or a
6 school administrator, or anyone employed or acting on behalf of the youth authority, school district
7 or school administrator, who sends or receives records under this section is not liable civilly or
8 criminally for failing to disclose the information under this section.

9 “(4) As used in this section:

10 “(a) ‘School administrator’ has the meaning given that term in ORS 419A.305.

11 “(b) ‘School district’ has the meaning given that term in ORS 332.002.

12 “**SECTION 11. Section 1 of this 2013 Act and the amendments to ORS 419A.015, 419A.200,**
13 **419A.253, 419A.255, 419A.256, 419A.257, 419A.300, 419B.367 and 420.048 by sections 2 to 10 of**
14 **this 2013 Act apply to juvenile court proceedings commenced on or after the effective date**
