

SENATE AMENDMENTS TO SENATE BILL 795

- 1 In line 2 of the printed bill, after “471.157” insert “and 471.200”.
2 After line 7, insert:
3 “**SECTION 2.** ORS 471.200 is amended to read:
4 “471.200. (1) A brewery-public house license allows the licensee:
5 “(a) To manufacture on the licensed premises, store, transport, sell to wholesale malt beverage
6 and wine licensees of the Oregon Liquor Control Commission and export malt beverages;
7 “(b) To sell malt beverages manufactured on or off the licensed premises at retail for consump-
8 tion on or off the premises;
9 “(c) To sell malt beverages in brewery-sealed packages at retail directly to the consumer for
10 consumption off the premises;
11 “(d) To sell on the licensed premises at retail malt beverages manufactured on or off the li-
12 censed premises in unpasteurized or pasteurized form directly to the consumer for consumption off
13 the premises, delivery of which may be made in a securely covered container supplied by the con-
14 sumer;
15 “(e) To sell wine and cider at retail for consumption on or off the premises;
16 “(f) To conduct the activities, **except manufacturing**, described in paragraphs [(b)] (a) to (e)
17 of this subsection at one location other than the premises where the manufacturing occurs; and
18 “(g) To obtain a special events brewery-public house license entitling the holder to conduct the
19 activities allowed under paragraphs (b), (c) and (e) of this subsection at a designated location other
20 than the location set forth in the brewery-public house license for a period not exceeding five days.
21 “(2) In addition to the privileges specified in subsection (1) of this section, in any calendar year
22 a brewery-public house licensee may sell at wholesale to licensees of the commission malt beverages
23 produced by the brewery-public house licensee if the brewery-public house licensee produced 5,000
24 barrels or less of malt beverages in the immediately preceding calendar year.
25 “(3) A brewery-public house licensee, or any person having an interest in the licensee, is a retail
26 licensee for the purposes of ORS 471.394 and, except as otherwise provided by this section and ORS
27 471.396, may not acquire or hold any right, title, lien, claim or other interest, financial or otherwise,
28 in, upon or to the premises, equipment, business or merchandise of any manufacturer or wholesaler,
29 as defined in ORS 471.392. A brewery-public house licensee, or any person having an interest in the
30 licensee, is also a manufacturer for the purposes of ORS 471.398 and, except as otherwise provided
31 by this section and ORS 471.400, may not acquire or hold any right, title, lien, claim or other in-
32 terest, financial or otherwise, in, upon or to the premises, equipment, business or merchandise of
33 any other retail licensee, as defined in ORS 471.392.
34 “(4) A brewery-public house licensee, or any person having an interest in the licensee, is a retail
35 licensee for the purposes of ORS 471.398 and, except as otherwise provided by this section and ORS

1 471.400, may not accept directly or indirectly any financial assistance described in ORS 471.398 from
2 any manufacturer or wholesaler, as defined in ORS 471.392. A brewery-public house licensee, or any
3 person having an interest in the licensee, is also a manufacturer for the purposes of ORS 471.398
4 and, except as otherwise provided by this section and ORS 471.400, may not provide directly or in-
5 directly any financial assistance described in ORS 471.398 to any retail licensee, as defined in ORS
6 471.392. The prohibitions on financial assistance in ORS 471.398 do not apply to financial assistance
7 between manufacturing and retail businesses licensed to the same person under the provisions of
8 this section.

9 “(5) Notwithstanding subsection (3) of this section, a brewery-public house licensee, or any per-
10 son having an interest in the licensee, may also hold a winery license authorized by ORS 471.223.
11 A brewery-public house licensee, or any person having an interest in the licensee, may also hold a
12 warehouse license authorized by ORS 471.242.

13 “(6) Notwithstanding subsection (3) of this section, a brewery-public house licensee is eligible for
14 limited on-premises sales licenses and temporary sales licenses.

15 “(7)(a) Notwithstanding subsection (3) of this section, and except as provided in this subsection,
16 a brewery-public house licensee, or any person having an interest in the licensee, may also hold a
17 full on-premises sales license. If a person holds both a brewery-public house license and a full on-
18 premises sales license, nothing in this chapter shall prevent the sale by the licensee of both distilled
19 liquor and malt beverages manufactured under the brewery-public house license.

20 “(b) The commission may not issue a full on-premises sales license to a brewery-public house
21 licensee under the provisions of this subsection if the brewery-public house licensee, or any person
22 having an interest in the licensee or exercising control over the licensee, is a brewery that brews
23 more than 200,000 barrels of malt beverages annually or a winery that produces more than 200,000
24 gallons of wine annually.

25 “(8) Notwithstanding any other provision of this chapter, a brewery-public house licensee, or any
26 person having an interest in the licensee, may also hold a distillery license. No provision of this
27 chapter prevents a brewery-public house licensee that also holds a distillery license from being ap-
28 pointed by the commission as the distillery’s retail outlet agent for the purpose of selling distilled
29 liquors under ORS 471.230.

30 “(9) Notwithstanding subsection (3) of this section, the commission by rule may authorize a
31 brewery-public house licensee to coproduce special events with other manufacturers.

32 “(10)(a) Notwithstanding subsection (3) of this section, a brewery-public house licensee may hold,
33 directly or indirectly, an interest in a manufacturer or wholesaler, provided that the interest does
34 not result in exercise of control over, or participation in the management of, the manufacturer’s or
35 wholesaler’s business or business decisions and does not result in exclusion of any competitor’s
36 brand of alcoholic liquor.

37 “(b) Notwithstanding subsection (3) of this section, a manufacturer or wholesaler, and any offi-
38 cer, director or substantial stockholder of any corporate manufacturer or wholesaler, may hold, di-
39 rectly or indirectly, an interest in a brewery-public house licensee, provided that the interest does
40 not result in exercise of control over, or participation in the management of, the licensee’s business
41 or business decisions and does not result in exclusion of any competitor’s brand of alcoholic liquor.

42 “(11) For purposes of ORS chapter 473, a brewery-public house licensee shall be considered to
43 be a manufacturer.”.
