

Senate Bill 806

Sponsored by Senator MONNES ANDERSON; Senators BATES, COURTNEY, DEVLIN, HANSELL, PROZANSKI, ROBLAN, STEINER HAYWARD

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes individual licensed to practice medicine or podiatry in another state or country to provide health care services for out-of-state athletic team under certain circumstances.

A BILL FOR AN ACT

2 Relating to providing health care services for athletic teams; amending ORS 677.060.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 677.060 is amended to read:

5 677.060. This chapter does not affect or prevent the following:

6 (1) The practice of medicine or podiatry in this state by any commissioned medical or podiatric
7 officer serving in the Armed Forces of the United States or Public Health Service, or any medical
8 or podiatric officer on duty with the United States Department of Veterans Affairs, while any such
9 medical or podiatric officer is engaged in the performance of the actual duties prescribed by the
10 laws and regulations of the United States.

11 (2) The meeting in this state of any licensed practitioner of medicine of any other state or
12 country with a licensed practitioner of medicine in this state, for consultation.

13 (3) Supervised clinical training by an acupuncture student who is enrolled in a school approved
14 to offer credit for post-secondary clinical education in Oregon or clinical practice of acupuncture
15 by a practitioner licensed to practice acupuncture in another state or foreign country who is en-
16 rolled in clinical training approved by the Oregon Medical Board.

17 (4) **The practice of medicine or podiatry by an individual licensed to practice medicine or**
18 **podiatry in another state or country who is providing health care services for an out-of-state**
19 **athletic team provided that:**

20 (a) **The individual is practicing pursuant to a written agreement with the team under**
21 **which the individual provides health care services:**

22 (A) **Only for team members, team staff members or family members traveling with the**
23 **team; and**

24 (B) **For a specific athletic event taking place in this state;**

25 (b) **The individual practices medicine or podiatry for no more than 10 consecutive days**
26 **for each athletic event or, upon written order by the executive director of the Oregon Med-**
27 **ical Board, an additional amount of time not to exceed 21 consecutive days for each athletic**
28 **event;**

29 (c) **The individual does not provide health care services or perform consultations for a**
30 **resident of this state unless the resident is a team member, team staff member or family**
31 **member traveling with the team; and**

1 **(d) The individual does not provide health care services at a health care facility, as de-**
 2 **defined in ORS 442.015, unless the health care facility is located in an arena or stadium or on**
 3 **a college campus or is a temporary facility established for an athletic event.**

4 [(4)] (5) The furnishing of medical or surgical assistance in cases of emergency requiring imme-
 5 diate attention.

6 [(5)] (6) The domestic administration of family remedies.

7 [(6)] (7) The practice of dentistry, pharmacy, nursing, optometry, psychology, regulated social
 8 work, chiropractic, naturopathic medicine or cosmetic therapy, by any person authorized by this
 9 state.

10 [(7)] (8) The practice of the religion of persons who endeavor to prevent or cure disease or
 11 suffering by prayer or other spiritual means in accordance with the tenets of any church. Nothing
 12 in this chapter interferes in any manner with the individual's right to select the practitioner or
 13 mode of treatment of an individual's choice, or interferes with the right of the person so employed
 14 to give the treatment so chosen if public health laws and rules are complied with.

15 [(8)] (9) The sale of lenses, artificial eyes, limbs or surgical instruments or other apparatus or
 16 appliances of a similar character.

17 [(9)] (10) The sale, rent or use for hire of any device or appliance, the sale of which is not
 18 prohibited by the laws of Oregon or the United States.

19 [(10)] (11) The practice of physiotherapy, electrotherapy or hydrotherapy carried on by a duly
 20 licensed practitioner of medicine, naturopathic medicine or chiropractic, or by ancillary personnel
 21 certified by the State Board of Chiropractic Examiners, pursuant to ORS 684.155 (1)(c)(A), to provide
 22 physiotherapy, electrotherapy or hydrotherapy and working under the direction of a chiropractic
 23 physician.

24 [(11)] (12) The practice or use of massage, Swedish movement, physical culture, or other natural
 25 methods requiring use of the hands.

26 [(12)] (13) The use of the title "doctor," "chiropractic physician," "naturopathic physician,"
 27 "doctor of optometry," "optometric physician" or "podiatric physician" in accordance with ORS
 28 676.110 and 676.120.
