SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs Department of Transportation to conduct interchange management study as part of redevelopment of Umatilla Chemical Depot.]

[Appropriates moneys for interchange management study conducted by department. Makes appropriation contingent upon receipt of federal funds.]

[Sunsets study on January 2, 2016.]

[Declares emergency, effective on passage.]

Creates program whereby registered owner or lessee of motor vehicle may pay per-mile road usage charge. Requires application. Becomes operative July 1, 2015.

Permits person paying per-mile road usage charge to apply for refund of motor vehicle fuel tax.

Permits person paying per-mile road usage charge to apply for refund for miles driven on private property.

Directs Department of Transportation to establish methods for reporting vehicle miles traveled.

Provides penalty for making false statements related to payment and reporting of road usage charge or for collecting, attempting to collect or receiving refund to which person is not entitled. Punishes by maximum fine of \$2,000.

Creates offense of tampering with vehicle metering system. Punishes by maximum fine of \$2,000.

Requires department to enter into agreements through Oregon Innovative Partnerships Program to undertake transportation projects related to operation of road usage charge system.

Authorizes department to enter into agreements with other United States and Canadian jurisdictions for research and development of similar pilot programs and sharing of costs. Provides, for biennium beginning July 1, 2013, that expenditures by department from funds received from other states, federal government, Canadian provinces or government of Canada are not limited.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

Relating to transportation; creating new provisions; amending ORS 305.410, 319.280, 319.550, 319.665, 319.831, 366.505, 367.802, 367.804 and 367.806; and prescribing an effective date.

Be It Enacted by the People of the State of Oregon:

DEFINITIONS

SECTION 1. Sections 2 to 15 of this 2013 Act are added to and made a part of ORS chapter 319.

SECTION 2. As used in sections 2 to 15 of this 2013 Act:

(1) "Highway" has the meaning given that term in ORS 801.305.

(2) "Lessee" means a person that leases a motor vehicle that is required to be registered

1 in Oregon.

2 (3)(a) "Motor vehicle" has the meaning given that term in ORS 801.360.

3 (b) "Motor vehicle" does not mean a motor vehicle designed to travel with fewer than
4 four wheels in contact with the ground.

5 (4) "Registered owner" means a person, other than a vehicle dealer that holds a certifi-
6 cate issued under ORS 822.020, that is required to register a motor vehicle in Oregon.

7 (5) "Subject vehicle" means a motor vehicle that is the subject of an application approved
8 pursuant to section 4 of this 2013 Act.

10 **ROAD USAGE CHARGES**

11
12 **SECTION 3.** (1)(a) Except as provided in paragraph (b) of this subsection, the registered
13 owner of a subject vehicle shall pay a per-mile road usage charge for metered use by the
14 subject vehicle of the highways in Oregon.

15 (b) During the term of a lease, the lessee of a subject vehicle shall pay the per-mile road
16 usage charge for metered use by the subject vehicle of the highways in Oregon.

17 (2) The per-mile road usage charge is 1.5 cents per mile.

18 **SECTION 4.** (1) A person wishing to pay the per-mile road usage charge imposed under
19 section 3 of this 2013 Act must apply to the Department of Transportation on a form pre-
20 scribed by the department.

21 (2) The department shall approve a valid and complete application submitted under this
22 section if:

23 (a) The applicant is the registered owner or lessee of a motor vehicle;

24 (b) The motor vehicle is equipped with a method selected pursuant to section 6 of this
25 2013 Act for collecting and reporting the metered use by the motor vehicle of the highways
26 in Oregon;

27 (c) The motor vehicle has a gross vehicle weight rating of 10,000 pounds or less; and

28 (d) Approval does not cause the number of subject vehicles active in the road usage
29 charge program on the date of approval to exceed 5,000.

30 (3) Approval of an application under this section subjects the applicant to the require-
31 ments of section 10 of this 2013 Act until the person ends the person's voluntary partic-
32 ipation in the road usage charge program in the manner required under subsection (4) of this
33 section.

34 (4) A person may end the person's voluntary participation in the road usage charge pro-
35 gram at any time by notifying the department, returning the emblem issued under section
36 15 of this 2013 Act to the department and paying any outstanding amount of road usage
37 charge for metered use by the person's subject vehicle.

39 **REVENUE**

40
41 **SECTION 5.** Moneys collected from the road usage charges imposed under section 3 of
42 this 2013 Act shall be deposited in the State Highway Fund and allocated for distribution as
43 follows:

44 (1) 50 percent to the Department of Transportation.

45 (2) 30 percent to counties for distribution as provided in ORS 366.762.

1 (3) 20 percent to cities for distribution as provided in ORS 366.800.

3 ADMINISTRATION
4

5 **SECTION 6.** (1) As used in this section, “open system” means an integrated system based
6 on common standards and an operating system that has been made public so that compo-
7 nents performing the same function can be readily substituted or provided by multiple pro-
8 viders.

9 (2)(a) The Department of Transportation, in consultation with the Road User Fee Task
10 Force, shall establish the methods for recording and reporting the number of miles that
11 subject vehicles travel on highways.

12 (b) When taking action under this subsection, the department shall consider:

13 (A) The accuracy of the data collected;

14 (B) Privacy options for persons liable for the per-mile road usage charge;

15 (C) The security of the technology;

16 (D) The resistance of the technology to tampering;

17 (E) The ability to audit compliance; and

18 (F) Other relevant factors that the department deems important.

19 (c) The department shall establish at least one method of collecting and reporting the
20 number of miles traveled by a subject vehicle that does not use vehicle location technology.

21 (d)(A) The department shall adopt standards for open system technology used in methods
22 established under this subsection.

23 (B) In adopting standards pursuant to this paragraph, the department shall collaborate
24 with agencies of the executive department as defined in ORS 174.112 to integrate information
25 systems currently in use or planned for future use.

26 (3) The department shall provide the persons liable for the per-mile road usage charge
27 the opportunity to select a method from among multiple options for collecting and reporting
28 the metered use by a subject vehicle of the highways in Oregon.

29 **SECTION 7.** The Department of Transportation shall provide by rule for the collection
30 of the road usage charges imposed under section 3 of this 2013 Act, including penalties and
31 interest imposed on delinquent charges.

32 **SECTION 8.** (1) The Department of Transportation shall establish by rule reporting pe-
33 riods for the road usage charges imposed under section 3 of this 2013 Act.

34 (2) Reporting periods established under this section may vary according to the facts and
35 circumstances applicable to classes of registered owners, lessees and subject vehicles.

36 (3) In establishing reporting periods, the department shall consider:

37 (a) The effort required by registered owners or lessees to report metered use and to pay
38 the per-mile road usage charge;

39 (b) The amount of the per-mile road usage charge owed;

40 (c) The cost to the registered owner or lessee of reporting metered use and of paying the
41 per-mile road usage charge;

42 (d) The administrative cost to the department; and

43 (e) Other relevant factors that the department deems important.

44 **SECTION 9.** (1) As used in this section:

45 (a) “Certified service provider” means an entity that has entered into an agreement with

1 the Department of Transportation under ORS 367.806 for reporting metered use by a subject
2 vehicle or for administrative services related to the collection of per-mile road usage charges
3 and authorized employees of the entity.

4 (b) "Personally identifiable information" means any information that identifies or de-
5 scribes a person, including, but not limited to, the person's travel pattern data, per-mile road
6 usage charge account number, address, telephone number, electronic mail address, driver
7 license or identification card number, registration plate number, photograph, recorded im-
8 ages, bank account information and credit card number.

9 (c) "VIN summary report" means a monthly report by the department or a certified
10 service provider that includes a summary of all vehicle identification numbers of subject
11 vehicles and associated total metered use during the month. The report may not include lo-
12 cation information.

13 (2) Except as provided in subsections (3) and (4) of this section, personally identifiable
14 information used for reporting metered use or for administrative services related to the
15 collection of the per-mile road usage charge imposed under section 3 of this 2013 Act is
16 confidential within the meaning of ORS 192.502 (9)(a) and is a public record exempt from
17 disclosure under ORS 192.410 to 192.505.

18 (3)(a) The department, a certified service provider or a contractor for a certified service
19 provider may not disclose personally identifiable information used or developed for reporting
20 metered use by a subject vehicle or for administrative services related to the collection of
21 per-mile road usage charges to any person except:

22 (A) The registered owner or lessee;

23 (B) A financial institution, for the purpose of collecting per-mile road usage charges
24 owed;

25 (C) Employees of the department;

26 (D) A certified service provider;

27 (E) A contractor for a certified service provider, but only to the extent the contractor
28 provides services directly related to the certified service provider's agreement with the de-
29 partment;

30 (F) An entity expressly approved to receive the information by the registered owner or
31 lessee of the subject vehicle; or

32 (G) A police officer pursuant to a valid court order based on probable cause and issued
33 at the request of a federal, state or local law enforcement agency in an authorized criminal
34 investigation involving a person to whom the requested information pertains.

35 (b) Disclosure under paragraph (a) of this subsection is limited to personally identifiable
36 information necessary to the respective recipient's function under sections 2 to 15 of this
37 2013 Act.

38 (4)(a) Not later than 30 days after completion of payment processing, dispute resolution
39 for a single reporting period or a noncompliance investigation, whichever is latest, the de-
40 partment and certified service providers shall destroy records of the location and daily me-
41 tered use of subject vehicles.

42 (b) Notwithstanding paragraph (a) of this subsection:

43 (A) For purposes of traffic management and research, the department and certified ser-
44 vice providers may retain, aggregate and use information in the records after removing
45 personally identifiable information.

1 (B) A certified service provider may retain the records if the registered owner or lessee
2 consents to the retention. Consent under this subparagraph does not entitle the department
3 to obtain or use the records or the information contained in the records.

4 (C) Monthly summaries of metered use by subject vehicles may be retained in VIN sum-
5 mary reports by the department and certified service providers.

6 (5) The department, in any agreement with a certified service provider, shall provide for
7 penalties if the certified service provider violates this section.

8 **SECTION 10.** (1) On a date determined by the Department of Transportation under sec-
9 tion 8 of this 2013 Act, the registered owner or lessee of a subject vehicle shall report the
10 metered use by the subject vehicle, rounded up to the next whole mile, and pay to the de-
11 partment the per-mile road usage charge due under section 3 of this 2013 Act for the re-
12 porting period.

13 (2) Unless a registered owner or lessee presents evidence in a manner approved by the
14 department by rule that the subject vehicle has been driven outside this state, the depart-
15 ment shall assume that all metered use reported represents miles driven by the subject ve-
16 hicle on the highways in Oregon.

17
18 **REFUNDS AND EXEMPTIONS**

19
20 **SECTION 11.** (1) The Department of Transportation shall provide a refund to a registered
21 owner or lessee that has overpaid the per-mile road usage charge imposed under section 3
22 of this 2013 Act.

23 (2) The department may provide by rule that the refund under this section be granted
24 as a credit against future per-mile road usage charges incurred by the registered owner or
25 lessee.

26 **SECTION 12.** (1) A registered owner or lessee that has paid the per-mile road usage
27 charge imposed under section 3 of this 2013 Act may apply to the Department of Transpor-
28 tation for a refund for metered use of a road, thoroughfare or property in private ownership.

29 (2) An application for a refund under this section must be submitted to the department
30 within 15 months after the date on which the per-mile road usage charge for which a refund
31 is claimed is paid.

32 (3) The application required under this section shall be in a form prescribed by the de-
33 partment by rule and must include a signed statement by the applicant indicating the num-
34 ber of miles for which the refund is claimed.

35 (4) The department may require the applicant for a refund under this section to furnish
36 any information the department considers necessary for processing the application.

37 **SECTION 13.** (1) The Department of Transportation may investigate a refund application
38 submitted under section 12 of this 2013 Act and gather and compile such information related
39 to the application as the department considers necessary to safeguard the state and prevent
40 fraudulent practices in connection with tax refunds and tax evasion.

41 (2) The department may, in order to establish the validity of an application, examine the
42 relevant records of the applicant for such purposes.

43 (3) If an applicant does not permit the department to examine the relevant records, the
44 applicant waives all rights to the refund to which the application relates.

45 **SECTION 14.** (1) A person may not intentionally make a false statement in a report or

1 refund application or when supplying other information required under section 10 or 12 of
2 this 2013 Act.

3 (2) A person may not intentionally apply for, receive or attempt to receive a refund under
4 section 11 or 12 of this 2013 Act to which the person is not entitled.

5 (3) A person may not intentionally aid or assist another person to violate any provision
6 of section 10, 11 or 12 of this 2013 Act.

7 (4) A person who violates any provision of this section commits a Class A violation.

8 **SECTION 15.** (1) Upon application on a form prescribed by the Department of Transpor-
9 tation, the department shall issue an emblem to the registered owner of a subject vehicle to
10 show that the use of fuel in the subject vehicle is exempt from taxation under ORS 319.510
11 to 319.880.

12 (2) An emblem issued under this section shall be displayed:

13 (a) In a conspicuous place on the subject vehicle; and

14 (b) Only upon the subject vehicle with respect to which it is issued.

15 **SECTION 16.** ORS 319.550 is amended to read:

16 319.550. (1) **Except as provided in this section,** a person may not use fuel in a motor vehicle
17 in this state unless the person holds a valid user's license. [*except that:*]

18 [(1)] (2) A nonresident may use fuel in a motor vehicle not registered in Oregon for a period not
19 exceeding 30 days without obtaining a user's license or the emblem [*provided in*] **issued under** ORS
20 319.600, if, for all fuel used in a motor vehicle in this state, the nonresident pays to a seller, at the
21 time of the sale, the tax provided in ORS 319.530.

22 [(2)] (3) A user's license is not required for a person who uses fuel in a motor vehicle with a
23 combined weight of 26,000 pounds or less if, for all fuel used in a motor vehicle in this state, the
24 person pays to a seller, at the time of the sale, the tax provided in ORS 319.530.

25 [(3)] (4)(a) A user's license is not required for a person who uses fuel as described in ORS
26 319.520 (7) in the vehicles specified in [*subsection (4) of this section*] **this subsection** if the person
27 pays to a seller, at the time of the sale, the tax provided in ORS 319.530.

28 [(4)] (b) [*Subsection (3) of this section*] **Paragraph (a) of this subsection** applies to the following
29 vehicles:

30 [(a)] (A) Motor homes as defined in ORS 801.350.

31 [(b)] (B) Recreational vehicles as defined in ORS 446.003.

32 (5) **A user's license is not required for a person who uses fuel in a motor vehicle:**

33 (a) **Metered use by which is subject to the per-mile road usage charge imposed under**
34 **section 3 of this 2013 Act; and**

35 (b) **That also uses fuels subject to ORS 319.510 to 319.880.**

36 **SECTION 17.** ORS 319.665 is amended to read:

37 319.665. (1) The seller of fuel for use in a motor vehicle shall collect the tax provided by ORS
38 319.530 at the time the fuel is sold, unless one of the following situations applies:

39 (a) The vehicle into which the seller delivers or places the fuel bears a valid permit or user's
40 emblem issued by the Department of Transportation.

41 (b) The fuel is dispensed at a nonretail facility, in which case the seller shall collect any tax
42 owed at the same time the seller collects the purchase price from the person to whom the fuel was
43 dispensed at the nonretail facility. A seller is not required to collect the tax under this paragraph
44 from a person who certifies to the seller that the use of the fuel is exempt from the tax imposed
45 under ORS 319.530.

1 (c) A cardlock card is used for purchase of the fuel at an attended portion of a retail facility
2 equipped with a cardlock card reader, in which case the cardlock card issuer licensed in this state
3 is responsible for collecting and remitting the tax unless the person making the purchase certifies
4 to the seller that the use of the fuel is exempt from the tax imposed under ORS 319.530.

5 **(d) Metered use by the vehicle is subject to the per-mile road usage charge imposed under**
6 **section 3 of this 2013 Act.**

7 (2) If a cardlock card is used for purchase of fuel at an attended portion of a retail facility
8 equipped with a cardlock card reader, the seller at the retail facility may deduct fuel purchases
9 made with a cardlock card from the seller's retail transactions if the seller provides the department
10 with the following information:

11 (a) A monthly statement from a cardlock card issuer that details the cardlock card purchases
12 at the retail facility; and

13 (b) A listing of cardlock card issuers and gallons of fuel purchased at the retail facility by the
14 issuers' customers.

15 (3) The department shall supply each seller of fuel for use in a motor vehicle with a chart which
16 sets forth the tax imposed on given quantities of fuel.

17 **SECTION 18.** ORS 319.831 is amended to read:

18 319.831. (1) If a user obtains fuel for use in a motor vehicle in this state and pays the use fuel
19 tax on the fuel obtained, the user may apply for a refund of that part of the use fuel tax paid which
20 is applicable to use of the fuel to propel a motor vehicle:

21 (a) In another state, if the user pays to the other state an additional tax on the same fuel;

22 (b) Upon any road, thoroughfare or property in private ownership;

23 (c) Upon any road, thoroughfare or property, other than a state highway, county road or city
24 street, for the removal of forest products, as defined in ORS 321.005, or the products of such forest
25 products converted to a form other than logs at or near the harvesting site, or for the construction
26 or maintenance of the road, thoroughfare or property, pursuant to a written agreement or permit
27 authorizing the use, construction or maintenance of the road, thoroughfare or property, with or by:

28 (A) An agency of the United States;

29 (B) The State Board of Forestry;

30 (C) The State Forester; or

31 (D) A licensee of an agency named in subparagraph (A), (B) or (C) of this paragraph;

32 (d) By an agency of the United States or of this state or of any county, city or port of this state
33 on any road, thoroughfare or property, other than a state highway, county road or city street;

34 (e) By any incorporated city or town of this state;

35 (f) By any county of this state or by any road assessment district formed under ORS 371.405 to
36 371.535;

37 (g) Upon any county road for the removal of forest products as defined in ORS 321.005, or the
38 products of such forest products converted to a form other than logs at or near the harvesting site,
39 if:

40 (A) Such use upon the county road is pursuant to a written agreement entered into with, or to
41 a permit issued by, the State Board of Forestry, the State Forester or an agency of the United
42 States, authorizing such user to use such road and requiring such user to pay for or to perform the
43 construction or maintenance of the county road;

44 (B) The board, officer or agency that entered into the agreement or granted the permit, by
45 contract with the county court or board of county commissioners, has assumed the responsibility for

1 the construction or maintenance of such county road; and

2 (C) Copies of the agreements or permits required by subparagraphs (A) and (B) of this paragraph
3 are filed with the Department of Transportation;

4 (h) By a school district or education service district of this state or the contractors of a school
5 district or education service district, for those vehicles being used to transport students;

6 (i) By a rural fire protection district organized under the provisions of ORS chapter 478;

7 (j) By any district, as defined in ORS chapter 198, that is not otherwise specifically provided for
8 in this section; or

9 (k) By any state agency, as defined in ORS 240.855.

10 **(L) In metered use subject to the per-mile road usage charge imposed under section 3**
11 **of this 2013 Act if the user has paid the charge.**

12 (2) An application for a refund under subsection (1) of this section shall be filed with the de-
13 partment within 15 months after the date the use fuel tax, for which a refund is claimed, is paid.

14 (3) The application for a refund provided by subsection (1) of this section shall include a signed
15 statement by the applicant indicating the amount of fuel for which a refund is claimed, and the way
16 in which the fuel was used which qualifies the applicant for a refund. If the fuel upon which the
17 refund is claimed was obtained from a seller to whom the use fuel tax was paid, the application shall
18 be supported by the invoices which cover the purchase of the fuel. If the applicant paid the use fuel
19 tax directly to the department, the applicant shall indicate the source of the fuel and the date it
20 was obtained.

21 (4) The department may require any person who applies for a refund provided by subsection (1)
22 of this section to furnish a statement, under oath, giving the person's occupation, description of the
23 machines or equipment in which the fuel was used, the place where used and such other information
24 as the department may require.

25 **(5) The department may provide by rule that a refund under subsection (1)(L) of this**
26 **section be granted as a credit against future per-mile road usage charges incurred by the**
27 **applicant under section 3 of this 2013 Act.**

28 **SECTION 19.** ORS 319.280 is amended to read:

29 319.280. (1) Any person who has paid any tax on motor vehicle fuel levied or directed to be paid
30 by ORS 319.010 to 319.430 either directly by the collection of the tax by the vendor from the con-
31 sumer, or indirectly by adding the amount of the tax to the price of the fuel and paid by the con-
32 sumer, shall be reimbursed and repaid the amount of such tax paid, except as provided in ORS
33 319.290 to 319.330, if such person has:

34 (a) Purchased and used such fuel for the purpose of operating or propelling a stationary gas
35 engine, a tractor or a motor boat, if the motor boat is used for commercial purposes at any time
36 during the period for which the refund is claimed;

37 (b) Purchased and used such fuel for cleaning or dyeing or other commercial use, except when
38 used in motor vehicles operated upon any highway;

39 (c) Purchased and exported such fuel from this state, in containers other than fuel supply tanks
40 of motor vehicles, provided that the person:

41 (A) Exports the motor vehicle fuel from this state to another state, territory or country, not
42 including a federally recognized Indian reservation located wholly or partially within the borders
43 of this state, where the motor vehicle fuel is unloaded; and

44 (B) Has a valid motor vehicle fuel dealer's license or its equivalent issued by the state, territory
45 or country to which the fuel is exported and where it is unloaded;

1 (d) Purchased and exported such fuel in the fuel supply tank of a motor vehicle and has used
2 such fuel to operate the vehicle upon the highways of another state, if the user has paid to the other
3 state a similar motor vehicle fuel tax on the same fuel, or has paid any other highway use tax the
4 rate for which is increased because such fuel was not purchased in, and the tax thereon paid, to
5 such state; [or]

6 (e) Purchased and used such fuel for small engines that are not used to propel motor vehicles
7 on highways, including but not limited to those that power lawn mowers, leaf blowers, chain saws
8 and similar implements[.]; or

9 **(f) Purchased and used such fuel for operating a motor vehicle the metered use of which**
10 **is subject to the per-mile road usage charge imposed under section 3 of this 2013 Act, if the**
11 **person has paid the charge.**

12 (2) When a motor vehicle with auxiliary equipment uses fuel and there is no auxiliary motor for
13 such equipment or separate tank for such a motor, a refund may be claimed and allowed as provided
14 by subsection [(4)] (5) of this section, except as otherwise provided by this subsection, without the
15 necessity of furnishing proof of the amount of fuel used in the operation of the auxiliary equipment.
16 The person claiming the refund may present to the Department of Transportation a statement of the
17 claim and be allowed a refund as follows:

18 (a) For fuel used in pumping aircraft fuel, motor vehicle fuel, fuel or heating oils or other pe-
19 troleum products by a power take-off unit on a delivery truck, refund shall be allowed claimant for
20 tax paid on fuel purchased at the rate of three-fourths of one gallon for each 1,000 gallons of pe-
21 troleum products delivered.

22 (b) For fuel used in operating a power take-off unit on a cement mixer truck or on a garbage
23 truck, claimant shall be allowed a refund of 25 percent of the tax paid on all fuel used in such a
24 truck.

25 (3) When a person purchases and uses motor vehicle fuel in a vehicle equipped with a power
26 take-off unit, a refund may be claimed for fuel used to operate the power take-off unit provided the
27 vehicle is equipped with a metering device approved by the department and designed to operate only
28 while the vehicle is stationary and the parking brake is engaged; the quantity of fuel measured by
29 the metering device shall be presumed to be the quantity of fuel consumed by the operation of the
30 power take-off unit.

31 **(4)(a) The department may provide by rule that a refund under subsection (1)(f) of this**
32 **section be granted as a credit against future per-mile road usage charges incurred by the**
33 **person under section 3 of this 2013 Act.**

34 **(b)(A) The department may provide by rule for refund thresholds that are met by ag-**
35 **gregating refund amounts or by estimating motor vehicle fuel tax refunds by vehicle type,**
36 **at the option of the person claiming the refund.**

37 **(B) If the person claiming the refund opts for an estimated refund based on vehicle type,**
38 **the requirement under subsection (5) of this section that the person claiming the refund**
39 **must present original invoices or reasonable facsimiles showing motor vehicle fuel purchases**
40 **does not apply.**

41 [(4)] (5) Before any such refund may be granted, the person claiming such refund must present
42 to the department a statement, accompanied by the original invoices, or reasonable facsimiles ap-
43 proved by the department, showing such purchases; provided that in lieu of original invoices or
44 facsimiles, refunds submitted under subsection (1)(d) of this section shall be accompanied by infor-
45 mation showing source of the fuel used and evidence of payment of tax to the state in which the fuel

1 was used. The statement shall be made over the signature of the claimant, and shall state the total
2 amount of such fuel for which the claimant is entitled to be reimbursed under subsection (1) of this
3 section. The department upon the presentation of the statement and invoices or facsimiles, or other
4 required documents, shall cause to be repaid to the claimant from the taxes collected on motor ve-
5 hicle fuel such taxes so paid by the claimant.

9 **SECTION 20. Section 21 of this 2013 Act is added to and made a part of the Oregon Ve-**
10 **hicle Code.**

11 **SECTION 21. (1) A person commits the offense of tampering with a vehicle metering**
12 **system if the person:**

13 **(a) With the intent to defraud, operates a motor vehicle that is subject to the per-mile**
14 **road usage charge imposed under section 3 of this 2013 Act on a highway knowing that the**
15 **vehicle metering system is disconnected or nonfunctional.**

16 **(b) Replaces, disconnects or resets the vehicle metering system of a motor vehicle that**

32 **SECTION 29.** The Department of Transportation may enter into agreements with other
33 state departments of transportation, the federal government and Canadian provinces for the
34 purposes of:

35 (1) Conducting joint research relating to road usage charges and development programs
36 on a multistate basis;

37 (2) Furthering the development and operation of single state or multistate road usage
38 charge pilot programs;

39 (3) Sharing costs incurred in conducting the research described in subsection (1) of this
40 section; and

41 (4) Developing a program for stakeholder outreach and communications with respect to
42 road usage charges.

43 **SECTION 30.** For the biennium beginning July 1, 2013, expenditures by the Department
44 of Transportation from funds received from other states, the federal government, Canadian
45 provinces or the government of Canada for the purposes described in section 29 of this 2013

1 **Act are not limited.**
