

SENATE AMENDMENTS TO SENATE BILL 810

“DEFINITIONS

5

8 **“SECTION 1. Sections 2 to 15 of this 2013 Act are added to and made a part of ORS**
9 **chapter 319.**

10 **“SECTION 2. As used in sections 2 to 15 of this 2013 Act:**

11 **“(1) ‘Highway’ has the meaning given that term in ORS 801.305.**

12 **“(2) ‘Lessee’ means a person that leases a motor vehicle that is required to be registered**
13 **in Oregon.**

14 **“(3)(a) ‘Motor vehicle’ has the meaning given that term in ORS 801.360.**

15 **“(b) ‘Motor vehicle’ does not mean a motor vehicle designed to travel with fewer than**
16 **four wheels in contact with the ground.**

17 **“(4) ‘Registered owner’ means a person, other than a vehicle dealer that holds a certifi-**
18 **cate issued under ORS 822.020, that is required to register a motor vehicle in Oregon.**

19 **“(5) ‘Subject vehicle’ means a motor vehicle that is the subject of an application approved**
20 **pursuant to section 4 of this 2013 Act.**

“ROAD USAGE CHARGES

22
23
24 **“SECTION 3. (1)(a) Except as provided in paragraph (b) of this subsection, the registered**
25 **owner of a subject vehicle shall pay a per-mile road usage charge for metered use by the**
26 **subject vehicle of the highways in Oregon.**

27 **“(b) During the term of a lease, the lessee of a subject vehicle shall pay the per-mile road**
28 **usage charge for metered use by the subject vehicle of the highways in Oregon.**

29 **“(2) The per-mile road usage charge is 1.5 cents per mile.**

30 **“SECTION 4. (1) A person wishing to pay the per-mile road usage charge imposed under**
31 **section 3 of this 2013 Act must apply to the Department of Transportation on a form pre-**
32 **scribed by the department.**

33 **“(2) The department shall approve a valid and complete application submitted under this**
34 **section if:**

35 **“(a) The applicant is the registered owner or lessee of a motor vehicle;**

1 “(b) The motor vehicle is equipped with a method selected pursuant to section 6 of this
2 2013 Act for collecting and reporting the metered use by the motor vehicle of the highways
3 in Oregon;

4 “(c) The motor vehicle has a gross vehicle weight rating of 10,000 pounds or less; and

5 “(d) Approval does not cause the number of subject vehicles active in the road usage
6 charge program on the date of approval to exceed 5,000.

7 “(3) Approval of an application under this section subjects the applicant to the require-
8 ments of section 10 of this 2013 Act until the person ends the person’s voluntary partic-
9 ipation in the road usage charge program in the manner required under subsection (4) of this
10 section.

11 “(4) A person may end the person’s voluntary participation in the road usage charge
12 program at any time by notifying the department, returning the emblem issued under section
13 15 of this 2013 Act to the department and paying any outstanding amount of road usage
14 charge for metered use by the person’s subject vehicle.

16 “REVENUE

17
18 “**SECTION 5.** Moneys collected from the road usage charges imposed under section 3 of
19 this 2013 Act shall be deposited in the State Highway Fund and allocated for distribution as
20 follows:

21 “(1) 50 percent to the Department of Transportation.

22 “(2) 30 percent to counties for distribution as provided in ORS 366.762.

23 “(3) 20 percent to cities for distribution as provided in ORS 366.800.

24
25 “ADMINISTRATION

26
27 “**SECTION 6.** (1) As used in this section, ‘open system’ means an integrated system based
28 on common standards and an operating system that has been made public so that compo-
29 nents performing the same function can be readily substituted or provided by multiple pro-
30 viders.

31 “(2)(a) The Department of Transportation, in consultation with the Road User Fee Task
32 Force, shall establish the methods for recording and reporting the number of miles that
33 subject vehicles travel on highways.

34 “(b) When taking action under this subsection, the department shall consider:

35 “(A) The accuracy of the data collected;

36 “(B) Privacy options for persons liable for the per-mile road usage charge;

37 “(C) The security of the technology;

38 “(D) The resistance of the technology to tampering;

39 “(E) The ability to audit compliance; and

40 “(F) Other relevant factors that the department deems important.

41 “(c) The department shall establish at least one method of collecting and reporting the
42 number of miles traveled by a subject vehicle that does not use vehicle location technology.

43 “(d)(A) The department shall adopt standards for open system technology used in meth-
44 ods established under this subsection.

45 “(B) In adopting standards pursuant to this paragraph, the department shall collaborate

1 with agencies of the executive department as defined in ORS 174.112 to integrate information
2 systems currently in use or planned for future use.

3 “(3) The department shall provide the persons liable for the per-mile road usage charge
4 the opportunity to select a method from among multiple options for collecting and reporting
5 the metered use by a subject vehicle of the highways in Oregon.

6 “**SECTION 7.** The Department of Transportation shall provide by rule for the collection
7 of the road usage charges imposed under section 3 of this 2013 Act, including penalties and
8 interest imposed on delinquent charges.

9 “**SECTION 8.** (1) The Department of Transportation shall establish by rule reporting pe-
10 riods for the road usage charges imposed under section 3 of this 2013 Act.

11 “(2) Reporting periods established under this section may vary according to the facts and
12 circumstances applicable to classes of registered owners, lessees and subject vehicles.

13 “(3) In establishing reporting periods, the department shall consider:

14 “(a) The effort required by registered owners or lessees to report metered use and to pay
15 the per-mile road usage charge;

16 “(b) The amount of the per-mile road usage charge owed;

17 “(c) The cost to the registered owner or lessee of reporting metered use and of paying
18 the per-mile road usage charge;

19 “(d) The administrative cost to the department; and

20 “(e) Other relevant factors that the department deems important.

21 “**SECTION 9.** (1) As used in this section:

22 “(a) ‘Certified service provider’ means an entity that has entered into an agreement with
23 the Department of Transportation under ORS 367.806 for reporting metered use by a subject
24 vehicle or for administrative services related to the collection of per-mile road usage charges
25 and authorized employees of the entity.

26 “(b) ‘Personally identifiable information’ means any information that identifies or de-
27 scribes a person, including, but not limited to, the person’s travel pattern data, per-mile road
28 usage charge account number, address, telephone number, electronic mail address, driver
29 license or identification card number, registration plate number, photograph, recorded im-
30 ages, bank account information and credit card number.

31 “(c) ‘VIN summary report’ means a monthly report by the department or a certified
32 service provider that includes a summary of all vehicle identification numbers of subject
33 vehicles and associated total metered use during the month. The report may not include lo-
34 cation information.

35 “(2) Except as provided in subsections (3) and (4) of this section, personally identifiable
36 information used for reporting metered use or for administrative services related to the
37 collection of the per-mile road usage charge imposed under section 3 of this 2013 Act is
38 confidential within the meaning of ORS 192.502 (9)(a) and is a public record exempt from
39 disclosure under ORS 192.410 to 192.505.

40 “(3)(a) The department, a certified service provider or a contractor for a certified service
41 provider may not disclose personally identifiable information used or developed for reporting
42 metered use by a subject vehicle or for administrative services related to the collection of
43 per-mile road usage charges to any person except:

44 “(A) The registered owner or lessee;

45 “(B) A financial institution, for the purpose of collecting per-mile road usage charges

1 owed;

2 “(C) Employees of the department;

3 “(D) A certified service provider;

4 “(E) A contractor for a certified service provider, but only to the extent the contractor
5 provides services directly related to the certified service provider’s agreement with the de-
6 partment;

7 “(F) An entity expressly approved to receive the information by the registered owner or
8 lessee of the subject vehicle; or

9 “(G) A police officer pursuant to a valid court order based on probable cause and issued
10 at the request of a federal, state or local law enforcement agency in an authorized criminal
11 investigation involving a person to whom the requested information pertains.

12 “(b) Disclosure under paragraph (a) of this subsection is limited to personally identifiable
13 information necessary to the respective recipient’s function under sections 2 to 15 of this
14 2013 Act.

15 “(4)(a) Not later than 30 days after completion of payment processing, dispute resolution
16 for a single reporting period or a noncompliance investigation, whichever is latest, the de-
17 partment and certified service providers shall destroy records of the location and daily me-
18 tered use of subject vehicles.

19 “(b) Notwithstanding paragraph (a) of this subsection:

20 “(A) For purposes of traffic management and research, the department and certified
21 service providers may retain, aggregate and use information in the records after removing
22 personally identifiable information.

23 “(B) A certified service provider may retain the records if the registered owner or lessee
24 consents to the retention. Consent under this subparagraph does not entitle the department
25 to obtain or use the records or the information contained in the records.

26 “(C) Monthly summaries of metered use by subject vehicles may be retained in VIN
27 summary reports by the department and certified service providers.

28 “(5) The department, in any agreement with a certified service provider, shall provide for
29 penalties if the certified service provider violates this section.

30 “SECTION 10. (1) On a date determined by the Department of Transportation under
31 section 8 of this 2013 Act, the registered owner or lessee of a subject vehicle shall report the
32 metered use by the subject vehicle, rounded up to the next whole mile, and pay to the de-
33 partment the per-mile road usage charge due under section 3 of this 2013 Act for the re-
34 porting period.

35 “(2) Unless a registered owner or lessee presents evidence in a manner approved by the
36 department by rule that the subject vehicle has been driven outside this state, the depart-
37 ment shall assume that all metered use reported represents miles driven by the subject ve-
38 hicle on the highways in Oregon.

39
40 “REFUNDS AND EXEMPTIONS

41
42 “SECTION 11. (1) The Department of Transportation shall provide a refund to a regis-
43 tered owner or lessee that has overpaid the per-mile road usage charge imposed under sec-
44 tion 3 of this 2013 Act.

45 “(2) The department may provide by rule that the refund under this section be granted

1 as a credit against future per-mile road usage charges incurred by the registered owner or
2 lessee.

3 **“SECTION 12.** (1) A registered owner or lessee that has paid the per-mile road usage
4 charge imposed under section 3 of this 2013 Act may apply to the Department of Transpor-
5 tation for a refund for metered use of a road, thoroughfare or property in private ownership.

6 **“(2)** An application for a refund under this section must be submitted to the department
7 within 15 months after the date on which the per-mile road usage charge for which a refund
8 is claimed is paid.

9 **“(3)** The application required under this section shall be in a form prescribed by the de-
10 partment by rule and must include a signed statement by the applicant indicating the num-
11 ber of miles for which the refund is claimed.

12 **“(4)** The department may require the applicant for a refund under this section to furnish
13 any information the department considers necessary for processing the application.

14 **“SECTION 13.** (1) The Department of Transportation may investigate a refund application
15 submitted under section 12 of this 2013 Act and gather and compile such information related
16 to the application as the department considers necessary to safeguard the state and prevent
17 fraudulent practices in connection with tax refunds and tax evasion.

18 **“(2)** The department may, in order to establish the validity of an application, examine the
19 relevant records of the applicant for such purposes.

20 **“(3)** If an applicant does not permit the department to examine the relevant records, the
21 applicant waives all rights to the refund to which the application relates.

22 **“SECTION 14.** (1) A person may not intentionally make a false statement in a report or
23 refund application or when supplying other information required under section 10 or 12 of
24 this 2013 Act.

25 **“(2)** A person may not intentionally apply for, receive or attempt to receive a refund
26 under section 11 or 12 of this 2013 Act to which the person is not entitled.

27 **“(3)** A person may not intentionally aid or assist another person to violate any provision
28 of section 10, 11 or 12 of this 2013 Act.

29 **“(4)** A person who violates any provision of this section commits a Class A violation.

30 **“SECTION 15.** (1) Upon application on a form prescribed by the Department of Trans-
31 portation, the department shall issue an emblem to the registered owner of a subject vehicle
32 to show that the use of fuel in the subject vehicle is exempt from taxation under ORS 319.510
33 to 319.880.

34 **“(2)** An emblem issued under this section shall be displayed:

35 **“(a)** In a conspicuous place on the subject vehicle; and

36 **“(b)** Only upon the subject vehicle with respect to which it is issued.

37 **“SECTION 16.** ORS 319.550 is amended to read:

38 **“319.550.** (1) **Except as provided in this section,** a person may not use fuel in a motor vehicle
39 in this state unless the person holds a valid user’s license.[*except that:*]

40 **“[(1)] (2)** A nonresident may use fuel in a motor vehicle not registered in Oregon for a period
41 not exceeding 30 days without obtaining a user’s license or the emblem [*provided in*] **issued under**
42 **ORS 319.600,** if, for all fuel used in a motor vehicle in this state, the nonresident pays to a seller,
43 at the time of the sale, the tax provided in ORS 319.530.

44 **“[(2)] (3)** A user’s license is not required for a person who uses fuel in a motor vehicle with a
45 combined weight of 26,000 pounds or less if, for all fuel used in a motor vehicle in this state, the

1 person pays to a seller, at the time of the sale, the tax provided in ORS 319.530.

2 “[3] (4)(a) A user’s license is not required for a person who uses fuel as described in ORS
3 319.520 (7) in the vehicles specified in [subsection (4) of this section] **this subsection** if the person
4 pays to a seller, at the time of the sale, the tax provided in ORS 319.530.

5 “[4] (b) [Subsection (3) of this section] **Paragraph (a) of this subsection** applies to the fol-
6 lowing vehicles:

7 “[a] (A) Motor homes as defined in ORS 801.350.

8 “[b] (B) Recreational vehicles as defined in ORS 446.003.

9 **“(5) A user’s license is not required for a person who uses fuel in a motor vehicle:**

10 **“(a) Metered use by which is subject to the per-mile road usage charge imposed under**
11 **section 3 of this 2013 Act; and**

12 **“(b) That also uses fuels subject to ORS 319.510 to 319.880.**

13 **“SECTION 17.** ORS 319.665 is amended to read:

14 “319.665. (1) The seller of fuel for use in a motor vehicle shall collect the tax provided by ORS
15 319.530 at the time the fuel is sold, unless one of the following situations applies:

16 “(a) The vehicle into which the seller delivers or places the fuel bears a valid permit or user’s
17 emblem issued by the Department of Transportation.

18 “(b) The fuel is dispensed at a nonretail facility, in which case the seller shall collect any tax
19 owed at the same time the seller collects the purchase price from the person to whom the fuel was
20 dispensed at the nonretail facility. A seller is not required to collect the tax under this paragraph
21 from a person who certifies to the seller that the use of the fuel is exempt from the tax imposed
22 under ORS 319.530.

23 “(c) A cardlock card is used for purchase of the fuel at an attended portion of a retail facility
24 equipped with a cardlock card reader, in which case the cardlock card issuer licensed in this state
25 is responsible for collecting and remitting the tax unless the person making the purchase certifies
26 to the seller that the use of the fuel is exempt from the tax imposed under ORS 319.530.

27 **“(d) Metered use by the vehicle is subject to the per-mile road usage charge imposed**
28 **under section 3 of this 2013 Act.**

29 “(2) If a cardlock card is used for purchase of fuel at an attended portion of a retail facility
30 equipped with a cardlock card reader, the seller at the retail facility may deduct fuel purchases
31 made with a cardlock card from the seller’s retail transactions if the seller provides the department
32 with the following information:

33 “(a) A monthly statement from a cardlock card issuer that details the cardlock card purchases
34 at the retail facility; and

35 “(b) A listing of cardlock card issuers and gallons of fuel purchased at the retail facility by the
36 issuers’ customers.

37 “(3) The department shall supply each seller of fuel for use in a motor vehicle with a chart
38 which sets forth the tax imposed on given quantities of fuel.

39 **“SECTION 18.** ORS 319.831 is amended to read:

40 “319.831. (1) If a user obtains fuel for use in a motor vehicle in this state and pays the use fuel
41 tax on the fuel obtained, the user may apply for a refund of that part of the use fuel tax paid which
42 is applicable to use of the fuel to propel a motor vehicle:

43 “(a) In another state, if the user pays to the other state an additional tax on the same fuel;

44 “(b) Upon any road, thoroughfare or property in private ownership;

45 “(c) Upon any road, thoroughfare or property, other than a state highway, county road or city

1 street, for the removal of forest products, as defined in ORS 321.005, or the products of such forest
2 products converted to a form other than logs at or near the harvesting site, or for the construction
3 or maintenance of the road, thoroughfare or property, pursuant to a written agreement or permit
4 authorizing the use, construction or maintenance of the road, thoroughfare or property, with or by:

5 “(A) An agency of the United States;

6 “(B) The State Board of Forestry;

7 “(C) The State Forester; or

8 “(D) A licensee of an agency named in subparagraph (A), (B) or (C) of this paragraph;

9 “(d) By an agency of the United States or of this state or of any county, city or port of this state
10 on any road, thoroughfare or property, other than a state highway, county road or city street;

11 “(e) By any incorporated city or town of this state;

12 “(f) By any county of this state or by any road assessment district formed under ORS 371.405
13 to 371.535;

14 “(g) Upon any county road for the removal of forest products as defined in ORS 321.005, or the
15 products of such forest products converted to a form other than logs at or near the harvesting site,
16 if:

17 “(A) Such use upon the county road is pursuant to a written agreement entered into with, or
18 to a permit issued by, the State Board of Forestry, the State Forester or an agency of the United
19 States, authorizing such user to use such road and requiring such user to pay for or to perform the
20 construction or maintenance of the county road;

21 “(B) The board, officer or agency that entered into the agreement or granted the permit, by
22 contract with the county court or board of county commissioners, has assumed the responsibility for
23 the construction or maintenance of such county road; and

24 “(C) Copies of the agreements or permits required by subparagraphs (A) and (B) of this para-
25 graph are filed with the Department of Transportation;

26 “(h) By a school district or education service district of this state or the contractors of a school
27 district or education service district, for those vehicles being used to transport students;

28 “(i) By a rural fire protection district organized under the provisions of ORS chapter 478;

29 “(j) By any district, as defined in ORS chapter 198, that is not otherwise specifically provided
30 for in this section; or

31 “(k) By any state agency, as defined in ORS 240.855.

32 “(L) **In metered use subject to the per-mile road usage charge imposed under section 3**
33 **of this 2013 Act if the user has paid the charge.**

34 “(2) An application for a refund under subsection (1) of this section shall be filed with the de-
35 partment within 15 months after the date the use fuel tax, for which a refund is claimed, is paid.

36 “(3) The application for a refund provided by subsection (1) of this section shall include a signed
37 statement by the applicant indicating the amount of fuel for which a refund is claimed, and the way
38 in which the fuel was used which qualifies the applicant for a refund. If the fuel upon which the
39 refund is claimed was obtained from a seller to whom the use fuel tax was paid, the application shall
40 be supported by the invoices which cover the purchase of the fuel. If the applicant paid the use fuel
41 tax directly to the department, the applicant shall indicate the source of the fuel and the date it
42 was obtained.

43 “(4) The department may require any person who applies for a refund provided by subsection (1)
44 of this section to furnish a statement, under oath, giving the person’s occupation, description of the
45 machines or equipment in which the fuel was used, the place where used and such other information

1 as the department may require.

2 **“(5) The department may provide by rule that a refund under subsection (1)(L) of this**
3 **section be granted as a credit against future per-mile road usage charges incurred by the**
4 **applicant under section 3 of this 2013 Act.**

5 **“SECTION 19.** ORS 319.280 is amended to read:

6 **“319.280. (1)** Any person who has paid any tax on motor vehicle fuel levied or directed to be paid
7 by ORS 319.010 to 319.430 either directly by the collection of the tax by the vendor from the con-
8 sumer, or indirectly by adding the amount of the tax to the price of the fuel and paid by the con-
9 sumer, shall be reimbursed and repaid the amount of such tax paid, except as provided in ORS
10 319.290 to 319.330, if such person has:

11 **“(a)** Purchased and used such fuel for the purpose of operating or propelling a stationary gas
12 engine, a tractor or a motor boat, if the motor boat is used for commercial purposes at any time
13 during the period for which the refund is claimed;

14 **“(b)** Purchased and used such fuel for cleaning or dyeing or other commercial use, except when
15 used in motor vehicles operated upon any highway;

16 **“(c)** Purchased and exported such fuel from this state, in containers other than fuel supply tanks
17 of motor vehicles, provided that the person:

18 **“(A)** Exports the motor vehicle fuel from this state to another state, territory or country, not
19 including a federally recognized Indian reservation located wholly or partially within the borders
20 of this state, where the motor vehicle fuel is unloaded; and

21 **“(B)** Has a valid motor vehicle fuel dealer’s license or its equivalent issued by the state, terri-
22 tory or country to which the fuel is exported and where it is unloaded;

23 **“(d)** Purchased and exported such fuel in the fuel supply tank of a motor vehicle and has used
24 such fuel to operate the vehicle upon the highways of another state, if the user has paid to the other
25 state a similar motor vehicle fuel tax on the same fuel, or has paid any other highway use tax the
26 rate for which is increased because such fuel was not purchased in, and the tax thereon paid, to
27 such state; [*or*]

28 **“(e)** Purchased and used such fuel for small engines that are not used to propel motor vehicles
29 on highways, including but not limited to those that power lawn mowers, leaf blowers, chain saws
30 and similar implements[.]; **or**

31 **“(f) Purchased and used such fuel for operating a motor vehicle the metered use of which**
32 **is subject to the per-mile road usage charge imposed under section 3 of this 2013 Act, if the**
33 **person has paid the charge.**

34 **“(2)** When a motor vehicle with auxiliary equipment uses fuel and there is no auxiliary motor
35 for such equipment or separate tank for such a motor, a refund may be claimed and allowed as
36 provided by subsection [(4)] (5) of this section, except as otherwise provided by this subsection,
37 without the necessity of furnishing proof of the amount of fuel used in the operation of the auxiliary
38 equipment. The person claiming the refund may present to the Department of Transportation a
39 statement of the claim and be allowed a refund as follows:

40 **“(a)** For fuel used in pumping aircraft fuel, motor vehicle fuel, fuel or heating oils or other pe-
41 troleum products by a power take-off unit on a delivery truck, refund shall be allowed claimant for
42 tax paid on fuel purchased at the rate of three-fourths of one gallon for each 1,000 gallons of pe-
43 troleum products delivered.

44 **“(b)** For fuel used in operating a power take-off unit on a cement mixer truck or on a garbage
45 truck, claimant shall be allowed a refund of 25 percent of the tax paid on all fuel used in such a

1 truck.

2 “(3) When a person purchases and uses motor vehicle fuel in a vehicle equipped with a power
3 take-off unit, a refund may be claimed for fuel used to operate the power take-off unit provided the
4 vehicle is equipped with a metering device approved by the department and designed to operate only
5 while the vehicle is stationary and the parking brake is engaged; the quantity of fuel measured by
6 the metering device shall be presumed to be the quantity of fuel consumed by the operation of the
7 power take-off unit.

8 “(4)(a) **The department may provide by rule that a refund under subsection (1)(f) of this
9 section be granted as a credit against future per-mile road usage charges incurred by the
10 person under section 3 of this 2013 Act.**

11 “(b)(A) **The department may provide by rule for refund thresholds that are met by ag-
12 gregating refund amounts or by estimating motor vehicle fuel tax refunds by vehicle type,
13 at the option of the person claiming the refund.**

14 “(B) **If the person claiming the refund opts for an estimated refund based on vehicle type,
15 the requirement under subsection (5) of this section that the person claiming the refund
16 must present original invoices or reasonable facsimiles showing motor vehicle fuel purchases
17 does not apply.**

18 “[~~(4)~~] (5) Before any such refund may be granted, the person claiming such refund must present
19 to the department a statement, accompanied by the original invoices, or reasonable facsimiles ap-
20 proved by the department, showing such purchases; provided that in lieu of original invoices or
21 facsimiles, refunds submitted under subsection (1)(d) of this section shall be accompanied by infor-
22 mation showing source of the fuel used and evidence of payment of tax to the state in which the fuel
23 was used. The statement shall be made over the signature of the claimant, and shall state the total
24 amount of such fuel for which the claimant is entitled to be reimbursed under subsection (1) of this
25 section. The department upon the presentation of the statement and invoices or facsimiles, or other
26 required documents, shall cause to be repaid to the claimant from the taxes collected on motor ve-
27 hicle fuel such taxes so paid by the claimant.

28
29 **“PENALTIES**

30
31 **“SECTION 20. Section 21 of this 2013 Act is added to and made a part of the Oregon
32 Vehicle Code.**

33 **“SECTION 21. (1) A person commits the offense of tampering with a vehicle metering
34 system if the person:**

35 **“(a) With the intent to defraud, operates a motor vehicle that is subject to the per-mile
36 road usage charge imposed under section 3 of this 2013 Act on a highway knowing that the
37 vehicle metering system is disconnected or nonfunctional.**

38 **“(b) Replaces, disconnects or resets the vehicle metering system of a motor vehicle that
39 is subject to the per-mile road usage charge imposed under section 3 of this 2013 Act with
40 the intent of reducing the metered use recorded by the vehicle metering system.**

41 **“(2) This section does not apply to a person who is servicing, repairing or replacing a
42 vehicle metering system.**

43 **“(3) As used in this section, ‘vehicle metering system’ means a system used to record the
44 metered use by a motor vehicle for the purpose of complying with the reporting require-
45 ments under section 10 of this 2013 Act.**

1 “(4) Tampering with a vehicle metering system is a Class A traffic violation.

9 “(b) All moneys and revenues accruing from the licensing of motor vehicles, operators and
10 chauffeurs.

13 (2)(a) that become part of the Department of Transportation Operating Fund.

20 “(2) The **State** Highway Fund shall be deemed and held as a trust fund, separate and distinct
21 from the General Fund, and may be used only for the purposes authorized by law and is continually
22 appropriated for such purposes.

23 “(3) Moneys in the State Highway Fund may be invested as provided in ORS 293.701 to 293.820.
24 All interest earnings on any of the funds designated in subsection (1) of this section shall be placed
25 to the credit of the highway fund.

26 “**SECTION 23.** ORS 367.802 is amended to read:

27 “367.802. As used in ORS 367.800 to 367.824:

28 “(1) ‘Agreement’ means a written agreement, including but not limited to a contract, for a
29 transportation project that is entered into under ORS 367.806.

30 “(2) ‘Private entity’ means any entity that is not a unit of government, including but not limited
31 to a corporation, partnership, company, nonprofit organization or other legal entity or a natural
32 person.

33 “(3) ‘Transportation project’ or ‘project’ means any proposed or existing undertaking that facil-

35 “(a) Any mode of transportation in this state [*or that facilitates*];

36 “(b) The collection of taxes and fees as an alternative to the motor vehicle fuel taxes imposed

38 “**(c) The collection of the per-mile road usage charge imposed under section 3 of this 2013**
39 **Act.**

40 “(4) ‘Unit of government’ means any department or agency of the federal government, any state

43 approved charter and any intergovernmental entity created under ORS 190.003 to 190.130, 190.410
44 to 190.440 or 190.480 to 190.490.

45 “**SECTION 24.** ORS 367.804 is amended to read:

1 “367.804. (1) The Department of Transportation shall establish the Oregon Innovative Partner-
2 ships Program for the planning, acquisition, financing, development, design, construction, recon-
3 struction, replacement, improvement, maintenance, management, repair, leasing and operation of
4 transportation projects.

5 “(2) The goals of the **Oregon Innovative Partnerships** Program are to:

6 “(a) Develop an expedited project delivery process;

7 “(b) Maximize innovation; and

8 “(c) Develop partnerships with private entities and units of government.

9 “(3) As part of the program established under this section[,]:

10 “(a) The department may:

11 “[*a*] (A) Solicit concepts or proposals for transportation projects from private entities and units
12 of government.

13 “[*b*] (B) Accept unsolicited concepts or proposals for transportation projects from private en-
14 tities and units of government.

15 “[*c*] (C) Evaluate the concepts or proposals received under this subsection and select potential

1 portation projects, consider any financing mechanisms, including but not limited to the imposition
2 and collection of franchise fees or user fees and the development or use of other revenue sources.

3 “(8) The department and any other unit of government may expend, out of any funds available
4 for the purpose, such moneys as may be necessary for the evaluation of concepts or proposals for
5 transportation projects and for negotiating agreements for transportation projects under ORS
6 367.806. The department or other unit of government may employ engineers, consultants or other
7 experts the department or other unit of government determines are needed for the purposes of doing
8 the evaluation and negotiation. Expenses incurred by the department or other unit of government

22 units of government. The subject of agreements entered into under this section may include, but

26 “(b) Include in any agreement entered into under this section any financing mechanisms, in-

4 “[3] (4) The department may, either separately or in combination with any other unit of gov-
5 ernment, enter into working agreements, coordination agreements or similar implementation agree-
6 ments to carry out the joint implementation of any transportation project selected under ORS
7 367.804.

8 “[4] (5) Except for ORS 383.015, 383.017 (1), (2), (3) and (5) and 383.019, the provisions of ORS
9 383.003 to 383.075 apply to any tollway project entered into under ORS 367.800 to 367.824.

10 “[5] (6) The provisions of ORS 279.835 to 279.855 and ORS chapters 279A, 279B and 279C do
11 not apply to concepts or proposals submitted under ORS 367.804, or to agreements entered into un-
12 der this section, except that if public moneys are used to pay any costs of construction of public
13 works that is part of a project, the provisions of ORS 279C.800 to 279C.870 apply to the public
14 works. In addition, if public moneys are used to pay any costs of construction of public works that
15 is part of a project, the construction contract for the public works must contain provisions that re-
16 quire the payment of workers under the contract in accordance with ORS 279C.540 and 279C.800 to
17 279C.870.

18 “[6](a) (7)(a) The department may not enter into an agreement under this section until the
19 agreement is reviewed and approved by the Oregon Transportation Commission.

20 “(b) The department may not enter into, and the commission may not approve, an agreement
21 under this section for the construction of a public improvement as part of a transportation project
22 unless the agreement provides for bonding, financial guarantees, deposits or the posting of other
23 security to secure the payment of laborers, subcontractors and suppliers who perform work or pro-

41 “(a) ‘Public improvement’ has the meaning given that term in ORS 279A.010.

42 “(b) ‘Public works’ has the meaning given that term in ORS 279C.800.

43 “**SECTION 26.** ORS 305.410 is amended to read:

44 “305.410. (1) Subject only to the provisions of ORS 305.445 relating to judicial review by the
45 Supreme Court and to subsection (2) of this section, the tax court shall be the sole, exclusive and

1 final judicial authority for the hearing and determination of all questions of law and fact arising
2 under the tax laws of this state. For the purposes of this section, and except to the extent that they
3 preclude the imposition of other taxes, the following are not tax laws of this state:

4 “(a) ORS chapter 577 relating to Oregon Beef Council contributions.

5 “(b) ORS 576.051 to 576.455 relating to commodity commission assessments.

6 “(c) ORS chapter 477 relating to fire protection assessments.

7 “(d) ORS chapters 731, 732, 733, 734, 737, 742, 743, 743A, 744, 746, 748 and 750 relating to in-
8 surance company fees and taxes.

9 “(e) ORS chapter 473 relating to liquor taxes.

10 “(f) ORS chapter 583 relating to milk marketing, production or distribution fees.

11 “(g) ORS chapter 825 relating to motor carrier taxes.

12 “(h) ORS chapter 319 relating to motor vehicle and aircraft fuel taxes **and the road usage**
13 **charges imposed under section 3 of this 2013 Act.**

14 “(i) ORS title 59 relating to motor vehicle and motor vehicle operators’ license fees and ORS
15 title 39 relating to boat licenses.

16 “(j) ORS chapter 578 relating to Oregon Wheat Commission assessments.

17 “(k) ORS chapter 462 relating to racing taxes.

18 “(L) ORS chapter 657 relating to unemployment insurance taxes.

19 “(m) ORS chapter 656 relating to workers’ compensation contributions, assessments or fees.

20 “(n) ORS 311.420, 311.425, 311.455, 311.650, 311.655 and ORS chapter 312 relating to foreclosure
21 of real and personal property tax liens.

22 “(o) Sections 15 to 22, 24 and 29, chapter 736, Oregon Laws 2003, relating to long term care

24 “(2) The tax court and the circuit courts shall have concurrent jurisdiction to try actions or
25 suits to determine:

26 “(a) The priority of property tax liens in relation to other liens.

27 “(b) The validity of any deed, conveyance, transfer or assignment of real or personal property
28 under ORS 95.060 and 95.070 (1983 Replacement Part) or 95.200 to 95.310 where the Department of
29 Revenue has or claims a lien or other interest in the property.

30 “(3) Subject only to the provisions of ORS 305.445 relating to judicial review by the Supreme
31 Court, the tax court shall be the sole, exclusive and final judicial authority for the hearing and de-
32 termination of all questions of law and fact concerning the authorized uses of the proceeds of bonded

40 **“SECTION 27. (1) Sections 3 to 5, 10 to 15 and 21 of this 2013 Act and the amendments**
41 **to ORS 319.280, 319.550, 319.665, 319.831 and 366.505 by sections 16 to 19 and 22 of this 2013**
42 **Act become operative on July 1, 2015.**

43 **“(2) The Department of Transportation may take any action before the operative date**
44 **specified in subsection (1) of this section that is necessary to enable the department to ex-**
45 **ercise, on and after the operative date specified in subsection (1) of this section, all the du-**

1 ties, functions and powers conferred on the department by sections 2 to 15 and 21 of this 2013
2 Act and the amendments to ORS 319.280, 319.550, 319.665, 319.831 and 366.505 by sections 16
3 to 19 and 22 of this 2013 Act.

4 “SECTION 28. The unit captions used in this 2013 Act are provided only for the conven-
5 ience of the reader and do not become part of the statutory law of this state or express any
6 legislative intent in the enactment of this 2013 Act.

8 “MULTIJURISDICTIONAL AGREEMENTS
9

10 “SECTION 29. The Department of Transportation may enter into agreements with other
11 state departments of transportation, the federal government and Canadian provinces for the
12 purposes of:

13 “(1) Conducting joint research relating to road usage charges and development programs
14 on a multistate basis;

15 “(2) Furthering the development and operation of single state or multistate road usage
16 charge pilot programs;

17 “(3) Sharing costs incurred in conducting the research described in subsection (1) of this
18 section; and

19 “(4) Developing a program for stakeholder outreach and communications with respect to
20 road usage charges.

21 “SECTION 30. For the biennium beginning July 1, 2013, expenditures by the Department
22 of Transportation from funds received from other states, the federal government, Canadian
23 provinces or the government of Canada for the purposes described in section 29 of this 2013
24 Act are not limited.
