SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Agricultural Experiment Station Fermentation Sciences and Value Added Program at Oregon State University.

Appropriates moneys from General Fund to **Oregon Department of Administrative Services for allocation to Oregon University System** for operation of program.

Declares emergency, effective July 1, 2013.

A BILL FOR AN ACT

2 Relating to research programs; appropriating money; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Agricultural Experiment Station Fermentation Sciences and Value**
5 **Added Program is established at Oregon State University for the purpose of providing**
6 **science-based research and innovation in support of Oregon's rapidly growing value-added**
7 **wine, cheese, microbrew, distilled spirits and artisan bread industries.**

8 **(2) Oregon State University shall collaborate with related workforce development and**
9 **outreach programs at Umpqua Community College, Chemeketa Community College and other**
10 **Oregon community colleges and high schools offering such programs.**

11 **SECTION 2. There is appropriated to the Oregon Department of Administrative Services,**
12 **for allocation to the Oregon University System, for the biennium beginning July 1, 2013, out**
13 **of the General Fund, the amount of \$2,500,000 to be distributed to Oregon State University**
14 **for the purpose of carrying out the provisions of section 1 of this 2013 Act.**

15 **SECTION 3. This 2013 Act being necessary for the immediate preservation of the public**
16 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
17 **on July 1, 2013.**
