SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows landlord to require tenants to maintain renter's liability insurance. Describes circumstances in which landlord may consider whether applicant has been arrested for, charged with or convicted of crime, or involved in action to recover possession of real property. Allows landlord to charge fee described in rental agreement when, contrary to written rules or policies, tenant keeps on premises pet capable of causing damage to persons or property.

4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. ORS 90.367 and sections 2 and 3 of this 2013 Act are added to and made a
6	part of ORS 90.100 to 90.465.
7	SECTION 2. (1) A landlord may require a tenant to obtain and maintain renter's liability
8	insurance in a written rental agreement. The amount of coverage may not exceed \$100,000
9	per occurrence or the customary amount required by landlords for similar properties with
10	similar rents in the same rental market, whichever is greater.
11	(2) Before entering a new tenancy, a landlord:
12	(a) Shall advise an applicant in writing of a requirement to obtain and maintain renter's
13	liability insurance and the amount of insurance required.
14	(b) May require an applicant to provide documentation of renter's liability insurance
15	coverage before the tenancy begins.
16	(3) For an existing month-to-month tenancy, the landlord may amend a written rental
17	agreement to require renter's liability insurance after giving the tenant at least 30 days'
18	written notice of the requirement. If the tenant does not obtain renter's liability insurance
19	within the 30-day period:
20	(a) The landlord may terminate the tenancy pursuant to ORS 90.392; and
21	(b) The tenant may cure the cause of the termination as provided by ORS 90.392 by ob-
22	taining insurance.
23	(4) A landlord may require documentation that the tenant maintains the renter's liability
24	insurance on a periodic basis related to the coverage period of the renter's liability insurance
25	policy or more frequently if the landlord reasonably believes that the insurance policy is no

1 longer in effect.

(5) A landlord may require that a tenant obtain or maintain renter's liability insurance only if the landlord obtains and maintains comparable liability insurance and provides documentation to any tenant who requests the documentation, orally or in writing. The landlord may provide documentation to a tenant in person, by mail or by posting in a common area or office. The documentation may consist of a current certificate of coverage. A written rental agreement that requires a tenant to obtain and maintain renter's liability insurance must include a description of the requirements of this subsection.

9 (6) Neither a landlord nor a tenant shall make unreasonable demands that have the effect 10 of harassing the other with regard to providing documentation of insurance coverage.

(7) A landlord may not:

12 (a) Require that a tenant obtain renter's liability insurance from a particular insurer;

(b) Require that a tenant name the landlord as an additional insured or as having any
 other special status on the tenant's renter's liability insurance policy;

15 (c) Require that a tenant waive the insurer's subrogation rights; or

16 (d) Make a claim against the tenant's renter's liability insurance unless:

(A) The claim is for damages or costs for which the tenant is legally liable and not for
damages or costs that result from ordinary wear and tear, acts of God or the conduct of the
landlord;

20 (B) The claim is greater than the security deposit of the tenant, if any; and

(C) The landlord provides a copy of the claim to the tenant contemporaneous with filing
 the claim with the insurer.

(8) A landlord may not require a tenant to obtain or maintain renter's liability insurance
if the household income of the tenant is equal to or less than 50 percent of the area median
income, adjusted for family size as measured up to a five-person family, as determined by the
State Housing Council based on information from the United States Department of Housing
and Urban Development.

(9) A landlord may not require a tenant to obtain or maintain renter's liability insurance
if the dwelling unit of the tenant has been subsidized with public funds:

(a) Including federal or state tax credits, federal block grants authorized in the HOME
Investment Partnerships Act under Title II of the Cranston-Gonzalez National Affordable
Housing Act, as amended, or the Community Development Block Grant program authorized
in the Housing and Community Development Act of 1974, as amended, and tax-exempt bonds.
(b) Not including federal rent subsidy payments under 42 U.S.C. 1437f.

35 (10) Subsection (9) of this section does not apply to a dwelling unit that is not subsidized

even if the unit is on premises in which some dwelling units are subsidized.

(11) If a landlord files a frivolous claim against the renter's liability insurance of a ten ant, the tenant may recover from the landlord the actual damages of the tenant plus \$500.

39 (12) This section does not:

40 (a) Affect rights or obligations otherwise provided in this chapter or in the rental 41 agreement.

42 (b) Apply to tenancies governed by ORS 90.505 to 90.840.

43 <u>SECTION 3.</u> (1) When evaluating an applicant, a landlord may not consider an action to 44 recover possession pursuant to ORS 105.105 to 105.168 if the action:

45 (a) Was dismissed or resulted in a general judgment for the applicant before the applicant

submits the application. This paragraph does not apply if the action has not resulted in a
 dismissal or general judgment at the time the applicant submits the application.

3 (b) Resulted in a general judgment against the applicant that was entered five or more
4 years before the applicant submits the application.

5 (2) When evaluating the applicant, a landlord may not consider a previous arrest of the 6 applicant if the arrest did not result in a conviction. This subsection does not apply if the 7 arrest has resulted in charges for criminal behavior as described in subsection (3) of this 8 section that have not been dismissed at the time the applicant submits the application.

9 (3) When evaluating the applicant, the landlord may consider criminal conviction and 10 charging history if the conviction or pending charge is for conduct that is:

- 11 (a) A drug-related crime;
- 12 (b) A person crime;

13 (c) A sex offense;

14 (d) A crime involving financial fraud, including identity theft and forgery; or

15 (e) Any other crime if the conduct for which the applicant was convicted or charged is

(B) The health, safety or right to peaceful enjoyment of the premises of residents, the
 landlord or the landlord's agent.

20 **SECTION 4.** ORS 90.160 is amended to read:

90.160. (1) Notwithstanding ORCP 10 and not including the seven-day and four-day waiting periods provided in ORS 90.394, where there are references in this chapter to periods and notices based on a number of days, those days shall be calculated by consecutive calendar days, not including the initial day of service, but including the last day until [*midnight*] **the end** of that last day **at 12 midnight**. Where there are references in this chapter to periods or notices based on a number of hours, those hours shall be calculated in consecutive clock hours, beginning immediately upon service.

SECTION 5. ORS 90.275 is amended to read:

90.275. (1) As provided under this section, a landlord may allow an individual to become a temporary occupant of the tenant's dwelling unit [*as a guest of the tenant*]. To create a temporary occupancy, the landlord, tenant and proposed temporary occupant must enter into a written temporary occupancy agreement that describes the temporary occupancy relationship.

- 38 (2) The temporary occupant:
- 39 (a) Is not a tenant entitled to occupy the dwelling unit to the exclusion of others; and

40 (b) Does not have the rights of a tenant.

41 (3) The temporary occupancy agreement may be terminated by:

42 (a) The tenant without cause at any time; and

(b) The landlord only for cause that is a material violation of the temporary occupancy agree-ment.

45 (4) The temporary occupant does not have a right to cure a violation that causes a landlord to

1 terminate the temporary occupancy agreement.

2 (5) Before entering into a temporary occupancy agreement, a landlord may screen the proposed 3 temporary occupant for issues regarding conduct or for a criminal record. The landlord may not 4 screen the proposed temporary occupant for credit history or income level.

5 (6) A temporary occupancy agreement:

(a) Shall expressly include the requirements of subsections (2) to (4) of this section;

(b) May provide that the temporary occupant is required to comply with any applicable rules forthe premises; and

9 (c) May have a specific ending date.

(7) The landlord, tenant and temporary occupant may extend or renew a temporary occupancy
 agreement or may enter into a new temporary occupancy agreement.

(8) A landlord or tenant is not required to give the temporary occupant written notice of thetermination of a temporary occupancy agreement.

(9) The temporary occupant shall promptly vacate the dwelling unit if a landlord terminates a temporary occupancy agreement for material violation of the temporary occupancy agreement or if the temporary occupancy agreement ends by its terms. Except as provided in ORS 90.449, the landlord may terminate the tenancy of the tenant as provided under ORS 90.392 or 90.630 if the temporary occupant fails to promptly vacate the dwelling unit or if the tenant materially violates the temporary occupancy agreement.

(10) A temporary occupant shall be treated as a squatter if the temporary occupant continues to occupy the dwelling unit after a tenancy has ended or after the tenant revokes permission for the occupancy by terminating the temporary occupancy agreement.

(11)(a) A landlord may not enter into a temporary occupancy agreement for the purpose of
 evading landlord responsibilities under this chapter or to diminish the rights of an applicant or
 tenant under this chapter.

(b) A tenant may not become a temporary occupant in the tenant's own dwelling unit.

(c) A tenancy may not consist solely of a temporary occupancy. Each tenancy must have at leastone tenant.

29 SECTION 6. ORS 90.295 is amended to read:

90.295. (1) A landlord may require payment of an applicant screening charge solely to cover the costs of obtaining information about an applicant as the landlord processes the application for a rental agreement. This activity is known as screening, and includes but is not limited to checking references and obtaining a consumer credit report or tenant screening report. The landlord must provide the applicant with a receipt for any applicant screening charge.

(2) The amount of any applicant screening charge shall not be greater than the landlord's average actual cost of screening applicants. Actual costs may include the cost of using a tenant screening company or a consumer credit reporting agency, and may include the reasonable value of any time spent by the landlord or the landlord's agents in otherwise obtaining information on applicants. In any case, the applicant screening charge may not be greater than the customary amount charged by tenant screening companies or consumer credit reporting agencies for a comparable level of screening.

42 (3) A landlord may not require payment of an applicant screening charge unless prior to ac-43 cepting the payment the landlord:

44 (a) Adopts written screening or admission criteria;

45 (b) Gives written notice to the applicant of:

1 (A) The amount of the applicant screening charge;

2 (B) The landlord's screening or admission criteria;

3 (C) The process that the landlord typically will follow in screening the applicant, including 4 whether the landlord uses a tenant screening company, credit reports, public records or criminal 5 records or contacts employers, landlords or other references; and

6 (D) The applicant's rights to dispute the accuracy of any information provided to the landlord 7 by a screening company or credit reporting agency;

8 (c) Gives actual notice to the applicant of an estimate, made to the best of the landlord's ability 9 at that time, of the approximate number of rental units of the type, and in the area, sought by the 10 applicant that are, or within a reasonable future time will be, available to rent from that landlord. 11 The estimate shall include the approximate number of applications previously accepted and remain-12 ing under consideration for those units. A good faith error by a landlord in making an estimate 13 under this paragraph does not provide grounds for a claim under subsection (8) of this section; 14 [and]

(d) Gives written notice to the applicant of the amount of rent the landlord will charge and the deposits the landlord will require, subject to change in the rent or deposits by agreement of the landlord and the tenant before entering into a rental agreement; and

(e) Gives written notice to the applicant whether the landlord requires tenants to obtain
 and maintain renter's liability insurance and, if so, the amount of insurance required.

(4) Regardless of whether a landlord requires payment of an applicant screening charge, if a 20landlord denies an application for a rental agreement by an applicant and that denial is based in 2122whole or in part on a tenant screening company or consumer credit reporting agency report on that 23applicant, the landlord shall give the applicant actual notice of that fact at the same time that the landlord notifies the applicant of the denial. Unless written notice of the name and address of the 2425screening company or credit reporting agency has previously been given, the landlord shall promptly give written notice to the applicant of the name and address of the company or agency that provided 2627the report upon which the denial is based.

(5) Except as provided in subsection (4) of this section, a landlord need not disclose the results
of an applicant screening or report to an applicant, with respect to information that is not required
to be disclosed under the federal Fair Credit Reporting Act. A landlord may give to an applicant a
copy of that applicant's consumer report, as defined in the Fair Credit Reporting Act.

(6) Unless the applicant agrees otherwise in writing, a landlord may not require payment of an
applicant screening charge when the landlord knows or should know that no rental units are available at that time or will be available within a reasonable future time.

(7) If a landlord requires payment of an applicant screening charge but fills the vacant rental unit before screening the applicant or does not conduct a screening of the applicant for any reason, the landlord must refund the applicant screening charge to the applicant within a reasonable time.

(8) The applicant may recover from the landlord twice the amount of any applicant screening
 charge paid, plus \$150, if:

40 (a) The landlord fails to comply with this section and does not within a reasonable time accept
41 the applicant's application for a rental agreement; or

42 (b) The landlord does not conduct a screening of the applicant for any reason and fails to refund43 an applicant screening charge to the applicant within a reasonable time.

44 **SECTION 7.** ORS 90.300 is amended to read:

45 90.300. (1) As used in this section, "security deposit" includes any last month's rent deposit.

(2)(a) Except as otherwise provided in this section, a landlord may require a tenant to pay a 1 2 security deposit. The landlord shall provide the tenant with a receipt for any security deposit the tenant pays. The landlord shall hold a security deposit or prepaid rent for the tenant who is a party 3 to the rental agreement. A tenant's claim to the security deposit or prepaid rent is prior to the claim 4 of a creditor of the landlord, including a trustee in bankruptcy. 5

(b) Except as provided in ORS 86.755 (10), the holder of the landlord's interest in the premises 6 at the time the tenancy terminates is responsible to the tenant for any security deposit or prepaid 7 rent and is bound by this section. 8

9 (3) A written rental agreement, if any, must list a security deposit paid by a tenant or required 10 by a landlord.

(4) A landlord may not charge a tenant a pet security deposit for keeping a service animal or 11 12 companion animal that a tenant with a disability requires as a reasonable accommodation under fair 13 housing laws.

(5)(a) Except as otherwise provided in this subsection, a landlord may not change the rental 14 15agreement to require the tenant to pay a new or increased security deposit during the first year 16after the tenancy has begun. Subject to subsection (4) of this section, the landlord may require an additional deposit if the landlord and tenant agree to modify the terms and conditions of the rental 17 18 agreement to permit a pet or for other cause and the additional deposit relates to the modification. 19 This paragraph does not prevent a landlord from collecting a security deposit that an initial rental 20agreement provided for but that remained unpaid at the time the tenancy began.

(b) If a landlord requires a new or increased security deposit after the first year of the tenancy, 2122the landlord shall allow the tenant at least three months to pay the new or increased deposit.

23(6) The landlord may claim all or part of the security deposit only if the landlord required the security deposit for any or all of the purposes specified in subsection (7) of this section. 24

25(7)(a) The landlord may claim from the security deposit only the amount reasonably necessary:

(A) To remedy the tenant's defaults in the performance of the rental agreement including, but 2627not limited to, unpaid rent; and

(B) To repair damages to the premises caused by the tenant, not including ordinary wear and 2829tear.

30 (b) A landlord is not required to repair damage caused by the tenant in order for the landlord 31 to claim against the deposit for the cost to make the repair. Any labor costs the landlord assesses 32under this subsection for cleaning or repairs must be based on a reasonable hourly rate. 1 for which the tenant is responsible under this subsection if the cleaning or repairs are per-2 formed in a timely manner.

3 (8) A landlord may not require a tenant to pay or to forfeit a security deposit or prepaid rent 4 to the landlord for the tenant's failure to maintain a tenancy for a minimum number of months in 5 a month-to-month tenancy.

6 (9) The landlord must apply any last month's rent deposit to the rent due for the last month of 7 the tenancy:

8 (a) When either the landlord or the tenant gives to the other a notice of termination, pursuant
9 to this chapter, other than a notice of termination under ORS 90.394;

10 (b) When the landlord and tenant agree to terminate the tenancy; or

11 (c) When the tenancy terminates in accordance with the provisions of a written rental agree-12 ment for a term tenancy.

(10) A landlord shall account for and refund as provided in subsections (12) to (14) of this section any portion of a last month's rent deposit the landlord does not apply as provided under subsection (9) of this section. Unless the tenant and landlord agree otherwise, the tenant may not require the landlord to apply a last month's rent deposit to rent due for any period other than the last month of the tenancy. A last month's rent deposit does not limit the amount of rent charged unless a written rental agreement provides otherwise.

(11) When the tenancy terminates, a landlord shall account for and refund to the tenant, in the same manner this section requires for security deposits, the unused balance of any prepaid rent the landlord has not previously refunded to the tenant under ORS 90.380 and 105.120 (5)(b) or any other provision of this chapter. The landlord may claim from the remaining prepaid rent only the amount reasonably necessary to pay the tenant's unpaid rent.

(12) In order to claim all or part of any prepaid rent or security deposit, within 31 days after the tenancy terminates and the tenant delivers possession the landlord shall give to the tenant a written accounting that states specifically the basis or bases of the claim. The landlord shall give a separate accounting for security deposits and for prepaid rent.

(13) The landlord shall return to the tenant the security deposit or prepaid rent or the portion of the security deposit or prepaid rent that the landlord does not claim in the manner provided by subsections (11) and (12) of this section not later than 31 days after the tenancy terminates and the tenant delivers possession to the landlord.

(14) The landlord shall give the written accounting required under subsection (12) of this section
 or shall return the security deposit or prepaid rent as required by subsection (13) of this section by
 personal delivery or by first class mail.

(15) If a security deposit or prepaid rent secures a tenancy for a space for a manufactured dwelling or floating home the tenant owns and occupies, whether or not in a facility, and the dwelling or home is abandoned as described in ORS 90.425 (2) or 90.675 (2), the 31-day period described in subsections (12) and (13) of this section commences on the earliest of:

45 (16) If the landlord fails to comply with subsection (13) of this section or if the landlord in bad

2 under this chapter or the rental agreement, the tenant may recover the money due in an amount

(a) Withheld without a written accounting under subsection (12) of this section; or

5 (b) Withheld in bad faith.

6 (17)(a) A security deposit or prepaid rent in the possession of the landlord is not garnishable 7 property, as provided in ORS 18.618.

(b) If a landlord delivers a security deposit or prepaid rent to a garnishor in violation of ORS 8 9 18.618 (1)(b), the landlord that delivered the security deposit or prepaid rent to the garnishor shall allow the tenant at least 30 days after a copy of the garnishee response required by ORS 18.680 is 10 delivered to the tenant under ORS 18.690 to restore the security deposit or prepaid rent. If the 11 12 tenant fails to restore a security deposit or prepaid rent under the provisions of this paragraph be-13 fore the tenancy terminates, and the landlord retains no security deposit or prepaid rent from the tenant after the garnishment, the landlord is not required to refund or account for the security de-14 15 posit or prepaid rent under subsection (11) of this section.

18 **SECTION 8.** ORS 90.302 is amended to read:

90.302. (1) A landlord may not charge a fee at the beginning of the tenancy for an anticipated
landlord expense and may not require the payment of any fee except as provided in this section.
A fee must be described in a written rental agreement.

(2) A landlord may charge a tenant a fee for each occurrence of the following:

23 (a) A late rent payment, pursuant to ORS 90.260.

(b) A dishonored check, pursuant to ORS 30.701 (5). The amount of the fee may not exceed the amount described in ORS 30.701 (5) plus any amount that a bank has charged the landlord for processing the dishonored check.

(c) Removal or tampering with a properly functioning smoke alarm, smoke detector or carbon
monoxide alarm, as provided in ORS 90.325 (2). The landlord may charge a fee of up to \$250
unless the State Fire Marshal assesses the tenant a civil penalty for the conduct under ORS
479.990 or under ORS 105.836 to 105.842 and 476.725.

(d) The violation of a written pet agreement or of a rule relating to pets in a facility, pursuant
 to ORS 90.530.

(e) The abandonment or relinquishment of a dwelling unit during a fixed term tenancy without
cause. The fee may not exceed one and one-half times the monthly rent. A landlord may not assess
a fee under this paragraph if the abandonment or relinquishment is pursuant to ORS 90.453 (2),
90.472 or 90.475. If the landlord assesses a fee under this paragraph:

(3)(a) A landlord may charge a tenant a fee under this subsection for a second noncom-7 pliance or for a subsequent noncompliance with written rules or policies that describe the 8 9 prohibited conduct and the fee for a second noncompliance, and for any third or subsequent noncompliance, that occurs within one year after a written warning notice described in 10 subparagraph (A) of this paragraph. The fee may not exceed \$50 for the second noncompli-11 12 ance within one year after the warning notice for the same or a similar noncompliance or 13 \$50 plus five percent of the rent payment for the current rental period for a third or subsequent noncompliance within one year after the warning notice for the same or a similar 14 15 noncompliance. (15) The landlord is not responsible for any loss to the tenant, lienholder or owner resulting from storage of personal property in compliance with this section unless the loss was caused by the landlord's deliberate or negligent act. In the event of a deliberate and malicious violation, the landlord is liable for twice the actual damages sustained by the tenant, lienholder or owner.

(16) Complete compliance in good faith with this section shall constitute a complete defense in
any action brought by a tenant, lienholder or owner against a landlord for loss or damage to such
personal property disposed of pursuant to this section.

(17) If a landlord does not comply with this section:

(a) The tenant is relieved of any liability for damage to the premises caused by conduct that
was not deliberate, intentional or grossly negligent and for unpaid rent and may recover from the
landlord up to twice the actual damages sustained by the tenant;

(b) A lienholder or owner aggrieved by the noncompliance may recover from the landlord the actual damages sustained by the lienholder or owner. ORS 90.255 does not authorize an award of attorney fees to the prevailing party in any action arising under this paragraph; and

30 (c) A county tax collector aggrieved by the noncompliance may recover from the landlord the 31 actual damages sustained by the tax collector, if the noncompliance is part of an effort by the 32 landlord to defraud the tax collector. (18) In the case of an abandoned recreational vehicle, manufactured dwelling or floating home, the provisions of this section regarding the rights and responsibilities of a tenant to the abandoned vehicle, dwelling or home also apply to any lienholder except that the lienholder may not sell or remove the vehicle, dwelling or home unless:

(a) The lienholder has foreclosed its lien on the recreational vehicle, manufactured dwelling orfloating home;

(b) The tenant or a personal representative or designated person described in subsection (20)
of this section has waived all rights under this section pursuant to subsection (26) of this section;
or

43 (c) The notice and response periods provided by subsections (6) and (8) of this section have ex-44 pired.

45 (19)(a) In the case of an abandoned manufactured dwelling or floating home but not including

a dwelling or home abandoned following a termination pursuant to ORS 90.429 and except as provided by subsection (20)(d) and (e) of this section, if a lienholder makes a timely response to a notice of abandoned personal property pursuant to subsections (6) and (8) of this section and so requests, a landlord shall enter into a written storage agreement with the lienholder providing that the dwelling or home may not be sold or disposed of by the landlord for up to 12 months. A storage agreement entitles the lienholder to store the personal property on the previously rented space during the term of the agreement, but does not entitle anyone to occupy the personal property.

(2) A landlord [may not] is responsible for abandoned personal property and shall store, sell

6 (b) If there is no buyer at a sale described under paragraph (a) of this subsection, the personal 7 property is considered to be worth \$8,000 or less, regardless of current market value, and the land-8 lord shall destroy or otherwise dispose of the personal property.

9 (12) Notwithstanding ORS 446.155 (1) and (2), unless a landlord intentionally misrepresents the 10 condition of personal property, the landlord is not liable for the condition of the personal property 11 to:

(a) A buyer of the personal property at a sale pursuant to subsection (10)(a) of this section, with
 or without consideration; or

(b) A person or nonprofit organization to whom the landlord gives the personal property pursu ant to subsection (1)(b), (10)(b) or (11)(b) of this section.

16 (13)(a) The landlord may deduct from the proceeds of the sale:

17 (A) The reasonable or actual cost of notice, storage and sale; and

18 (B) Unpaid rent.

(b) After deducting the amounts listed in paragraph (a) of this subsection, the landlord shall
remit the remaining proceeds, if any, to the county tax collector to the extent of any unpaid property taxes and assessments owed on the dwelling or home.

(c) After deducting the amounts listed in paragraphs (a) and (b) of this subsection, if applicable,
the landlord shall remit the remaining proceeds, if any, to any lienholder to the extent of any unpaid
balance owed on the lien on the personal property.

(d) After deducting the amounts listed in paragraphs (a), (b) and (c) of this subsection, if applicable, the landlord shall remit to the tenant the remaining proceeds, if any, together with an itemized accounting.

(e) If the tenant cannot after due diligence be found, the landlord shall deposit the remaining
proceeds with the county treasurer of the county in which the sale occurred. If not claimed within
three years, the deposited proceeds revert to the general fund of the county and are available for
general purposes.

(14) The county tax collector shall cancel all unpaid property taxes and assessments as provided
 under ORS 311.790 only under one of the following circumstances:

(a) The landlord disposes of the personal property after a determination described in subsection
 (10)(b) of this section.

(b) There is no buyer of the personal property at a sale described under subsection (11) of this
 section.

(c)(A) There is a buyer of the personal property at a sale described under subsection (11) of this

40 (B) The current market value of the personal property is \$8,000 or less; and

41 (C) The proceeds of the sale are insufficient to satisfy the unpaid property taxes and assessments
42 owed on the personal property after distribution of the proceeds pursuant to subsection (13) of this

(d)(A) The landlord buys the personal property at a sale described under subsection (11) of this
 section;

(B) The current market value of the personal property is more than \$8,000; 1

2 (C) The proceeds of the sale are insufficient to satisfy the unpaid property taxes and assessments owed on the personal property after distribution of the proceeds pursuant to subsection (13) of this 3 4 section; and

5

(D) The landlord disposes of the personal property.

(15) The landlord is not responsible for any loss to the tenant or lienholder resulting from 6 7 storage of personal property in compliance with this section unless the loss was caused by the landlord's deliberate or negligent act. In the event of a deliberate and malicious violation, the 8 9 landlord is liable for twice the actual damages sustained by the tenant or lienholder.

(16) Complete compliance in good faith with this section shall constitute a complete defense in 10 any action brought by a tenant or lienholder against a landlord for loss or damage to such personal 11 12 property disposed of pursuant to this section.

13 (17) If a landlord does not comply with this section:

(a) The tenant is relieved of any liability for damage to the premises caused by conduct that 14 15 was not deliberate, intentional or grossly negligent and for unpaid rent and may recover from the landlord up to twice the actual damages sustained by the tenant; 16

(b) A lienholder aggrieved by the noncompliance may recover from the landlord the actual 17 18 damages sustained by the lienholder. ORS 90.255 does not authorize an award of attorney fees to the prevailing party in any action arising under this paragraph; and 19

20(c) A county tax collector aggrieved by the noncompliance may recover from the landlord the actual damages sustained by the tax collector, if the noncompliance is part of an effort by the 2122landlord to defraud the tax collector. ORS 90.255 does not authorize an award of attorney fees to 23the prevailing party in any action arising under this paragraph.

(18) The provisions of this section regarding the rights and responsibilities of a tenant to the 24 abandoned personal property also apply to any lienholder, except that the lienholder may not sell 25or remove the dwelling or home unless: 26

27

(a) The lienholder has foreclosed the lien on the manufactured dwelling or floating home;

(b) The tenant or a personal representative or designated person described in subsection (20) 28of this section has waived all rights under this section pursuant to subsection (22) of this section; 2930 or

31 (c) The notice and response periods provided by subsections (6) and (8) of this section have ex-32pired.

(19)(a) Except as provided by subsection (20)(d) and (e) of this section, if a lienholder makes a 33 34 timely response to a notice of abandoned personal property pursuant to subsections (6) and (8) of 35 this section and so requests, a landlord shall enter into a written storage agreement with the lienholder providing that the personal property may not be sold or disposed of by the landlord for 36 37 up to 12 months. A storage agreement entitles the lienholder to store the personal property on the 38 previously rented space during the term of the agreement, but does not entitle anyone to occupy the personal property. 39

40 (b) The lienholder's right to a storage agreement arises upon the failure of the tenant or, in the case of a deceased tenant, the personal representative, designated person, heir or devisee to remove 41 or sell the dwelling or home within the allotted time. 42

(c) To exercise the right to a storage agreement under this subsection, in addition to contacting 43 the landlord with a timely response as described in paragraph (a) of this subsection, the lienholder 44 must enter into the proposed storage agreement within 60 days after the landlord gives a copy of 45

the agreement to the lienholder. The landlord shall give a copy of the proposed storage agreement to the lienholder in the same manner as provided by subsection (4)(b) of this section. The landlord may include a copy of the proposed storage agreement with the notice of abandoned property required by subsection (4) of this section. A storage charge may include a utility or service charge, as described 12 in ORS 90.532, if limited to charges for electricity, water, sewer service and natural gas and if in-13 cidental to the storage of personal property. (B) The lienholder pay a late charge or fee for failure to pay a storage charge by the date required in the agreement, if the amount of the late charge is no greater than for late charges imposed
on facility tenants;

18 (C) The lienholder maintain the personal property and the space on which the personal property 19 is stored in a manner consistent with the rights and obligations described in the rental agreement 20 that the landlord currently provides to tenants as required by ORS 90.510 (4); and

(D) The lienholder repair any defects in the physical condition of the personal property that 2122existed prior to the lienholder entering into the storage agreement, if the defects and necessary re-23pairs are reasonably described in the storage agreement and, for homes that were first placed on the space within the previous 24 months, the repairs are reasonably consistent with facility stan-2425dards in effect at the time of placement. The lienholder shall have 90 days after entering into the storage agreement to make the repairs. Failure to make the repairs within the allotted time consti-2627tutes a violation of the storage agreement and the landlord may terminate the agreement by giving at least 14 days' written notice to the lienholder stating facts sufficient to notify the lienholder of 28the reason for termination. Unless the lienholder corrects the violation within the notice period, the 2930 agreement terminates as provided and the landlord may sell or dispose of the property without fur-31 ther notice to the lienholder.

(e) Notwithstanding subsection (7)(b) of this section, a landlord may increase the storage charge
if the increase is part of a facility-wide rent increase for all facility tenants, the increase is no
greater than the increase for other tenants and the landlord gives the lienholder written notice
consistent with the requirements of ORS 90.600 (1).

(f) During the term of an agreement described under this subsection, the lienholder has the right to remove or sell the property, subject to the provisions of the lien. Selling the property includes a sale to a purchaser who wishes to leave the property on the rented space and become a tenant, subject to the provisions of ORS 90.680. The landlord may condition approval for occupancy of any purchaser of the property upon payment of all unpaid storage charges and maintenance costs.

(g)(A) Except as provided in paragraph (d)(D) of this subsection, if the lienholder violates the storage agreement, the landlord may terminate the agreement by giving at least 90 days' written notice to the lienholder stating facts sufficient to notify the lienholder of the reason for the termination. Unless the lienholder corrects the violation within the notice period, the agreement terminates as provided and the landlord may sell or dispose of the property without further notice to the 1 lienholder.

(B) After a landlord gives a termination notice pursuant to subparagraph (A) of this paragraph for failure of the lienholder to pay a storage charge and the lienholder corrects the violation, if the lienholder again violates the storage agreement by failing to pay a subsequent storage charge, the landlord may terminate the agreement by giving at least 30 days' written notice to the lienholder stating facts sufficient to notify the lienholder of the reason for termination. Unless the lienholder corrects the violation within the notice period, the agreement terminates as provided and the landlord may sell or dispose of the property without further notice to the lienholder.

(a) The provisions of this section regarding the rights and responsibilities of a tenant to the
abandoned personal property shall apply to any personal representative named in a will or appointed
by a court to act for the deceased tenant or any person designated in writing by the tenant to be
contacted by the landlord in the event of the tenant's death.

(b) The notice required by subsection (3) of this section must be:

23 (A) Sent by first class mail to the deceased tenant at the premises; and

(B) Personally delivered or sent by first class mail to any personal representative or designated
 person if actually known to the landlord.

(c) The notice described in subsection (5) of this section must refer to any personal representative or designated person, instead of the deceased tenant, and must incorporate the provisions of

(d) If a personal representative, designated person or other person entitled to possession of the 2930 property, such as an heir or devisee, responds by actual notice to a landlord within the 45-day period 31 provided by subsection (6) of this section and so requests, the landlord shall enter into a written 32storage agreement with the representative or person providing that the personal property may not be sold or disposed of by the landlord for up to 90 days or until conclusion of any probate pro-33 34 ceedings, whichever is later. A storage agreement entitles the representative or person to store the 35 personal property on the previously rented space during the term of the agreement, but does not entitle anyone to occupy the personal property. If such an agreement is entered, the landlord may 36 37 not enter a similar agreement with a lienholder pursuant to subsection (19) of this section until the 38 agreement with the personal representative or designated person ends.

(e) If a personal representative or other person requests that a landlord enter into a storage
agreement, subsection (19)(c) to (e) and (g)(C) of this section applies, with the representative or
person having the rights and responsibilities of a lienholder with regard to the storage agreement.

(f) During the term of an agreement described under paragraph (d) of this subsection, the representative or person has the right to remove or sell the property, including a sale to a purchaser or a transfer to an heir or devisee where the purchaser, heir or devisee wishes to leave the property on the rented space and become a tenant, subject to the provisions of ORS 90.680. The landlord also

1 may condition approval for occupancy of any purchaser, heir or devisee of the property upon pay-2 ment of all unpaid storage charges and maintenance costs.

3 (g) If the representative or person violates the storage agreement, the landlord may terminate 4 the agreement by giving at least 30 days' written notice to the representative or person stating facts 5 sufficient to notify the representative or person of the reason for the termination. Unless the rep-6 resentative or person corrects the violation within the notice period, the agreement terminates as 7 provided and the landlord may sell or dispose of the property without further notice to the repre-8 sentative or person.

9 (1) "Accessory building or structure" means any portable, demountable or permanent structure,

(3) "Applicant screening charge" means any payment of money required by a landlord of an applicant prior to entering into a rental agreement with that applicant for a residential dwelling unit, the purpose of which is to pay the cost of processing an application for a rental agreement for a residential dwelling unit.

(4) "Building and housing codes" includes any law, ordinance or governmental regulation con cerning fitness for habitation, or the construction, maintenance, operation, occupancy, use or appearance of any premises or dwelling unit.

24 (5) "Carbon monoxide alarm" has the meaning given that term in ORS 105.836.

25 (6) "Carbon monoxide source" has the meaning given that term in ORS 105.836.

26 (7) "Conduct" means the commission of an act or the failure to act.

(8) "Dealer" means any person in the business of selling, leasing or distributing new or used
manufactured dwellings or floating homes to persons who purchase or lease a manufactured dwelling
or floating home for use as a residence.

30 (9) "Domestic violence" means:

31 (a) Abuse between family or household members, as those terms are defined in ORS 107.705; or

32 (b) Abuse, as defined in ORS 107.705, between partners in a dating relationship.

33 (10) "Drug and alcohol free housing" means a dwelling unit described in ORS 90.243.

(11) "Dwelling unit" means a structure or the part of a structure that is used as a home, residence or sleeping place by one person who maintains a household or by two or more persons who maintain a common household. "Dwelling unit" regarding a person who rents a space for a manufactured dwelling or recreational vehicle or regarding a person who rents moorage space for a floating home as defined in ORS 830.700, but does not rent the home, means the space rented and not the manufactured dwelling, recreational vehicle or floating home itself.

40 (12) "Essential service" means:

(a) For a tenancy not consisting of rental space for a manufactured dwelling, floating home or
 recreational vehicle owned by the tenant and not otherwise subject to ORS 90.505 to 90.840:

(13) "Facility" means a manufactured dwelling park or a marina. 11

12(14) "Facility purchase association" means a group of three or more tenants who reside in a 13 facility and have organized for the purpose of eventual purchase of the facility.

(15) "Fee" means a nonrefundable payment of money.

15 (16) "First class mail" does not include certified or registered mail, or any other form of mail that may delay or hinder actual delivery of mail to the recipient. 16

(17) "Fixed term tenancy" means a tenancy that has a fixed term of existence, continuing to a 17 18 specific ending date and terminating on that date without requiring further notice to effect the termination. 19

(18) "Floating home" has the meaning given that term in ORS 830.700. "Floating home" includes 20an accessory building or structure. 21

(19) "Good faith" means honesty in fact in the conduct of the transaction concerned.

(20) "Hotel or motel" means "hotel" as that term is defined in ORS 699.005.

(21) "Informal dispute resolution" means, but is not limited to, consultation between the landlord 24 or landlord's agent and one or more tenants, or mediation utilizing the services of a third party. 25

(22) "Landlord" means the owner, lessor or sublessor of the dwelling unit or the building or 2627premises of which it is a part. "Landlord" includes a person who is authorized by the owner, lessor or sublessor to manage the premises or to enter into a rental agreement. 28

(23) "Landlord's agent" means a person who has oral or written authority, either express or 2930 implied, to act for or on behalf of a landlord.

31 (24) "Last month's rent deposit" means a type of security deposit, however designated, the primary function of which is to secure the payment of rent for the last month of the tenancy. 32

(25) "Manufactured dwelling" means a residential trailer, a mobile home or a manufactured 33 34 home as those terms are defined in ORS 446.003. "Manufactured dwelling" includes an accessory building or structure. "Manufactured dwelling" does not include a recreational vehicle. 35

(26) "Manufactured dwelling park" means a place where four or more manufactured dwellings 36 37 are located, the primary purpose of which is to rent space or keep space for rent to any person for 38 a charge or fee.

(27) "Marina" means a moorage of contiguous dwelling units that may be legally transferred as 39 a single unit and are owned by one person where four or more floating homes are secured, the pri-40 mary purpose of which is to rent space or keep space for rent to any person for a charge or fee. 41

42(28) "Month-to-month tenancy" means a tenancy that automatically renews and continues for successive monthly periods on the same terms and conditions originally agreed to, or as revised by 43 the parties, until terminated by one or both of the parties. 44

(29) "Organization" includes a corporation, government, governmental subdivision or agency,

business trust, estate, trust, partnership or association, two or more persons having a joint or common interest, and any other legal or commercial entity.

3 (30) "Owner" includes a mortgagee in possession and means one or more persons, jointly or se-4 verally, in whom is vested:

5 (a) All or part of the legal title to property; or

6 (b) All or part of the beneficial ownership and a right to present use and enjoyment of the 7 premises.

8 (31) "Person" includes an individual or organization.

9 (32) "Premises" means:

(a) A dwelling unit and the structure of which it is a part and facilities and appurtenancestherein;

(b) Grounds, areas and facilities held out for the use of tenants generally or the use of whichis promised to the tenant; and

14 (c) A facility for manufactured dwellings or floating homes.

(33) "Prepaid rent" means any payment of money to the landlord for a rent obligation not yet
 due. In addition, "prepaid rent" means rent paid for a period extending beyond a termination date.

(34) "Recreational vehicle" has the meaning given that term in ORS 446.003.

(35) "Rent" means any payment to be made to the landlord under the rental agreement, periodic or otherwise, in exchange for the right of a tenant and any permitted pet to occupy a dwelling unit to the exclusion of others **and to use the premises**. "Rent" does not include security deposits, fees or utility or service charges as described in ORS 90.315 (4) and 90.532.

(36) "Rental agreement" means all agreements, written or oral, and valid rules and regulations adopted under ORS 90.262 or 90.510 (6) embodying the terms and conditions concerning the use and occupancy of a dwelling unit and premises. "Rental agreement" includes a lease. A rental agreement shall be either a week-to-week tenancy, month-to-month tenancy or fixed term tenancy.

(37) "Roomer" means a person occupying a dwelling unit that does not include a toilet and either a bathtub or a shower and a refrigerator, stove and kitchen, all provided by the landlord, and
where one or more of these facilities are used in common by occupants in the structure.

(38) "Screening or admission criteria" means a written statement of any factors a landlord considers in deciding whether to accept or reject an applicant and any qualifications required for acceptance. "Screening or admission criteria" includes, but is not limited to, the rental history, character references, public records, criminal records, credit reports, credit references and incomes or resources of the applicant.

(39) "Security deposit" means a refundable payment or deposit of money, however designated,
the primary function of which is to secure the performance of a rental agreement or any part of a
rental agreement. "Security deposit" does not include a fee.

(40) "Sexual assault" has the meaning given that term in ORS 147.450.

(41) "Squatter" means a person occupying a dwelling unit who is not so entitled under a rental
agreement or who is not authorized by the tenant to occupy that dwelling unit. "Squatter" does
not include a tenant who holds over as described in ORS 90.427 (7).

(42) "Stalking" means the behavior described in ORS 163.732.

(43) "Statement of policy" means the summary explanation of information and facility policies
to be provided to prospective and existing tenants under ORS 90.510.

44 (44) "Surrender" means an agreement, express or implied, as described in ORS 90.148 between 45 a landlord and tenant to terminate a rental agreement that gave the tenant the right to occupy a 1 dwelling unit.

2 (45) "Tenant":

3 (a) Except as provided in paragraph (b) of this subsection:

4 (A) Means a person, including a roomer, entitled under a rental agreement to occupy a dwelling 5 unit to the exclusion of others, including a dwelling unit owned, operated or controlled by a public 6 housing authority.

(B) Means a minor, as defined and provided for in ORS 109.697.

8 (b) For purposes of ORS 90.505 to 90.840, means only a person who owns and occupies as a 9 residence a manufactured dwelling or a floating home in a facility and persons residing with that 10 tenant under the terms of the rental agreement.

11 (c) Does not mean a guest or temporary occupant.

12 (46) "Transient lodging" means a room or a suite of rooms.

(47) "Transient occupancy" means occupancy in transient lodging that has all of the followingcharacteristics:

15 (a) Occupancy is charged on a daily basis and is not collected more than six days in advance;

(b) The lodging operator provides maid and linen service daily or every two days as part of the
 regularly charged cost of occupancy; and

18 (c) The period of occupancy does not exceed 30 days.

(48) "Vacation occupancy" means occupancy in a dwelling unit, not including transient occu pancy in a hotel or motel, that has all of the following characteristics:

21 (a) The occupant rents the unit for vacation purposes only, not as a principal residence;

22 (b) The occupant has a principal residence other than at the unit; and

23 (c) The period of authorized occupancy does not exceed 45 days.

24 (49) "Victim" means:

(a) The person against whom an incident related to domestic violence, sexual assault or stalking
 is perpetrated; or

(b) The parent or guardian of a minor household member against whom an incident related to
domestic violence, sexual assault or stalking is perpetrated, unless the parent or guardian is the
perpetrator.

30 (50) "Week-to-week tenancy" means a tenancy that has all of the following characteristics:

(a) Occupancy is charged on a weekly basis and is payable no less frequently than every seven
 days;

(b) There is a written rental agreement that defines the landlord's and the tenant's rights and
 responsibilities under this chapter; and

(c) There are no fees or security deposits, although the landlord may require the payment of an
 applicant screening charge, as provided in ORS 90.295.

37 SECTION 15. ORS 105.120 is amended to read:

105.120. (1) As used in this section, "rent" does not include funds paid under the United States
Housing Act of 1937 (42 U.S.C. 1437f).

(2) Except as provided in subsection (3) of this section, an action for the recovery of the possession of the premises may be maintained in cases provided in ORS 105.115 (1)(b), when the notice to terminate the tenancy or to quit has been served upon the tenant or person in possession in the manner prescribed by ORS 91.110 and for the period prescribed by ORS 91.060 to 91.080 before the commencement of the action, unless the leasing or occupation is for the purpose of farming or agriculture, in which case the notice must be served for a period of 90 days before the commencement

1 of the action. Any person entering into the possession of real estate under written lease as the

tenant of another may, by the terms of the lease, waive the giving of any notice required by thissubsection.

4 (3) An action for the recovery of the possession of a dwelling unit to which ORS chapter 90 5 applies may be maintained in situations described in ORS 105.115 (2) when the notice to terminate 6 the tenancy or to quit has been served by the tenant upon the landlord or by the landlord upon the 7 tenant or person in possession in the manner prescribed by ORS 90.155.

8 (4) Except when a tenancy involves a dwelling unit subject to ORS chapter 90, the service of a 9 notice to quit upon a tenant or person in possession does not authorize an action to be maintained 10 against the tenant or person in possession for the possession of premises before the expiration of 11 any period for which the tenant or person has paid the rent of the premises in advance.

(5) An action to recover possession of a dwelling unit subject to ORS chapter 90 may not be brought or filed against a tenant or person in possession based upon a notice under ORS 90.427 to terminate the tenancy until after the expiration of any period for which the tenant or person has paid the rent of the dwelling unit in advance, unless:

(a) The only other money paid by the tenant was collected as a last month's rent deposit as
 provided under ORS 90.300; or

(b) The only unused rent was paid by the tenant for a rental period extending beyond the termination date specified in a valid outstanding notice to terminate the tenancy and the landlord refunded the unused rent within [six] 10 days after receipt by delivering the unused rent to the tenant
