

**PROPOSED AMENDMENTS TO  
SENATE BILL 623**

1 On page 1 of the printed bill, delete lines 6 through 31 and delete pages  
2 2 through 15 and insert:

3 **“SECTION 1.** ORS 109.304 is amended to read:

4 “109.304. As used in ORS 109.305 to 109.410, unless the context requires  
5 otherwise:

6 “[*(1) ‘Home study’ means an investigation conducted by the Department of*  
7 *Human Services or by an Oregon licensed adoption agency that:*]

8 “[*(a) Provides information to a prospective adoptive parent about*  
9 *adoption;*]

10 “[*(b) Includes investigation and study by the department or by an Oregon*  
11 *licensed adoption agency concerning a prospective parent’s suitability to*  
12 *adopt;*]

13 “[*(c) Includes a written report concerning the prospective parent’s suitabil-*  
14 *ity to adopt; and*]

15 “[*(d) Is completed before the petition for adoption is filed.*]

16 **“(1) ‘Home study’ means a written report documenting the result**  
17 **of an assessment conducted by the Department of Human Services, a**  
18 **licensed adoption agency or other public agency to evaluate the suit-**  
19 **ability of a prospective adoptive parent or parents to adopt.**

20 **“(2) ‘Placement report’ means a written report prepared by the department**  
21 **or by an Oregon licensed adoption agency after the petition for adoption has**  
22 **been filed that includes the department’s or the agency’s recommendation to**

1 the court concerning whether the court should grant the petition for  
2 adoption based upon the department's or the agency's evaluation of:

3 “(a) The status and adjustment of the child; and

4 “(b) The status and adjustment of the child's prospective adoptive parent.

5 “[~~(3)~~ *Information gathered by the department or by an Oregon licensed*  
6 *adoption agency during the preparation of the placement report may include*  
7 *information concerning the child's social, medical and genetic history and the*  
8 *birth parent's history as may be required by ORS 109.312 or 109.342.*]

9 “**(3) ‘Records, papers and files’ means all documents, writings, in-**  
10 **formation, exhibits and other filings retained in the court's record of**  
11 **an adoption case pursuant to section 6 of this 2013 Act, and includes**  
12 **but is not limited to the Adoption Summary and Segregated Informa-**  
13 **tion Statement described in section 5 of this 2013 Act, and exhibits**  
14 **attached to the statement, the petition and exhibits attached to the**  
15 **petition pursuant to section 4 of this 2013 Act, and any other motion,**  
16 **judgment, document, writing, information, exhibit or filing retained**  
17 **in the court's record of the adoption case.**

18 “**SECTION 2.** ORS 109.309 is amended to read:

19 “109.309. (1) Any person may petition the circuit court for leave to adopt  
20 another person and, if desired, for a change of the other person's name.

21 “**(2)** One petitioner, the child, one parent or the person, who is not an  
22 adoption agency, consenting to the adoption as required under ORS 109.312  
23 (1) must be a resident of this state. As used in this subsection, ‘resident’  
24 means a person who has resided in this state continuously for a period of  
25 six months prior to the date of the petition.

26 “[~~(2)~~] **(3)** Except as provided in subsection [~~(3)~~] **(4)** of this section, when  
27 the petition is for the adoption of a minor child, the adoption is governed  
28 by the Uniform Child Custody Jurisdiction and Enforcement Act, ORS  
29 109.701 to 109.834.

30 “[~~(3)(a)~~] **(4)(a)** Notwithstanding ORS 109.741 and 109.744, a court of this

1 state has jurisdiction over the adoption of a minor child if, immediately prior  
2 to the filing of a petition for adoption:

3 “(A) The minor child resided in this state for at least six consecutive  
4 months including periods of temporary absence;

5 “(B) One parent or another person, who is not an adoption agency, con-  
6 senting to the adoption as required under ORS 109.312 (1) resided in this  
7 state for at least six consecutive months including periods of temporary ab-  
8 sence;

9 “(C) The prospective adoptive parent resided in this state for at least six  
10 consecutive months including periods of temporary absence and substantial  
11 evidence is available in this state concerning the present or future care of  
12 the minor child;

13 “(D) It appears that no court of another state would have jurisdiction  
14 under circumstances substantially in accordance with subparagraphs (A) to  
15 (C) of this paragraph; or

16 “(E) A court of another state has declined to exercise jurisdiction on the  
17 grounds that this state is a more appropriate forum to hear a petition for  
18 adoption of the minor child and it is in the best interests of the minor child  
19 that a court of this state assume jurisdiction.

20 “(b) As used in paragraph (a) of this subsection, ‘periods of temporary  
21 absence’ means periods of absence of not more than a total of 30 days in the  
22 prior six consecutive months.

23 “[*(4) The petition to adopt a person 18 years of age or older may be filed*  
24 *in the county where the petitioner, the person to be adopted or the person who*  
25 *consents to the adoption resides.*]

26 “(5) In a petition to adopt a minor child, venue lies in the Oregon county  
27 with which the child has the most significant connection or in the Oregon  
28 county in which the licensed adoption agency is located.

29 “[*(6)(a) When the petition is for the adoption of a minor child, the petitioner*  
30 *shall also file at the time of filing the petition.*]

1       “(A) A written statement containing the full names and permanent ad-  
2 dresses of:]

3       “[(i) The child;]

4       “[(ii) The petitioner;]

5       “[(iii) All persons whose consent to the adoption is required under ORS  
6 109.312 when such names are either known or may be readily ascertained by  
7 the petitioner;]

8       “[(iv) The persons with whom the child has lived during the last five years  
9 and the places where the child has lived during that period, if the names and  
10 addresses may be readily ascertained by the petitioner;]

11       “[(v) If known to the petitioner, any person not a party to the proceeding  
12 who has physical custody of the child or claims rights of legal custody or  
13 physical custody of, or parenting time or visitation with, the child; and]

14       “[(vi) The Oregon licensed adoption agency, if any, or the relative or person  
15 that privately placed the child for adoption.]

16       “[(B) The documents demonstrating consent under ORS 109.312 to the  
17 adoption of the minor child.]

18       “[(C) Written evidence documenting a current home study that has been  
19 approved by either the Department of Human Services or an Oregon licensed  
20 adoption agency submitted for the purpose of demonstrating that the petitioner  
21 meets the minimum standards for adoptive homes as set forth in the  
22 department’s administrative rules.]

23       “[(b) A relative who qualifies under the department administrative rules for  
24 a waiver of the department’s home study requirements described in paragraph  
25 (a)(C) of this subsection may file the request for waiver along with the petition  
26 for adoption.]

27       “[(c) The department, upon request by the petitioner, may waive the home  
28 study requirements described in paragraph (a)(C) of this subsection in an  
29 adoption in which one of the child’s biological or adoptive parents retains  
30 parental rights. The department shall waive post-placement reports in an

1 *adoption in which one of the child’s biological or adoptive parents retains*  
2 *parental rights.]*

3 *“(7)(a) The petitioner shall cause copies of the documents required to be*  
4 *filed with the court under subsection (6) of this section to be served upon the*  
5 *Director of Human Services, by either registered or certified mail with return*  
6 *receipt or personal service, within 30 days after the documents have been filed*  
7 *with the court.]*

8 *“(b) In the case of an adoption described in subsection (6)(c) of this section,*  
9 *the petitioner shall also serve the petition, by either registered or certified mail*  
10 *with return receipt or personal service:]*

11 *“(A) On all persons whose consent to the adoption is required under ORS*  
12 *109.312 unless the person’s written consent is filed with the court; and]*

13 *“(B) On the parents of the party whose parental rights would be termi-*  
14 *nated, if the names and addresses are known or may be readily ascertained*  
15 *by the petitioner. Service required by this subparagraph may be waived by the*  
16 *court for good cause.]*

17 *“(c) When a parent of the child is deceased or incapacitated, the petitioner*  
18 *shall also serve the petition on the parents of the deceased or incapacitated*  
19 *parent, if the names and addresses are known or may be readily ascertained*  
20 *by the petitioner. Service required by this paragraph may be waived by the*  
21 *court for good cause. As used in this paragraph:]*

22 *“(A) ‘Incapacitated’ means a condition in which a person’s ability to re-*  
23 *ceive and evaluate information effectively or to communicate decisions is im-*  
24 *paired to such an extent that the person lacks the capacity to meet the essential*  
25 *requirements for the person’s physical health or safety.]*

26 *“(B) ‘Meet the essential requirements for the person’s physical health or*  
27 *safety’ means those actions necessary to provide the health care, food, shelter,*  
28 *clothing, personal hygiene and other care without which serious physical in-*  
29 *jury or illness is likely to occur.]*

30 *“(d) The court may not rule upon the petition until at least 90 days after*

1 *the date that the documents were served upon the director. However, the de-*  
2 *partment may waive the 90-day period.]*

3 **“(6) A petition for adoption of a minor child must comply with the**  
4 **requirements, and be served in the manner, described in section 4 of**  
5 **this 2013 Act.**

6 **“(7)(a) In a proceeding for the adoption of a minor child, a current**  
7 **home study must be approved by either the Department of Human**  
8 **Services or an Oregon licensed adoption agency for the purpose of**  
9 **demonstrating that the petitioner meets the minimum standards for**  
10 **adoptive homes as set forth in the department’s administrative rules.**

11 **“(b) The department, upon request by the petitioner, may waive the**  
12 **home study requirement in an adoption proceeding in which one of the**  
13 **child’s biological parents or adoptive parents retains parental rights,**  
14 **or when a relative who qualifies under the department’s administra-**  
15 **tive rules for a waiver of the home study requirement is the prospec-**  
16 **tive adoptive parent.**

17 **“(c) The department shall adopt rules to implement the provisions**  
18 **of this subsection.**

19 **“(8)(a) [Within 90 days after the service on the director, the department]**  
20 **Within 90 days after service upon the Director of Human Services as**  
21 **required under section 4 of this 2013 Act, the Department of Human**  
22 **Services shall investigate and file for the consideration of the judge before**  
23 **whom the petition for adoption is pending a placement report containing**  
24 **information regarding the status of the child and evidence concerning the**  
25 **suitability of the proposed adoption. The department may designate an**  
26 **Oregon licensed adoption agency to investigate and report to the court. If**  
27 **the department designates an Oregon licensed adoption agency to investigate**  
28 **and report to the court, the department shall make the designation and pro-**  
29 **vide all necessary information and materials to the Oregon licensed adoption**  
30 **agency no later than 30 days after the service on the director[. However, the**

1 *department may waive the placement report requirement.] and upon receipt*  
2 **of all required documentation and fees. The department may waive the**  
3 **placement report requirement under this subsection but shall waive**  
4 **the placement report requirement in an adoption proceeding in which**  
5 **one of the child’s biological parents or adoptive parents retains par-**  
6 **ental rights.**

7 “(b) Upon receipt of a written request by the **petitioner or the**  
8 petitioner’s attorney, the department shall furnish to [*that*] **the petitioner**  
9 **or the petitioner’s** attorney copies of any information that the department  
10 has filed with the court.

11 “(c) **Information gathered by the department or by an Oregon li-**  
12 **censed adoption agency during the preparation of the placement report**  
13 **may include information concerning the child’s social, medical and**  
14 **genetic history and the birth parent’s history as may be required by**  
15 **ORS 109.312 or 109.342.**

16 “(d) **The department shall adopt rules to implement the provisions**  
17 **of this subsection.**

18 “[*(c)*] **(9)** The department may charge the petitioner a fee for investigating  
19 a proposed nonagency adoption and preparing the home study [*report de-*  
20 *scribed in subsection (6)(a)(C)*] **required under subsection (7)** of this section  
21 and the placement report [*described in paragraph (a) of this subsection*] **re-**  
22 **quired under subsection (8) of this section.** The petitioner shall report the  
23 fee amount to the court. The court granting the adoption shall make a find-  
24 ing as to whether the fee is necessary and reasonable. Any fee charged may  
25 not exceed reasonable costs for investigation, home study and placement re-  
26 port preparation. The department shall prescribe by rule the procedure for  
27 computing the investigation, home study and placement report preparation  
28 fee. The rules shall provide a waiver of either part or all of the fee based  
29 upon the petitioner’s ability to pay.

30 “**(10) The court may not rule upon a petition for the adoption of a**

1 **minor child until at least 90 days after the date that the petition and**  
2 **documents required to be served on the Director of Human Services**  
3 **under sections 4 and 5 of this 2013 Act have been served upon the di-**  
4 **rector. The department may waive the 90-day waiting period.**

5 “[9] (11) The amounts of any fees collected under subsection [(8)] (9) of  
6 this section are continuously appropriated to the department for use in pre-  
7 paring [*the home study*] **home studies** and placement reports required under  
8 [*subsections (6)(a)(C) and (8)(a) of*] this section.

9 “[10(a)] (12)(a) Except as provided in paragraph (b) of this subsection,  
10 a court may not grant a judgment for the adoption of a minor child unless  
11 the petitioner has filed with the court [*the documents described in subsections*  
12 *(6) and (8)(a) of this section.*]:

13 **“(A) A petition, including exhibits attached to the petition, meeting**  
14 **the requirements of section 4 of this 2013 Act;**

15 **“(B) Written evidence that a home study has been completed and**  
16 **approved, unless waived, under subsection (7) of this section;**

17 **“(C) A placement report under subsection (8) of this section unless**  
18 **waived; and**

19 **“(D) The Adoption Summary and Segregated Information State-**  
20 **ment under section 5 of this 2013 Act, including exhibits attached to**  
21 **the statement.**

22 “(b) A person is not required to file a home study or a placement report  
23 with the court when the department has granted the person a waiver under  
24 department rules.

25 “[11] (13) The adoption shall comply with the Indian Child Welfare Act  
26 (25 U.S.C. 1901 et seq.), if applicable. [*Every adoption petition involving the*  
27 *Indian Child Welfare Act shall include the following:*]

28 “[a) A statement of the efforts to notify the appropriate Indian tribe or  
29 tribes of the adoption; and]

30 “[b) A statement of the efforts to comply with the placement preferences of



1 *the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) or the placement pref-*  
2 *erences of the appropriate Indian tribe.]*

3 **“SECTION 3. Sections 4 to 6 of this 2013 Act are added to and made**  
4 **a part of ORS 109.305 to 109.410.**

5 **“SECTION 4. (1) A petition for adoption of a minor child must be**  
6 **signed by the petitioner and notarized and, unless stated in the peti-**  
7 **tion why the information or statement is omitted, must contain the**  
8 **following:**

9 **“(a) The full name of the petitioner;**

10 **“(b) The state and length of residency in the state of the petitioner**  
11 **and information sufficient to establish that the residency requirement**  
12 **of ORS 109.309 (2) has been met;**

13 **“(c) The current marital or domestic partnership status of the**  
14 **petitioner;**

15 **“(d) An explanatory statement as to why the petitioner is of suffi-**  
16 **cient ability to bring up the minor child and furnish suitable nurture**  
17 **and education sufficient for judgment to be entered under ORS 109.350;**

18 **“(e) Information sufficient for the court to establish that the**  
19 **petitioner has complied with the jurisdictional and venue requirements**  
20 **of ORS 109.309 (4) and (5);**

21 **“(f) The full name, sex and date and place of birth of the minor**  
22 **child;**

23 **“(g) The marital or domestic partnership status of the biological**  
24 **mother at the time of conception, at the date of birth and during the**  
25 **300 days prior to the date of birth of the minor child;**

26 **“(h) A statement that the minor child is not an Indian child as de-**  
27 **finied in the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) or, if the**  
28 **Indian Child Welfare Act applies:**

29 **“(A) A statement of the efforts to notify the appropriate Indian**  
30 **tribe or tribes of the adoption; and**

1       **“(B) A statement of the efforts to comply with the placement pref-**  
2 **erences of the Indian Child Welfare Act or the placement preferences**  
3 **of the appropriate Indian tribe;**

4       **“(i) The name and relationship to the minor child of any person**  
5 **who has executed a written release or surrender of parental rights or**  
6 **of rights of guardianship of the minor child as provided by ORS 418.270**  
7 **and the date of the release or surrender;**

8       **“(j) The name and relationship to the minor child of any person**  
9 **who has given written consent as required under ORS 109.312, and the**  
10 **date the consent was given;**

11       **“(k) The name and relationship to the minor child of any person**  
12 **or entity for whom the written consent requirement under ORS 109.312**  
13 **is waived or not required as provided in ORS 109.314, 109.316, 109.318,**  
14 **109.322, 109.324 and 109.326 or whose written consent may be substituted**  
15 **for the written consent requirement under ORS 109.312 as provided in**  
16 **ORS 109.314, 109.316, 109.318, 109.322, 109.324, 109.326, 109.328 and 109.329;**

17       **“(L) The name and relationship to the minor child of all persons**  
18 **who have signed and attested to a written certificate of irrevocability**  
19 **and waiver as provided in ORS 109.312 (2);**

20       **“(m) A statement of the facts and circumstances under which the**  
21 **petitioner obtained physical custody of the minor child, including date**  
22 **of placement with the petitioner for adoption and the name and re-**  
23 **lationship to the minor child of the individual or entity placing the**  
24 **minor child with the petitioner;**

25       **“(n) The length of time that a minor child has been in the physical**  
26 **custody of the petitioner and, if the minor child is not in the physical**  
27 **custody of the petitioner, the reason why, and the date and manner**  
28 **in which the petitioner will obtain physical custody of the minor child;**

29       **“(o) Whether a continuing contact agreement exists under ORS**  
30 **109.305, including names of the parties to the agreement and date of**

1 **execution;**

2 **“(p) A statement establishing that the requirements of ORS 109.353**  
3 **regarding advisement about the voluntary adoption registry and the**  
4 **registry’s services have been met;**

5 **“(q) A statement establishing that the requirements of ORS 109.346**  
6 **regarding notice of right to counseling sessions have been met;**

7 **“(r) A statement that the information required by the Uniform**  
8 **Child Custody Jurisdiction and Enforcement Act under ORS 109.701 to**  
9 **109.834 has been provided in the Adoption Summary and Segregated**  
10 **Information Statement under section 5 of this 2013 Act;**

11 **“(s) A statement that the Interstate Compact on the Placement of**  
12 **Children does or does not apply and, if applicable, a statement of the**  
13 **efforts undertaken to comply with the compact; and**

14 **“(t) Unless waived, a statement that a current home study was**  
15 **completed in compliance with ORS 109.309 (7).**

16 **“(2) A petition filed under ORS 109.309 must, if applicable, request**  
17 **the following:**

18 **“(a) Entry of a general judgment of adoption;**

19 **“(b) That the petitioner be permitted to adopt the minor child as**  
20 **the child of the petitioner for all legal intents and purposes;**

21 **“(c) A finding that the court has jurisdiction over the adoption**  
22 **proceeding, the parties and the minor child;**

23 **“(d) With respect to the appropriate persons, the termination of**  
24 **parental rights or a determination of nonpaternity;**

25 **“(e) Approval of a change to the minor child’s name;**

26 **“(f) A finding that a continuing contact agreement entered into**  
27 **under ORS 109.305 is in the best interests of the minor child and that,**  
28 **if the minor child is 14 years of age or older, the minor child has**  
29 **consented to the agreement, and that the court incorporate the con-**  
30 **tinuing contact agreement by reference into the adoption judgment;**

1       **“(g) That the court require preparation of and certify a report of**  
2 **adoption as provided in ORS 432.415;**

3       **“(h) That all records, papers and files in the record of the adoption**  
4 **case be sealed as provided under section 6 of this 2013 Act; and**

5       **“(i) Any other relief requested by the petitioner.**

6       **“(3) A petition filed under ORS 109.309 must, if applicable, have the**  
7 **following attached as exhibits:**

8       **“(a) Any written release or surrender of the minor child for**  
9 **adoption, or a written disclaimer of parental rights;**

10       **“(b) Any written consent to the adoption;**

11       **“(c) Any certificate of irrevocability and waiver;**

12       **“(d) Any continuing contact agreement under ORS 109.305;**

13       **“(e) The written disclosure statement required under ORS 109.311;**  
14 **and**

15       **“(f) Any other supporting documentation necessary to comply with**  
16 **the petition requirements in this section and ORS 109.309.**

17       **“(4) The petition and documents filed as exhibits under subsection**  
18 **(3) of this section are confidential and may not be inspected or copied**  
19 **except as provided under ORS 109.305 to 109.410 and 109.425 to 109.507.**

20       **“(5)(a) Within 30 days after being filed with the court, the petitioner**  
21 **shall serve copies of the petition, the documents filed as exhibits under**  
22 **subsection (3) of this section and the Adoption Summary and Segre-**  
23 **gated Information Statement described in section 5 of this 2013 Act,**  
24 **including any amendments and exhibits attached to the statement, on**  
25 **the Director of Human Services by either registered or certified mail**  
26 **with return receipt or personal service.**

27       **“(b) In the case of an adoption in which one of the child’s biological**  
28 **or adoptive parents retains parental rights, the petitioner shall also**  
29 **serve the petition by either registered or certified mail with return**  
30 **receipt or personal service:**

1       **“(A) On all persons whose consent to the adoption is required under**  
2 **ORS 109.312 unless the person’s written consent is filed with the court;**  
3 **and**

4       **“(B) On the parents of the party whose parental rights would be**  
5 **terminated, if the names and addresses are known or may be readily**  
6 **ascertained by the petitioner.**

7       **“(c) When a parent of the child is deceased or incapacitated, the**  
8 **petitioner shall also serve the petition on the parents of the deceased**  
9 **or incapacitated parent, if the names and addresses are known or may**  
10 **be readily ascertained by the petitioner. As used in this paragraph:**

11       **“(A) ‘Incapacitated’ means a condition in which a person’s ability**  
12 **to receive and evaluate information effectively or to communicate**  
13 **decisions is impaired to such an extent that the person lacks the ca-**  
14 **capacity to meet the essential requirements for the person’s physical**  
15 **health or safety.**

16       **“(B) ‘Meet the essential requirements for the person’s physical**  
17 **health or safety’ means those actions necessary to provide health care,**  
18 **food, shelter, clothing, personal hygiene and other care without which**  
19 **serious physical injury or illness is likely to occur.**

20       **“(d) Service required by this subsection may be waived by the court**  
21 **for good cause.**

22       **“SECTION 5. (1) An Adoption Summary and Segregated Informa-**  
23 **tion Statement must be filed concurrently with every petition for**  
24 **adoption of a minor child filed under ORS 109.309. The statement must**  
25 **summarize information in the adoption proceeding and include addi-**  
26 **tional information and attached exhibits as required under this sec-**  
27 **tion. The statement must contain, at a minimum, the following**  
28 **information if the information is known or readily ascertainable by**  
29 **the petitioner:**

30       **“(a) The full name, permanent address and telephone number of**

1 each petitioner;

2 “(b) The current full name, the proposed adoptive name and the  
3 date and place of birth of the minor child;

4 “(c) The names, permanent addresses and telephone numbers of any  
5 person whose consent to the adoption is required under ORS 109.312;

6 “(d) The name and relationship to the minor child and address of  
7 any person or entity for whom the written consent requirement under  
8 ORS 109.312 is waived or not required as provided in ORS 109.314,  
9 109.316, 109.318, 109.322, 109.324 and 109.326 or whose written consent  
10 may be substituted for the written consent requirement under ORS  
11 109.312 as provided in ORS 109.314, 109.316, 109.318, 109.322, 109.324,  
12 109.326, 109.328 and 109.329;

13 “(e) The information required by the Uniform Child Custody Juris-  
14 diction and Enforcement Act under ORS 109.701 to 109.834;

15 “(f) The name, address and telephone number of any adoption  
16 agency that will be consenting, or has consented, to the adoption;

17 “(g) The name, bar number and contact information for any attor-  
18 ney representing a petitioner or a person whose consent to the  
19 adoption is required under ORS 109.312; and

20 “(h) An indication of the type of adoption proceeding as follows:

21 “(A) Private agency adoption, whether domestic or international;

22 “(B) Nonrelated independent adoption;

23 “(C) Determination of validity of an adoption in a foreign nation  
24 under ORS 109.385;

25 “(D) Relative independent adoption;

26 “(E) Stepparent independent adoption;

27 “(F) An independent adoption involving one petitioner who retains  
28 parental rights;

29 “(G) Out-of-state public agency adoption;

30 “(H) An adoption in which the Department of Human Services gives

1 consent under ORS 109.316; or

2 “(I) Any other specified adoption.

3 “(2) An Adoption Summary and Segregated Information Statement  
4 must, if applicable, have the following attached as exhibits:

5 “(a) A home study or written evidence that a home study has been  
6 approved as required by ORS 109.309, unless waived;

7 “(b) A report of adoption on a form prescribed and furnished by the  
8 State Registrar of the Center for Health Statistics as required under  
9 ORS 432.415; and

11 ents as required under ORS 109.342.

12 “(3) A waiver of the home study requirement may be substituted for  
13 the requirement under subsection (2)(a) of this section.

14 “(4) Before judgment is entered in the case, a petitioner shall file  
15 an amended Adoption Summary and Segregated Information State-  
16 ment when any of the required information changes or when infor-  
17 mation that was not previously known or ascertainable becomes  
18 known or ascertainable.

19 “(5) The Adoption Summary and Segregated Information Statement  
20 and the exhibits submitted under subsection (2) of this section are  
21 confidential and may not be inspected or copied except as otherwise  
22 provided under ORS 109.305 to 109.410 or 109.425 to 109.507. The  
23 Adoption Summary and Segregated Information Statement and the  
24 exhibits submitted under this section must be segregated in the record  
25 of the adoption case from other records, papers and files in the record  
26 of the adoption case.

27 **“SECTION 6. (1) The clerk or court administrator of any court**  
28 **having jurisdiction over adoption proceedings shall keep a separate**  
29 **record of the case for each adoption proceeding filed with the court.**  
30 **Adoption proceedings shall not be entered upon the general records**

1 of the court.

2 “(2) The clerk, court administrator or other person having custody  
3 of the records, papers and files in the court’s record of an adoption  
4 case shall cause all records, papers and files relating to the adoption  
5 proceeding that are filed with the court, both prior to entry of judg-  
6 ment and after entry of judgment, to be sealed in the court’s record  
7 of the adoption case. The clerk, court administrator or any other

15 entry of judgment in an adoption proceeding but prior to the minor  
16 child who is the subject of the adoption proceeding attaining 18 years  
17 of age, the following may inspect and copy sealed records, papers and  
18 files in the court’s record of an adoption case without a court order:

19 “(a) Judges of the court operating under the Judicial Department  
20 and court staff or other persons operating under the direction of the  
21 judges;

22 “(b) Petitioners and their attorneys of record; and

23 “(c) The Department of Human Services.

24 “(4) After entry of judgment in an adoption proceeding and after the  
25 minor child who is the subject of the adoption proceeding has attained  
26 18 years of age, the following may inspect and copy sealed records,  
27 papers and files in the court’s record of the adoption case without a  
28 court order:

29 “(a) Judges of the court operating under the Judicial Department  
30 and court staff or other persons operating under the direction of the



1 **judges;**

2 **“(b) The person who was the minor child in the adoption proceed-**  
3 **ing, except that the person who was the minor child in the adoption**  
4 **proceeding may not inspect or copy the home study or evidence of a**  
5 **home study approved under ORS 109.309 (7) except pursuant to a court**  
6 **order and with good cause;**

7 **“(c) Petitioners and their attorneys of record; and**

8 **“(d) The Department of Human Services.**

9 **“(5)(a) After entry of judgment in an adoption proceeding and after**  
10 **the minor child who is the subject of the adoption proceeding has at-**  
11 **tained 18 years of age, an individual whose consent for the adoption**  
12 **is required under ORS 109.312 may file a motion with the court to in-**  
13 **spect and copy sealed records, papers and files in the court’s record**  
14 **of the adoption case.**

15 **“(b) Except as provided in paragraph (c) of this subsection, the**  
16 **court shall grant the motion except for good cause but must exclude**  
17 **from inspection and copying:**

18 **“(A) The Adoption Summary and Segregated Information State-**  
19 **ment and any exhibits attached to the statement that are contained**  
20 **in the court’s record of the adoption case; or**

21 **“(B) For adoption cases filed before the effective date of this 2013**  
22 **Act, any information, record, document or exhibit described in section**  
23 **5 of this 2013 Act.**

24 **“(c) If the Department of Human Services consented or has the**  
25 **authority to consent to the adoption of a minor child under ORS**  
26 **109.316 or 419B.529:**

27 **“(A) A parent who has signed a release and surrender to the de-**  
28 **partment under ORS 418.270, that was accepted by the department, or**  
29 **whose parental rights were terminated under ORS 419B.500 and**  
30 **419B.502 to 419B.524, may file a motion with the court to inspect or**

1 copy sealed records, papers and files maintained in the court's record  
2 of the adoption case but may not be granted the right to inspect or  
3 copy:

4 “(i) The Adoption Summary and Segregated Information Statement  
5 and exhibits attached to the statement; or

6 “(ii) For adoption cases filed before the effective date of this 2013  
7 Act, any information, record, document or exhibit described in section  
8 5 of this 2013 Act.

9 “(B) The court may grant the motion for good cause. The name,  
10 address or other identifying information of any individual or entity  
11 other than the parent filing the motion contained in the records, pa-  
12 pers and files must be redacted and may not be disclosed as part of the  
13 inspection or copying allowed under this paragraph.

14 “(6) Except as provided in subsection (5)(c) of this section, an indi-  
15 vidual or entity that signed a record, paper or document in a file  
16 contained in the court's record of the adoption case is entitled to in-  
17 spect and obtain a copy of that record, paper or document without a  
18 court order. The signature of any other individual or entity on the  
19 same record, paper or document must be redacted or otherwise not  
20 disclosed as part of the inspection and copying permitted under this  
21 subsection.

22 “(7) The Department of Human Services or an Oregon licensed  
23 child-caring agency as defined in ORS 418.205 may, without a court  
24 order, access, use or disclose records, papers and files in the court's  
25 record of an adoption case that are in the possession of the department  
26 or the agency for the purpose of providing adoption services or the  
27 administration of child welfare services that the department or agency  
28 is authorized to provide under applicable federal or state law.

29 “(8) Except as otherwise provided in this section, a court may grant  
30 a motion and enter an order allowing inspection, copying or other

1 disclosure of records, papers and files in the court's record of an  
2 adoption case for good cause.

3 “(9) Nothing contained in this section shall prevent the clerk or  
4 court administrator from certifying or providing copies of a judgment  
5 of adoption to the petitioner in an adoption proceeding, to the  
6 petitioner's attorney of record or to the Department of Human Ser-  
7 vices.

8 “(10) The provisions of this section do not apply to the disclosure  
9 of information under ORS 109.425 to 109.507.

10 “(11) The court may impose and collect fees for copies and services  
11 provided under this section, including but not limited to filing, in-  
12 spection and research fees.

13 “(12) Unless good cause is shown, when the court grants a motion  
14 to inspect, copy or otherwise disclose records, papers and files in the  
15 court's record of an adoption case, the court shall order a prohibition  
16 or limitation on redisclosure of the records, papers and files, or of in-  
17 formation contained in the records, papers and files.

18 “(13) When inspection, copying or disclosure is allowed under this  
19 section, the court may require appropriate and reasonable verification  
20 of the identity of the requesting person to the satisfaction of the court.

22 **“SECTION 8.** ORS 419B.529 is amended to read:

23 “419B.529. (1) Notwithstanding ORS 109.309, a prospective adoptive parent  
24 is not required to file a petition for adoption when:

25 **“(a) One of the following has occurred:**

26 “[*a*] (A) A juvenile court that is a circuit court has entered an order  
27 of permanent commitment of a ward to the Department of Human Services  
28 under ORS 419B.527; or

29 **“(B) The parent has signed and the department has accepted a release and**  
30 **surrender to the department, and the parent has signed:**

1       “(i) A certificate of irrevocability and waiver as provided in ORS 418.270  
2 regarding a child; or

3       **“(ii) A certificate of waiver under the Indian Child Welfare Act re-**  
4 **garding a child;**

5       “(b) The department has completed a home study as defined in ORS  
6 109.304 that finds the prospective parent is suitable to adopt the child or  
7 ward and the department consents to the adoption of the child or ward by  
8 the prospective parent;

9       “(c) [A *home study*] **Written evidence of a home study** and a placement

3 **“SECTION 9.** ORS 109.311 is amended to read:

4 “109.311. (1) Each adoption petition filed pursuant to ORS 109.309 seeking  
5 adoption of a minor child shall be accompanied by a written disclosure  
6 statement containing an itemized accounting of all moneys paid or estimated  
7 to be paid by the petitioner for fees, costs and expenses related to the  
8 adoption, including all legal, medical, living and travel expenses. The form  
9 of the disclosure statement shall be prescribed by the Department of Human  
10 Services after consultation with approved Oregon licensed adoption agencies.

11 “(2) A court may not grant a judgment for an adoption of a minor child  
12 in the absence of a placement report by the department or an Oregon li-  
13 censed adoption agency unless the filing of such report has been waived by  
14 the department. A court may not grant a judgment for an adoption of a mi-

30 “(A) The department or a licensed Oregon adoption agency or an agent,

1 employee or person with whom the department or adoption agency has a  
2 contract authorizing such actions; or

17 “109.312. (1) Except as provided in ORS 109.314 to 109.329, consent in  
18 writing to the adoption **of a minor child pursuant to a petition filed un-**  
19 **der ORS 109.309 [of a child shall be given by] is required to be given by**  
20 **the following:**

21 “(a) The parents of the child, or the survivor of them.

22 “(b) The guardian of the child, if the child has no living parent.

23 “(c) The next of kin in this state, if the child has no living parent and  
24 no guardian.

25 “(d) Some suitable person appointed by the court to act in the proceeding  
26 as next friend of the child to give or withhold consent, if the child has no  
27 living parent and no guardian or next of kin qualified to consent.

28 “(2)(a) A person who gives consent to adoption under subsection (1) of  
29 this section may agree concurrently or subsequently to the giving of such  
30 consent that the consent shall be or become irrevocable, and may waive such

1 In such a case, the court shall allow the attorney for the excluded party to  
2 attend the conference.

3 “(d) Require that notice of the proceeding be provided by each petitioner  
4 to any or all of the following:

5 “(A) The spouse of each petitioner.

6 “(B) A person cohabiting with a petitioner who is interested in the affairs  
7 and welfare of the petitioner.

8 “(C) The adult children of each petitioner.

9 “(5) If, upon a petition for adoption presented and consented to in writing  
10 by each petitioner and the person to be adopted, the court is satisfied as to  
11 the identity and relations of each petitioner and the person to be adopted,

13 adoption, that each petitioner is not acting under duress, coercion or undue

25 a motion with the court asking the court to award a grandparent the right

10 “(a) Place the ward in the legal custody and guardianship of a public or  
11 private institution or agency authorized to consent in loco parentis to the  
12 adoption of children. An order pursuant to this paragraph is a ‘permanent  
13 commitment’ for the purposes of ORS 109.305, [109.309,] **109.118**, 109.312 to  
14 109.330 and 109.350 to 109.390; or

15 “(b) Make any order directing disposition of the ward that it is em-  
16 powered to make under this chapter.

17 “(2) If the rights of only one parent have been terminated, the authority  
18 to consent to the adoption of the ward as provided in subsection (1)(a) of this  
19 section is effective only with respect to the parent whose rights have been  
20 terminated.

21 **“SECTION 14.** ORS 109.400 is amended to read:

22 “109.400. (1) When a petition for adoption is filed with a court, the  
23 petitioner or the **petitioner’s** attorney [*thereof*] shall file with the petition  
24 an adoption report form as provided in ORS 432.415.

25 “(2) Notwithstanding [*ORS 7.211*] **section 6 of this 2013 Act**, if the court  
26 enters a judgment of adoption, the clerk of the court shall review the per-  
27 sonal particulars filled in on the form, shall fill in the remaining blanks on  
28 the form, shall certify the form and mail it to the State Registrar of the  
29 Center for Health Statistics as the adoption report as required under ORS

1       **“SECTION 15.** ORS 109.430 is amended to read:

2       “109.430. It is the policy of this state that adoption is based upon the legal  
3 termination of parental rights and responsibilities of birth parents and the  
4 creation of the legal relationship of parents and child between an adoptee  
5 and the adoptive parents. These legal and social premises underlying  
6 adoption must be maintained. The state recognizes that some adults who  
7 were adopted as children have a strong desire to obtain identifying infor-  
8 mation about their birth parents or putative father while other such adult  
9 adoptees have no such desire. The state further recognizes that some birth  
10 parents have a strong desire to obtain identifying information about their  
11 biological children who were adopted, while other birth parents have no such

23 genetic history of the adult adoptees, birth parents, putative fathers and  
24 other specified persons; and

25       “(4) Provide for disclosure of specific identifying information to Indian

27 igibility for tribal membership or for benefits or to a person responsible for  
28 settling an estate that refers to the adoptee.

29       **“SECTION 16. (1) Sections 3 to 5 of this 2013 Act and the amend-**  
30 **ments to ORS 109.304, 109.309, 109.311, 109.312, 109.329, 109.332, 109.400,**

1 **109.430, 419B.527 and 419B.529 by sections 1 and 2 and 8 to 15 of this 2013**  
2 **Act, apply to adoption cases commenced on or after the effective date**  
3 **of this 2013 Act.**

4 **“(2) Section 6 of this 2013 Act and the repeal of ORS 7.211 and 109.440**  
5 **by section 7 of this 2013 Act apply to adoption cases commenced before,**  
6 **on or after the effective date of this 2013 Act.”.**
