

**PROPOSED AMENDMENTS TO
HOUSE BILL 2748**

1 On page 1 of the printed bill, line 2, after “students;” delete the rest of
2 the line and line 3 and insert “and declaring an emergency.”.

3 Delete lines 5 through 31 and delete pages 2 through 6 and insert:

4 **“SECTION 1. (1) The Task Force on Tuition for Nonresident Stu-**
5 **dents is established.**

6 **“(2) The task force consists of 21 members appointed as follows:**

7 **“(a) The President of the Senate shall appoint four members from**
8 **among members of the Senate.**

9 **“(b) The Speaker of the House of Representatives shall appoint four**
10 **members from among members of the House of Representatives.**

11 **“(c) The Governor shall appoint six members as follows:**

12 **“(A) One member who is a parent of a student enrolled in a school**
13 **district that charges tuition from nonresident students;**

14 **“(B) One member who is a student who is enrolled in a school dis-**
15 **trict that charges tuition from nonresident students;**

16 **“(C) One member who represents the Department of Education;**

17 **“(D) One member who represents a school district that has an en-**
18 **rollment of fewer than 3,000 students;**

19 **“(E) One member who represents a school district that has an en-**
20 **rollment of 3,000 or more students, but fewer than 10,000 students; and**

21 **“(F) One member who represents a school district that has 10,000**
22 **or more students.**

1 **“(d) The Chief Education Officer shall appoint seven members as**
2 **follows:**

3 **“(A) One member who is a high school registrar;**

4 **“(B) Two members who are high school counselors;**

5 **“(C) Two members who teach special education and related services**
6 **in a high school; and**

7 **“(D) Two members who are high school principals.**

8 **“(3) The task force shall evaluate the impact of prohibiting school**
9 **district boards from charging tuition from nonresident students.**

10 **“(4) A majority of the voting members of the task force constitutes**
11 **a quorum for the transaction of business.**

12 **“(5) Official action by the task force requires the approval of a**
13 **majority of the voting members of the task force.**

14 **“(6) The task force shall elect one of its members to serve as**
15 **chairperson.**

16 **“(7) If there is a vacancy for any cause, the appointing authority**
17 **shall make an appointment to become immediately effective.**

18 **“(8) The task force shall meet at least quarterly in different regions**
19 **of this state at times and places specified by the call of the chairperson**
20 **or of a majority of the voting members of the task force.**

21 **“(9) The task force may adopt rules necessary for the operation of**
22 **the task force.**

23 **“(10) The task force shall submit a report in the manner provided**
24 **by ORS 192.245, and may include recommendations for legislation, to**
25 **the interim legislative committees on education no later than Decem-**
26 **ber 31, 2014.**

27 **“(11) The Department of Education shall provide staff support to**
28 **the task force.**

29 **“(12) Members of the task force who are not members of the Leg-**
30 **islative Assembly are not entitled to compensation, but may be reim-**

1 bursed for actual and necessary travel and other expenses incurred by
2 them in the performance of their official duties in the manner and
3 amounts provided for in ORS 292.495. Claims for expenses incurred in
4 performing functions of the task force shall be paid out of funds ap-
5 propriated to Department of Education for purposes of the task force.

6 “(13) All agencies of state government, as defined in ORS 174.111,
7 are directed to assist the task force in the performance of its duties
8 and, to the extent permitted by laws relating to confidentiality, to
9 furnish such information and advice as the members of the task force
10 consider necessary to perform their duties.

11 “SECTION 2. Section 1 of this 2013 Act is repealed on the date of
12 the convening of the 2015 regular session of the Legislative Assembly
13 as specified in ORS 171.010.

14 “SECTION 3. This 2013 Act being necessary for the immediate
15 preservation of the public peace, health and safety, an emergency is
16 declared to exist, and this 2013 Act takes effect on its passage.”.
