- In line 32, delete the boldfaced material.
- Delete lines 35 through 45.
- On page 10, delete lines 1 through 32 and insert:
- "(4)(a) Within 10 calendar days after the date of the trustee's sale, the trustee may rescind the trustee's sale and void the trustee's deed if:
- "(A) The trustee asserts that an error occurred during the trustee's sale, including but not limited to an error in the opening bid amount for the trustee's sale;
- "(B) The grantor and the beneficiary agreed to a foreclosure avoidance measure, as defined in section 2, chapter 112, Oregon Laws 2012, that would postpone or discontinue the trustee's sale; or
- "(C) The beneficiary accepted funds to reinstate the trust deed and obligation in accordance with ORS 86.753, even if the beneficiary did not have a legal duty to do so.
- "(b) Within 10 calendar days after the date of the trustee's sale that the trustee rescinded under paragraph (a) of this subsection, the trustee shall provide notice of the rescission of the trustee's sale to any person to whom

 - "(d) The trustee's deed conveys to the purchaser the interest in the property that the grantor had, or had the power to convey, at the time the grantor executed the trust deed, together with any interest the grantor or the grantor's successors in interest acquire after the execution of the trust deed."

On page 16, delete lines 4 through 7 and insert:

"(c) Shall continuously maintain a registered agent and a registered office in this state and file a statement that identifies the person's registered agent and lists the address of the person's registered office with the Secretary of State, if the trustee is a person described in paragraph (b)(B) of this subsection, or with the Director of the Department of Consumer and Business Services under ORS 731.434, if the trustee is a person described in paragraph (b)(C) of this subsection."
