

**PROPOSED AMENDMENTS TO
HOUSE BILL 2004**

1 On page 1 of the printed bill, line 2, after “amending” delete the rest of
2 the line and line 3 and insert “sections 3 and 4, chapter 566, Oregon Laws
3 2011; and declaring an emergency.”.

4 Delete lines 5 through 30 and delete page 2 and insert:

5 **“SECTION 1.** Section 3, chapter 566, Oregon Laws 2011, is amended to
6 read:

7 **“Sec. 3.** (1) Notwithstanding the \$15 million limitation [*expressed*] **de-**
8 **scribed** in ORS 757.612 (7)(b), the Public Utility Commission shall direct
9 electric companies or Oregon Community Power to collect a combined total
10 of an additional \$5 million per 12-month period from residential electricity
11 consumers for the low-income electric bill payment assistance provided for
12 in ORS 757.612 (7)(a) if the Housing and Community Services Department
13 requests an increase. [*due to finding, in consultation with the advisory com-*
14 *mittee on energy, that two or more of the following events have occurred:*]

15 “[*(a) The unemployment rate in Oregon as determined by the Bureau of*
16 *Labor Statistics of the United States Department of Labor has exceeded 10*
17 *percent for at least six months of the previous 12-month period.*]

18 “[*(b) The poverty rate in Oregon as determined by the United States Census*
19 *Bureau has exceeded 12 percent during the previous 12-month period.*]

20 “[*(c) The moneys allocated for the year under the federal Low Income Home*
21 *Energy Assistance Act of 1981 (42 U.S.C. 8621 et seq.) are 75 percent or less*
22 *of the previous year’s allocation.*]

1 “(d) *The number of households in Oregon receiving supplemental nutrition*
2 *assistance has exceeded 20 percent during the previous 12-month period.*”]

3 “(2) The additional moneys collected pursuant to this section may not be
4 collected for more than[.] **a total of 24 months.**

5 “(a) *Twelve months from the date that the Public Utility Commission di-*
6 *rects the electric companies or Oregon Community Power to make the col-*
7 *lection, without an additional finding by the Housing and Community Services*
8 *Department, not less than nine months after its initial finding under sub-*
9 *section (1) of this section, that two or more of the events specified in subsection*
10 *(1) of this section have occurred; or]*

11 “[(b) *A total of 24 months.*]

12 “**SECTION 2.** Section 4, chapter 566, Oregon Laws 2011, is amended to
13 read:

14 “**Sec. 4.** Section 3, **chapter 566, Oregon Laws 2011**, [*of this 2011 Act*] is
15 repealed on January 2, [*2014*] **2016.**

16 “**SECTION 3. (1) The Director of the Housing and Community Ser-**
17 **VICES Department shall appoint an advisory committee on low-income**
18 **electric bill payment assistance funding. Members of the committee**
19 **must include:**

20 “(a) **A representative from each electric company whose ratepayers**
21 **contribute funding to the Housing and Community Services Depart-**
22 **ment Low-Income Electric Bill Payment Assistance Fund established**
23 **in ORS 456.587;**

24 “(b) **A representative of the Citizens’ Utility Board established un-**
25 **der ORS chapter 774; and**

26 “(c) **A representative of Community Action Partnership of Oregon,**
27 **as defined in ORS 456.515.**

28 “(2) **The committee shall study the duties, functions and powers of**
29 **the Housing and Community Services Department under ORS 757.612**
30 **(7) for the purpose of determining to which agency or entity those**

1 duties, functions and powers should be transferred during the 2014
2 regular session of the Seventy-seventh Legislative Assembly. In mak-
3 ing the determination, the committee shall consider:

4 “(a) How best to minimize costs associated with the administration
5 of ORS 757.612 (7);

6 “(b) How to provide better service to low-income retail electricity
7 consumers; and

8 “(c) The circumstances under which funds for low-income electric
9 bill payment assistance under ORS 757.612 (7) should be collected.

10 “(3) The committee shall report the results of the study under
11 subsection (2) of this section, and shall make recommendations for
12 proposed legislation, to the appropriate interim committees of the
13 Legislative Assembly, as determined by the committee, no later than
14 December 1, 2013.

15 “(4) Official action by the committee requires the approval of a
16 majority of the members of the committee.

17 “(5) The committee shall elect one of its members to serve as
18 chairperson.

19 “(6) The committee shall meet at times and places specified by the
20 call of the chairperson or of a majority of the members of the com-
21 mittee.

22 “(7) If there is a vacancy for any cause, the Director of the Housing
23 and Community Services Department shall make an appointment to
24 become immediately effective.

25 “(8) All agencies of state government, as defined in ORS 174.111, are
26 directed to assist the committee in the performance of its duties and,
27 to the extent permitted by laws relating to confidentiality, to furnish
28 such information and advice as the members of the committee con-
29 sider necessary to perform their duties.

30 **SECTION 4.** Section 3 of this 2013 Act is repealed on the date of

1 **the convening of the 2014 regular session of the Legislative Assembly**
2 **as specified in ORS 171.010.**

3 **“SECTION 5. This 2013 Act being necessary for the immediate**
4 **preservation of the public peace, health and safety, an emergency is**
5 **declared to exist, and this 2013 Act takes effect on its passage.”.**
